**HOUSE RESOLUTION 1313**

Offered by Representative Lang:

WHEREAS, Hamas was founded with the stated goal of destroying the State of Israel; and

WHEREAS, Hamas has been designated by the United States Secretary of State as a Foreign Terrorist Organization; and

WHEREAS, Hamas refuses to recognize Israel's right to exist, renounce violence, and accept previous agreements between Israel and the Palestinians; and

WHEREAS, Hamas has launched thousands of rockets and missiles since Israel dismantled settlements and withdrew from Gaza in 2005; and

WHEREAS, Terrorists in the Hamas-controlled Gaza Strip have fired approximately 900 rockets and

missile shells into Israel this year, an increase from roughly 675 attacks in 2011 and 350 in 2010; and

WHEREAS, Hamas has increased the range of its rockets, reportedly with support from Iran and others; these rockets put additional numbers of Israelis in danger of rocket attacks from Gaza; and

WHEREAS, There are many public and private connections between the State of Illinois and the State of Israel and a desire to deepen and expand mutual opportunities; and

WHEREAS, On November 14, 2012, President Barack Obama condemned the rocket fire from Gaza into Israel and reiterated Israel's right to self-defense; and

WHEREAS, Israel, a fellow democracy, has an inherent right to self defense in the face of terrorist attacks; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we express our unwavering commitment to the security of the State of Israel as a Jewish and democratic state with secure borders and recognize and strongly support its inherent right to act in self-defense to protect its citizens against acts of terrorism; and be it further

RESOLVED, That we state our unequivocal belief that Hamas must end Gaza-linked terrorist rocket and missile attacks against Israel, recognize Israel's right to exist, renounce violence, and agree to accept previous agreements between Israel and the Palestinians; and be it further

RESOLVED, That we urge the United Nations Security Council to condemn the recent spike in Gaza-linked terrorist missile attacks against Israel, which risk causing civilian casualties in both Israel and Gaza; and be it further

RESOLVED, That we encourage the President to continue to work diplomatically with the international community to prevent Hamas and other Gaza-based terrorist organizations from retaining or rebuilding the capability to launch rockets and missiles against Israel.

#### HOUSE RESOLUTION 1316

Offered by Representative Ford:

WHEREAS, Small businesses are the engine for job recovery in the State of Illinois; and

WHEREAS, Adding a new employee for a small business is one of the most important decisions a small business owner can make; and

WHEREAS, Letting an employee go, either for cause or because of a poor fit, affects the experience rating of an employer, which determines the unemployment insurance tax rate the employer pays; and

WHEREAS, The experience rating calculation affects a small business that lets a single employee go disproportionately more than a large business that lets a single employee go, as a single employee is a much larger percentage of the workforce of a small business than a large business; and

WHEREAS, Small businesses are particularly leery of a higher experience rating, as that will lead to a higher unemployment insurance tax rate; and

WHEREAS, Current law only permits employers 30 working days to review the performance of a new employee before that employee impacts the experience rating of the employer; and

WHEREAS, Many small business employers believe that 30 days is not enough time to properly review whether a new employee is the right fit for a company; and

WHEREAS, The relatively short period of time before an employer is liable for a higher experience rating to pay the unemployment benefits of a former employee is a disincentive to hiring; and

WHEREAS, A more reasonable period of time, such as 90 days, would lessen this disincentive to hiring; and

WHEREAS, This period of time before the experience rating of an employer is affected for an employee that does not work out is unrelated to the question of how many weeks of benefits an employee is entitled to; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that all stakeholders in the State's unemployment insurance system are encouraged to consider the best amount of time to give employers to decide whether an employee is a good fit before their experience rating is affected, in order to encourage job growth.

## HOUSE RESOLUTION 1317

Offered by Representative Ford:

WHEREAS, The unemployment insurance tax is assessed against employers in order to cover the costs of any benefits drawn out by the former employees of each employer; and

WHEREAS, The unemployment insurance tax rate varies according to each employer; and

WHEREAS, The unemployment insurance tax is assessed against the same base wage of the first \$11,000 earned by each employee; and

WHEREAS, For the vast majority of employers, the entire unemployment insurance tax is assessed and paid in the first quarter of the calendar year, as most employees earn more than \$11,000 in the first quarter of the year; and

WHEREAS, For example, if a typical unemployment tax is approximately \$800 per employee, a 10-employee firm must come up with \$8,000 in the first quarter of the year, instead of \$2,000 every quarter, to pay the unemployment tax; and

WHEREAS, This situation presents a cash crunch for small and mid-market employers who must finance the entire year's unemployment tax in the first quarter of the calendar year; and

WHEREAS, Larger employers are more likely to have the capital to finance the unemployment insurance tax over the entire year, while small and mid-market businesses without the capital must pay all the tax as it comes due; this situation hits small and mid-market businesses with a cash flow impact proportionately harder than larger employers; and

WHEREAS, Small and mid-market businesses would prefer to spread out the payments for the unemployment insurance tax over the entire year to avoid the cash crunch in the first quarter, while still paying the same total amount; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we state our belief that eliminating the first quarter cash crunch of small and mid-market businesses paying unemployment taxes by allowing for quarterly payments based upon the accrued obligation is a pro-business public policy move; and be it further

RESOLVED, That we encourage all interested stakeholders in the State's unemployment insurance system to consider this shift before the next General Assembly in order to reach a consensus on the best revenue-neutral method of eliminating the current policy of imposing a first-quarter cash crunch on Illinois businesses.

## HOUSE JOINT RESOLUTION 106

Offered by Representative Chapa LaVia:

WHEREAS, The State of Illinois has deemed it important to undo historical prejudices by creating special classifications for businesses that are majority owned and operated by minorities (MBE), women (WBE), or veterans (VOB and SDVOB); and

WHEREAS, The State of Illinois' procurement policies commonly request that goals be met by MBE, WBE, and VOB/SDVOB businesses; and

WHEREAS, The State of Illinois has defined a special classification company as a company that is at least 51% owned and fully controlled by a special classification individual or a group of special classification individuals; and

WHEREAS, The State of Illinois Central Management Services' Business Enterprise Council has been charged with the task of determining whether a company meets the criteria for a special classification; and

WHEREAS, There have been well documented cases of fraudulent MBE, WBE, SDVOB, and VOB companies being created; it is the responsibility of the Business Enterprise Council to vigilantly oppose these applications for special classification; and

WHEREAS, Small businesses in the present day marketplace will often sell equity in their company to investors, such as angel investors and venture capitalists, in order to raise capital; and

WHEREAS, It is acknowledged that equity investors in companies often will have no say in the operation, control, or direction of the company; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we request that the Central Management Services Business Enterprise Council includes the equity ownership of silent investors of the same special classification in the calculations of the majority ownership of a company; and be it further

RESOLVED, That we request that the Central Management Services Business Enterprise Council include silent investor equity when calculating control of a company when the silent investors have given controlling authority to one or more persons of that classification; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Central Management Services Business Enterprise Council.
