HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 38

Offered by Representative Chapa LaVia:

WHEREAS, The State of Illinois has deemed it important to undo historical prejudices by creating special classifications for businesses that are majority owned and operated by minorities (MBE), females (WBE), or veterans (VOB and SDVOB); and

WHEREAS, The State of Illinois' procurement policies commonly request that goals be met by MBE, WBE, and VOB/SDVOB businesses; and

WHEREAS, The State of Illinois has defined a special classification company as a company that is at least 51% owned by a special classification individual or a group of special classification individuals and is actually controlled by the same special individual or group of individuals; and

WHEREAS, The State of Illinois Central Management Services' Business Enterprise Program Council has been charged with the task of determining whether a company meets the criteria for a special classification; and

WHEREAS, There have been well documented cases of fraudulent MBE, WBE, SDVOB, and VOD companies being created; it is the responsibility of the Business Enterprise Program to continue to oppose these applications for special classification; and

WHEREAS, Small businesses in the present day marketplace will often sell equity in their company to investors, such as angel investors and venture capitalists, in order to raise capital; and

WHEREAS, It is acknowledged that equity investors in companies often will have no say in the operation, control, or direction of the company; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we request that the Central Management Services Business Enterprise Program Council includes the equity ownership of silent investors of the same special classification in the calculations of the majority ownership of a company; and be it further

RESOLVED, That we request that the Central Management Services Business Enterprise Program Council include silent investor equity when calculating control of a company when the silent investors have given controlling authority to one or more persons of that classification; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Central Management Services Business Enterprise Program Council.

HOUSE RESOLUTION 39

Offered by Representative Jones:

WHEREAS, February 7, 2013, is the 12th annual commemoration and observance of National African-American HIV/AIDS Awareness Day; and

WHEREAS, This observance is a nationwide effort to mobilize African-American communities to get educated, get tested, get involved, and get treated around HIV/AIDS, as it continues to devastate African-American communities; and

WHEREAS, National African-American HIV/AIDS Awareness Day is directed, planned, and strategically implemented by HIV/AIDS organizations to mobilize community-based organizations aid stakeholders involved in HIV/AIDS prevention, care and treatment; and

WHEREAS, Nearly 46,000 residents of Illinois are living with HIV and 55% of people diagnosed with HIV are African-American; and

WHEREAS, African-American gay men under the age of 30 in Chicago have an infection rate 3 times greater than their white counterparts; and

WHEREAS, Over two-thirds of women diagnosed with HIV in the United States are African-American; and

WHEREAS, Among African-Americans ages 25-44, HIV was the 4th leading cause of death for men and third leading cause of death for women, higher than any other racial group; and

WHEREAS, Numerous organizations, faith-based institutions, public health entities, and impacted citizens are hosting community events to recognize this day and its importance to African-Americans and all concerned citizens; and

WHEREAS, It is fitting that we join with these local, national, and international groups to express our strong support for National African-American HIV/AIDS Awareness Day and the initiatives to prevent the spread of HIV/AIDS in African-American communities and provide access to and utilization of HIV/AIDS prevention, treatment and support services to those affected by HIV/AIDS; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate February 7, 2013, as National African-American HIV/AIDS Awareness Day in State of Illinois and encourage the citizens of this State to strongly support this day and participate in events planned to commemorate the occasion.

HOUSE RESOLUTION 47

Offered by Representative DeLuca:

WHEREAS, During pregnancy, expecting mothers will receive a variety of tests for conditions such as Down Syndrome and other birth defects; and

WHEREAS, Moms have always known that movement is the best sign of their babies' well-being in utero; scientific studies indicate that kick counting, a daily record of moms' perception of their babies' movement during the third trimester, is a reliable, harmless, simple and effective screening for the babies' well-being; and

WHEREAS, Kick counting can document changes in the fetal movement pattern and can help moms-tobe alert their healthcare provider of potential problems; a timely evaluation can allow intervention and prevention of potential problems, including stillbirth; and

WHEREAS, The American College of Obstetricians and Gynecologists recommends kick counting as one method to monitor pregnancy health, through noting the time it takes for a baby to complete 10 movements, such as kicks, jabs, rolls, twists, and turns, when the baby is usually most active during the day; and

WHEREAS, A mother's familiarity with her baby's movements helps identify changes that may indicate potential pregnancy problems, which can allow her provider to institute timely intervention; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage the people of this State to help us in raising awareness of the importance of kick counting during pregnancy.

Offered by Representative Ford:

WHEREAS, The members of the Illinois House of Representatives recognize that over the last 150 years, beginning with the Emancipation Proclamation, African Americans have made strides and advancements toward equality; the Civil Rights Movement enabled groundbreaking legislation such as the Voting Rights Act of 1965; today, we pay annual tribute to one of the pioneers and most prominent stars of the Civil Rights Movement, Dr. Martin Luther King Jr.; however, there is still much work to be done particularly as it relates to the economic disparity in too many African American communities; and

WHEREAS, We recognize that communities throughout Illinois are struggling under the weight of many economic and social problems including unemployment, poverty, mortgage foreclosures, deficiencies in public health services, and crime; and

WHEREAS, These economic and societal challenges created or exacerbated conditions which include inequalities in access to justice in the civil court system, an overburdened and ineffective criminal justice system, overcrowding conditions in correctional facilities, increased homelessness, increases in teen pregnancy, inadequate educational opportunities, a lack of affordable housing, insufficient delivery of social services to the less fortunate, and deficiencies in the delivery of public health services; and

WHEREAS, Although unemployment is a lingering problem for the economy as a whole, a recent study revealed that the recent unemployment rate for blacks in Illinois was 17.5%, compared to 8.2% for whites, and 9.8% for all workers; and

WHEREAS, 75.5% of homicide victims in the State of Illinois are black, and in the first 6 months of 2012, when there was a 38% increase in the homicide rate, 77.6% of homicide victims in the City of Chicago were black; and

WHEREAS, The teen birth rate in the United States was recently 38.1 births for every 1,000 teens, but in a comparable time period in Illinois the teen birth rate was 77.9 births for every 1,000 teens for black teens, while the white teen birth rate was 20.6 per every 1,000 teens; and

WHEREAS, The inmate population in the Illinois Correctional system is approximately 58% black, and the high proportion of young black males with criminal convictions is a well-recognized phenomenon; and

WHEREAS, Black leaders in Illinois are not alone in recognizing that these broad social problems often strike the hardest in the black community; and

WHEREAS, It is painful for the black leaders to ponder the stories of human struggle, despair, and hurt that all too often over shadow the stories of success and hope; and

WHEREAS, State government resources are expended in ever-increasing amounts to address these social and economic problems and those expenditures are a significant drain on the State's road to financial stability; and

WHEREAS, State government, taxpayers, members of the General Assembly, and the black community could benefit from the creation of an action plan that identifies: what modifications could be made to existing State of Illinois programs, including those statutory and regulatory changes to the current laws and regulations in Illinois that could dramatically improve the delivery of services and also reduce wasteful spending, how leadership programs and new educational opportunities will foster and equip new leadership in the black community, and ways in which State government may actively create a change environment that will have positive impacts on the many social problems that exist in Illinois, especially in the black community; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor to create a commission, composed of stakeholders in the communities where these problems continue to devastated families, representatives of appropriate State agencies, ministers, business leaders, and all community appropriate stake holders to explore, discuss, and coordinate efforts to prepare an action plan to offer enhanced State governmental services in a meaningful way, foster leadership in communities, and create programs that can foster success in addressing the myriad of social and economic problems in the affected communities; and be it further

RESOLVED, That we urge that the Governor appoint members of the commission by August 1, 2013 so as to allow the commission to hold its first meeting soon after the appointments; and be it further

RESOLVED, That the commission be charged with: finding and creating innovative means to address and meet the numerous needs of the black community, designing plans to assist and enhance the efforts of State agencies and local governments that serve blacks in communities throughout the State, analyzing other successful State and local governmental programs in law enforcement, job retraining, education,

economic opportunity, job creation, social services, and public health, and developing an action plan that includes information about changes and improvements to existing programs that can be made without allocating additional tax dollars to the programs by reallocating existing resources; and be it further

RESOLVED, That we urge the commission to hold public hearings and issue a written report of its findings and recommendations to the Governor and to the General Assembly on or before December 30, 2013; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Governor Pat Quinn.

HOUSE JOINT RESOLUTION 8

Offered by Representative Verschoore:

WHEREAS, The Rock River, known for its beauty and ecological importance, flows south through Rockford, then southwest across northwestern Illinois, passing Oregon, Dixon, Sterling, and Rock Falls before joining the Mississippi River at Rock Island; and

WHEREAS, The Rock River provides opportunities for conservation and recreation for many residents of this State; and

WHEREAS, The Rock River has had an important role in Illinois history, and it attracts many tourists each year to such spots as the area in Dixon where former President Ronald Reagan once served as a lifeguard and his favorite fishing spot, now called "Dutch Landing", located just southwest of Lowell Park; and

WHEREAS, Designating the roads along the Illinois portion of the Rock River Trail as a Scenic and Historic Route will encourage residents and visitors alike to explore, appreciate, and enjoy the many wonders of the Rock River; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Rock River Trail Scenic and Historic Route is designated as follows:

- (1) from the Illinois-Wisconsin State Line at Shirland Avenue, along South Bluff Road in Rockton Township to Rockton Road on County Highway 9;
- (2) along Rockton Road from South Bluff Road to Race Street in Rockton;
- (3) along Race Street from Rockton Road to West Main Street in Rockton;
- (4) along West Main Street from Race Street to South Blackhawk Boulevard;
- (5) along South Blackhawk Boulevard from West Main Street to Russell Street;
- (6) along Russell Street from South Blackhawk Boulevard to Old River Road;
- (7) along Old River Road from Russell Street to Latham Road;
- (8) along Latham Road from Old River Road to Illinois Route 2;
