HOUSE RESOLUTION 241

Offered by Representative McSweeney:

WHEREAS, Illinois' income tax has been levied at a non-graduated rate since its inception in 1969; and
 WHEREAS, The current flat rate structure is a commitment from the Constitution of the State of Illinois;
 and

WHEREAS, Illinois' current flat tax rate provides a more predictable, sustainable, and enticing climate for businesses and individuals alike; and

WHEREAS, A graduated income tax is unresponsive to a modern economy, contributing to slower economic growth, less entrepreneurship, and fewer new jobs; and

WHEREAS, States with lower tax burdens, lower marginal tax rates, and less progressivity have more robust economies, with strong incentives to live, work, and start new businesses; and

WHEREAS, A graduated income tax creates an ever-increasing disincentive for work at each "step" in the marginal tax rate; and

WHEREAS, Sound tax policy should reward work effort, saving, investment, risk-taking, and entrepreneurship to promote self-sustaining prosperity; and

WHEREAS, Taxpayers would have no certainty what the final tax rates would be in the event that a constitutional amendment permitting a graduated income tax goes before voters; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we state our belief that the Illinois Constitution should not be amended to permit a graduated income tax; and be it further

RESOLVED, That suitable copies of this resolution be delivered to all Illinois constitutional officers, the Speaker and Minority Leader of the Illinois House of Representatives, and the President and Minority Leader of the Illinois Senate.

HOUSE RESOLUTION 242

Offered by Representative Jones:

WHEREAS, During the 97th General Assembly, a tax incentive package was approved for the Sears Holdings Corporation in order to ensure that the company would remain in the State and continue to provide jobs to thousands of Illinois citizens; and

WHEREAS, The tax incentive package enabled Sears to receive \$15 million in annual tax credits for 10 years and extend a special taxing district that reduces the company's local property tax rates for 15 years; and

WHEREAS, Less than 2 weeks after the tax incentive package was finalized, Sears announced that it planned to close more than 100 Sears and Kmart stores throughout the nation; the company also laid off 100 workers at its headquarters in Hoffman Estates and closed the Sears store in Calumet City, which resulted in 164 employees left without gainful employment; and

WHEREAS, As an Illinois corporate resident, the General Assembly passed legislation in good faith to assist with keeping the Sears headquarters in Illinois and safeguarding the jobs of Illinoisans; by closing stores and taking jobs away from Illinois taxpayers, Sears has abandoned Illinois and its communities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Sears Holdings Corporation to reconsider the financial impact that the removal of jobs has on rebuilding communities and to pay back any tax incentive revenue received in Fiscal Years 2012 and 2013; and be it further

RESOLVED, That we urge the Illinois Attorney General's Office to review the actions taken by the Sears Holding Corporation regarding the tax incentive program; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Illinois Attorney General and the Sears Holdings Corporation.

(ROLL CALL 5)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

On motion of Representative Drury, HOUSE BILL 353 was taken up and read by title a third time. And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 115, Yeas; 0, Nays; 0, Answering Present.

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.
