Representative Monique Davis, withdrew the following written motion, that was previously placed on the order of Motions in Writing:

MOTION

Pursuant to Rule 65, and having voted on the prevailing side, I move to reconsider the vote by which HOUSE BILL 2473 passed in the House on April 19, 2013.

With the consent of the affected members, Representative Currie was removed as principal sponsor, and Representative Williams became the new principal sponsor of SENATE BILL 1640.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 301

Offered by Representative Sims:

WHEREAS, Alpha Phi Alpha Fraternity, Incorporated, was founded on December 4, 1906, by 7 college men, respectfully known as the "Seven Jewels", on the campus of Cornell University in Ithaca, New York, becoming the first intercollegiate Greek-letter fraternity established by and for African-Americans; and

WHEREAS, The Seven Jewels of the Fraternity, Henry Arthur Callis, Charles Henry Chapman, Eugene Kinckle Jones, George Biddle Kelley, Nathaniel Allison Murray, Robert Harold Ogle, and Vertner Woodson Tandy, recognized the need for a strong bond of brotherhood among African descendants in this country while stressing academic excellence among its members; the founders recognized the need to help correct the educational, economic, political, and social injustices faced by African-Americans and other people of color; and

WHEREAS, Alpha Phi Alpha initially served as a study and support group for minority students who faced racial prejudice, both educationally and socially, at Cornell University; the Jewel Founders and early leaders of the Fraternity succeeded in laying a firm foundation for Alpha Phi Alpha's principles of scholarship, fellowship, good character, and the uplifting of humanity; and

WHEREAS, Since its founding, Alpha Phi Alpha has consistently supplied its voice and vision to the struggle of African-Americans, people of color, and issues of civil rights around the world; and

WHEREAS, The aims of Alpha Phi Alpha are manly deeds, scholarship, and love for all mankind; and

WHEREAS, The mission of Alpha Phi Alpha is to develop leaders, promote brotherhood and academic excellence, and provide service and advocacy for communities, as exemplified through its national programs, which include "Go to High School, Go to College", which focus on the educational achievement of students in elementary, secondary, and post-secondary schools and has given thousands of dollars in scholarship funds

to deserving students; "Project Alpha", which teaches teenage pregnancy prevention and sexually transmitted disease prevention to young males, and "Voteless People is a Hopeless People", a voter registration and education program, through which thousands of voters have been educated and registered; Alpha Phi Alpha also focuses on providing service through its strategic partnerships with Big Brothers Big Sisters, the Boy Scouts of America, March of Dimes, the American Heart/American Stroke Association, and the American Cancer Society; and

WHEREAS, For over 106 years, Alpha Phi Alpha has played a fundamental role in the positive development of the character and education of more than 200,000 men; and

WHEREAS, Alpha Phi Alpha has over 700 college and alumni chapters in the United States of America, the District of Columbia, Africa, Asia, the Caribbean, and Europe; this total includes 140 chapters in the Midwestern Region, including 31 in Illinois; the Midwestern Region includes the states of Illinois, Indiana, Iowa, Kansas, Kentucky, Michigan, Minnesota, Missouri, Ohio, Nebraska, West Virginia, Wisconsin, and Canada; Alpha Phi Alpha's presence started in Illinois, with the founding of the first college chapter in Illinois, the Theta Chapter, in 1910, and the first alumni chapter, the Xi Lambda Chapter, which was founded in 1924, both in Chicago; and

WHEREAS, Members of Alpha Phi Alpha include many noteworthy leaders in the areas of government, business, entertainment, science, and higher education, including the likes of Dr. Martin Luther King, Jr., Thurgood Marshall, W.E.B. DuBois, John Hope Franklin, John H. Johnson, Adam Clayton Powell, Andrew Young, and Cornel West; its membership also includes State and local elected officials, including former U.S. Senator Roland Burris, former Cook County Board Presidents John and Todd Stroger, and former Mayor of Chicago Eugene Sawyer, among countless others who have long stood at the forefront of the fight for civil and human rights and social change for all Americans; and

WHEREAS, Several Alpha Phi Alpha members have served in the Illinois General Assembly, including the following members of the 98th General Assembly: Senator Donne E. Trotter and Representatives Al Riley, Arthur Turner, Jr., Emanuel "Chris" Welch, and Elgie R. Sims, Jr., who also serves as the 26th Vice President of the Midwestern Region; and

WHEREAS, Alpha Phi Alpha continues to enrich the lives of its members, who, in turn, provide service and advocacy for the communities they serve with a commitment to service and the uplifting of humanity; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize and honor the 2013 Alpha Phi Alpha Day held at the Illinois State Capitol and welcome the members of Alpha Phi Alpha to the Capitol; and be it further

RESOLVED, That we designate the date of May 8, 2013 as Alpha Phi Alpha Day in the State of Illinois in honor of Alpha Phi Alpha Fraternity, Incorporated, and its continued service and impact on the communities it serves; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Elgie R. Sims, Jr., Esq., Midwestern Regional Vice President; Sharron R. Anderson, Assistant Regional Vice President; the Illinois District Director and the Assistant Illinois District Director; and the Presidents of the 31 College and Alumni Chapters of Alpha Phi Alpha Fraternity, Incorporated, located in the District of Illinois.

HOUSE RESOLUTION 303

Offered by Representative Martwick:

WHEREAS, The members of the Illinois General Assembly are saddened to learn of the death of polka sensation Eddie Blazonczyk Sr., who passed away on May 21, 2012; and

WHEREAS, Eddie Blazonczyk Sr. was born on July 12, 1941, in Chicago; he grew up hearing a broad range of polka bands at the Pulaski Ballroom and the Mountaineer Tavern, which were operated on the southwest side of Chicago by his parents; he attended high school in Wisconsin and ventured out into rock-and-roll, initially performing under the name of Eddie Bell and touring with the likes of Buddy Holly, Gene Vincent, and Brenda Lee; and

WHEREAS, Eddie Blazonczyk Sr. had his own publishing company, his own label known as Bel-Aire, a music school, and was constantly touring with the Versatones, a band that flourished from the early 1960s until December of 2011; and

WHEREAS, Eddie Blazonczyk Sr. is a 1986 Grammy award winner for the album "Another Polka Celebration; he received over a dozen Grammy nominations throughout his career and was awarded a National Heritage Fellowship in 1998 presented by then First Lady Hillary Rodham Clinton; and

WHEREAS, Eddie Blazonczyk Sr. is survived by his son, Eddie Blazonczyk, Jr.; his wife, Christine "Tish" Blazonczyk; his son, Anthony (Rena); his daughter, Katherine; his grandchildren, Cayle, Anya, and Anthony, Jr.; his sister, Louise Kurek; and many nieces and nephews; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we mourn the passing of Eddie Blazonczyk Sr., and extend our sincere condolences to his family, friends, and all who knew and loved him; and be it further

RESOLVED, That to honor his memory we declare Eddie Blazonczyk Sr.'s song "Polka Celebration" as the official Illinois State polka; and be it further

HOUSE JOINT RESOLUTION 35

WHEREAS, Ray LaHood was appointed United States Secretary of Transportation in January of 2009; and

WHEREAS, Prior to becoming the United States Secretary of Transportation, Ray LaHood served Illinois' 18th Congressional District for 7 terms spanning the years 1995 to 2009, where he served on the House Transportation and Infrastructure Committee and the House Appropriations Committee; and

WHEREAS, Secretary LaHood is a lifelong Peoria resident; he earned a degree in education and sociology at Bradley University and taught in public and Catholic Schools; and

WHEREAS, Secretary LaHood has dedicated his career to improving Peoria and central Illinois; he served as the chief planner for the Rock Island-based Bi-Metropolitan Commission, as an aid to Congressman Tom Railsback and Congressman Robert Michel, and as a member in the Illinois House of Representative from 1982 to 1983; and

WHEREAS, During his time serving in congress, Secretary LaHood was a leader in efforts to enhance central Illinois' infrastructure and promote economic development and helped make possible the funding for the construction of Interstate 74 between the Murray Baker Bridge and the Sterling Avenue Exit; and

WHEREAS, The City of Peoria made the decision to name this section of highway after Secretary LaHood; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, That we designate the section of Interstate 74 between the Murray Baker Bridge and the Sterling Avenue Exit in Peoria as the Ray LaHood Highway in honor of the Secretary's service to the State of Illinois and his essential role in securing funding for the highway; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State regulations, plaques or signs giving notice of the name; and be it further
