HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 347

Offered by Representative William Davis:

WHEREAS, The members of the Illinois House of Representatives recognize the critical importance of reading proficiency for children to prepare for college and careers in the 21st century workplace; and

WHEREAS, The most important period for development of reading proficiency is kindergarten through grade 2; and

WHEREAS, The State of Illinois in 2000 authorized and funded the development of a multifaceted, classroom-based literacy assessment that provides data to design meaningful instruction in order to identify students in need of additional attention and to enable all children to meet the Illinois Learning Standards as measured by the Illinois Standards Achievement Test in grade 3; and

WHEREAS, This assessment, known as the Illinois Snapshot of Early Literacy (ISEL), was developed collaboratively by Illinois institutions of higher education, classroom teachers, and administrators throughout our State; and

WHEREAS, ISEL has been used beneficially to help guide instruction for thousands of Illinois schoolchildren, thus proving its value in literacy development and subsequent advanced reading skills; and

WHEREAS, ISEL is owned by the State Board of Education; and

WHEREAS, ISEL is research-based, valid and reliable, endorsed by national literacy experts, and aligns closely to the Illinois Learning Standards and Common Core State Standards, which have been adopted by Illinois; and

WHEREAS, ISEL is made available by this State to all Illinois schools in paper form free of charge; and

WHEREAS, ISEL is complemented by a sophisticated technology platform that was funded by this State, the Chicago Community Trust, and other charitable foundations and was developed by the Center, Resources for Teaching and Learning, an Illinois 501(c)(3) organization that has worked closely with the State Board of Education and other State agencies for the past 40 years; and

WHEREAS, ISEL can be administered by school districts at a substantially lower cost per student than any other technology-based commercial assessment instrument, thus saving schools a substantial amount of money; and

WHEREAS, ISEL was designed by this State and its collaborators to work effectively with any computer operating system and mobile device, thus further reducing the cost of using this instrument; and

WHEREAS, Illinois has adopted the Common Core State Standards and is a member of the Partnership for Assessment of Readiness for College and Careers (PARCC); and

WHEREAS, Other states have received recognition for the national use of assessments and other diagnostic instruments developed with their own resources; and

WHEREAS, PARCC plans to develop a K-2 formative assessment for early literacy; therefore, be it

RESOLVED, That the State of Illinois formally encourages ISBE to make ISEL available to the other states within the PARCC consortium so that their students and teachers may benefit from this excellent

assessment, developed in Illinois by Illinois early literacy experts, institutions of higher learning, educators, and administrators; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Chairperson of the State Board of Education and the PARCC governing board.

HOUSE RESOLUTION 350

Offered by Representative Arroyo:

WHEREAS, Military heroes who served valiantly and honorably in wars in which this country's freedom was at stake should be recognized by the people of this great nation; the courage with which these soldiers fought should never be forgotten; and

WHEREAS, Attendant to such concern, and in full accord with its long standing traditions, it is the sense of the members of this body to urge Congress to recognize the 65th Infantry Regiment, known as the Borinqueneers, and recommend that the regiment receives the Congressional Gold Medal; and

WHEREAS, This auspicious honor is an award bestowed by the United States Congress and is, along with the Presidential Medal of Freedom, the highest civilian award in the United States; it is given to persons who have had an impact on American history and culture that is likely to be recognized long after the achievement of the meritorious events; the Borinqueneers have truly had this kind of impact; and

WHEREAS, Mandated by Congress in 1899, the 65th Infantry Regiment from Puerto Rico, the Borinqueneers, played a prominent role in American military history; the regiment has participated in 3 United States wars, World War I, World War II, and, most notably, the Korean War; and

WHEREAS, Enlisted in the United States Armed Forces, the Borinqueneers courageously shed their blood, sweat, and tears to defend our freedoms; and

WHEREAS, The 65th Infantry Regiment of Puerto Rico earned the sole distinction of conducting the last battalion-sized bayonet charge in American military history; one battalion from the 65th Infantry Regiment, the Borinqueneers, gallantly faced overwhelming odds on February 2, 1951, while in combat against the 9th Chinese Infantry Division; and

WHEREAS, The 65th Infantry Regiment served with distinction and valor, earning two Presidential Unit Citations, an Army Unit Superior Award, a Navy Unit Citation, two Republic of Korea Presidential Unit Citations, and the Bravery Gold Medal of Greece; and

WHEREAS, The Congressional Gold Medal of Honor would affirm that the 65th Infantry Regiment, the Borinqueneers, is an American national treasure, who served their country with honor and bravery; and

WHEREAS, In the spirit of true American heroism, the 65th Infantry Regiment of Puerto Rico is an inspiration to every American; they are exceptional soldiers who deserve to be recognized, commended, acknowledged, and remembered by the people of the State of Illinois and the citizens of this great nation; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to recognize the 65th Infantry Regiment of Puerto Rico, known as the Borinqueneers, and further recommend that they receive the Congressional Gold Medal based on their gallant record of achievement on the battlefields, particularly in Korea from 1950 to 1953; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the Senate of the United States; the Speaker of the House of Representatives; the members of the Illinois congressional delegation; Frank Medina, National Chair of the Borinqueneers Congressional Gold Medal Alliance; Anthony Mele, Chairman of the 65th Infantry Regiment Honor Task Force and great-grandson of Leonicio Beauchamp (65th Infantry Regiment of Puerto Rico - 1917); and Javier Morales, President of the 65th Infantry Veterans Association in Puerto Rico.

HOUSE RESOLUTION 354

Offered by Representative Flowers:

WHEREAS, An effective money and banking system is essential to the functioning of the economy; and

WHEREAS, Such a system must function in the public interest, without any bias; and

WHEREAS, Since 1933, the Federal Banking Act of 1933, also known as the Glass-Steagall Act, protected the public interest in matters dealing with the regulation of commercial and investment banking, in addition to insurance companies and securities; and

WHEREAS, The Glass-Steagall Act was repealed in 1999, partially contributing to the greatest speculative bubble and worldwide recession since the Great Depression; and

WHEREAS, The worldwide recession has left millions of homes in foreclosure; and

WHEREAS, The worldwide recession has caused the loss of millions of jobs nationwide; and

WHEREAS, The recession has also put severe financial strains on states, counties, and cities, exacerbating unemployment and loss of civil services; and

WHEREAS, The United States Senate and the United States House of Representatives have been making efforts to restore the protections of the Glass-Steagall Act; and

WHEREAS, United States Representative Marcy Kaptur has introduced H. Res. 129 (sic H.R. 129), known as the Return to Prudent Banking Act of 2013, reviving the separation between commercial banking and the securities business in the manner provided in the Glass-Steagall Act; and

WHEREAS, The Glass-Steagall Act has widespread national support from prominent economic and business leaders and national publications, including Thomas Hoenig of the FDIC, Sanford Weill, former CEO of Citigroup, economist Luigi Zingales, the New York Times, the St. Louis Post-Dispatch, the Los Angeles Times, and many others; and

WHEREAS, As of now, 16 states have filed resolutions demanding immediate action on HR 129 to return to Glass-Steagall; two of those states, Maine and South Dakota, have passed those resolutions through both houses of their legislatures; in the remaining states, legislative action is still pending; and

WHEREAS, Overwhelming pressure must be brought to bear on members of the U.S. House of Representatives to add their names as co-sponsors to HR 129, the bill to restore Glass-Steagall, as well as on members of the U.S. Senate, where, as of now, no companion bill has yet been introduced; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress and the President to enact legislation that would reinstate the separation of commercial and investment banking functions in effect under the Glass-Steagall Act, prohibiting commercial banks and bank holding companies from investing in stocks, underwriting securities, or investing in or acting as guarantors to derivative transactions, in order to prevent American taxpayers from being called upon to fund hundreds of billions of dollars to bail out financial institutions; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the President Pro Tempore of the United States Senate, the Speaker of the United States House of Representatives, the members of the Illinois congressional delegation, and United States Representative Marcy Kaptur.
