### **HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 361

Offered by Representative Sims:

WHEREAS, The Illinois State Constitution provides that the fundamental goal of the people of this State is the educational development of all persons and that the State shall provide for an efficient system of high quality public educational institutions and services; and

WHEREAS, It is the intent and policy of the State of Illinois as previously established by the General Assembly to make the individual school in a school district the essential unit for educational governance; and

WHEREAS, The Chicago Public School (CPS) system estimates that it will have a budget deficit exceeding \$1 billion for its fiscal year 2014 budget; and

WHEREAS, CPS indicates that it needs to close, co-locate, and turnaround underutilized and underperforming schools in an effort to attempt to close the estimated fiscal year 2014 budget deficit; and

WHEREAS, After providing a preliminary list of 129 schools, and participating in a series of public meetings regarding the schools on the preliminary list, CPS, on March 21, 2013, announced proposed actions involving 114 schools; and

WHEREAS, A major factor contributing to the underutilization of CPS schools is the expansion of school capacity; currently CPS has only about 1% fewer students than it did in 1991 but has almost 100 more school facilities; and

WHEREAS, Nearly 50,000 CPS students will be impacted by overall school actions; and

WHEREAS, The CPS school closing plan will impact 6,479 students with disabilities, each of whom has an Individualized Educational Plan; and

WHEREAS, School closings often have profound ramifications for the educational experience of students and the surrounding community, as numerous studies have shown that when a school is closed or negative actions take place, student academic outcomes are negatively impacted, safety concerns are increased as children have to travel farther and through sometimes dangerous territory, and parental and community confidence in the school system is shaken; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Chicago Public School system to actively engage parents, local school councils, educators, and communities affected by the proposed school actions prior to taking final action on any schools; and be it further

RESOLVED, That the Chicago Public Schools system is urged to provide information to families affected by the proposed school actions and to the Illinois General Assembly on cost savings from planned school closings, extra security and safety programs for students, as well as equipment upgrades for "welcoming" schools prior to final action on the school closings issue by the Chicago Board of Education; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the City of Chicago School District 299.

HOUSE RESOLUTION 365

Offered by Representative Nekritz:

WHEREAS, During the Japanese colonial and wartime expansion of Asia and the Pacific Islands from 1932 through the duration of World War II, approximately 200,000 women and girls were coerced into a system of forced military prostitution; and

WHEREAS, The term "comfort women" was a euphemism used by the Japanese government to describe women and girls forced into sexual slavery by the Imperial Japanese military at camps, known as "comfort stations"; and

WHEREAS, The majority of "comfort women" were of Korean or Chinese descent, but women from Thailand, Vietnam, Indonesia, Malaysia, the Philippines, Australia, and the Netherlands were also interned in military camps run directly by the Imperial Japanese military or private agents working for the military; and

WHEREAS, Some of the women were sold to these military camps as minors, others were deceptively recruited by middlemen with the promise of employment and financial security, and still others were forcibly



kidnapped and forced to become "sexual slaves" for soldiers stationed throughout the Japanese occupied territories; and

WHEREAS, Approximately three-quarters of the "comfort women" have died as a direct result of the brutality inflicted on them during their internment; some of those who survived were left infertile due to sexual violence or sexually transmitted diseases and many are now dying without an official acknowledgement or apology by the Japanese government of the suffering they endured during their forced internment in military comfort stations; and

WHEREAS, The stories of the "comfort women" are an essential part of the history of human trafficking; and

WHEREAS, The United Nations reports that 2.4 million people across the globe are victims of human trafficking at any one time, and 80 percent of them are being exploited as sexual slaves; and

WHEREAS, At least 16,000 women and girls are involved in the sex trade every year in Chicago, many of whom are victims of human trafficking; and

WHEREAS, The State of Illinois stands against human trafficking in all its forms, as evidenced by the 2005 formation of the Illinois Rescue and Restore Coalition, a partnership between the Illinois Department of Human Services and the federal government to combat labor and sex trafficking in Illinois; and

WHEREAS, The State of Illinois further showed its commitment to fighting human trafficking when this year the Illinois House of Representatives passed House Bill 2640, which creates a process for trafficking victims to receive financial assistance to remove "trafficking tattoos" that traffickers often use to brand their victims as their property; and

WHEREAS, It is fitting for this House to support H.R. 121 passed by the United States House of Representatives that called upon the Japanese government to accept historical responsibility for the sexual enslavement of "comfort women" by the Imperial Japanese Army and educate future generations about these crimes; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, That we recognize and support "comfort women" by acknowledging as historical fact the suffering they endured during their forced internment in Japanese military comfort stations; and be it further

RESOLVED, That we urge all Illinois educators to share with students of an appropriate age the story of "comfort women" when discussing the history of Asia or World War II, or the issue of human trafficking; and be it further

RESOLVED, That we further commit to exploring ways to develop an Asian American social science and history curriculum for public schools that would provide one centralized structure the shared history of events, such as the story of "comfort women" or the forced incarceration of Japanese-Americans during World War II, along with many other examples of Asian American experiences in the United States; and be it further

RESOLVED, That we reaffirm our commitment to ending all forms of violence and trafficking of women in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to the executive directors of the Korean American Resource & Cultural Center, Korean American Voter Organizing Initiative & Community Empowerment, Korean American Women in Need, the Japanese American Service Committee, the Cambodian Association of Illinois, and Asian Americans Advancing Justice-Chicago.

On motion of Representative Mayfield, SENATE BILL 1953 was taken up and read by title a third time. And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 97, Yeas; 11, Nays; 2, Answering Present.

(ROLL CALL 2)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate.

On motion of Representative Harms, SENATE BILL 2101 was taken up and read by title a third time. And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 110, Yeas; 0, Nays; 0, Answering Present.

(ROLL CALL 3)

This bill, as amended, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence in the House amendment/s adopted.

On motion of Representative Schmitz, SENATE BILL 1988 was taken up and read by title a third time. And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 110, Yeas; 0, Nays; 0, Answering Present.

(ROLL CALL 4)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate.

On motion of Representative McAsey, SENATE BILL 2157 was taken up and read by title a third time. And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 110, Yeas; 0, Nays; 0, Answering Present.

(ROLL CALL 5)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate.

On motion of Representative Brown, SENATE BILL 2163 was taken up and read by title a third time. And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 109, Yeas; 1, Nay; 0, Answering Present.

(ROLL CALL 6)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate.

On motion of Representative Zalewski, SENATE BILL 2169 was taken up and read by title a third time. And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 97, Yeas; 13, Nays; 0, Answering Present.

(ROLL CALL 7)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate.

On motion of Representative William Davis, SENATE BILL 2178 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 71, Yeas; 39, Nays; 1, Answering Present.

(ROLL CALL 8)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate.

On motion of Representative Sandack, SENATE BILL 2182 was taken up and read by title a third time. And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote:

111, Yeas; 0, Nays; 0, Answering Present.

(ROLL CALL 9)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate.

On motion of Representative Nekritz, SENATE BILL 2183 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 111, Yeas; 0, Nays; 0, Answering Present.

(ROLL CALL 10)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate.

On motion of Representative Martwick, SENATE BILL 2184 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 87, Yeas; 24, Nays; 0, Answering Present.

(ROLL CALL 11)

This bill, as amended, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence in the House amendment/s adopted.

On motion of Representative Fortner, SENATE BILL 2186 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 110, Yeas; 0, Nays; 1, Answering Present.

(ROLL CALL 12)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate.

On motion of Representative Evans, SENATE BILL 2194 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the negative by the following vote: 31, Yeas; 79, Nays; 0, Answering Present.

(ROLL CALL 13)

This bill, having failed to receive the votes of a constitutional majority of the Members elected, was declared lost.
