Offered by Representative Moffitt:

WHEREAS, The Illinois Department of Transportation included in its multi-year plan a potential new rail route that would go from Moline/Rock Island to Danville, via Galesburg, Peoria, Bloomington/Normal, and Champaign/Urbana; and

WHEREAS, This east-west corridor further enhances access for our students to colleges and universities throughout the State of Illinois and increases the number destinations available on our passenger rail system, which makes passage rail service an even more attractive method of alternative transportation; and

WHEREAS, IDOT has asked Amtrak for a feasibility study to analyze the ridership, capital costs, and operating costs of this potential new route; and

WHEREAS, The new route will consist of two round-trips per day, with the tightest connectivity to the Chicago-St. Louis corridor and connection times to the Carbondale and Quincy corridors as well; and

WHEREAS, The study will also include requirements for service facilities at either end of the corridor, along with those estimated costs; and

WHEREAS, Amtrak should also include in its proposal cost a study of a very tightly-scheduled express bus service, similar to California's tightly-scheduled Thruway service that connects the various passenger rail corridors with towns throughout that state; and

WHEREAS, The study should analyze the revenue and costs of bus service that would meet Chicago-St. Louis trains each way at Normal, with single-ticketing so passengers can buy one ticket and check bags only once; the study also should analyze the ticket price that would make the bus service self-sufficient; and

WHEREAS, The express bus service would possibly be a forerunner to actual train service between the identified cities; and

WHEREAS, Amtrak is expected to begin the study in the summer of 2013; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Illinois Department of Transportation is supported and encouraged to continue its efforts in studying the feasibility of passenger rail service between Moline/Rock Island, Galesburg, Peoria, Bloomington/Normal, Champaign/Urbana, and Danville; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois Department of Transportation.

#### HOUSE RESOLUTION 375

Offered by Representative Golar:

WHEREAS, Behavioral healthcare disparities exist across Illinois, and these disparities include underserved populations with behavioral health care needs as one of their immediate, acute, chronic or co-morbid condition; and

WHEREAS, Behavioral health care disparities include racial, ethnic, and rural behavioral health disparities, underserved, or professional shortage areas; and

WHEREAS, The mental well-being of young people and their ability to not use alcohol or other drugs is strongly linked to their academic success; helping students stay healthy is a fundamental mission of schools; and

WHEREAS, According to the US Surgeon General, approximately 50% of children with emotional disturbances and behavioral disturbances drop out of school; and

WHEREAS, According to the Centers for Disease Control, suicides are among the leading cause of death for the ages of 15 through 54; and

WHEREAS, County coroners in Illinois report that in some counties the suicide rate has doubled since 2002 while in other counties the suicide rate has increased in recent years; and

WHEREAS, According to the Department of Defense Annual Suicide Report, suicides in the military started climbing considerably in 2005, and the trend has not abated; and

WHEREAS, Cook County Jail is the largest "mental institution" in the State due to its active inpatient psychiatric population, and there are over 1700 people on psychotropic medication for treatment of bipolar disorder, clinical depression, and schizoaffective disorder in the jail; and

WHEREAS, In Cook County Jail, 80% of the women who are there have a chronic mental illness, and 80% of the women in that jail are the sole caretakers of their children; and

WHEREAS, Illinois courts, municipal and county jails, and the juvenile justice system have direct contact with many individuals who could be diverted away from these systems if behavioral health care services were available to them; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Governor, through the use of education, outreach, technology, and innovation, should seek to empower and engage individuals and communities where behavioral healthcare disparities exist; and be it further

RESOLVED, That we urge the administration to work with the 98th General Assembly to develop strategies to remediate behavioral health disparities in areas and regions of the State with poor access to behavioral health care treatment or services, with high rates of trauma, or with high rates of acute or chronic behavioral health illnesses; strategies to remediate behavioral health care disparities may include work force development so that primary care physicians and behavioral health care clinicians would be encouraged to practice in areas with behavioral health disparities; and be it further

RESOLVED, That we encourage the administration to call on the Department of Human Services in collaboration with the Department of Healthcare and Family Services to identify a method to establish pilots for Health Homes, Systems of Care, and Essential Community Behavioral Health Care Providers to address the racial, ethnic, and rural behavioral health disparities, underserved populations, and underserved areas or professional shortage designated areas; and be it further

RESOLVED, That we encourage the administration to include in Department of Human Services data collation a standardize collection and analysis of data on the impact on racial, ethnic, and rural health care disparities, underserved populations, and underserved or professional shortage designated areas; and be it further

RESOLVED, That we encourage the administration to create an Illinois Behavioral Health Innovation Prize; the Illinois Behavioral Innovation Prize would provide public recognition for a new intervention or program that successfully reduces or eliminates behavioral healthcare disparities; the goal of the prize is to broaden the scope of community participation and discover new solutions that can be copied and employed throughout the State; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor Pat Quinn and the Secretary of Human Services.

#### HOUSE RESOLUTION 377

Offered by Representative Acevedo:

WHEREAS, The United States was founded as a nation of immigrants, a place where people could find economic opportunity and a better life, or escape persecution in their home country, and fulfill their hopes of a brighter future based on freedom and democratic ideals; and

WHEREAS, The cultural diversity of immigrants to the United States adds to the social fabric of this nation, and the new ideas and energies immigrants contribute to the economy strengthen the nation as a whole; and

WHEREAS, There are currently over 11 million undocumented immigrants residing in the United States, the vast majority of whom abide by the laws, work hard, and pay taxes; and

WHEREAS, Comprehensive immigration reform must provide law-abiding, tax paying immigrant workers and their families with an opportunity to obtain legal permanent residency and eventually United States citizenship through fair and reasonable requirements; and

WHEREAS, Undocumented immigrants are at risk of abuse by employers and live in fear of arrest and deportation; and

WHEREAS, Any new worker visa program must provide workers with all rights afforded by the Constitution of the United States, portability of visas so that workers can change jobs, and the ability for workers to petition for permanent residency; and

WHEREAS, The Diversity Visa program was established by federal law in 1990 to provide an opportunity for 55,000 immigrants each year from countries that send smaller numbers of immigrants to United States to immigrate legally; and

WHEREAS, The Diversity Visa program has truly diversified the range of countries from which immigrants come to the United States and is one of the few options for African immigrants to come to the

United States, as shown in many years where as many as half of all Diversity Visas are issued to immigrants from Africa; and

WHEREAS, Abolishing the Diversity Visa program would limit the opportunities for many immigrants, especially from Africa, to come to the United States lawfully; and

WHEREAS, The nation's immigration system is laden with backlogs and as a result, legal immigrants may wait decades for family reunification; and

WHEREAS, At present, the "line" for legal immigration is about 4 million people long; and

WHEREAS, Family unity is a component of a strong economy, and reunification of families has been a key part of federal immigration policy for almost 50 years; and

WHEREAS, It is our country's best interests to create a streamlined process to resolve the backlog of existing visa applications and develop methods to ensure the efficient processing of future immigration applications in a timely manner, which will expedite reunification of families; and

WHEREAS, Keeping families, which includes husbands and wives, sons and daughters, and brothers and sisters, together not only is the correct and moral thing to do but is also good for the economy because families provide a base of support that increases worker productivity and spurs entrepreneurship; and

WHEREAS, Illinois recognizes that immigration reform must protect the right of all families to stay together, regardless of immigration status, family structure, sexual orientation, gender identity, or marital status, and provide sufficient family-based channels for migration in the future; and

WHEREAS, The State of Illinois is home to 1.8 million immigrants, the sixth largest immigrant population of any state in the nation; and

WHEREAS, Immigrants make up 13.5% of Illinois' population and 17.5% of Illinois' workforce and accounted for half of the State's population growth over the last decade; and

WHEREAS, Illinois has a special pride as being one of the most immigrant-friendly states in the country, as evidenced by its deep commitment to successful programs such as the New Americans Initiative & Refugee and Immigrant Citizenship Initiative, Immigrant Family Resource Program, Parent Mentor Program and Uniting America Program; and

WHEREAS, Illinois believes in the human dignity of all Illinois residents, regardless of immigration status, and recognize the importance of immigrants' many contributions to the social and economic fabric of the state of Illinois; and

WHEREAS, Illinois, therefore, has a strong interest in immigration policy and the impact it has on immigrants seeking a new life in the United States; and

WHEREAS, Immigration reform must occur in a comprehensive, thoughtful manner that builds the strength and unity of working people, keeps families together wherever possible, and guarantees the same rights, obligations, and basic fairness for all lawful workers, no matter where they come from; and

WHEREAS, The federal government has the exclusive authority to develop, implement, and enforce immigration policy under the United States Constitution, and the regulation of immigration is solely the responsibility of the federal government; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the President of the United States and the United States Congress are urged to enact comprehensive immigration reform and provide a practical and inclusive path to permanent citizenship that promotes fairness and justice, while also protecting and valuing families and upholding human dignity and mutual respect; and be it further

#### HOUSE JOINT RESOLUTION 40

Offered by Representative Lang:

WHEREAS, Language barriers continue to exist for many Illinois residents who are limited English proficient, known as "LEP"; these barriers limit their ability to fully participate in civic life and maximize their economic productivity; and



WHEREAS, Such language barriers for LEP residents create very real challenges when trying to access information about available government services or an individual's legal rights or obligations under State and local laws; and

WHEREAS, Title VI of the Civil Rights Act requires program recipients of federal funds, such as certain State agencies, to take reasonable steps to insure that LEP persons have meaningful access to their programs and activities; and

WHEREAS, Nearly 10% of Illinois' population is LEP, giving Illinois the 5th largest LEP population in the United States at over 1.1 million residents; and

WHEREAS, Illinois' immigrant communities have rapidly grown and now one in every five Illinois residents is an immigrant; and

WHEREAS, Illinois is proud of being one of the most immigrant-friendly states in the nation; and

WHEREAS, The public safety, health, economic prosperity, and general welfare of all Illinois residents is furthered by increasing language access to State programs and services; and

WHEREAS, The Governor's Office of New Americans Interagency Task Force, which met from 2006 to 2008, recommended that Illinois commit to providing meaningful access to State services for the LEP population to encourage and accelerate immigrant and refugee integration; and

WHEREAS, Despite admirable efforts by certain State agencies, much work remains to provide meaningful access; and

WHEREAS, Other immigrant-friendly states and cities have attempted to address this issue by implementing language access laws or ordinances that require a base-line level of language access to government services and information for LEP individuals; and

WHEREAS, The Illinois General Assembly is committed to exploring legislative solutions to improve language access for LEP residents by researching lessons learned and best practices from these other parts of the country; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Task Force on Language Access to Government Services is created to:

(1) review existing language access laws or ordinances in other parts of the country, including existing reports or academic publications on such laws or ordinances;

(2) evaluate their effectiveness in eliminating language barriers for LEP communities;

(3) consider any other available and relevant information on language access issues in Illinois, including Census data, community feedback, or surveys

(4) identify and recommend specific best-practices and provisions for a State language access law; and

(5) produce a final report summarizing the task force's findings and detailing its specific recommendations for a State language access law and highlight any areas of major disagreement within the task force; and be it further

RESOLVED, That the Task Force shall consist of the following members, who shall serve without compensation:

(1) one member of the Senate appointed by the President of the Senate;

(2) one member of the Senate appointed by the Minority Leader of the Senate;

(3) one member of the House of Representatives appointed by the Speaker of the House of Representatives;

(4) one member of the House of Representatives appointed by the Minority Leader of the House of Representatives;

(5) one member appointed by the Governor as a representative of his office;

(6) one member appointed by the Attorney General as a representative of her office;

(7) one member appointed by the Secretary of State as a representative of his office;

(8) one member appointed by the Secretary of the Illinois Department of Human Services as a representative of her office;

(9) five members appointed by the Governor, upon recommendation of a non-profit organization that promotes civic engagement and advocates on behalf of immigrant communities through a coalition of member organizations that serve Latino, Asian, African, Arab, and European immigrants; and

(10) five members appointed by the Governor, upon recommendation of a non-profit organization that promotes civic engagement among Asian American communities and advocates on behalf of Asian American communities through its Pan-Asian coalition; and be it further

RESOLVED, That the members of the Task Force shall be appointed within 30 days after the adoption of this resolution and shall begin meeting no later than 30 days after the appointments are finalized; in the event

that any appointments are not made within 30 days after the adoption of this resolution, the Secretary of Human Services shall make such appointments within 15 days after the appointment deadline; and be it further

RESOLVED, That the members of the Task Force shall elect a chairperson from among their membership and that the Department of Human Services shall provide administrative support; and be it further

RESOLVED, That the Task Force shall hold its first meeting by September 1, 2013; and be it further

RESOLVED, That the Task Force shall submit its final report to the Illinois General Assembly, the Governor, and the Attorney General no later than July 1, 2014.

#### HOUSE JOINT RESOLUTION 41

Offered by Representative Flowers:

WHEREAS, The General Assembly passed legislation and the Governor signed into law major reforms of Illinois' Medical Assistance Programs, including Senate Bill 2840, The Save Medicaid Access and Resources Together (SMART) Act (Public Act 97-0689) and House Bill 5429 (Public Act 96-1501) and these new laws intend to "address the significant spending and liability deficit in the medical assistance program budget of the Department of Healthcare and Family Services by implementing changes, improvements, and efficiencies"; and

WHEREAS, The reforms require the Illinois Department of Healthcare and Family Services to enroll at least 50% of recipients eligible for comprehensive medical benefits in a care coordination program by January 1, 2015; and

WHEREAS, Care coordination programs may be provider-sponsored programs that contract directly with the State or traditional managed care programs; they must operate integrated delivery systems where recipients will receive their care from providers who are responsible for providing or arranging the majority of care, including primary care physician services, referrals from primary care physicians, diagnostic and treatment services, behavioral health services, in-patient and outpatient hospital services, dental services, and rehabilitation and long-term care services; and

WHEREAS, The Department must designate or contract for integrated delivery systems that ensure enrollees have a choice of systems and of primary care providers within the systems; and

WHEREAS, Payment for coordinated care must be based on arrangements where the State pays for performance related to health care outcomes, the use of evidence-based practices, the use of primary care delivered through comprehensive medical homes, the use of electronic medical records, and the appropriate exchange of health information electronically made either on a capitated basis in which a fixed monthly premium per recipient is paid and full financial risk is assumed for the delivery of services, or through other risk-based payment arrangements; and

WHEREAS, Health care providers, including hospitals, physicians and nurses, federally qualified health centers (FQHCs), nursing homes, home health agencies, social service organizations, and pharmacies can assume responsibility for coordinating the care of Medicaid recipients under a direct arrangement with the State that requires the providers to assume increasing risk over a short period of time; and

WHEREAS, In order to achieve significant savings needed to cover administrative expenses and generate profits for shareholders, HMOs often prevent beneficiaries from getting the services they need; Medicaid HMOs in Illinois have previously placed barriers to care, and in some instances, either reduced rates to providers or made it very difficult for providers to get approvals to provide the care that people need; major policy reviews of various studies on Medicaid HMO managed care have found little savings from HMOs and that such an approach is unlikely to significantly lower costs; and

WHEREAS, HMOs in Illinois have a checkered track record in "managing" Medicaid patients; Illinois failed in its first major attempt to enroll a large number of children into a managed care program, the Healthy Moms/Kids program, which was scrapped in 1995 after having failed to meet performance standards and spending millions in failed computer systems; the State also scrapped the ambitious MediPlan Plus program; and

WHEREAS, Even more concern should be given to the 2004 federal court ruling in *Memisovski v. Maram* that HMOs provided less preventive and primary care and poorer quality care to children in the Medicaid program in Cook County than non-HMO, fee-for-service programs; and in 2008, an HMO in Illinois paid \$225 million - the largest jury verdict in a false claims case in U.S. history - to settle charges that it deliberately excluded pregnant women and sick people from its program; and

WHEREAS, The 50% goal must be achieved by enrolling medical assistance enrollees from each medical assistance enrollment category, including parents, children, seniors, and people with disabilities only to the extent that current State Medicaid payment laws would not limit federal matching funds for the State; and

WHEREAS, Moving most or all recipients to full-capitation HMOs will contravene federal rules, cause the State to exceed the federal upper payment limit and thus jeopardize up to \$1 billion in federal funding under the Hospital Assessment Program; and

WHEREAS, The Illinois Department of Healthcare and Family Services has selected only a limited number of provider-sponsored Care Coordination Entities while giving preference to health maintenance organizations; another solicitation of interest could ensure further expansion of care coordination beyond mandatory HMO enrollment; and

WHEREAS, The State should thoroughly evaluate its experience with HMOs before substantially increasing mandatory enrollment in these types of plans; hastily moving large portions of the Medicaid population into HMOs (i.e., 1.5 million to 2 million) is inherently risky; and

WHEREAS, Given that the Department is planning more aggressive use of HMOs, all policymakers should know that there is little evidence to date that the initiatives will contain program costs; Illinois needs to be far more cautious and conservative in estimates of the likely benefits of HMO Medicaid managed care; the State should work with providers to develop innovative partnerships that share risk, rather than abdicate responsibilities to HMOs, which often achieve savings by denying services or reducing payment; and

WHEREAS, Hastily moving large numbers of Medicaid recipients to full-capitation HMOs will jeopardize up to \$1 billion in federal funding under the Hospital Assessment Program; care coordination must be carefully designed so that the State does not jeopardize the funding provided by the Hospital Assessment Program; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the Department of Healthcare and Family Services to carefully evaluate and reconsider its actions to quickly move larger numbers of Medicaid beneficiaries into HMOs; and urge that the agency refocus its current preferences and give more favorable consideration to innovative, provider-based care coordination strategies; Accountable Care Entities should be utilized as important and valued alternatives to traditional HMOs; these models bring together a wide variety of entities such as hospitals, physician-led groups, Federally Qualified Health Centers, social service organizations, pharmacies, and behavioral health providers and closely resemble the Accountable Care Organizations (ACOs) that participate in the Medicare Shared Savings Program, under which these entities provide care coordination services to seniors and adults with disabilities who have the most complex physical health and behavioral health conditions by facilitating the delivery of appropriate health care and other services and managing needed transitions in care among providers and community agencies; and be it further

RESOLVED, That the General Assembly recommends that the Department of Healthcare and Family Services should more actively pursue provider-sponsored care coordination in the Medicaid program, including application for relevant federal grants and Medicaid waivers; and give provider-sponsored entities a more meaningful and substantive opportunity to succeed, because provider-sponsored care coordination, done at the local level, is best for patients.
