HOUSE RESOLUTION 673

Offered by Representative Bost:

WHEREAS, The members of the Illinois House of Representatives value the safety of the hundreds of Capitol employees and the citizens who come to visit their State Capitol; and

WHEREAS, The members of the Illinois House of Representatives honor and thank the Illinois Secretary of State Police for their outstanding work and dedication to protecting the Capitol and those who visit and work in the Capitol; and

WHEREAS, Illinois' talented and devoted Secretary of State officers are stationed at every public entrance, where they operate metal detectors for visitors without State-issued badges; and

WHEREAS, Due to the recent beautiful renovations at the State Capitol, Secretary of State officers no longer have the visibility needed to ensure safety to all who visit the Capitol; and

WHEREAS, To ensure that the upmost security precautions and safety measures are being taken, cameras should be installed outside of every Capitol door; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Secretary of State and the Architect of the Capitol to install security cameras outside the doors of the Capitol to allow the officers to proactively search for security risks and actively protect and serve the citizens of this State; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Secretary of State and the Architect of the Capitol.

HOUSE RESOLUTION 675

Offered by Representative Riley:

WHEREAS, The Chicago Transit Authority is proposing a 5.3-mile extension of the Red Line from the existing 95th Street Terminal to the vicinity of 130th Street; and

WHEREAS, The proposed extension would include 4 new stations near 103rd Street, 111th Street, Michigan Avenue, and 130th Street; each new station would include bus and parking facilities; and

WHEREAS, Following the Red Line Extension Project open house meeting during the summer of 2011, the agency began work on a technical analysis of the project and a Draft Environmental Impact Statement on behalf of the Federal Transit Administration, which serves as the federal lead agency for the project; and

WHEREAS, The Red Line Extension Project would reduce travel times to jobs for far South Side and South Suburban residents and improve the performance of the existing Red Line 95th Street Station terminal; the project would also support current and future economic development initiatives; and

WHEREAS, The Red Line Extension Project is needed for many reasons, including the lack of Park and Ride and passenger drop off and poor pedestrian facilities, which limit access to the existing 95th Street terminal of the Red Line; lengthy delays experienced by customers who access the existing terminal facility by bus, caused by the poor performance of surrounding arterial intersections, insufficient space for bus loading and unloading, and insufficient space for bus layovers; congested bus and passenger conditions at the existing terminal station and bus facility, which result in safety issues and diminish the attractiveness of transit as an alternative to other travel modes; the adverse impact of narrow arterial streets and frequent at-grade freight rail crossings on roadway performance in the study area; and the nature of transit dependence of minority and low-income populations in the study area; and

WHEREAS, Discussion of a Red Line Extension has been going on since Mayor Richard J. Daley proposed it and many other infrastructure improvement plans for the Chicago area in April of 1967; planners and community groups have discussed the necessity and benefits of the extension in the intervening years, but have received no tangible information as to its construction; and

WHEREAS, In 2007, the Regional Equity Subcommittee of the Illinois House of Representatives' Mass Transit Committee held a comprehensive subject matter hearing on transportation equity in the south suburbs of Chicago; the hearing shone a light on the Red Line Extension and other transportation projects and issues where, seemingly, resources were spent in areas other than the south side and southern suburbs; and

WHEREAS, It has been the policy and priority of many General Assembly members in the affected areas to call into question the Chicago Transit Authority's commitment to this long overdue project and have not seen any funding allocated to the Red Line extension in the Chicago Transit Authority's 2014 budget; many elected officials and members of the community have shown patience, but now want financial, planning, and programmatic commitments from the Chicago Transit Authority to make the Red Line Extension a top priority; and

WHEREAS, While Chicago Transit Authority officials say the extension is a top priority, the agency has not established a timeline for building the 5.3 miles of new track or any of the proposed 4 new stations; and

WHEREAS, By making firm financial commitments and setting specific dates, the Chicago Transit Authority would see increased credibility in the project area and would provide hope and confidence to taxpayers on the South Side and in the south suburbs that the Chicago Transit Authority is indeed concerned about all of the citizens in its service area; therefore, be it

WHEREAS, Crossrail Chicago could connect Rockford, Elgin, Hoffman Estates, Schaumburg, Arlington Heights, and O'Hare through Union Station to McCormick Place, Hyde Park, Homewood, University Park, the south suburban airport, Kankakee, and Champaign-Urbana in one electrified track; and

WHEREAS, The new electrified line of Crossrail Chicago would be located largely on publicly-owned rights-of-way and could bring tremendous economic benefits to the region and State; and

WHEREAS, Metra service along the Metro Electric Line from University Park to McCormick Place could be significantly improved through the Crossrail Chicago initiative; and

WHEREAS, Crossrail Chicago can also serve as the trunk of a Midwest high-speed rail network, which would bring millions of people together into one stronger economic unit; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Chicago Metropolitan Agency for Planning to include Crossrail Chicago in its list of fiscally unconstrained projects as consistent with the GOTO2040 vision, making the projects of Crossrail Chicago eligible for federal funds; and be it further

WHEREAS, SNAP is an important component of Illinois' economy that generates over \$3 billion in annual spending; and

WHEREAS, The Department of Human Services issues SNAP benefits on the 1st, 3rd, 4th, 5th, 6th, 7th, 8th, 9th, and 10th days of the month; and

WHEREAS, The Department of Human Services has switched from operating on two fiscal months to utilizing one fiscal month, consistent with nearly every other state in the nation, for greater efficiency and accuracy; and

WHEREAS, In order to minimize the "stretch" newly approved customers experience between their first and second issuances, the Department of Human Services instituted a 10 day issuance schedule, effective July 2013; and

WHEREAS, The United States Department of Agriculture (USDA), which controls the funding for SNAP, sent a letter to each state encouraging states to stagger SNAP distribution throughout the month; and

WHEREAS, The Department of Human Services must balance staggering benefits to meet the needs of retailers with minimizing hardship to SNAP recipients; and

WHEREAS, The Department of Human Services, grocers, and poverty advocates are all interested in establishing a distribution system that meets the needs of all parties; and

WHEREAS, On May 31, 2013, the Task Force on Hunger and the Efficient Distribution of SNAP Benefits was created by House Joint Resolution 43 of the 98th General Assembly to discuss these issues and prepare a report to the General Assembly that detailed how SNAP benefits could be distributed more evenly throughout the month without increasing hunger in the State of Illinois; and

WHEREAS, On October 1, 2013, the Task Force prepared and submitted the report to the General Assembly which detailed an agreed, temporary solution to gradually move, over a 3-month period, current cases from the 4th, 7th, and 10th to the 13th, 17th, and 20th days of the month, and to place new and returning cases on the 4th, 7th, and 10th days of the month; and

WHEREAS, As the number of cases on the 13th, 17th, and 20th days of the month will diminish over time, there is a need to continue to discuss a permanent solution for 2016 and beyond; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Task Force on Hunger and the Efficient Distribution of SNAP Benefits be re-established and remain active through December 31, 2015; and be it further

RESOLVED, That the Task Force shall work to identify ways to achieve a permanent solution on how SNAP benefits are distributed in Illinois that addresses how SNAP benefits could be distributed more evenly throughout the month without increasing hunger in the State of Illinois.
