WHEREAS, Many thousands of Illinoisans have had their health insurance plans cancelled and many more thousands will soon face cancellation in 2014 as a direct result of the Affordable Care Act; and

WHEREAS, Many Illinois families that were forced into the Affordable Care Act health insurance exchange are now facing higher deductibles, higher premiums, and limited provider networks, or are forgoing insurance coverage altogether; and

WHEREAS, Some Illinois lawmakers are seeking to adopt a State-based health insurance exchange under the Affordable Care Act that could cost Illinoisans more than \$100 million; and

WHEREAS, Illinois lawmakers are receiving generous taxpayer-funded health premium subsidies toward their Illinois State Employees' Group Insurance Program benefits; and

WHEREAS, Illinois lawmakers participating in the program may pay anywhere from \$119 to \$211 per month in Fiscal Year 2014 for their own coverage, which is a fraction of the true insurance coverage cost to taxpayers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge any lawmaker who supports any further expansion of the Affordable Care Act in the State of Illinois to immediately forfeit his or her taxpayer-funded premium subsidy and voluntarily enroll in the Affordable Care Act health insurance exchange; and be it further

RESOLVED, That we urge Illinois' elected senators and representatives to live by the same set of rules that they impose upon those they claim to represent.

HOUSE JOINT RESOLUTION 94

Offered by Representative Riley:

WHEREAS, Formally established by the Governors State University Board of Trustees in 1978, the Nathan Manilow Sculpture Park was named for Nathan Manilow, a visionary developer who, along with Carrol Sweet and Philip Klutznick, formed American Community Builders at the conclusion of World War II and planned and built the neighboring Village of Park Forest for returning GIs; and

WHEREAS, The history of the Nathan Manilow Sculpture Park predates Governors State University, in that sculptor Mark diSuvero spent the summers of 1968 and 1969 living and building sculptures on the land that was to become the university; and

WHEREAS, Set within the prairie landscape of Governors State University, the Nathan Manilow Sculpture Park serves its constituency with distinctive educational outreach and original programming, encouraging an interdisciplinary understanding of sculpture and art in contemporary life; the Park offers 29 master works of sculpture for public viewing situated within 100-plus acres of prairie landscape on the campus of Governors State University; the permanent collection includes 24 pieces, with 5 additional works on long-term loan from the artists; highlights include several important landscape-based sculptures created by distinguished artists at the height of their creative powers, a group of works by major late-20th century American sculptors, and a number of works representing Chicago-based artists circa 1973 to 2010; sculptors from France and Mexico are also represented; and

WHEREAS, Nathan Manilow Sculpture Park is supported by numerous volunteers and donors who believe in its mission and its primary goals of education, acquisition, and conservation; and

WHEREAS, Governors State University's Nathan Manilow Sculpture Park provides the Chicagoland region with a premier presentation of large-scale contemporary sculpture; programs and events present the landscape and sculpture in new and unexpected ways that are both educational and inspiring; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Illinois Department of Transportation is requested to erect on Interstate 57 at Sauk Trail Road and the new interchange at Interstate 57 and Interstate 294, consistent with State and federal regulations, appropriate plaques or signs giving notice of Nathan Manilow Sculpture Park; and be it further
