## 127TH LEGISLATIVE DAY

## **Perfunctory Session**

### **FRIDAY, MAY 9, 2014**

At the hour of 10:20 o'clock a.m., the House convened perfunctory session.

### HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

## **HOUSE RESOLUTION 1086**

Offered by Representative Wheeler:

WHEREAS, Loren Duke Abdalla is the great-grandson of Head Chief Running Bull of the Yankton Sioux Tribe from South Dakota; and

WHEREAS, Loren Duke Abdalla, who went by Duke, enlisted in the United States Marine Corps in October of 1943, at the age of 18; and

WHEREAS, When Duke finished basic training he was assigned and sent to New Caledonia, and later reassigned to Pavuvu Island with the First Marine Division, 1st Regiment, 1st Battalion, A Company, 1st Platoon, under the command of Colonel Chesty Puller and Major Ray Davis; and

WHEREAS, After months of island training as a rifleman and machine gunner, Duke's regiment was given its first orders, to invade the Island of Peleliu; on September 15, 1944, Duke's battalion invaded Peleliu; he was stationed with his machine gun team and on the third day of the attack his team was pinned down on 3 sides by enemy fire; 3 of his comrades were struck and he was blown back against a coral wall which caused shrapnel holes in both his legs and blew out his ear drums; he survived and was one of only 6 Marines left in A Company, with just 29 left standing in 1st Battalion after the battle; he received the Purple Heart and was promoted to Corporal, becoming the squad leader of the 3rd Squad, 1st Platoon, A Company; and

WHEREAS, Duke recovered in the hospital from his wounds and returned to A Company ready for the Battle of Okinawa, where he would again become a hero; the Battle of Okinawa began on April 1, 1945 and would last for 82 days until June 22nd; the First Marine Division was ordered to relieve the 27th Army Division near the Shuri Line on April 29th; 1st Platoon B and C Company were both first ordered to take the Shuri Line but were continually pushed back by the enemy machine gun fire; on May 5th it was A Company's order to take the line; the morning of May 5th before the attack, Corporal John Brady, the 2nd Squadron leader, was burned by an enemy grenade and under heavy fire; Duke became a hero again, throwing Corporal Brady over his shoulder and carrying him to safety before returning to his squad of 12 marines; it was Duke's squad's order to take out the 6 machine gun nests across the ridge; after the 4th nest was taken out Duke stood alone, his entire squad was either killed or wounded; he continued to push forward and take out the final 2 machine gun nests, while the other 2 squads worked around the base taking out spider traps and a big gun hidden in a cave; in clearing the ridge, Duke allowed the First Marine Division to advance, although many of his comrades were honored for their bravery on that day, Duke was not recognized for his action; and

WHEREAS, During Duke's tour on Okinawa he saved 2 other men's lives; he pulled fellow Marine H. T. Clark out of fire when he froze at the ridge known as Three Sisters; Duke also pulled a war correspondent out of a shell hole while under fire, saving his life; and

WHEREAS, Loren Duke Abdalla ended his service on February 28, 1947 with an honorable discharge from the United States Marine Corp; he fought valiantly during his service in the Pacific Theater; he was awarded the Purple Heart, saved the lives of 3 men, and saved many of his fellow comrades with his brave efforts; and

WHEREAS, The family of Loren Duke Abdalla has been telling his story from World War II with the goal of his service being reviewed and his actions deserving of a Medal of Honor; they believe Duke was passed over for this award because of discrimination against his Native American Heritage; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the President of the United States and Congress to act swiftly and review the case of Loren Duke Abdalla's actions during World War II, which are deserving of the Medal of Honor; and be it further

RESOLVED, That suitable copies of this resolution be presented to President Barack Obama, the entire Illinois Congressional Delegation, the Speaker of the U.S. House of Representatives John Boehner, the Minority Leader of the U.S. House of Representatives Nancy Pelosi, the U.S. Senate Majority Leader Harry Reid, and the U.S. Senate Minority Leader Mitch McConnell.

### **HOUSE RESOLUTION 1092**

Offered by Representative Martwick:

WHEREAS, The State of Illinois has published proposed rules pursuant to the Medical Cannabis Pilot Program Act; and

WHEREAS, Medical cannabis carries with it a high potential for abuse and diversion; and

WHEREAS, Such proposed rules shall provide for the safe dispensing of therapeutic medicinal cannabis;

WHEREAS, Medical cannabis must be used safely and only by registered qualifying patients; and

WHEREAS, One in 4 teens reports having abused or misused a drug such as marijuana, a 33% increase over a 5-year period, and marijuana use is growing among teens; and

WHEREAS, The use of a 4-digit locking mechanism closure will prevent the unintended and accidental ingestion of medicinal cannabis by young children; and

WHEREAS, The use of a locking mechanism closure will prevent the intentional misuse or diversion of medicinal cannabis by adults; and

WHEREAS, A 4-digit locking mechanism closure may be obtained in the State of Illinois as there are Illinois companies that manufacture such devices; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge regulatory agencies in the State to implement regulations that would require 4-digit locking mechanisms to be placed on prescription containers for medical cannabis; and be it further

RESOLVED, That we urge dispensing organizations, including cultivators and retailers, to only dispense medical cannabis in medical cannabis prescription containers equipped with a 4-digit locking mechanism.

## **HOUSE RESOLUTION 1093**

Offered by Representative Gabel:

WHEREAS, Feeding Illinois, the State association of 8 food banks serving all 102 counties, has found that more than 1.8 million of our 12.9 million citizens are "food insecure", meaning that 14.2% of our families, neighbors, and colleagues lack adequate access to the sustenance needed for a healthy and productive life; and

WHEREAS, Washington Post reporter Eli Saslow won a 2014 Pulitzer Prize for a series of articles about food insecurity which he described as "a lasting scar" of the 2008 economic collapse; and

WHEREAS, The number of Illinois citizens participating in the federal Supplemental Nutrition Assistance Program (SNAP) (formerly the Food Stamp Program) has increased 40.7% between January of 2009 and January of 2014; and

WHEREAS, The federal government responded to changing public interest by modifying SNAP to enable program recipients to purchase fresh fruits and vegetables at farmers markets and farm stands; and

WHEREAS, SNAP is one of 16 federal feeding programs spending approximately \$4 billion a year in Illinois; and

WHEREAS, On May 5, 1964, President Lyndon B. Johnson's aide, Sargent Shriver, proposed that the "War on Poverty" incorporate a grassroots component based on this observation: "Wherever local communities have started programs to help the poor help themselves, the response has exceeded all expectations"; and

WHEREAS, The Illinois Commission on the Eradication of Poverty, created by statute in 2008, produced a strategic plan that affirms Sargent Shriver's proposal by asserting: "...the best solutions for poverty (oftentimes) come from local innovation"; and

WHEREAS, Illinois schools provide subsidized meals for one of every 5 Illinois children because they come from families that exceed federal poverty guidelines; and

WHEREAS, Local food, nutrition, and agriculture plans at the municipal and rural township level could provide structure to support projects designed to help end hunger and poverty in urban, suburban, exurban, and rural communities throughout Illinois; and

WHEREAS, At least 6 Governors' councils and commissions possess unique expertise and functions that, if aligned through a collaborative process, could result in the improved delivery of public and private resources for the benefit of community-based initiatives to help end hunger and reduce poverty in Illinois; and

WHEREAS, The Illinois Commission to End Hunger, created by statute in 2010, is exploring how to encourage partnerships between the State's 2,000-plus food pantries and its 375-plus farmers' markets; and

WHEREAS, The Greater Chicago Food Depository is partnering with Heartland Alliance on an urban agriculture pilot project, Chicago FarmWorks, to create transitional jobs for hard-to-employ people on a 2.6-acre vegetable farm in the West Side Chicago community of East Garfield Park; and

WHEREAS, The Illinois Local Food, Farms, and Jobs Council, created by statute in 2009, is working to facilitate action supporting the growth of local food and farm economies from the metropolitan Chicago area to Cairo; and

WHEREAS, The Illinois Commission on Volunteerism and Community Service, created by statute, is discovering that community-based local food projects could be a pathway to build a statewide "volunteer infrastructure"; and

WHEREAS, The Illinois Task Force on Social Innovation, Entrepreneurship, and Enterprise, created by Executive Order 11-05, has a set of charges that include the attraction of funds "to accelerate progress on social issues, work cross-sector, and advance social and economic development goals"; and

WHEREAS, The Illinois Business Development Council, created by statute in 2013, will enact an annual State business plan based on input from such sources as "State and local business development and marketing efforts focusing on areas of high unemployment or poverty"; and

WHEREAS, Collaboration between these 6 State entities could accelerate development of community-based food, nutrition, and agricultural initiatives that contribute to broader efforts to end hunger and reduce poverty in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor to design and execute a strategy to align the unique expertise and functions of the Illinois Commission to End Hunger, the Illinois Commission on the Eradication of Poverty, the Illinois Local Food, Farms, and Jobs Council, the Illinois Commission on Volunteerism and Community Service, the Illinois Task Force of Social Innovation, Entrepreneurship, and Enterprise, and the Illinois Business Development Council in an ongoing program to embolden and empower communities to advance low-cost and high-return strategies to help end hunger and poverty; and be it further RESOLVED, That a suitable copy of this resolution be delivered to the Governor.

## **HOUSE JOINT RESOLUTION 95**

Offered by Representative Tracy:

WHEREAS, The State of Illinois seeks to support development that enhances agriculture, industry, public safety, and the overall economy of Illinois; and

WHEREAS, Levees protect against reoccurring flood damage and have the ability to block wide floodplains and displace floodwater; and

WHEREAS, Permitting processes should be straightforward and timely so that lawful and responsible economic growth can be feasibly accomplished while preserving the goal of this State to protect the people of Illinois from unmitigated flood damages caused by others; and

WHEREAS, State regulatory processes should consider the regulatory processes of federal agencies, especially the U.S. Army Corps of Engineers and the federal Emergency Management Agency, to minimize the burden of meeting conflicting technical requirements between agencies; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the Illinois Department of Natural Resources to develop amendments to Part 3700 of Title 17 of the Illinois Administrative Code for consideration of the Joint Committee on Administrative Rules that:

- (1) better define the flood risk associated with levee construction by adjusting the upper regulatory limit for a worst-case analysis to be the flood discharge with a 0.2% annual chance of exceedance (500-year frequency) for levees and floodwalls;
- (2) create uniform technical policies, when applicable and appropriate, with those imposed by other regulatory agencies at the federal, State, and local levels; and
- (3) create standards for responding to application submissions in a timely manner with identification of requirements for necessary submissions to demonstrate compliance with administrative rules; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Director of Natural Resources.
