## HOUSE RESOLUTIONS

### HOUSE RESOLUTION 1185

Offered by Representative Harms:

WHEREAS, Medicaid is an entitlement program that provides healthcare coverage for low income children, adults, adults with disabilities, and seniors; and

WHEREAS, Medicaid is jointly funded between the states and the federal government; and

WHEREAS, The federal participation to state Medicaid programs is based upon 2 factors - the amount the state spends on Medicaid matchable services and the state's individual Federal Medical Assistance Percentage (FMAP); and

WHEREAS, The FMAP is calculated by the federal government each year through administrative rule, via a formula that considers the average per capita income for that state relative to the national average; and

WHEREAS, The FMAP cannot be less than 50% or more than 83% for federal Medicaid reimbursements to states; and

WHEREAS, Illinois has historically been among the lowest reimbursed FMAP states at the 50% rate; and

WHEREAS, Only in 2014 will Illinois receive a slight adjustment to the FMAP rate with an effective reimbursement rate of 50.76%; and

WHEREAS, Illinois is one of only 22 states with an FMAP less than 54% and only one of 13 states with an FMAP of less than 51%; 7 states have an FMAP rate of 70% or more; and

WHEREAS, All of the contiguous states surrounding Illinois have a higher FMAP reimbursement rate for Medicaid - between 5% and 19% higher; and

WHEREAS, Other states with low relative FMAP reimbursements include New York, New Jersey, California, Connecticut, Maryland, and Virginia; these states are similar to Illinois with proximity to a large metropolitan area; and

WHEREAS, Concerns have been raised that the FMAP formula fails to take into account the total number of Medicaid eligible residents which may live in an area with a large metropolitan area and is slow to reflect current economic conditions present in a state; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the federal government to revisit the formula used to calculate the Federal Medical Assistance Percentage with variables which take into account the total number of low income residents in a state and variables which represent a timely reflection of economic conditions in a state; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the U.S. Secretary of Health and Human Services.

### HOUSE RESOLUTION 1188

Offered by Representative Christian Mitchell:

WHEREAS, The proliferation of illegally-acquired firearms are destroying lives and hurting the public perception of the City of Chicago and our State, which has had a detrimental effect on our economy; and

WHEREAS, The Chicago Police Department recovered more than 50,000 illegal guns between 2001 and 2012; and

WHEREAS, In 2012, 87% of murders committed in the City of Chicago were caused by gun violence; in 2013, 1,864 shootings occurred within the City; and

(1) the necessary levels of coordination, funding, and interdepartmental and State/federal cooperation for effective gun trafficking interdiction;

(2) the legal framework necessary for getting guns off the streets, including the examination of current gunrunning, straw purchasing, and unlicensed dealer penalties and their interaction with city, State, and federal policies; and

(3) the feasibility of Office of Juvenile Justice and Delinquency Prevention and Department of Justice anti-violence programs that have worked in other similarly situated states and cities, including after-school programs and job readiness, that are peer-reviewed and cost-effective; and be it further

RESOLVED, That the members of the Task Force shall be appointed by the Speaker and Minority Leader of the Illinois House of Representatives in equal numbers; and be it further

RESOLVED, That the Illinois State Police shall provide administrative and other support to the Task Force; and be it further

RESOLVED, That the Task Force shall submit a report of its findings to the General Assembly on or before November 1, 2014; and be it further

RESOLVED, That we declare an Illegal Gun Trafficking State of Emergency in the State of Illinois; and be it further

RESOLVED, That the members of this body recognize the inextricable links between illegal guns, gangs, and drugs and urge the members of the Task Force to work with existing Task Forces like the House Task Force on Heroin Crisis to combat this growing menace; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor and Chicago Mayor Rahm Emanuel.

#### HOUSE RESOLUTION 1189

Offered by Representative Gabel:

WHEREAS, The Patient Protection and Affordable Care Act was signed into law on March 23, 2010, signifying a historic change in access to health care in the United States; and

WHEREAS, The Affordable Care Act expands health coverage options through health insurance marketplaces and Medicaid, allowing consumers more affordable and comprehensive coverage options; and

WHEREAS, Governor Pat Quinn issued Executive Order #2010-12 establishing the Health Care Reform Implementation Council, which was charged with making recommendations to assist the State in establishing a State Based Marketplace, establish consumer protections reforms, reform Medicaid, assure high quality care, and adopt the use of electronic medical records; and

WHEREAS, A State Based Marketplace was the unanimous recommendation of the Health Care Reform Implementation Council; after holding hearings throughout Illinois, businesses, labor, consumers, and insurers agreed that a State exchange was preferable to a Federally Facilitated Marketplace; and

WHEREAS, The General Assembly passed and Governor Quinn signed Public Act 97-0412 in 2011, the Illinois Health Benefits Exchange Law, establishing the intent for Illinois to operate a State Based Marketplace for individuals and small businesses and creating a Legislative Study Committee on the subject; and

WHEREAS, Based on Public Act 97-0312 and the recommendation of the Health Care Reform Implementation Council, Governor Quinn submitted his intent to the Department of Health and Human Services for Illinois to function in a partnership capacity with the Federally Facilitated Marketplace until the State marketplace became operational; and

WHEREAS, Illinois has functioned as a State Partnership Marketplace since October 1, 2013, branding the campaign as Get Covered Illinois, and enrolling more than 217,000 people in the Federal Health Insurance Marketplace by working with many partners across the State; and

WHEREAS, Some state-based marketplaces have functioned well (generally accepted as including Connecticut, Kentucky, New York, and California) and others have functioned poorly (commonly considered as including Oregon and Maryland); and

WHEREAS, States with poorly functioning marketplaces are exploring the utilization of the IT platform from states with smoothly operating marketplaces; and

WHEREAS, The state of Maryland has concluded that costs of adopting the IT platform from Kentucky and Connecticut are greatly reduced compared to the costs of constructing a new state marketplace and would provide a well-functioning state marketplace with much less risk in a shorter period of time; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Governor's Office of Health Innovation and Transformation, in collaboration with the Illinois Health Insurance Marketplace, is requested to assess the experiences of State Based Marketplaces during their first year of operation and identify those states whose marketplaces worked as intended and whose IT platforms would be compatible with the State's Medicaid Integrated Eligibility System and could serve as the technological base for an Illinois state-based marketplace; and be it further

RESOLVED, That we urge the Governor's Office of Health Innovation and Transformation to submit the results of the assessment to the House of Representatives by November 10, 2014, for its consideration of options for maintaining the federally-facilitated marketplace or developing a State Based Marketplace that meets the needs of Illinois while federal funding for state-based marketplaces is still available.

"ARTICLE I

BILL OF RIGHTS

SECTION 8.1. CRIME ~~VICTIMS'~~ ~~VICTIMS~~ RIGHTS.

(a) Crime victims, as defined by law, shall have the following rights ~~as provided by law~~:

(1) The right to be treated with fairness and respect for their dignity and privacy and to be free from harassment, intimidation, and abuse throughout the criminal justice process.

(2) The right to notice and to a hearing before a court ruling on a request for access to any of the victim's records, information, or communications which are privileged or confidential by law.

(3) ~~(2)~~ The right to timely notification of all court proceedings.

(4) ~~(3)~~ The right to communicate with the prosecution.

(5) ~~(4)~~ The right to be heard at any post-arraignment court proceeding in which a right of the victim is at issue and any court proceeding involving a post-arraignment release decision, plea, or sentencing ~~make a statement to the court at sentencing.~~

(6) ~~(5)~~ The right to be notified of information about the conviction, the sentence, the imprisonment, and the release of the accused.

(7) ~~(6)~~ The right to timely disposition of the case following the arrest of the accused.

(8) ~~(7)~~ The right to be reasonably protected from the accused throughout the criminal justice process.

(9) The right to have the safety of the victim and the victim's family considered in denying or fixing the amount of bail, determining whether to release the defendant, and setting conditions of release after arrest and conviction.

(10) ~~(8)~~ The right to be present at the trial and all other court proceedings on the same basis as the accused, unless the victim is to testify and the court determines that the victim's testimony would be materially affected if the victim hears other testimony at the trial.

(11) ~~(9)~~ The right to have present at all court proceedings, subject to the rules of evidence, an advocate and ~~or~~ other support person of the victim's choice.

(12) (40) The right to restitution.

(b) The victim has standing to assert the rights enumerated in subsection (a) in any court exercising jurisdiction over the case. The court shall promptly rule on a victim's request. The victim does not have party status. The accused does not have standing to assert the rights of a victim. The court shall not appoint an attorney for the victim under this Section. Nothing in this Section shall be construed to alter the powers, duties, and responsibilities of the prosecuting attorney. The General Assembly may provide by law for the enforcement of this Section.

(c) The General Assembly may provide for an assessment against convicted defendants to pay for crime victims' rights.

(d) Nothing in this Section or any law enacted under this Section creates a cause of action in equity or at law for compensation, attorney's fees, or damages against the State, a political subdivision of the State, an officer, employee, or agent of the State or of any political subdivision of the State, or an officer or employee of the court, or in any law enacted under

(e) Nothing in this Section or any law enacted under this Section shall be construed as creating (1) a basis for vacating a conviction or (2) a ground for any relief requested by the defendant appellate relief in any criminal case."; and be it further

RESOLVED, That a brief explanation of the proposed amendment, a brief argument in favor of the amendment, a brief argument against the amendment, and the form in which the amendment will appear on the ballot shall be published and distributed as follows:

*To the Electors of the State of Illinois:*

The purpose of a state constitution is to establish a structure for government and laws. There are three ways to initiate change to the Illinois Constitution: (1) a constitutional convention may propose changes to any part; (2) the General Assembly may propose changes to any part; or (3) a petition initiative may propose amendments limited to structural and procedural subjects contained in the Legislative Article. The people of Illinois must approve any changes to the Constitution before they become effective.

**EXPLANATION**

The Constitution sets forth substantial rights for crime victims. The proposed amendment expands certain current rights:

1) Victims are currently entitled to fairness and respect throughout the criminal justice process. The amendment would also provide that they shall be protected from harassment, intimidation and abuse.

2) Victims can make a statement to the court when a criminal defendant is sentenced to punishment. The amendment would allow a victim to be heard at any proceeding that involves the victim's rights, and any proceeding involving a plea agreement, release of the defendant or convicted individual, or sentencing.

3) Victims may obtain information about conviction, sentencing, imprisonment or release. The amendment would require prosecutors and the court to notify victims of those events before they happen.

The amendment would also grant additional rights to crime victims:

1) A victim would have a right to formal notice and a hearing before the court rules on any request for access to privileged or confidential information.

2) A victim would have the right to have the judge consider the victim's safety and the safety of his or her family before deciding whether to release a criminal defendant, setting the amount of bail to be paid before release, or setting conditions of release after arrest or conviction.

3) The victim would have the right to assert his or her rights in any court with jurisdiction over the criminal case, but would not have the same rights as the prosecutor or the criminal defendant and the court could not appoint an attorney for the victim at taxpayer expense.

The proposed amendment would not alter the powers, duties or responsibilities of the prosecutor. Further, a criminal defendant would not be able to challenge his or her conviction on the basis of a failure to follow these provisions.

**Arguments in Favor of the Proposed Amendment**

Crime victims deserve stronger protections under the Constitution than are currently provided. Victims should not have to fear intimidation and harassment when they participate in the criminal justice process. Judges must consider a victim's safety when setting bail, deciding whether a criminal defendant should be released during his or her trial, or sentencing a convicted defendant.

Further, victims should also be allowed to object when a defendant or a defendant's attorney attempts to obtain confidential or private information, like mental health records or personal journals. A judge would still be able to require a victim to turn those records or communications over to the court, but the amendment would allow the victim to object if he or she feels that a privacy violation would result.

A constitutional amendment is necessary because judges need to be certain what rights a victim has before the court. This amendment would provide that judges and prosecutors have a constitutional duty to keep the victim informed of developments in the case, and to allow the victim to participate when appropriate.

**Arguments Against the Proposed Amendment**

The proposed amendment would disrupt the criminal justice process and impede the work of prosecutors. Our criminal justice system tasks prosecutors, not victims, with punishing criminals and restoring justice after a crime is committed. Victims and their attorneys may attempt to take over that important role, second-guessing prosecutors and objecting to decisions made by judges.

Victims already have a right to be present and informed during the process, and Illinois already provides extensive rights to crime victims under the Rights of Crime Victims and Witnesses Act.

The proposed amendment threatens the rights of criminal defendants, both the guilty and the innocent. Our system gives criminal defendants the right to access information, documents and records that could prove their innocence; however, the amendment would give a victim the opportunity to prevent disclosure of certain materials or documents that might prove the defendant's innocence.
