23RD LEGISLATIVE DAY

Perfunctory Session

THURSDAY, MARCH 12, 2015

At the hour of 2:08 o'clock p.m., the House convened perfunctory session.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 269

Offered by Representative Verschoore:

WHEREAS, More than half of Illinois residents receive their water from groundwater wells; this makes Illinois groundwater a valuable natural resource that needs to be protected; and

WHEREAS, Next to breathable air, groundwater may be the next most important resource necessary for human life; and

WHEREAS, Agricultural irrigation is the single largest use of groundwater, nourishing much of the produce and livestock that fills our grocery stores; and

WHEREAS, Groundwater can be found beneath the surface virtually anywhere, making it possible to live in rural or even remote places where public water systems do not exist; and

WHEREAS, Groundwater makes it possible for ecosystems teeming with life to exist as it supplies plants and animals with life-giving water and often meets critical water needs in the midst of drought because of its abundance beneath the surface of the earth; and

WHEREAS, Spring is a good season to have an annual water well checkup before the peak water use season begins according to the National Ground Water Association and the Illinois Association of Groundwater Professionals (IAGP); and

WHEREAS, An abandoned well as defined by the Illinois Water Well Construction Code is a water or monitoring well that is no longer used to supply water, or that is in such a state of disrepair that the well or boring has the potential for transmitting contaminants into an aquifer or otherwise threatens the public health or safety; furthermore, the code requires that an abandoned well be properly sealed within 30 days after it is abandoned and no longer in use; and

WHEREAS, The IAGP encourages the Illinois Department of Public Health and units of local government to identify the number and location of abandoned wells, educate communities of the need for building demolition policies and procedures to include inspection for abandoned wells, provide evaluation processes to determine appropriateness of well for non-potable use, support annual inspections by local government of well non-potable use, build awareness and raise funds to provide help and support well-sealing, and to recognize private wells as a viable means to reduce and conserve potable water for non-potable use; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate March 8-14, 2015 as "Illinois Groundwater Awareness Week"; and be it further

RESOLVED, That we urge the Governor to issue a proclamation calling on the people of the great State of Illinois to observe the week by learning more about groundwater and its importance in peoples' lives and to encourage them to act in ways that value and protect this resource.

HOUSE RESOLUTION 270

Offered by Representative Flowers:

WHEREAS, School districts that do not follow laws under the School Code are subject to non-recognition action by the Illinois State Board of Education; and

WHEREAS, The Illinois State Board of Education may withhold General State Aid funds from any district that is not recognized and is not abiding by the laws of the School Code; and

WHEREAS, The School Code requires districts to have trained personnel for the use of automated external defibrillators; and

WHEREAS, The School Code requires districts to include a unit of instruction studying the events of black history, including the history of the African slave trade, slavery in America, and the vestiges of slavery in this country; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Chicago Public Schools to adhere to all laws under the School Code, including the training of personnel on the use of automated external defibrillators and the teaching of black history in schools; and be it further

RESOLVED, That we urge the Illinois State Board of Education to ensure that Chicago Public Schools are in compliance with all applicable laws and to withhold General State Aid funds if it finds the district is not in compliance; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Chicago Board of Education and the Illinois State Board of Education.

HOUSE RESOLUTION 271

Offered by Representative Lilly:

WHEREAS, Arts education, comprising a rich array of disciplines including dance, music, theatre, media arts, literature, design, and visual arts, is a core academic subject and an essential element of a complete and balanced education for all students; and

WHEREAS, According to Albert Einstein, "After a certain high level of technical skill is achieved, science and art tend to coalesce in esthetics, plasticity, and form. The greatest scientists are artists as well."; and

WHEREAS, Arts education enables students to develop critical thinking and problem solving skills, imagination and creativity, discipline, alternative ways to communicate and express feelings and ideas, and cross-cultural understanding, which supports academic success across the curriculum and personal growth outside the classroom; and

WHEREAS, The non-profit arts sector is an economic engine and plays a significant role in the economic health of communities large and small with direct expenditures of wages and benefits and in goods and services; and

WHEREAS, To succeed in today's economy, students must masterfully use words, images, sounds, and movement to communicate; and

WHEREAS, The arts provide the skills and knowledge students need to develop the creativity and determination necessary for success in the global information age; and

WHEREAS, Where schools and communities are delivering high quality learning opportunities in, through, and about the arts for children, extraordinary results occur; and

WHEREAS, Studies have found that 8th graders from under-resourced environments who are highly involved in the arts have better grades, less likelihood of dropping out by grade 10, have more positive attitudes about school, and are more likely to go to college; and

WHEREAS, Attracting and retaining the best teachers is vital and can be achieved by ensuring that schools embrace the arts, becoming havens for creativity and innovation; and

WHEREAS, Arts education has the power to make students want to learn not just within the arts, but other areas of study; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we call upon the Governor to remember the importance of the arts throughout the budgeting process; and be it further

RESOLVED, That we call upon elected officials and schools throughout the State of Illinois to maintain art programs; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Governor.

HOUSE RESOLUTION 273

Offered by Representative Leitch:

WHEREAS, The Export-Import Bank of the United States (Ex-Im Bank) is the official export credit agency of the United States; and

WHEREAS, The mission of the Ex-Im Bank is to ensure that United States companies have access to export sales through working capital guarantees, loan guarantees, export-credit insurance, and financing to help foreign buyers purchase U.S. goods and services; and

WHEREAS, The Ex-Im Bank does not compete with private institutions because it finances exports that the private sector is unwilling or unable to undertake alone; and

WHEREAS, The Ex-Im Bank has generated nearly \$3 billion in fees from its customers over the past 3 fiscal years, including \$674.7 million in FY 2014; these funds were deposited in the U.S Treasury to reduce the U.S. deficit and indebtedness; and

WHEREAS, Eighty-five percent of Ex-Im Bank transactions benefit small businesses; and

WHEREAS, Between 2007 and 2014, the Ex-Im Bank supported 382 Illinois companies including 246 small companies employing 35,000 workers that exported products; and

WHEREAS, These 382 Illinois companies sold more than \$8 billion in goods and services across the globe; and

WHEREAS, Since FY 2012, the Ex-Im Bank has supported nearly \$115 billion in exports; and

WHEREAS, The Ex-Im Bank has supported more than 1.3 million American jobs in all 50 states since FY 2009; and

WHEREAS, Illinois exported a record \$68.2 billion of goods and services in 2014; and

WHEREAS, Illinois companies, particularly in the manufacturing and agricultural sectors, rely on the sales of products across the world; and

WHEREAS, Nearly 90% of world trade relies on trade finance provided by 60 export credit agencies, according to the Congressional Research Service; and

WHEREAS, The Ex-Im Bank's statutory authority has been renewed many times over the past 80 years under both Democrat and Republican administrations; and

WHEREAS, The Ex-Im Bank's statutory charter is scheduled to expire on June 30, 2015; and

WHEREAS, Expiration of the Ex-Im Bank's authority would stop operations and prevent Illinois companies from selling billions of dollars in products; and

WHEREAS, Expiration of the Ex-Im Bank will have a negative impact on the Illinois economy, its communities, and its workers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge President Barack Obama and members of the United States Senate and House of Representatives to reauthorize the United States Export-Import Bank before June 30, 2015; and be it further

RESOLVED, That suitable copies of this resolution be provided to U.S. House Speaker John Boehner, House Minority Leader Nancy Pelosi, Senate Majority Leader Mitch McConnell, Senate Minority Leader Harry Reid, U.S. Senator Dick Durbin, U.S. Senator Mark Kirk, and every member of the Illinois Congressional Delegation.

Representative Smiddy introduced the following:

**HOUSE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT 34**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 6 of Article VII as follows:

ARTICLE VII
LOCAL GOVERNMENT

SECTION 6. POWERS OF HOME RULE UNITS

(a) A County which has a chief executive officer elected by the electors of the county and any municipality which has a population of more than 20,000 ~~25,000~~ are home rule units. Other municipalities may elect by referendum to become home rule units. Except as limited by this Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs including, but not limited to, the power to regulate for the protection of the public health, safety, morals and welfare; to license; to tax; and to incur debt.

(b) A home rule unit by referendum may elect not to be a home rule unit.

(c) If a home rule county ordinance conflicts with an ordinance of a municipality, the municipal ordinance shall prevail within its jurisdiction.

(d) A home rule unit does not have the power (1) to incur debt payable from ad valorem property tax receipts maturing more than 40 years from the time it is incurred or (2) to define and provide for the punishment of a felony.

(e) A home rule unit shall have only the power that the General Assembly may provide by law (1) to punish by imprisonment for more than six months or (2) to license for revenue or impose taxes upon or measured by income or earnings or upon occupations.

(f) A home rule unit shall have the power subject to approval by referendum to adopt, alter or repeal a form of government provided by law, except that the form of government of Cook County shall be subject to the provisions of Section 3 of this Article. A home rule municipality shall have the power to provide for its officers, their manner of selection and terms of office only as approved by referendum or as otherwise authorized by law. A home rule county shall have the power to provide for its officers, their manner of selection and terms of office in the manner set forth in Section 4 of this Article.

(g) The General Assembly by a law approved by the vote of three-fifths of the members elected to each house may deny or limit the power to tax and any other power or function of a home rule unit not exercised or performed by the State other than a power or function specified in subsection (l) of this section.

(h) The General Assembly may provide specifically by law for the exclusive exercise by the State of any power or function of a home rule unit other than a taxing power or a power or function specified in subsection (l) of this Section.

(i) Home rule units may exercise and perform concurrently with the State any power or function of a home rule unit to the extent that the General Assembly by law does not specifically limit the concurrent exercise or specifically declare the State's exercise to be exclusive.

(j) The General Assembly may limit by law the amount of debt which home rule counties may incur and may limit by law approved by three-fifths of the members elected to each house the amount of debt, other than debt payable from ad valorem property tax receipts, which home rule municipalities may incur.

(k) The General Assembly may limit by law the amount and require referendum approval of debt to be incurred by home rule municipalities, payable from ad valorem property tax receipts, only in excess of the following percentages of the assessed value of its taxable property: (1) if its population is 500,000 or more, an aggregate of three percent; (2) if its population is more than 20,000 ~~25,000~~ and less than 500,000, an aggregate of one percent; and (3) if its population is 20,000 ~~25,000~~ or less, an aggregate of one-half percent. Indebtedness which is outstanding on the effective date of this Constitution or which is thereafter approved by referendum or assumed from another unit of local government shall not be included in the foregoing percentage amounts.

(l) The General Assembly may not deny or limit the power of home rule units (1) to make local improvements by special assessment and to exercise this power jointly with other counties and municipalities, and other classes of units of local government having that power on the effective date of this Constitution unless that power is subsequently denied by law to any such other units of local government or (2) to levy or impose additional taxes upon areas within their boundaries in the manner provided by law for the provision of special services to those areas and for the payment of debt incurred in order to provide those special services.

(m) Powers and functions of home rule units shall be construed liberally.
