## HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

### HOUSE RESOLUTION 402

Offered by Representative Phelps:

WHEREAS, The November 17, 2013 tornado outbreak was the deadliest and costliest in Illinois to occur in the month of November and fourth largest for the State overall; and

WHEREAS, Severe weather during the tornado outbreak caused over 100 injuries and 11 fatalities, 8 of which were tornado related; and

WHEREAS, With damage estimated at approximately \$1.6 billion, the tornado outbreak became the seventh weather event and fifth tornado outbreak in the United States to accrue over \$1 billion in damage that year; and

WHEREAS, Tornadoes alone were responsible for \$1.067 billion in damage, with the EF4 tornado that struck Washington, Illinois accounting for \$935 million of the total; and

WHEREAS, On January 9, 2014, the Federal Emergency Management Agency notified the State that it was denying a \$6.1 million request for local governments on the grounds that the damage wasn't severe enough; this decision impacted Champaign, Douglas, Grundy, Massac, Tazewell, Vermilion, Washington, Wayne, and Woodford counties; and

WHEREAS, The Federal Emergency Management Agency twice denied disaster funding to Harrisburg after it was demolished by tornadoes in 2012; and

WHEREAS, Illinois Senators Dick Durbin and Mark Kirk have introduced the Fairness in Federal Disaster Declarations Act; both senators say that the current system for delivering federal disaster assistance funds discriminates against smaller communities in states with large population centers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to pass the Fairness in Federal Disaster Declarations Act to ensure that Illinois residents who are impacted by deadly and destructive weather receive the level of assistance that they require; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Speaker and Minority Leader of the United States House of Representatives, the Majority and Minority Leaders of the United States Senate, and the members of the Illinois congressional delegation.

### HOUSE RESOLUTION 403

Offered by Representative Bellock:

WHEREAS, In 1982, Congress designated June 6-12 as the first National Child Abuse Prevention Week; the following year, President Ronald Reagan proclaimed April to be the first National Child Abuse Prevention Month, a tradition that continues to this day; and

WHEREAS, Child abuse and neglect is a major social problem in Illinois, annually affecting 30,000 children in more than 17,000 families statewide; according to the Children's Bureau's Child Maltreatment 2013 Report, an estimated 1,520 children died as a result of abuse or neglect in the United States in 2013; and

WHEREAS, It is estimated that more than 100,000 cases of abuse go unreported each year; the impact of abuse on children manifests itself in many ways; the affected children may experience a range of emotional, psychological, and physical problems and trauma as a result of being abused or neglected; and

WHEREAS, There are various organizations and agencies that devote their full-hearted efforts to combating this vicious problem and seek to provide these at-risk children with options that help prevent and relieve afflicted children from the hardship that is child neglect and abuse; and

WHEREAS, Organizations like the Children's Advocacy Centers of Illinois, Children's Home + Aid, and Prevent Child Abuse America have provided children and families the opportunity of healing the wounds left from the harmful results of child neglect and abuse; and

WHEREAS, Established in 1995, the Children's Advocacy Centers of Illinois is a network that coordinates and provides a comprehensive response to child abuse in Illinois through 37 locations in the State, working closely with the Department of Children and Family Services and the Illinois Attorney General's Office; and

WHEREAS, Children's Home + Aid has regional offices in Bloomington, Rockford, Chicago, and Granite City; the organization is a leading child and family service agency in Illinois; each year, it protects, educates, and counsels more than 40,000 children, youth, and families to overcome the overwhelming obstacles of poverty, abuse, and neglect; and

WHEREAS, Founded in Chicago in 1972, Prevent Child Abuse America works to ensure the healthy development of children nationwide; the organization promotes this mission through a network of chapters in 50 states and nearly 600 Healthy Families America home visiting sites in 39 states, the District of Columbia, American Samoa, Guam, the Northern Commonwealth of the Marianas, Puerto Rico, the United States Virgin Islands, and Canada; and

WHEREAS, Illinois State law requires that Mandated Reporters, including most professionals in education, health care, law enforcement and social work, report suspected neglect or abuse; and

WHEREAS, Health care professionals and concerned individuals continue to try and raise awareness for and education in emotional child abuse in the community and among parents so as to produce a pro-active solution to the problem of child abuse and neglect; and

WHEREAS, The National Child Abuse Prevention Month is a time to acknowledge the importance of families and communities working together to prevent child abuse and neglect, and to promote the social and emotional well-being of children and families; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of April in 2015 and 2016 as Child Abuse Prevention Month in the State of Illinois; and be it further

RESOLVED, That we encourage communities throughout the State to share child abuse and neglect prevention awareness strategies and promote prevention across the State of Illinois.

#### HOUSE RESOLUTION 404

Offered by Representative Barbara Wheeler:

WHEREAS, Implementation of the Partnership for Assessment of Readiness for College and Careers (PARCC) assessment has been an object of contention for students, parents, teachers, and school districts in this State, as well as in other states; and

WHEREAS, In 2010, 23 states were slated to participate in PARCC, and now there are only 12 states participating; and

WHEREAS, To date, a comprehensive fiscal impact to this State and school districts regarding technology and infrastructure needs to fully implement the PARCC assessment has yet to be determined; and

WHEREAS, The State Board of Education submitted a capital request of \$450 million last year and \$126 million this year for technology infrastructure, which is a cost directly associated with the PARCC assessment; and

WHEREAS, New learning standards were adopted through the Joint Committee on Administrative Rules; and

WHEREAS, Approval of any new standards and assessments, particularly those with tremendous financial and educational repercussions, should come before the entire General Assembly; and

WHEREAS, State law requires that school districts use an assessment that gauges career and college readiness; and

WHEREAS, Unlike the previous State assessment, the PARCC assessment is not inclusive of the ACT, which is a common and accepted measurement of college readiness for admissions purposes in institution of higher education across the country; and

WHEREAS, The General Assembly recognizes that not complying with federal testing requirements could jeopardize close to \$1.1 billion in federal funds for K through 12 education, which is unacceptable; and

WHEREAS, The State Board of Education entered into a contract for the PARCC assessment, which is set to expire on June 30, 2018; and

WHEREAS, State and federal law allows for other assessment options outside of the PARCC assessment; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor, in conjunction with the State Board of Education, to reevaluate its contract with PARCC in the hopes of making new recommendations on how this State can comply with State and federal law, while maintaining a rigorous and comprehensive assessment that accurately evaluates student academic needs and growth; and be it further

RESOLVED, That we urge the State Board of Education to better communicate changes of this size, scope, and cost, particularly those pertaining to learning standards and assessments, to the General Assembly and the public before entering into the rulemaking process; and be it further

RESOLVED, That suitable copies of this resolution be delivered the Governor and the State Board of Education.

#### HOUSE RESOLUTION 405

Offered by Representative Ford:

WHEREAS, In the past year, the nation's attention has turned to police practices because of high profile killings, including Michael Brown in Ferguson, Missouri, Tamir Rice in Ohio, and Eric Garner in New York; and

WHEREAS, Concerns about policing extend beyond the use of force and into the everyday interactions of police with community members; and

WHEREAS, In African-American and Latino communities, everyday interactions with police often result in a "stop and frisk"; and

WHEREAS, Under the United States Supreme Court decision in *Terry v. Ohio*, 392 U.S. 1 (1968), an officer is allowed to stop a person if the officer has reasonable suspicion that the person has been, is, or is about to be engaged in criminal activity; once a person is stopped, if an officer has reasonable suspicion that the person is dangerous and has a weapon, the officer may frisk the person including ordering him or her to put his or her hands on a wall or car, and allowing the officer to frisk the person's body to determine if a weapon is being carried; and

WHEREAS, This experience is often invasive, humiliating, and disturbing; and

WHEREAS, Many police departments have failed to adequately train, supervise, and monitor law enforcement in minority communities for decades, resulting in a failure to ensure that officers' use of stop and frisk is lawful; and

WHEREAS, A report by the American Civil Liberties Union of Chicago found that the Chicago Police Department has a current practice of unlawfully using stop and frisk: "Although officers are required to write down the reason for stops, in nearly half of the stops we reviewed, officers either gave an unlawful reason for the stop or failed to provide enough information to justify the stop."; and

WHEREAS, The report states that "stop and frisk" in Chicago is disproportionately concentrated in the African-American community comprising 72% of all stops, even though African-Americans constitute just 32% of the city's population and in majority white police districts, minorities were stopped disproportionately to the number of minority people living in those districts; and this failure to properly record data makes it impossible for police supervisors, or the public, to identify bad practices and make policy changes to address them; the abuse of stop and frisk is a violation of individual rights, but it also poisons police and community relations; and

WHEREAS, In Chicago, there were more than 250,000 stops that did not lead to an arrest; Chicagoans were stopped more than 4 times as often as New Yorkers at the height of New York City's stop and frisk practice; and

WHEREAS, Chicago refuses to keep adequate data about its officers' stops; officers do not identify stops that result in an arrest or ordinance violation, and they do not keep any data on when they frisk someone; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the House urges the General Assembly to pass legislation that adopts the recommendations of the American Civil Liberties Union of Chicago as follows:

(1) require police departments to collect data on each frisk, record the frisk, the reason for the frisk (which must be separate from the reasons for the stop), and the results of the search such as whether there was a weapon or other contraband and if so, what type and make the data public;

(2) expand and make permanent the Illinois Traffic Stop Statistical Study Act;

- (3) require police departments to collect data on all stops and make the data public;
- (4) require police officers to receive regular training on the legal requirements for stop and frisk and how to record them properly; and
- (5) require that police officers provide civilians with a receipt at the end of pedestrian stops, traffic stops, and consensual encounters stating the officer's name, the time and place of the encounter, and the reason for the encounter.
