HOUSE RESOLUTION 657

Offered by Representative Brown:

WHEREAS, Sharon Conatser, a proud citizen of Champaign, will be elected to serve as National President of the American Legion Auxiliary during the organization's 95th National Convention in Baltimore, Maryland on September 3, 2015, with the theme of "Keeping the Promise"; she is a proud American Legion Family member of Urbana Auxiliary Unit 71; and

WHEREAS, Founded in 1919, the American Legion Auxiliary is the world's largest women's patriotic service organization with a national membership of nearly 800,000; the organization has a strong presence in more than 9,000 communities nationwide, including 496 Auxiliary units in the State of Illinois; and

WHEREAS, Sharon Conatser joined the American Legion Auxiliary with her eligibility through her father, Clay Lofton, a World War II and Korean War veteran; she is also eligible through her husband, Marty, a Vietnam veteran, and her son, Rick, a veteran from the Gulf War era; her 3 sons, daughters-in-law, and 5 grandchildren are all members of the American Legion Family; and

WHEREAS, Sharon Conatser has held numerous Auxiliary leadership positions in the organization at the unit, district, and department levels; at the national level, she has chaired many committees and has served special appointments since 2001; during the 2007-2008 administrative year, she served as First Lady of The American Legion; and

WHEREAS, Sharon Conatser chose Springfield as the site and host city of her National President's Homecoming to show her the rich historic and cultural fabric within her boundaries; and

WHEREAS, The City of Springfield has hosted the annual Department of Illinois American Legion Auxiliary Convention on numerous occasions; the hometown of Abraham Lincoln is the perfect canvas on which to showcase the American Legion's history of service to our nation's veterans; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate October 23-25, 2015 as National American Legion Auxiliary President Sharon Conatser's Homecoming Weekend in the State of Illinois and encourage all of our citizens to recognize the honorable 95-year tradition of the American Legion Auxiliary's volunteerism of "Service not Self"; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Sharon Conatser as a symbol of our respect and esteem.

HOUSE RESOLUTION 658

Offered by Representative Barbara Wheeler:

WHEREAS, On July 16, 2015 in Chattanooga, Tennessee, 5 United States Marines were murdered and 2 other individuals were wounded at a United States Armed Services recruiting center and a Naval Reserve Facility; and

WHEREAS, In recent years, there have been multiple other attacks planned, and at least 8 completed, against United States military members on military sites; and

WHEREAS, The United States Armed Forces and the Illinois National Guard serve our country with courage and honor and protect the freedom of our nation; and

WHEREAS, This country should take any and every measure available to ensure military personnel are appropriately protected against attacks, including but not limited to securing their work areas and recruiting stations; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to swiftly promulgate laws that ensure members of the military are adequately armed for their protection, including, but not limited to the arming of military personnel at facilities and recruiting stations, enhancing security at military facilities, and providing for any other measure to ensure the preservation of lives; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Speaker and Minority Leader of the United States House of Representatives, the Majority and Minority Leaders of the United States Senate, and the members of the Illinois congressional delegation.

WHEREAS, USA Gymnastics and gymnastics clubs across the nation annually celebrate National Gymnastics Day to showcase the sport of gymnastics and to encourage and promote physical fitness among our nation's youth; and

WHEREAS, Gymnastics provides a great foundation for building strength, flexibility, fitness, life skills, enhancing self-esteem, and goal-setting abilities; and

WHEREAS, National Gymnastics Day seeks to promote the value of physical fitness and good nutrition for everyone, regardless of age, gender, and ability level; and

WHEREAS, On National Gymnastics Day, gymnastics clubs around the world partner with USA Gymnastics to heighten the visibility of the sport and encourage participation at the grassroots level; and

WHEREAS, National Gymnastics Day aims to serve the greater community good by supporting the mission of the Nastia Liukin Fund through outreach to clubs that aid athletes who need financial assistance to remain or become involved in gymnastics; and

WHEREAS, USA Gymnastics, along with the State of Illinois and the nation, strive to encourage greatness and achievement in young people; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate September 19, 2015 as "Gymnastics Day" in the State of Illinois in support of National Gymnastics Day; and be it further

RESOLVED, That a suitable copy of this resolution be presented to USA Gymnastics as an expression of our esteem and respect.

HOUSE RESOLUTION 667

Offered by Representative Anthony:

WHEREAS, The game of baseball is the "National Pastime"; it is an institution that transcends the realm of sport and has become an integral part of the American experience; the game, and those players that make

it such an enjoyable and communal event, has been a part of the American way of life for well over a century; and

WHEREAS, The State of Illinois has been a proud producer of talent and supporter of the game of baseball, standing as the proud home of 2 of the most distinguished franchises in Major League Baseball (MLB) history, the Chicago Cubs and the Chicago White Sox; and

WHEREAS, Players including former Chicago Cub, Joe Girardi (from Peoria), former White Sox, Jim Thome (from Peoria), former New York Yankee, Rickey Henderson (Chicago native), former St. Louis Cardinal, Jason Istringhausen (from Brighton), and current Washington National, Jayson Werth, born in the State's capital of Springfield, are only but a few Illinoisans who have contributed to the game over the years, and they represent the importance that the game has on baseball fans and enthusiasts here in the Land of Lincoln; and

WHEREAS, The Chicago Cubs and Chicago White Sox organizations, being 2 of the most historic teams in baseball, have contributed much to the game and have had the privilege to have a number of their players recognized in the National Baseball Hall of Fame located in Cooperstown, New York; and

WHEREAS, It is understood that induction into the Hall of Fame is one of the most incredible rewards and honors that can be bestowed upon an MLB player; the Hall represents all of the principles that the game of baseball embodies and demands of those players who compete for a chance to, one day, have the opportunity to win a World Series and be admitted into Cooperstown; and

WHEREAS, The game of baseball is also a game that is played by the rules, and the "Big Leaguers" that play the game are expected to play by those rules; nevertheless, those rules and regulations are, at times, presented an exceptional case - one that needs to be considered in more than a standard, uniform manner; and

WHEREAS, In recent times, the integrity of the game of baseball has been sullied, adulterated by the introduction of performance enhancing drugs (PEDs); the use of PEDs has introduced an added challenge to the game, resulting in certain users of those substances receiving an unfair advantage on the field; this abuse of the rules of the game is something that owners and players, both past and present, will continue to deal with; and

WHEREAS, Former MLB Commissioner Bud Selig met this problem head-on and took measures that ultimately resulted in new restrictions and steeper penalties for those players found in violation of the revised rules on the use of PEDs; yet, there are players who have been found guilty of abusing these restricted substances but remain eligible to be considered for induction into the Hall of Fame; and

WHEREAS, The punishment for players found guilty of having used PEDs, some of whom hold groundbreaking records, have devoted many years to our nation's pastime, and have fans across the country and world, is fair; and

WHEREAS, There remains one exceptional case before MLB - the case of Pete Rose, otherwise known as "Charlie Hustle"; and

WHEREAS, Pete Rose, born Peter Edward Rose, is one of the most remarkable individuals to have ever played the game, as his career statistics substantiate; he is also one of the most popular Cincinnati Reds player to ever have put on the uniform, most notably as part of the "Big Red Machine"; and

WHEREAS, Pete Rose is a career .303 hitter; in his 14,053 at-bats, he totaled 160 home runs, 1,314 runs-batted-in, and 2,165 runs scored; he holds the MLB record for total hits with 4,256; and

WHEREAS, A Cincinnati native, Pete Rose is a hometown hero who brought more than 2 decades of entertainment, excitement, and prestige to "The Queen City"; among his many achievements, he won the Rookie of the Year Award in 1963, 3 World Series titles, and one Most Valuable Player award; he won 3 batting titles, 2 Gold Gloves, and took part in 17 All-Star Games as a first, second, and third baseman and left and right-fielder; and

WHEREAS, Pete Rose served as manager for the Cincinnati Reds from 1984 to 1989, accumulating a record of 426 wins and 388 losses; and

WHEREAS, In 1989, MLB Commissioner A. Bartlett Giamatti issued a permanent, lifetime ban on Pete Rose after accusations arose surrounding his involvement in illicit gambling, outlawed by MLB's Rule 21; and

WHEREAS, A fault was committed, and Pete Rose has since admitted to having illegally bet on his team as manager of the Cincinnati Reds; the illegality of his actions are undeniable and his punishment was deserved; and

WHEREAS, The game that Americans love and enjoy needs to be respected and cannot be subject to misconduct by any player, manager, or owner; every team should have the same access to the opportunity of winning, and all games should be played on the level; and

WHEREAS, Consideration for the National Baseball Hall of Fame has been granted to players that have been linked to the abuse of banned substances; this decision, while controversial and the subject of much debate among current and former baseball players and sports writers, has been decided to be fair treatment given to otherwise guilty players that committed a wrong against the institution of baseball; and

WHEREAS, Players such as Barry Bonds, Roger Clemens, Mark McGwire, and Sammy Sosa have been granted enough of a reprieve that they have had, at the very least, an opportunity to be considered for induction into baseball's most sacred fraternity; they have been signaled and reprimanded for their past actions; yet, they have been allowed to have their "day in court"; Pete Rose's career and legacy should earn him the same leniency and treatment; and

WHEREAS, Speaking before a crowd of devoted fans and onlookers in Normal, where he was invited to act as "Manager for a Day" for the Normal CornBelters of the independent Illinois Frontier League, Pete Rose sincerely stated, "There comes a time when you see all your friends go in the Hall of Fame. To think that you could be a member of the Hall of Fame, it would be goosebumpy. A Hall of Fame is more for your fans and your family. And a lot of the people responsible for me being a baseball player aren't here [any] more."; He added, "I got 6 grandkids that would love to go to Cooperstown. I got 2 daughters and 2 sons who would love to go to Cooperstown ... It would mean a lot to them. It would mean a lot to anybody"; and

WHEREAS, Although Pete Rose committed an injustice against his fans, players, and Major League Baseball, the punishment should be reconsidered; he is a legendary sports figure who commands the respect of even the harshest of his critics; and

WHEREAS, With the permission of Major League Baseball, Pete Rose was recognized by the Cincinnati Reds organization on September 11, 2010 for the 25th anniversary of his 4,192nd hit, which put him past the previous hits-leader, Ty Cobb, and, most recently, during the 2015 All-Star Game in Cincinnati, Ohio on July 14, 2015; and

WHEREAS, No greater recognition can be offered to Pete Rose than allowing his name to be considered by the voting members of the Baseball Writers' Association of America for induction into the National Baseball Hall of Fame after his 26th year of a lifetime ban from the sport that was, and continues to be, his livelihood; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Major League Baseball Commissioner, Rob Manfred, to reconsider the case of Pete Rose and work towards reinstating him as a testament to his legendary achievements and contribution to the game of baseball; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Pete Rose; MLB Commissioner, Rob Manfred; Chicago Cubs owner, Thomas Ricketts; Chicago White Sox Chairman, Jerry Reinsdorf; Cincinnati Reds Chief Executive Officer, Robert "Bob" Castellini; and the National Baseball Hall of Fame in Cooperstown, New York.

HOUSE RESOLUTION 668

Offered by Representative Turner:

WHEREAS, In 2011, the Illinois General Assembly passed legislation increasing protections for consumers who decide to take out payday loans; and

WHEREAS, The Illinois General Assembly continues to support legislation to make it more difficult for predatory lenders to take advantage of persons and families across the State; and

WHEREAS, In 2005, the State Universities Retirement System invested in JLL Partners Fund V, LLC; and

WHEREAS, In 2006, JLL Partners Fund V, LLC purchased ACE Cash Express, Inc., a payday loan company, which was found to be using illegal debt collection practices, including harassment and threats of lawsuits against overdue borrowers to pressure them to borrow more; and

WHEREAS, The federal Consumer Financial Protection Bureau reached an agreement with ACE Cash Express, Inc. to pay \$10 million in civil penalties and financial restitution to its customers; and

WHEREAS, It is important for Illinois pension funds to be invested in a way that reflects the priorities of the State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the State Universities Retirement System review its

investments in JLL Partners Fund V, LLC and any other entity that supports small-dollar lenders, payday loans, and predatory lenders; and be it further

RESOLVED, That other Illinois pension systems, including, the State Employees' Retirement System, the Judges' Retirement System, the General Assembly Retirement System, and the Teachers' Retirement System review their investments in any entity that supports small-dollar lenders, payday loans, and predatory lenders; and be it further

RESOLVED, That on or before January 1, 2016, the State Universities Retirement System, State Employees' Retirement System, the Judges' Retirement System, the General Assembly Retirement System, and the Teachers' Retirement System shall each submit a report, which shall be made publicly available on the website of each retirement system, to the General Assembly and the Governor of its findings regarding any investment currently held by that retirement system in any entity that supports small-dollar lenders, payday loans, and predatory lenders, including any investment held in JLL Partners Fund V, LLC; and be it further

RESOLVED, That we urge the State Universities Retirement System to divest from JLL Partners Fund V, LLC and any entity that supports small-dollar lenders, payday loans, and predatory lenders; and be it further

RESOLVED, That we urge the State Employees' Retirement System, the Judges' Retirement System, the General Assembly Retirement System, and the Teachers' Retirement System to divest from any entity that supports small-dollar lenders, payday loans, and predatory lenders; and be it further

RESOLVED, That we urge the State Universities Retirement System, the State Employees' Retirement System, the Judges' Retirement System, the General Assembly Retirement System, and the Teachers' Retirement System to develop policies and procedures to prevent investments from being made in small-dollar lenders, payday loan lenders, and predatory lenders in the future; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the State Universities Retirement System, the State Employees' Retirement System, the Judges' Retirement System, the General Assembly Retirement System, and the Teachers' Retirement System.

HOUSE RESOLUTION 670

Offered by Representative Ford:

WHEREAS, The Boy Scouts of America Pathway to Adventure Council supplies unit leaders with the knowledge and tools they need to deliver the best possible Scouting program to youth and young adults in the community to prepare them for life; building strong units creates strong districts, a strong council, and a bright future; and

WHEREAS, The Pathway to Adventure Council spans 2 states, serves more than 26,000 youth members, and includes 9,000 volunteers, 7 camp properties, and 4 Service Centers; while Pathway to Adventure Council is new in name, it is rooted in over 100 years of distinguished history, talent, and culture; and

WHEREAS, The members of the Illinois House of Representatives were saddened to learn of the death of our esteemed colleague Henry Woods Bowman of Evanston, also known as H. Woods Bowman, and even more commonly known as Woody; and

WHEREAS, Woody was killed on July 10, 2015 in a tragic automobile accident in Michigan; and

WHEREAS, Woody grew up in Charleston, West Virginia, and came to Chicago to serve as a research economist for the Federal Reserve Bank of Chicago; he then became an assistant professor of economics at the University of Illinois at Chicago; and

WHEREAS, With a strong desire to help solve challenges facing the State and its people, Woody won election to the Illinois General Assembly in 1976; he represented the 18th Representative District, serving Evanston and its environs, from 1977 to 1990; and

WHEREAS, Between 1983 and 1990, Woody chaired the House Appropriations II Committee; as an expert budget negotiator, he brought transparency, accountability, and reform to the budget process; and

WHEREAS, During his tenure in the Legislature, Woody was a strong advocate for human services and education, he fought for civil rights and civil liberties; he pressed for more State support for the most vulnerable Illinois residents and the mentally ill; he earned the respect of his colleagues on both sides of the aisle for his steady commitment to his convictions, his compassion for others, and his integrity; and

WHEREAS, Following his service in the Illinois House of Representatives, Woody served as the chief financial officer of Cook County; he then returned to teaching as a member of the faculty of DePaul University's School of Public Service until his recent retirement; and

WHEREAS, Before, during, and after his service in elective office, Woody was a highly respected political observer and adviser, devoting himself to supporting like-minded candidates and counseling elected officials throughout his life; and

WHEREAS, Woody was interested in economics, finance, and ethics; he received bachelor's degrees in physics and economics from the Massachusetts Institute of Technology and a master's degree in public administration and a doctorate in economics from Syracuse University; and

WHEREAS, Woody's book, "Finance Fundamentals for Nonprofits: Building Capacity and Sustainability", received the 2013 Hodgkinson Research Prize from the Association for Research on Nonprofit Organizations and Voluntary Action (ARNOVA); he also authored, co-authored, and refereed numerous peer-reviewed articles, including "Issues in Nonprofit Finance Research: Surplus, Endowment, and Endowment Portfolios"; and

WHEREAS, Woody was married to his wife, Michele Thompson, for nearly 30 years; the couple met after Michele testified at a legislative hearing on behalf of the University of Illinois, where she served as Assistant Vice Chancellor for academic affairs and later as Secretary to the University of Illinois Board of Trustees; in their retirement, Woody and Michele enjoyed music, theater, art, foreign languages, and travel; and

WHEREAS, H. Woods Bowman will long be remembered for his generosity, his political independence, his willingness to help others, and his work to improve lives; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we mourn the passing of H.
