MOTION

I move to concur with Senate Amendment No. 1 to HOUSE BILL 745.

CHANGE OF SPONSORSHIP

With the consent of the affected members, Representative Madigan was removed as principal sponsor, and Representative Greg Harris became the new principal sponsor of HOUSE BILL 972.

With the consent of the affected members, Representative Madigan was removed as principal sponsor, and Representative Bradley became the new principal sponsor of HOUSE BILL 683.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 689

Offered by Representative Morrison:

WHEREAS, Recent multiple news articles have reported on the harvesting and sale of body parts from aborted babies by Planned Parenthood; and

WHEREAS, Trafficking in human body parts is a federal crime; and

WHEREAS, Trafficking in human body parts is a form of human trafficking; and

WHEREAS, Illinois has provided State taxpayer dollars and has acted as a conduit for federal taxpayer dollars for Planned Parenthood agencies in Illinois for many years, including most recently \$2.54 million in Fiscal Year 2013, \$2.28 million in Fiscal Year 2014, and \$2.28 million in Fiscal Year 2015; and

WHEREAS, Illinois taxpayers, through their State government, are indirectly involved and are cooperating with Planned Parenthood in these particular immoral and potentially criminal acts; and

WHEREAS, State tax dollars enable Planned Parenthood to divert an equal amount of financial resources from other sources to fund their operations; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Governor Bruce Rauner and the members of this body to end any and all State funding of Planned Parenthood immediately; and be it further

RESOLVED, That we urge the proper State agencies, including, but not limited to the Illinois Department of Public Health and the Illinois State Police, to conduct a thorough investigation to determine if any Illinois taxpayer dollars are directly involved in the harvesting and selling of baby body parts by Planned Parenthood and associated agencies in Illinois; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor, the Directors of the Illinois Department of Public Health and the Illinois State Police, and the members of the Illinois congressional delegation.

HOUSE RESOLUTION 690

Offered by Representative Ford:

WHEREAS, The Governor and the members of the General Assembly seek to reduce the number of prisoners incarcerated in penal facilities of the Illinois Department of Corrections; and

WHEREAS, A significant reduction in the prison population cannot be achieved without a significant reduction in the recidivism rate; and

WHEREAS, The General Assembly has begun to revisit and review some of the outdated policies that trap people with criminal convictions at the margins of society and drive many of them back to jail by denying them jobs, housing, and education; and

WHEREAS, The United States Department of Education recently announced a Second Chance Pell Pilot Program to test new models to allow incarcerated Americans to receive Pell Grants and pursue post-

secondary education with the goal of helping them turn their lives around and ultimately get jobs, support their families, and stay out of trouble; and

WHEREAS, Through this pilot program, incarcerated individuals who otherwise meet Title IV eligibility requirements and are eligible for release, particularly within the next 5 years, could access Pell Grants to pursue post-secondary education and training; and

WHEREAS, The Pell Grants acquired through this pilot program can only be used to pay for tuition, fees, books, and supplies required by an individual's education program; and

WHEREAS, A 2013 Department of Justice-funded study from the RAND Corporation found that incarcerated individuals who participated in correctional education were 43% less likely to return to prison within 3 years than prisoners who didn't participate in correctional education programs; the researchers involved in the RAND study estimated that, for every dollar invested in correctional education programs, four to five dollars are saved on 3-year re-incarceration costs; and

WHEREAS, The deadline for post-secondary institutions to apply for this pilot program for the 2016-2017 academic year is September 31, 2015; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Department of Corrections to collaborate with one or more institutions of higher learning in the submission of an application for the Second Chance Pell Pilot Program; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Director of the Illinois Department of Corrections.

HOUSE RESOLUTION 691

Offered by Representative Gabel:

WHEREAS, The meningitis B vaccine has been newly approved by the Centers for Disease Control and Prevention's Advisory Committee on Immunization Practices; and

WHEREAS, Incoming college freshman students are most likely to be infected with meningitis due to the close living quarters and social nature of college students; college athletes are frequently together and commonly share items that can serve as a mechanism to transmit disease, promoting a high possibility of becoming infected with this disease; and

WHEREAS, There has recently been an outbreak of meningitis at the University of Oregon, infecting 6 individuals and resulting in one death; and

WHEREAS, In recent months and years, there have been multiple college students who have been infected with meningitis at different universities across several states, including San Diego State University, Drexel University, Princeton University, and Providence College, with some resulting in death and lifelong medical conditions not limited to loss of mental function, brain and kidney damage, loss of hearing, and amputation of limbs; and

WHEREAS, There are 5 strains of meningitis, with serogroup B being the most deadly and just recently becoming vaccine preventable; and

WHEREAS, Meningitis B resembles the flu but escalates much more quickly; one in ten cases of those infected with meningitis B has resulted in death; and

WHEREAS, Health insurers commonly only cover immunizations that are recommended by the Advisory Committee on Immunization Practices; public schools and universities cannot require that which is not recommended; and

WHEREAS, The Advisory Committee on Immunization Practices met in February of 2014, but did not make any changes relating to meningitis due to a shortened meeting; the sub-group then deferred the topic of meningitis B recommendations until June of 2015; and

WHEREAS, After the severe outbreak of meningitis, government leaders sent out a public safety announcement strongly urging parents to immunize their children; and

WHEREAS, Physicians do not keep in stock that which is not in demand, making access to the life-saving vaccine difficult for parents who desire to vaccinate their children; and

WHEREAS, A recommendation of this vaccine by the Advisory Committee on Immunization Practices would result in immunity for a majority of college students, allowing incoming students to develop immunity and protect their great, young minds and their futures from this known killer; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Centers for Disease Control and Prevention's Advisory Committee on Immunization Practices to recommend that incoming college students receive the meningitis B vaccine; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Centers for Disease Control and Prevention's Advisory Committee on Immunization Practices.

HOUSE RESOLUTION 694

Offered by Representative Ford:

WHEREAS, In 2008, 6 million Americans did not vote because they missed a registration deadline or did not know how to register; and

WHEREAS, August 6 was the 50th anniversary of the Voting Rights Act of 1965 becoming law; and

WHEREAS, On September 22, 2015, volunteers, celebrities, and organizations from all over the country will partake in National Voter Registration Day activities, including various coordinated field, technology, and media efforts in order to create pervasive awareness of voter registration opportunities and enabling them to reach tens of thousands of voters who would not otherwise register to vote; and

WHEREAS, Many initiatives are being used to encourage people to partake in the democratic process, including the registration of voters, the mobilization of thousands of volunteers, the education of eligible voters, and a celebration of the rights that unite us as Americans; and

WHEREAS, The members of this body are proud to join in the concerted effort to ensure that all Americans become involved in the electoral process and make their voices count; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate September 22, 2015 as Voter Registration Day in the State of Illinois.

HOUSE JOINT RESOLUTION 92

Offered by Representative DeLuca:

WHEREAS, The members of the Illinois General Assembly are saddened to learn of the death of Thomas Cellini, who passed away on June 9, 2015; and

WHEREAS, Thomas Cellini was born on May 30, 1939 in Chicago Heights; his parents were Paul and Maria Cellini; and

WHEREAS, At the age of 16, Thomas Cellini started showing interest in auto repair, which led him to start a business in 1956; the business was made into a corporation in 1960; he was also the proprietor for Broadway Auto in South Chicago Heights from 1970 to 2013 and served his community for many years; and

WHEREAS, In 1986, Thomas Cellini started showing signs of Huntington's disease, a degenerative brain disorder that causes spontaneous body movements and eventually diminishes one's ability to walk, talk, think, and reason; in 2005, he and his wife started The Thomas Cellini Huntington's Foundation to help those with Huntington's disease and their families; and

WHEREAS, Thomas Cellini was the loving husband of Barbara Embry, whom he married on June 23, 1959; the father of 5 children; the grandfather of 13; the great-grandfather of 2; and the brother of Paul Cellini, late baby Betty Jean, and baby Tommy Cellini; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the portion of East End Avenue between the intersections of 26th Street and East End Avenue and Sauk Trail and East End Avenue in South Chicago Heights as Honorary Thomas Cellini Way; and be it further

MESSAGES FROM THE GOVERNOR

August 7, 2015

To the Honorable Members of
The Illinois House of Representatives,
99th General Assembly:

Today I veto House Bill 227 from the 99th General Assembly.

Current law requires a person using a non-powered watercraft to obtain a water usage stamp from the Department of Natural Resources, which is available for \$6 per year. This bill would exempt "a non-resident operating a non-powered watercraft while engaged in a paddling event or race."

Tourism is an important economic driver for Illinois, and I appreciate non-residents who come to Illinois to enjoy sporting events. The Department of Natural Resources has committed to working with event organizers to ensure that the organizers are able to sell stamps to participants on the day of the race.

While we work to make compliance more convenient and efficient, I do not support exempting one particular group of non-residents, particularly when Illinois residents are not being exempted.

Therefore, pursuant to Section 9(b) of Article IV of the Illinois Constitution of 1970, I hereby return House Bill 227, entitled "AN ACT concerning transportation", with the foregoing objections, vetoed in its entirety.

To the Honorable Members of
The Illinois House of Representatives,
99th General Assembly:

Today I return House Bill 439 with specific recommendations for change.

Under current law, contract carriers transporting employees in the course of their employment are required to maintain uninsured and underinsured motor vehicle coverages of not less than \$250,000 per passenger. This legislation would first increase the minimum coverage required to \$500,000 per passenger by 2016, and then further increase the minimum coverage required to \$750,000 per passenger by 2020.

Insurance coverages required under current Illinois law are already higher than coverages required by many other Midwestern states. Although it is important to ensure adequate coverage, we must be careful about the impact on the cost of doing business in Illinois.

Given that the legislation initially *doubles* the minimum insurance coverages, the further increase by 2020 is premature. Before pre-determining the requirement applicable more than four years from now, we should wait to examine the adequacy of then-existing insurance coverage requirements, whether there is a need for a further increase and to what amount, and how our requirements compare to other states at that time.

Therefore, pursuant to Section 9(e) of Article IV of the Illinois Constitution of 1970, I hereby return House Bill 439, entitled "AN ACT concerning transportation", with the following specific recommendations for change:

On page 2, line 16, by replacing ". and not" with "."; and

On page 2, by deleting line 17.

With these changes, House Bill 439 will have my approval. I respectfully request your concurrence.
