Offered by Representative Ford:

WHEREAS, The members of the Illinois House of Representatives recognize that there are distressed counties and communities throughout Illinois that struggle with many economic and social problems including crime, unemployment, poverty, mortgage foreclosures, declining property values, deficiencies in public health services, and deficits in public education; and

WHEREAS, In recent years these economic and social problems have become more prevalent and they have exacerbated existing conditions which include: inequalities in access to justice in the civil court system, an overburdened and ineffective criminal justice system, overcrowded correctional facilities, increased homelessness, inadequate educational opportunities, insufficient affordable housing, inadequate delivery of social services to the less fortunate, and deficiencies in the availability and quality of public health services; and

WHEREAS, Some counties and communities disproportionately experience these serious social and economic ills; for example, Illinois counties which had 16% or more of their population in poverty in 2010 included: Alexander, Champaign, Coles, Cook, Franklin, Gallatin, Hardin, Jackson, Lawrence, McDonough, Macon, Marion, Massac, Perry, Pike, Pope, Pulaski, Saline, Union, Vermilion, White, Williamson, and Winnebago; and municipalities with a population of over 100,000 which had family poverty rates of 10% or more are: Aurora, Chicago, Joliet, Naperville, Peoria, Rockford, and Springfield; and

WHEREAS, It is important to take a comprehensive approach to the ongoing crisis of distressed counties and communities in Illinois and a significant poverty rate is among the best indicators that a community is in distress; and

WHEREAS, Care must be taken when addressing poverty and its associated problems in counties with distressed communities because an emphasis on serving the largest number of people in poverty will miss other areas of the State with significant poverty problems and an emphasis on areas with the highest rates of poverty will ignore large populations in need, as shown by these facts:

(1) Cook County has the highest number of persons living in poverty (which amounts to nearly 50% of the State's poverty population), but DuPage County (which has historically been considered to be a wealthy county with a small low-income population) has the second-highest number of persons in poverty;

(2) the 10 poorest counties in Illinois, as measured by poverty rate, are generally downstate with small total populations and while their poverty rates are very high (the highest county rate is 31.1%, with an average for all 10 of the poorest counties of 21.6%), these counties collectively account for less than 10% of the State's total poverty population;

(3) the 10 counties with the highest numbers of persons in poverty are, for the most part, near urban centers with 5 in the Chicago metropolitan area and these 10 counties include over 70% of the State's poverty population;

(4) a Statewide emphasis on the top 10 counties with high poverty rates will ignore the needs of 94% of the State's poverty population, but an emphasis on the 10 counties with the highest numbers of people in poverty will deemphasize the counties with the highest poverty rates; and

WHEREAS, The U.S. Census Bureau on September 12, 2012, announced that, in 2011:

(1) the median household income in the United States declined by 1.5% from the 2010 median, which was the second consecutive annual drop;

(2) the weighted average poverty threshold for a family of four in 2011 was \$23,021;

(3) the nation's official poverty rate was 15.0 percent, with 46.2 million people in poverty;

(4) and although the poverty rate and number of people remained statistically unchanged since 2010, this is the fourth year in a row with such significant amounts of poverty in this country; and

WHEREAS, The poverty rate in Illinois was 14.2% in 2011 and this amounts to a 42% increase in the poverty rate in Illinois from 2007 to 2011; and

WHEREAS, Living in an area with a high poverty rate may include threats to life itself; for example, a recent comparison of 2 sets of Chicago neighborhoods, the 5 poorest and the 5 least poor, showed that:

(1) the poorest neighborhoods had a homicide rate that is 11 times the homicide rate in the least poor neighborhoods;

(2) the mortality rate for the leading causes of death in Chicago (cancer, heart disease, diabetes-related illnesses, stroke, and unintentional injury) is 5 times higher in the 5 poorest neighborhoods than it is in the 5 least poor neighborhoods;

(3) the infant mortality rate is 2 1/2 times higher in the poorest neighborhoods than in the 5 least poor neighborhoods; and

(4) that the Years of Potential Life Lost (YPLL) due to homicide in the 5 poorest neighborhoods was 2,172 for every 100,000 residents (assuming a life expectancy of 75 years) compared to the YPLL homicide rate of only 186 in the 5 least poor neighborhoods (the concept of Years of Potential Life Lost is an estimate of the average years a person would have lived if he or she had not died prematurely); and

WHEREAS, So long as these social and economic problems are not successfully addressed in distressed counties and communities, the cost to tax payers in Illinois for the many programs operated or funded by the State will only increase; and

WHEREAS, State government resources are expended in ever-increasing amounts to address these social and economic problems and those expenditures are a significant drain on the State's road to financial stability; and

WHEREAS, There exist numerous ways for State government programs to be operated more efficiently and more economically; and

WHEREAS, State government, taxpayers, and those living in distressed counties and communities with a significant poverty problem could benefit from the creation of a State action plan that identifies: modifications that should be made to existing State programs so as to dramatically improve the delivery of services, reduce the cost of those services, and eliminate wasteful spending; how leadership programs and new educational opportunities could foster and equip new leaders; and ways in which State government could actively create a change environment that will have numerous positive impacts; and

WHEREAS, If more effective, efficient, and economical ways to deliver social, law enforcement, correctional, educational, and medical programs can be developed, then significant strides can be made in the overall welfare of the distressed counties and communities and those solutions could be replicated, with adjustments as appropriate, to all communities in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor to create a Distressed Counties and Communities Commission composed of stake holders in distressed counties and communities, representatives of appropriate State agencies, and community leaders to explore, discuss, and coordinate efforts to prepare an action plan to offer enhanced State governmental services in a meaningful way, to foster leadership, and to create programs that can succeed in addressing the myriad social and economic problems that exist; this, in turn, can benefit all Illinois communities; and be it further;

RESOLVED, That we urge that the Governor designate an executive department to provide administrative support for the Commission and appoint members of the Distressed Counties and Communities Commission by December 31, 2015, so as to allow the Distressed Counties and Communities Commission to hold its first meeting in January 2016, and be it further

RESOLVED, That the Distressed Counties and Communities Commission be charged with: finding and creating innovative means to address and meet the numerous needs of those who receive State social services; designing plans to assist and enhance the efforts of State agencies and local governments that provide law enforcement and social services; analyzing successful state and local governmental programs in other locales in the subject areas of law enforcement, court administration, corrections, job skill retraining, education, economic opportunity, job creation, social services, and public health; and developing an action plan that includes information about changes and improvements to existing programs, statutes, and regulations that can be made by reallocating existing resources and not increasing State taxes; and be it further;

RESOLVED, That we urge the Governor to call upon the Distressed Counties and Communities Commission to hold public hearings and issue a written report of its findings and recommendations to the Governor and to the General Assembly on or before April 15, 2016; and be it further
RESOLVED, That a suitable copy of this resolution be delivered to the Governor.

HOUSE RESOLUTION 724

Offered by Representative Guzzardi:

WHEREAS, Housing authorities and landlords can legally evict tenants if they do not pay their utilities, regardless of rent payment; and

WHEREAS, The Supplemental Low Income Home Energy Assistance Program (LIHEAP) is designed to help individuals survive extreme summer and winter temperatures - it prevents deaths and excessive emergency room hospitalizations and other public health costs often associated with heat-related illnesses; over 171,000 Illinois households rely on LIHEAP to provide them with adequate levels of heating and cooling; and

WHEREAS, Governor Rauner has issued a directive to suspend the expenditure of State funds under LIHEAP; this directive is dangerous and prohibited under Illinois law; the Governor's actions will not save the State any money and could, in fact, significantly increase preventable public health costs; and

WHEREAS, Without the aid of LIHEAP, many families and seniors will be unable to pay their utility bills and could be subject to eviction based on the legal protection for landlords; and

WHEREAS, Further confusing the situation, LIHEAP is federally funded and that funding may not be distributed by Illinois State agencies without a State budget in place; and

WHEREAS, Cuts to LIHEAP put Illinois citizens in danger during extreme weather conditions and evicting them during this time puts them in further danger; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge housing authorities and landlords statewide not to evict tenants based on an inability to pay utilities alone in light of the State budget impasse and cuts to the LIHEAP program; and be it further

RESOLVED, That suitable copies of this resolution be delivered to all housing authorities throughout the State.

Offered by Representative Gordon-Booth:

WHEREAS, Royce Elliott was born on March 29, 1936, in Stephenville, Texas; his parents were Earl and Loretta Elliott; he married Helen Milford on October 14, 1961; and

WHEREAS, Royce Elliott graduated from Woodruff High School, where he played baseball, basketball, and football and participated in choir; he later attended Western Illinois University, where he played football and baseball, and Bradley University; and

WHEREAS, Royce Elliott was best known as "America's funniest clean comedian"; he traveled all over North America performing as an emcee for sports, corporate, and charity events; he entertained at numerous venues, such as Bally's Las Vegas, the Grand Ole Opry, and Atlantic City; he also performed his routine at the Stadium Club in Peoria, Two Brother's Tap, and local baseball fields; and

WHEREAS, Royce Elliott made dozens of national television appearances on "The Ralph Emery Show", "Crook and Chase", "Nashville Now", and "The Statler Brothers Show"; he worked with many celebrities, including Frank Sinatra, Lou Rawls, Rich Little, Barbara Mandrell, Vince Gill, and Conway Twitty; he also worked sports banquets and fantasy camps with sports stars Lou Brock, Bob Gibson, Fergie Jenkins, Terry Bradshaw, Jack Buck, Harry Caray, and many others; and

WHEREAS, After semi-retiring, Royce Elliott worked locally as a co-host of "Breakfast With Royce and Roger", where he connected with his all-time favorite comedian, Jonathan Winters; he spent most Thursday mornings at the Sterling Family Restaurant with good friends from the ROMEO club; and

WHEREAS, Royce Elliott enjoyed sports and coaching and sponsoring local teams; he played for several years in the Peoria Sunday Morning League and played fast pitch softball for about 20 years; Elliott's Jesters

sponsored fast pitch teams, park district men's basketball teams, and youth track teams; he also coached in the Salvation Army Bidy Basketball league and West Peoria Little League; and

WHEREAS, The City of Peoria has designated the portion of Evans Street between Monroe Street and Perry Avenue in Peoria as "Royce Elliott Place" in honor of his work; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate March 26, 2016 as Royce Elliott Day in the State of Illinois in honor of Mr. Elliott and his legacy of entertainment; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the family of Royce Elliott as a symbol of our respect and esteem.

HOUSE RESOLUTION 740

Offered by Representative Gordon-Booth:

WHEREAS, Rev. Dr. Cordy Tindell Vivian was born in Booneville, Missouri on July 28, 1924; he and his family later moved to Macomb, where he graduated from high school in 1942; he enrolled in Western Illinois University before moving to Peoria; and

WHEREAS, C.T. Vivian participated in his first civil rights protest in 1947, successfully desegregating Peoria's lunch counters; he began preaching in Peoria before moving to Nashville, Tennessee in 1954 to study at the American Baptist Theological Seminary; during that time, he worked with many of the leaders of the civil rights movement and took part in leading 4,000 demonstrators in a march on Nashville's City Hall; and

WHEREAS, C.T. Vivian joined the Student Nonviolent Coordinating Committee (SNCC) in 1960, emerging as one the leaders of the Nashville sit-ins; he and other SNCC members traveled to Jackson, Mississippi to support the original Freedom Riders when they were met with violence; in 1961, he was appointed by Martin Luther King, Jr. as Director of Affiliates for the Southern Christian Leadership Council; in 1963, he helped lead the fight to desegregate Birmingham and, in 1965, he was an organizer of the voter registration drive in Selma, Alabama that became the catalyst for the 1965 Voting Rights Act; and

WHEREAS, C.T. Vivian returned to Illinois by 1966 and began helping to establish organizations to assist black children in their efforts to stay in school and attend college; he also worked with Jesse Jackson's Operation Breadbasket to push the city and labor unions to promote affirmative action in building trades; and

WHEREAS, After leaving Dr. King's executive staff, C.T. Vivian trained ministers and developed the urban curriculum for seminaries throughout the nation at the Urban Training Center in Chicago; he returned to the area of seminary education as the Dean of Divinity at Shaw University Divinity School, where he originated and acquired funding for an unprecedented national level program and the basis of his doctoral work, Seminary Without Walls; and

WHEREAS, C.T. Vivian has served on the boards of the Center for Democratic Renewal and the National Voting Rights Museum; he currently serves as Board Chair of BASIC Diversity, Inc., the nation's oldest diversity consulting firm; he has provided civil rights counsel to Presidents Johnson, Carter, Reagan, Clinton, and Obama and he continues to lecture on racial justice and democracy throughout the world; and

WHEREAS, In November of 2013, C.T. Vivian was awarded the Presidential Medal of Freedom - the highest civilian honor from the United States government; the New School for Social Research named Dr. C.T. Vivian a " ... spiritual leader, apostle of social justice, strategist of the civil rights movement ... For decades he has been in the vanguard of the struggle for racial equality in America", as they presented him with one of his many honorary doctorates; he was featured throughout PBS's acclaimed documentary "Eyes On The Prize"; PBS later produced a full-length presentation, "The Healing Ministry of the Rev. Dr. C.T. Vivian"; he is also featured as both an activist and analyst in the series "People's Century" and in the Tom Brokaw documentary "King"; and

WHEREAS, C.T. Vivian and his wife have lived in Atlanta, Georgia for over 3 decades; he continues to work on behalf of the needy, most recently with the victims of Hurricane Katrina; he has 7 children; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the life of Rev. Dr. Cordy Tindell Vivian and declare July 28, 2016 as "C.T. Vivian Day" in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to C.T. Vivian as an expression of our esteem and respect.

Perfunctory Session

WEDNESDAY, SEPTEMBER 2, 2015

At the hour of 7:06 o'clock p.m., the House reconvened perfunctory session.

INTRODUCTION AND FIRST READING OF BILLS

The following bills were introduced, read by title a first time, ordered reproduced and placed in the Committee on Rules:

HOUSE BILL 4278. Introduced by Representative Ford, AN ACT concerning criminal law.
