HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 745

Offered by Representative Meier:

WHEREAS, The Warren G. Murray Developmental Center in Centralia was built in 1964 to meet the needs of children faced with severe developmental disabilities; and

WHEREAS, There are currently 229 residents at Murray Center; over half of the residents have called Murray home for at least 20 years; and

WHEREAS, More than half of Murray Center residents have a dual diagnosis of a developmental disability and a mental illness; 45% of the Murray residents are non-ambulatory and many cannot express themselves verbally and understand very little of the world around them; medical issues are prevalent and complicate even further the labor intensive needs of these individuals, leaving some individuals completely dependent upon others for every need; and

WHEREAS, In 2012, it was announced that the Warren G. Murray Developmental Center would close its doors; thanks to the dedication and hard work from the Murray Parents Association, Friends of Murray Center, Illinois State Representative John Cavaletto, Illinois State Representative Charlie Meier, Illinois State Senator Kyle McCarter, Governor Bruce Rauner, and dozens of Illinois legislators, the Murray Center will remain open; and

WHEREAS, The Murray Center Coalition will be hosting a festival and parade on October 18, 2015 to celebrate Murray Center remaining open; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate October 18, 2015 as Murray Center Day in the State of Illinois to honor the residents living at the Warren G. Murray Developmental Center in Centralia; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Murray Center Coalition, the Murray Parents Association, and Governor Bruce Rauner in recognition of Murray Center Day.

HOUSE RESOLUTION 752

Offered by Representative Batinick:

WHEREAS, According to the Commission on Government Forecasting and Accountability (COGFA), based upon the actuarial value of assets, the total unfunded pension liabilities of the State retirement systems totaled \$111.2 billion on June 30, 2014; and

WHEREAS, COGFA has also indicated that between Fiscal Year 2001 and Fiscal Year 2014, the combined unfunded liabilities of the retirement systems increased by \$86.2 billion based upon the market value of assets; and

WHEREAS, The certified contribution to the 5 State-funded retirement systems has increased from \$1.33 billion in Fiscal Year 2001 to \$7.6 billion in Fiscal Year 2016; and

WHEREAS, The Illinois Supreme Court made a unanimous ruling on SB 1 (Public Act 98-599), which found that pension benefits are a contractual and constitutionally protected right that cannot be diminished or impaired; and

WHEREAS, Regardless of the Illinois Supreme Court ruling, the effects of increased pension payments and liabilities are still serious problems, which are currently crowding out spending on other essential State services, and represent problems that must be addressed in a constitutional way; and

WHEREAS, The Illinois Supreme Court's opinion laid a framework for the adjustment of benefits through a legal approach called "consideration", which allows for the adjustment of benefits if both parties agree to the changes; and

WHEREAS, The General Assembly has not thoroughly broached the possibility of a pension or partial pension exchange option for participants in State-funded retirement systems, which would consist of giving participants a lump sum payment for their annuity or a portion of their annuity, as a viable solution to addressing short and long-term savings; and

WHEREAS, Many of those nearing retirement may be attracted to having more control over their retirement assets, but unfortunately the State does not provide a versatile and competitive alternative to the current pension arrangement; and

WHEREAS, Providing a lump sum payment in exchange for all or a portion of an annuity would provide a voluntary, constitutional approach to addressing the State's pension obligations, while simultaneously providing participants the options and flexibility needed when planning for retirement; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Speaker of the House of Representatives and the Chairperson of the House Personnel and Pensions Committee to hold a series of hearings on how the State could potentially approach a lump sum exchange option; and be it further

RESOLVED, That the Committee invite interested parties and stakeholders to these hearings in hopes of better understanding the positive and negative outcomes of an exchange proposal as well as any potential barriers that would prevent an exchange option from becoming a common practice within our State-funded retirement systems.

HOUSE RESOLUTION 755

Offered by Representative Dunkin:

WHEREAS, Many people believe that if they are released after being mistakenly arrested and the charges are dropped or dismissed without any court date being set, they will not have an arrest record; and

WHEREAS, Even in the case of a mistaken arrest, the damaging documents are not automatically removed; and

WHEREAS, Hundreds of thousands of innocent Americans who are mistakenly arrested are still haunted by arrest records; and

WHEREAS, An arrest record can ruin an innocent individual's chance to get into college or secure employment, loans, and housing; and

WHEREAS, An arrest record is an ugly stain for law-abiding citizens who, in some cases, found themselves arrested for circumstances beyond their control; and

WHEREAS, When an individual answers questions about an arrest on a job application, he or she is treated as though he or she is guilty no matter what the outcome was; and

WHEREAS, The process to remove an arrest record can cost an average of \$5,000 and can take a significant amount of time; and

WHEREAS, The wrongful arrest rates of African Americans are the highest among all races; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we applaud the nationwide efforts of the #AutoErase Campaign to bring awareness to the fact that individuals wrongfully arrested may still have an arrest record even after they are released and to remove the burden from the individual of having that wrongful arrest record erased; and be it further

RESOLVED, That we call on all local, state, and federal agencies to automatically erase and destroy all information pertaining to arrest records of innocent individuals wrongfully arrested immediately after the

individual is no longer being detained by the arresting agency and to ensure the arrest record does not appear in any local, state, or federal agency's database; and be it further

RESOLVED, That we call on the United States Congress, states, and localities, under such circumstances indicated above, to ensure that an innocent individual's record appears as it did before the wrongful arrest occurred, at no expense and with no action required by the individual; and be it further

RESOLVED, That we support that, under such circumstances, the innocent individual can in the future be legally and factually allowed to deny the arrest under all circumstances and on any local, state, federal, corporate, or private form, including, but not limited to, applying for a state-issued professional license, applying for a law enforcement job, applying for a federal or national security clearance, applying for a school-related job, buying a firearm or applying for a concealed carry permit, running for public office, or applying as a candidate for a state bar; and be it further

RESOLVED, That a copy of this resolution be delivered to the President of the United States, the Vice-President of the United States, members of the United States House of Representatives and the United States Senate, and other federal and state government officials as appropriate.

HOUSE RESOLUTION 759

Offered by Representative Mussman:

WHEREAS, Retinoblastoma is a malignant cancer that develops in the retina during early childhood; most children diagnosed with the disease are younger than 3 years old; it is often found when a parent or doctor notices that a child's eye displays unusual signs or symptoms; and

WHEREAS, If the disease goes undetected, retinoblastoma requires the removal of the eye to keep the disease from spreading to the optic nerve and the brain; and

WHEREAS, Retinoblastoma is a rare disease, with only about 200 to 300 children diagnosed with the disease each year in the United States; and

WHEREAS, The members of this body believe that greater attention must be placed on raising awareness of retinoblastoma and other cancers in order to fight these debilitating diseases and the effects they have on the citizens of this State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of September as Childhood Cancer Awareness Month in the State of Illinois and urge the citizens of this State to ask their pediatricians to perform red-reflex tests on their children in order to aid in the fight against retinoblastoma and other childhood cancers; and be it further

RESOLVED, That a suitable copy of this resolution be presented to BeyondRB as a symbol of our respect and esteem for the organization's work.

HOUSE RESOLUTION 768

Offered by Representative Rita:

WHEREAS, The Illinois General Assembly has approved legal video gaming to help generate economic activity for local established businesses, to create jobs, to reduce illegal gaming activity, and to provide much-needed revenue to local communities and the State budget; and

WHEREAS, Video gaming has produced strong growth since its inception in September of 2012 in local economic activity, in jobs created and supported, and in tax revenue for local and State governments; and

WHEREAS, The General Assembly has worked closely with the Illinois Gaming Board, the State's regulatory body for gaming issues, to ensure careful scrutiny and oversight of approval and operations of the nearly 5,000 video gaming businesses and more than 20,000 video gaming machines in Illinois; and

WHEREAS, A proposed new form of video gaming business is generating concern around Illinois, both with policymakers in Springfield and within the video gaming industry; and

WHEREAS, News reports have detailed developers' interest in creating "casino malls" in Chicago suburbs where strip malls could be converted to have multiple storefronts with neighboring video gaming establishments packaged together; and

WHEREAS, While proponents argue these "casino malls" could generate more economic activity and revenue, there are legitimate concerns about these malls shifting video gaming away from its intended purpose of main street community entertainment for bars, restaurants, and other local businesses; and

WHEREAS, The Illinois General Assembly did not envision allowing these types of malls in legalizing video gaming originally and is not interested in seeing this type of activity authorized in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Gaming Board to issue a report to the General Assembly stating the reasons that the Board refuses to grant video gaming licenses to "casino malls"; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Chairman of the Illinois Gaming Board.

HOUSE RESOLUTION 776

Offered by Representative Chapa LaVia:

WHEREAS, September 15 through October 15 marks National Hispanic Heritage Month; and

WHEREAS, Our State's hospitals and surgery centers rely on a continual safe supply of 100% donated blood; and

WHEREAS, Although Latinos make up 17% of the general population nationwide, they make up less than 4% of blood donors; and

WHEREAS, The Latino population has a high percentage of type O blood, which is in high demand since it can be transfused to patients with other blood types; Latino blood also contains important antibodies, unique to the Latino population, making their donations especially vital to other Latinos in need of an exact antigen match for a transfusion; and

WHEREAS, A single unit of blood can save up to 3 lives, while a single trauma patient can use over 100 units of blood; and

WHEREAS, Blood only has a shelf life of 42 days; and

WHEREAS, Blood centers rely heavily not only on blood donated on their premises, but on blood drives organized throughout their communities by volunteers; and

WHEREAS, Blood can be donated every 56 days and can improve the health of the donor by reducing excess iron and encouraging the body to produce more blood; and

WHEREAS, The State of Illinois recognizes the importance of blood donation through the Blood Donation Act, the Employee Blood Donation Leave Act, and the Organ Donor Leave Act; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage the Latino community in the State to share its unique gift of life by donating blood; and be it further

RESOLVED, That we further encourage Latino businesses, churches, and other organizations to consider hosting a blood drive in their community and urge community colleges, colleges, universities, and trade schools to host blood drives and participate in the National Cesar E. Chavez Blood Drive Scholarship Challenge; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Coalition of Community Blood Centers.

HOUSE JOINT RESOLUTION 95

Offered by Representative Dunkin:

WHEREAS, During the month of September, teens and young adults are beginning a new school year; thousands of students are entering high schools, colleges, and universities throughout the State of Illinois; and

WHEREAS, In 2013 and 2014, the Illinois General Assembly supported legislation to strengthen laws to punish adults for furnishing alcoholic beverages to persons under the legal drinking age and for knowingly

making their property available to teens and young adults for the purpose of underage alcohol consumption; and

WHEREAS, Progress has been made in combating underage drinking in Illinois, but young people between the ages of 15 and 20 who continue to illegally consume alcohol are at a substantially heightened risk of death or serious injury from automobile accidents, falls, drowning, fights, and other hazards resulting from alcohol abuse; and

WHEREAS, Researchers at the University of Illinois at Chicago recently found that adolescent binge drinking may disrupt gene regulation and brain development in ways that promote anxiety and excessive drinking behaviors; other studies show that teens who start drinking before the age of 15 are up to 4 times more likely to meet the criteria for alcohol dependence at some point in their lives than those who delay drinking until age 21; and

WHEREAS, Over the last decade, the Federal Trade Commission has maintained a consumer awareness program known as "We Don't Serve Teens", highlighting the fact that the vast majority of teens obtain alcohol from parents, older siblings, friends, and other "social sources"; and

WHEREAS, The "We Don't Serve Teens" message has been publicized each fall for many years in the greater Chicago area by Constellation Brands Beer Division in cooperation with retailers throughout the region with billboards, signage, and broadcast messages; therefore, be it

WHEREAS, Representative Golar's passion for helping others and improving the quality of life in Chicago and throughout the State led to her involvement in dozens of community and service organizations, including Children's Home and Aid, the Back of the Yards Neighborhood Council, the Chicago Coalition for the Homeless, LUBAA Women's Shelter, the Canaryville Little League, Teamwork Englewood, the Englewood Black Chamber of Commerce, Faith in Place, Ada S. McKinley Community Services, The Arc

of Illinois, Faith Coalition for the Common Good, Illinois Action for Children, and the Anti-Violence Initiative at the University of Chicago School of Public Health; and

WHEREAS, Representative Golar worked for the Chicago Police Department on Chicago's South and West sides in the Troubled Buildings Unit and as a Community Policing Coordinator; a testament to her selflessness and loyalty, though she began her service with the Police Department on Chicago's South Side, after she was transferred to the West Side, she continued to help her coworkers on the South Side; and

WHEREAS, Representative Golar joined the Illinois House of Representatives in 2005; committed to constituent service, her constituents would often stop her at the grocery store, the pharmacy, and throughout the community asking for assistance; she did her best to deliver needed services, from street sweeping and street lighting to enforcing child support payments; she regularly attended events in the community, such as the Englewood Back to School Parade and the Resident Association of Greater Englewood's "So Fresh Saturdays" series; she visited and met with constituents, and worked to build bridges and strengthen relationships for the betterment of local neighborhoods; and

WHEREAS, Throughout her nearly 10 years in the House of Representatives, Representative Golar served as House Chairwoman of the Legislative Black Caucus, Chair of the Elementary and Secondary Education: School Curriculum and Policies Committee, Chair of the Public Policy and Accountability for Education Committee, and Chair and Vice-Chair of the Housing and Disability Services committees; her committee membership included service on the Elementary and Secondary Education, Child Support Enforcement, Health Care Availability and Accessibility, Human Services Appropriations, Elementary and Secondary Education Appropriations, and Judiciary-Criminal Law Committees; and

WHEREAS, Representative Golar's legislative achievements include the Senator Penny Sevens Memorial Award for her advocacy for persons with disabilities, the Back of the Yards Neighborhood Leadership Award, and the Safer Foundation's CARRE Visionary Award for her outstanding contributions to eliminate barriers to employment for people with criminal records; and

WHEREAS, Ignoring Donald Trump in hopes that he will just fade away is not an adequate response to his inexcusable behavior; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we call upon the Republican Party to publicly denounce Donald Trump for his disgraceful behavior and to distance itself from him in the future; and be it further
