HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE JOINT RESOLUTION 100

Offered by Representative Madigan:

WHEREAS, Section 3 of Article VIII of the Constitution of the State of Illinois provides that the General Assembly, by a vote of three-fifths of the members elected to each house, shall appoint an Auditor General; and

WHEREAS, The General Assembly has, by Section 2-3 of the Illinois State Auditing Act, charged the Legislative Audit Commission with the responsibility of diligently searching out qualified candidates for the office and making recommendations to the General Assembly, and, pursuant to this statutory mandate, the Legislative Audit Commission has conducted a diligent search and has recommended to the General Assembly the appointment of Frank J. Mautino of Spring Valley, Illinois, as Auditor General; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that pursuant to Section 3 of Article VIII of the Constitution and upon the recommendation of the Legislative Audit Commission, Frank J. Mautino of Spring Valley, Illinois, is appointed Auditor General for the State of Illinois for a term commencing on January 1, 2016.

HOUSE JOINT RESOLUTION 101

Offered by Representative Chapa LaVia:

WHEREAS, The State Board of Education has filed its Report on Waiver of School Code Mandates, dated October 1, 2015, with the Senate, the House of Representatives, and the Secretary of State of Illinois as required by Section 2-3.25g of the School Code; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the General Assembly is encouraged to promptly review and evaluate the Report and determine whether to disapprove, in whole or in part, the Report or any waiver request or appealed request outlined in the Report.
