CHANGE OF SPONSORSHIP

With the consent of the affected members, Representative Nekritz was removed as principal sponsor, and Representative Rita became the new principal sponsor of SENATE BILL 1369.

With the consent of the affected members, Representative Lang was removed as principal sponsor, and Representative Turner became the new principal sponsor of SENATE BILL 155.

With the consent of the affected members, Representative Welch was removed as principal sponsor, and Representative Rita became the new principal sponsor of SENATE BILL 1596.

With the consent of the affected members, Representative Martwick was removed as principal sponsor, and Representative Hoffman became the new principal sponsor of SENATE BILL 377.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 787

Offered by Representative Phelps:

WHEREAS, The State of Illinois has a rich and storied tradition of hunting and angling that dates back further than the State itself and carries forward to this day; and

WHEREAS, Illinois' sportsmen and women were among the first conservationists to support the establishment of the Illinois Department of Natural Resources to conserve fish, wildlife, and their habitat, and, through their license fees, helped fund State efforts to provide for healthy and sustainable natural resources; and

WHEREAS, Upon realizing that license fees alone were insufficient to restore and sustain healthy fish and wildlife populations, sportsmen and women supported self-imposed excise taxes on hunting, fishing, and boating equipment to raise additional conservation funds; and

WHEREAS, To this day, the Illinois Department of Natural Resources is funded primarily by sportsmen and women through the American System of Conservation Funding - a "user pays - public benefits" approach that is widely recognized as the most successful model of fish and wildlife management in the world; and

WHEREAS, In 2013 alone, Illinois's sportsmen and women generated \$63,419,348 through this System to support the conservation efforts of the Illinois Department of Natural Resources; and

WHEREAS, Illinois' 1,309,000 hunters and anglers support the State's economy through spending more than \$2.34 billion while engaged in their pursuits; this spending supports over 31,597 jobs in Illinois and generates \$277 million in State and local taxes; and

WHEREAS, National Hunting and Fishing Day was established in 1972 to celebrate and recognize hunters and anglers for their immense contributions to fish and wildlife conservation and to our society; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate September 26, 2015 as National Hunting and Fishing Day in Illinois, a day to be set aside in celebration of Illinois's sportsmen and women; and be it further

RESOLVED, That we recognize the many and varied social, cultural, economic, and ecological benefits of our time-honored traditions of hunting and angling.

HOUSE RESOLUTION 788

Offered by Representative Sims:

WHEREAS, The London Towne Houses Cooperative recently renamed Community Building #2 at 901 East 100th Place as the "Ida Curtis Fisher Community Building"; and

WHEREAS, Ida Fisher passed away on February 11, 2013; and

WHEREAS, Ida Fisher was an African-American woman, born in Cincinnati, Ohio in 1931; she grew up in a time when society repressed both women and African-Americans; she strongly valued education and work, becoming the first woman to pass the Cincinnati police officer exam; and

WHEREAS, Ida Fisher worked as a secretary for the Foundation for Cooperative Housing; she eventually began managing the Kansas City, Missouri location and, due to her accomplishments there, was soon asked to travel the country to duplicate her success; she created thousands of cooperative housing units, eventually landing in Chicago, where she broke ground for the 800-unit London Towne Houses Cooperative; and

WHEREAS, Ida Fisher worked as a Vice-President of the First Pennsylvania Bank, where she opened and managed its subsidiary in Chicago, Midwest Mortgage Company, and became the bank's top money maker in the country; she was inspired to open her own company, ICF Development; she was also the director of

the National Cooperative Bank, the Independence Bank of Chicago, Indecorp (Independence and the Drexel National Bank), the National Association of Housing Cooperatives, the Midwest Association of Housing Cooperatives, Chicago's Museum of Contemporary Art, and the Joseph Holmes Dance Group; and

WHEREAS, Ida Fisher was the recipient of the Chicago Rising Women in Business award, the Most Success Business Women in Chicago award, and the coveted Jerry Voorhis Award from the National Association of Housing Cooperatives; and

WHEREAS, Ida Fisher was the wife of Herbert Fisher and the mother of 2 daughters; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the extraordinary life of Ida Curtis Fisher and support the London Towne Houses Cooperative's decision to name a building in her honor; and be it further

RESOLVED, That suitable copies of this resolution be presented to the London Towne Houses Cooperative and the family of Ida Fisher.

HOUSE RESOLUTION 796

Offered by Representative Batinick:

WHEREAS, The people of Illinois - who pay for a General Assembly to plan for the long-term affairs of the State - deserve to have a budget planning document in place that considers medium-term and long-term spending pressures in the setting of State spending priorities; and

WHEREAS, No budget has been enacted for fiscal year 2016, the fiscal year that began on July 1, 2015; as a result, soon the State of Illinois will have operated under 4 different budgets in the span of 2 years - the fiscal 2015 budget signed by former Governor Quinn, the revised fiscal year 2015 budget containing necessary "fixes" to the original, flawed FY15 budget, the fiscal year 2016 non-budgeted State spending cycle being carried out right now under a series of State and federal court orders, and an enacted budget that will cover the remainder of FY16; and

WHEREAS, Under the fiscal year 2016 non-budgeted State spending cycle, State spending is continuing without legislative participation, putting Illinois on the financial brink and setting our State on a path to utter financial ruin and economic devastation for our taxpayers; and

WHEREAS, Political pressures associated with the 2016 election cycle will only increase with time, further tainting the budget process with politics and raising the possibility that, in the absence of corrective action, a repetition of this dismal pattern will occur as the spring 2016 deadline nears to craft and enact a budget for fiscal year 2017; and

WHEREAS, The General Assembly needs to re-establish a budget cycle and re-establish the credibility it needs in order to shift its attention to pension reform, property tax relief, crime and violence, the jobs climate, the outmigration from Illinois of younger and highly-educated workers and professionals, and other urgent issues; and

WHEREAS, Many states such as Nebraska, Ohio, and Texas, and including the neighboring state of Indiana, practice 2-year spending plans or full-scale biennial budgeting; and

WHEREAS, The Constitution of Illinois directs the Governor of Illinois to present an annual budget proposal to the General Assembly, but, as we have come to know all too well, nothing constrains the General Assembly's actual responses to these proposals, and nothing prevents the General Assembly from adopting a planning process that faces the fact that we, as a State, are on the financial brink, and responds to it in a professional manner and in keeping with our identity as legislators and our oaths of office; and

WHEREAS, In these times, moving toward a long-term budget planning cycle will enable State agencies performing essential services, third-party service providers whose services are no less essential, and institutions and entities of higher education to obtain the information that their leaders have testified is essential to carrying out their duties; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare that it is expedient for the General Assembly to adopt a 2-year budget planning document to cover revenues in all of fiscal years 2016 and 2017, take account of moneys already spent, and control spending in the remainder of fiscal year 2016 and all of fiscal year 2017; and be it further

RESOLVED, That this planning document should rely upon an honest estimate, without false promises or shoddy planning, of the actual financial income (especially general funds income) that the State will take in during fiscal years 2016 and 2017; and be it further

RESOLVED, That we urge the Commission on Government Forecasting and Accountability and the Governor's Office of Management and Budget to work together to develop an extraordinary consolidated revenue estimate for fiscal years 2016 and 2017, this estimate to be presented to both chambers of the General Assembly no later than 30 days after the adoption of this resolution; and be it further

RESOLVED, That we, the sponsors of this resolution, pledge to use this consolidated 2-year revenue estimate to work with our colleagues to develop a 2-year State budget and financial planning document; and be it further

RESOLVED, That our goal, as we develop this budget planning document, will be to end the current political cycle of reactive emergency measures and budget court orders; and be it further

RESOLVED, That suitable copies of this resolution be presented to Michael J. Madigan, Speaker of the House of Representatives, John Cullerton, President of the Senate, and Bruce Rauner, Governor.

HOUSE RESOLUTION 797

Offered by Representative Gabel:

WHEREAS, Meningococcal disease is any infection caused by the bacterium *Neisseria meningitidis*, or meningococcus; although 1 in 10 people are carriers for this bacteria with no signs or symptoms of disease, sometimes *Neisseria meningitidis* bacteria can cause illness; and

WHEREAS, Meningococcal disease is spread from person to person via the exchange of the bacteria through respiratory and throat secretion during close or lengthy contact; and

WHEREAS, There are approximately 1,000 to 1,200 cases of meningococcal disease that occur in the United States each year; 10-15% of infected individuals will die, while 11-19% of those who live will suffer from serious morbidity, including loss of limbs and impacts to the nervous system; and

WHEREAS, Infants under one year of age and young adults between the ages of 16 and 21 are most commonly impacted by this disease; and

WHEREAS, There are different strains or serogroups of *Neisseria meningitidis*, with serogroups B, C, and Y accounting for most meningococcal diseases in the United States; and

WHEREAS, There have been several recent outbreaks of serogroup B meningococcal disease on college campuses, with some cases resulting in death; and

WHEREAS, Vaccines are available to prevent meningococcal disease; different vaccines provide coverage against certain specific serogroups of the disease; and

WHEREAS, While there are vaccines that help provide protection against all 3 serogroups (B, C, and Y) commonly seen in the United States, only vaccination for serogroups A, C, W, and Y is routinely recommended by the Centers for Disease Control and Prevention; and

WHEREAS, The Centers for Disease Control and Prevention's Advisory Committee on Immunization Practices recommends that decisions to vaccinate adolescents and young adults 16 through 23 years of age against serogroup B meningococcal disease should be made at the individual level with health care providers; and

WHEREAS, It is critical that students, parents, educators, and health care providers understand the dangers of meningitis B and are aware that a vaccine is available to prevent disease resulting from this serogroup; and

WHEREAS, The recent incidences of meningococcal disease has served as a reminder of the critical role vaccinations play in helping to prevent this devastating illness; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge all private and public high schools, colleges, and universities in the State of Illinois to provide information to all students and parents about meningococcal disease, explaining the different disease serogroups, symptoms, risks, and treatments; and be it further

RESOLVED, That such information should also include a notice of availability, benefits, risks, and limitations of all meningococcal vaccines receiving a recommendation from the Advisory Committee on Immunization Practices, including Category A and Category B recommendations, with specific information as to those persons at higher risk for the disease; and be it further

RESOLVED, That we urge each private and public high school, college, and university in the State to recommend that current and entering students receive meningococcal vaccines in accordance with current Advisory Committee on Immunization Practices guidelines; and be it further

RESOLVED, That suitable copies of this resolution be made available to all private and public high schools, colleges, and universities in the State.

HOUSE RESOLUTION 799

Offered by Representative McDermed:

WHEREAS, An estimated 15 million Americans are current or former military brats, including those who spent all or part of their childhood or adolescence in the lifestyle; and

WHEREAS, The number of military brats has grown over the past 250 years alongside the United States Armed Forces; these adolescents have a unique American cultural experience through their travels around the country and world; and

WHEREAS, Military brats live a very mobile upbringing, moving with their parents when they are deployed or transferred to new military bases; and

WHEREAS, Military brats are often asked by others where they are from and provide an array of responses, with many saying everywhere or nowhere because of the many places they have lived and traveled; and

WHEREAS, Military brats are very adaptive to their new surroundings, are outgoing in nature, are able to adapt to new changes, and are constantly making new friends everywhere they move; and

WHEREAS, Military brats are typically very worldly in their knowledge of foreign cultures and customs based on their many moves and by living in other nations, providing a unique experience that is not typically experienced by the general public; and

WHEREAS, Military brats are known for being disciplined and outstanding students, with approximately 60% of brats holding higher education degrees and 30% holding advanced degrees; and

WHEREAS, Many of the military brats grow up to find great careers in public service, becoming police officers, firefighters, teachers, doctors, and nurses; many of them end up finding the same call their parents did by serving in the United States Armed Forces; and

WHEREAS, Unlike most of their military parents, military brats did not volunteer for this assignment, but most take it on proudly and execute it with distinction; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate April 30, 2016 as Military Brat Day in Illinois to appreciate the sacrifice and service of these patriots by giving them our thanks and respect.

HOUSE RESOLUTION 805

Offered by Representative Madigan:

WHEREAS, There is a critical need in the United States to instill in the minds of students the possibilities unleashed by education and innovation in the fields of Science, Technology, Engineering, and Mathematics (STEM) by providing students, their teachers, and their parents with deep exposure to and a sustainable experience with companies and organizations that provide career paths in these specialized fields; and

WHEREAS, PepsiCo is partnering with STEMconnector and other companies and organizations across the United States, including NASA and Teach for America, to address the need for encouraging youth to pursue STEM degrees and careers; and

WHEREAS, As a strong supporter of STEM education, PepsiCo will host students, teachers, and parents in October of 2015 at its PepsiCo facility to provide career visibility, honor teachers, share insights into a real business environment, provide learning about innovation science, and engage parents; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the date of October 19, 2015 as STEM Career Accelerator Day and commend the students from Hancock High School who will participate in the program at PepsiCo's facility in Chicago; and be it further

RESOLVED, That suitable copies of this resolution be presented to the students from Hancock High School participating in PepsiCo's program.

HOUSE RESOLUTION 808

Offered by Representative McDermed:

WHEREAS, Lincoln-Way Community High School District 210 is a public school district serving the following high schools: Lincoln-Way Central and Lincoln-Way West located in New Lenox, as well as Lincoln-Way North and Lincoln-Way East located in Frankfort; and

WHEREAS, The District is governed by the Lincoln-Way Community High School District 210 Board of Education; and

WHEREAS, The Illinois State Board of Education has placed Lincoln-Way Community High School District 210 on their 2015 Financial Watch List; and

WHEREAS, Lincoln-Way Community High School District 210 is not a State agency; and

WHEREAS, Under the Illinois Constitution, the Auditor General's authority to conduct audits is limited to "public funds of the State" and case law has interpreted that phrase to mean only those funds directly appropriated or otherwise authorized by the General Assembly following the Governor's preparation and submission of the State budget; and

WHEREAS, Section 5 of the Intergovernmental Cooperation Act provides that "one or more public agencies may contract with any one or more other public agencies to perform any governmental service, activity or undertaking or to combine, transfer, or exercise any powers, functions, privileges, or authority which any of the public agencies entering into the contract is authorized by law to perform ..."; and

WHEREAS, The General Assembly urges the Auditor General to conduct a performance audit of Lincoln-Way Community High School District 210; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a performance audit of Lincoln-Way Community High School District 210 by entering into an intergovernmental agreement with the District that sets forth the scope of the audit; and be it further

RESOLVED, That the performance audit include, but not be limited to, the following determinations:

1. the District's sources of revenue during Fiscal Years 2005 through 2015;
2. the District's expenditures, by broad category, during Fiscal Years 2005 through 2015;
3. the amount, purpose, and uses of General State Aid received during Fiscal Years 2005

through 2015;

4. whether, during Fiscal Years 2005 through 2015, the Board met its fiduciary responsibilities required by school board policy, including annually evaluating the Superintendent, annually reviewing the financial performance of the Board and the Superintendent and causing an audit to be made, adopting the annual financial plan of the Board, adopting a comprehensive long-term plan, and reviewing the Board's annual report on the outcomes of the District or any report submitted by the Superintendent; and

5. whether the Board and Superintendent are meeting their fiduciary responsibilities and ensuring compliance with the School Code and Board policies, including those related to the investment of school funds, procurements and contracts, construction activities, and budget transfers; and be it further

RESOLVED, That Lincoln-Way Community High School District 210 is responsible for paying the Auditor General's costs in conducting this audit; and be it further

RESOLVED, That the District, the State Board of Education, and any other entity having information relevant to this audit cooperate fully and promptly with the Auditor General's Office in its conduct; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and report his findings and recommendations upon completion in accordance with Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Auditor General.

HOUSE RESOLUTION 816

Offered by Representative Ford:

WHEREAS, Pope Francis, in his address to Congress, called upon the American people to come together in aiding those "trapped in a cycle of poverty"; in his address, Pope Francis asserted that "[t]he Golden Rule . . . reminds us of our responsibility to protect and defend human life at every stage of its development"; and

WHEREAS, It is the responsibility of this State to ensure that every child has access to the high quality education he or she deserves, whether in the childcare context, early childhood education classrooms, elementary school, middle school, high school, or college; and

WHEREAS, House Resolution 56 of the 96th General Assembly urged the State Board of Education to establish a comprehensive plan to close the student achievement gap by the 2010-2011 school year; and

WHEREAS, Time and time again, schools in low-income communities are strapped for resources and are labeled underperforming; and

WHEREAS, The ongoing inequality of education resources is a potential human rights violation that needs to be investigated immediately; and

WHEREAS, Low-income neighborhoods have a clear disadvantage in our State's education system and this body seeks to be responsive to the needs of these communities; and

WHEREAS, A closer look at systemic income-related discrimination in our schools is needed to develop a clear understanding of the challenges we face and what we can do to overcome them; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Task Force on Equality in Education be created to conduct an investigation on education services provided to low-income families; and be it further

RESOLVED, That the task force shall consist of the following members: 3 task force members appointed by the Speaker of the House; 3 task force members appointed by the Minority Leader of the House; one task force member from the Department of Human Rights, appointed by the Governor; one task force member from the State Board of Education, appointed by the Governor; and one task force member who is a member of the Illinois Federation of Teachers, appointed by the governing board of that entity; and be it further

RESOLVED, That the task force be appointed and hold its first meeting by March 1, 2016; and be it further

RESOLVED, That the task force shall take voluntary assistance and testimony from individuals and professional organizations and institutions; and be it further

RESOLVED, That the members of the task force shall serve without compensation; and be it further

RESOLVED, That the Department of Human Rights shall provide staffing and administrative support services to the task force upon request; and be it further

RESOLVED, That the task force shall submit its final report to the General Assembly and the Governor no later than December 31, 2016.

HOUSE RESOLUTION 817

Offered by Representative Batinick:

WHEREAS, In 2015, an estimated 48,960 people will be diagnosed with pancreatic cancer in the United States; 40,560 of these people will die from the disease; and

WHEREAS, Pancreatic cancer is one of the deadliest cancers; it is currently the fourth leading cause of cancer death in the United States and is projected to become the second by 2020; and

WHEREAS, Pancreatic cancer is the only major cancer with a 5-year relative survival rate in the single digits at just 7%; and

WHEREAS, When symptoms of pancreatic cancer present themselves, it is generally late stage; 73% of pancreatic cancer patients die within the first year of their diagnosis, while 93% of pancreatic cancer patients die within the first 5 years; and

WHEREAS, Approximately 1,640 deaths from pancreatic cancer will occur in Illinois in 2015; and

WHEREAS, Pancreatic cancer is the seventh most common cause of cancer-related death in men and women across the world; there will be an estimated 367,000 new pancreatic cancer cases diagnosed globally in 2015; and

WHEREAS, The good health and well-being of the residents of State of Illinois are enhanced as a direct result of increased awareness about pancreatic cancer and research into early detection, causes, and effective treatments; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate November 13, 2015 as World Pancreatic Cancer Day in the State of Illinois in recognition of this disease and its effects on the citizens of this State.

HOUSE RESOLUTION 821

Offered by Representative Stewart:

WHEREAS, In October of 2015, the National Down Syndrome Society (NDSS) will be celebrating Down Syndrome Awareness Month; and

WHEREAS, Down syndrome occurs when an individual has a full or partial extra copy of chromosome 21; this additional genetic material alters the course of development and causes the characteristics typically associated with Down syndrome; and

WHEREAS, One in every 691 babies in the United States is born with Down syndrome, making it the most common genetic condition; approximately 400,000 Americans have Down syndrome and about 6,000 babies with Down syndrome are born in the United States each year; and

WHEREAS, Down syndrome occurs in people of all races and economic levels; and

WHEREAS, The cause of the extra full or partial chromosome is still unknown; maternal age is the only factor that has been linked to an increased chance of having a baby with Down syndrome; and

WHEREAS, People with Down syndrome have an increased risk for certain medical conditions such as congenital heart defects, respiratory and hearing problems, Alzheimer's disease, childhood leukemia, and thyroid conditions; many of these conditions are now treatable, so many people with Down syndrome lead healthy lives; life expectancy for people with Down syndrome has increased dramatically in recent decades - from 25 in 1983 to 60 today; and

WHEREAS, People with Down syndrome attend school, work, participate in decisions that affect them, and contribute to society in many wonderful ways; and

WHEREAS, Quality educational programs, a stimulating home environment, good health care, and positive support from family, friends, and the community enable people with Down syndrome to develop their full potential and lead fulfilling lives; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the National Down Syndrome Society's October 2015 celebration of Down Syndrome Awareness Month; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the NDSS as a symbol of our respect and esteem.

HOUSE JOINT RESOLUTION 99

Offered by Representative Hays:

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to the truly great individuals who have served our country and, in doing so, have made the ultimate sacrifice for our nation; and

WHEREAS, Army Sgt. Kenneth R. Nichols, Jr. was killed in Kunar Province, Afghanistan on December 1, 2009 when his unit was attacked by small-arms fire and rocket-propelled grenades; and

WHEREAS, Sgt. Nichols grew up in Chrisman; he graduated from Georgetown-Ridge High School in 2000 and joined the United States Army 5 years later; and
