I previously indicated I would recuse myself from consideration of House Bill 2482, which concerns changes to the determination of need score. While I do not believe an actual conflict exists, I recused myself in an abundance of caution.

As you know, legislators are not required to abstain from voting on matters that may present a conflict of interest, provided that their vote is cast with the public interest in mind. Despite this, it is my personal policy to recuse myself from any matter that may potentially pose an actual or perceived conflict of interest with a client of my law firm or a client of a family member. However, given the significance of this legislation and the fact that I have not identified an actual conflict, I intend to vote on a motion to override the Governor's veto of House Bill 2482.

WHEREAS, Over the years, the Illinois Brass Band has presented dozens of concerts indoors and out and showcased exceptional artists, including Roger Webster, Michael Mulcahy, and Brett Baker; the Illinois Brass Band has produced 6 recordings to date; "Cookin' with Brass", the latest recording project by the Illinois Brass Band, is the first recording by the band in over 10 years; the tracks were recorded over a series of sessions in May and early June 2013 at First United Methodist Church in Arlington Heights, where the band regularly rehearses; the pieces selected are a selection of pieces that might be typically performed at one of the band's outdoor summer concerts; and

WHEREAS, The Illinois Brass Band is a 30-member British style brass band and is a 6-time national champion of the North American Brass Band Association; the band is a Section 501(c)(3) recognized organization and is supported in part by a grant from the Illinois Arts Council, a State agency; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the 25th anniversary of the Illinois Brass Band and we wish them many more successful years; and be it further

RESOLVED, That we declare June 11, 2016 as Illinois Brass Band Day; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Brass Band as an expression of our esteem and respect.

HOUSE RESOLUTION 830

Offered by Representative Flowers:

WHEREAS, The State of Illinois and the nation at large has seen a horrid outbreak of gun violence, seen daily on the streets of Chicago and other major cities and tragically spotlight in Tucson, Arizona, Denver, Colorado, Sandy Hook, Connecticut, Roanoke, Virginia, and Roseburg, Oregon; and

WHEREAS, The citizens of the major cities of our State and our nation see killings on the order of these highly publicized mass murders on a regular basis; and

WHEREAS, Today, there are enough privately owned guns in the United States of America to arm every man, woman, and child; and

WHEREAS, The fallout of the Great Recession of 2008 is still being felt in many parts of this country, where there are foreclosed homes and businesses, abandoned properties and vacant lots, and a desperate need for economic development; and

WHEREAS, In Illinois, we see high levels of unemployment and broad declines in healthcare, deteriorating infrastructure, and shrinking pensions and retirement savings as workers in all fields of education, healthcare, and public safety are laid off as a result of a financial crisis they did not create; and

WHEREAS, In 1967, the report of the Kerner Commission stated that "To pursue our present course will involve the continuing polarization of the American community and, ultimately, the destruction of basic democratic values. The alternative is not blind repression or capitulation to lawlessness. It is the realization of common opportunities for all within a single society"; and

WHEREAS, Since 1980, cities, states, and the nation have asked our citizens to Just Say No, recognize A Thousand Points of Light, and pass Three Strike laws and have preached Zero Tolerance, but the violence continues unabated; and

WHEREAS, The City of Chicago has seen a year of gun violence among the worst in the history of the City, with 400 people killed, a 15% increase over the previous year; on average, a person is shot every 2.8 hours; and

WHEREAS, Unemployment in the neighborhoods of Chicago and other inner cities is at 30% or higher, with limited economic opportunities and underserved, overcrowded, and technologically outdated schools; and

WHEREAS, As a State, we need to find new strategies and tactics and come up with solutions that protect our citizens from the scourge of gun violence, recognizing that enacting the same policies that we have passed the last half century and expecting different results is, by definition, insanity; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge President Barack Obama to call for a national conference on gun violence to be held by the end of 2015 in Chicago, with participants that include, but are not limited to, the United States Department of Justice, the Federal Bureau of Investigation, the Department of Homeland Security, the Department of Labor, the Department of Housing and Urban Development, the Department of Education, leaders of the private sector, elected officials at the city and state levels, members of our law enforcement community, and citizens who are organizing in their communities; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the President.

HOUSE RESOLUTION 834

Offered by Representative Ford:

WHEREAS, Pope Francis, in his address to Congress, called upon the American people to come together in aiding those "trapped in a cycle of poverty"; in his address, Pope Francis asserted that "[t]he Golden Rule . . . reminds us of our responsibility to protect and defend human life at every stage of its development"; and

WHEREAS, Article X, Section 1 of the Illinois Constitution states that a fundamental goal of the people of the State is the educational development of all persons to the limits of their capacities; and

WHEREAS, It is the responsibility of this State to ensure that every child has access to the high quality education he or she deserves, whether in the childcare context, early childhood education classrooms, elementary school, middle school, high school, or college; and

WHEREAS, House Resolution 56 of the 96th General Assembly urged the State Board of Education to establish a comprehensive plan to close the student achievement gap by the 2010-2011 school year; and

WHEREAS, Time and time again, schools in low-income communities are strapped for resources and are labeled underperforming; and

WHEREAS, The ongoing inequality of education resources is a potential human rights violation that needs to be investigated immediately; and

WHEREAS, Illinois should support gifted students with educational resources, regardless of school district; and

WHEREAS, Low-income neighborhoods have a clear disadvantage in our State's education system and this body seeks to be responsive to the needs of these communities; and

WHEREAS, A closer look at systemic income-related discrimination in our schools is needed to develop a clear understanding of the challenges we face and what we can do to overcome them; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Task Force on Equality in Education be created to conduct an investigation on education services provided to low-income families; and be it further

RESOLVED, That the task force shall consist of the following members: 3 task force members appointed by the Speaker of the House; 3 task force members appointed by the Minority Leader of the House; one task force member from the Department of Human Rights, appointed by the Governor; one task force member from the State Board of Education, appointed by the Governor; one task force member who is an educator representing a statewide professional teachers' organization, appointed by the State Superintendent of Education; one task force member who is an educator representing a different statewide professional teachers' organization, appointed by the State Superintendent of Education; one task force member who is an educator representing a professional teachers' organization in a city having a population exceeding 500,000, appointed by the State Superintendent of Education; one task force member from an organization that exists to ensure the political, educational, social, and economic equality of rights of all persons and to eliminate race-based discrimination, appointed by the State Superintendent of Education; and one task force member from an organization that works for economic, educational, and social progress for African Americans and promotes strong, sustainable communities through advocacy, collaboration, and innovation, appointed by the State Superintendent of Education; and be it further

RESOLVED, That the task force be appointed and hold its first meeting by March 1, 2016; and be it further

RESOLVED, That the task force shall take voluntary assistance and testimony from individuals and professional organizations and institutions; and be it further

RESOLVED, That the members of the task force shall serve without compensation; and be it further

RESOLVED, That the Department of Human Rights shall provide staffing and administrative support services to the task force upon request; and be it further

RESOLVED, That the task force shall submit its final report to the General Assembly and the Governor no later than December 31, 2016.

HOUSE RESOLUTION 835

Offered by Representative Chapa LaVia:

WHEREAS, Computer science is a foundational skill for every 21st century student; however, many schools in the United States do not teach courses on the subject; and

WHEREAS, Computer science jobs are growing at a rate of 2 times the national average compared to other professions; there are over 25,000 open computing jobs in Illinois, which is over 4 times the average State demand rate; and

WHEREAS, It is estimated that 1.4 million computer programming jobs will need to be filled by the next decade; only 400,000 of these positions are expected to be filled, causing a loss of nearly \$500 billion in future salaries; and

WHEREAS, Less than 2.5% of American college students graduate with degrees in computer science; enrollment figures for computer science have dropped compared to the previous decade; and

WHEREAS, Only 0.7% of 2012 high school Advanced Placement students studied computer science; only 15% of those students were women, and only 8% were students from communities of color; and

WHEREAS, Computer science credits can only be put toward high school graduation in 27 states; and

WHEREAS, The Hour of Code challenge teaches individuals how to create computer code for an hour to show anyone can learn the basics of computer programming; and

WHEREAS, Over 47,000 Hour of Code events have been conducted on every habitable continent and within 180 countries; and

WHEREAS, Over 100 million students have tried the Hour of Code challenge to boost problem solving, logic, and creativity skills; and

WHEREAS, The Hour of Code challenge promotes awareness of computer science and helps all students realize their full potential; Illinois schools should strive to ensure all students are prepared to be part of a 21st century workforce; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the week of December 7-13, 2015 as "Hour of Code Week" in the State of Illinois; and be it further

RESOLVED, That we encourage all public and private educational institutions in Illinois to have their students participate in the challenge.

HOUSE RESOLUTION 839

Offered by Representative Andersson:

WHEREAS, Bacon is consumed at breakfast an average of 12 times per person per year; 69% of all food service operators serve bacon; more than half of all homes (53%) keep bacon on hand at all times; each year in the United States, more than 1.7 billion lbs. of bacon are consumed in food service; bacon contains a high level of nutrients and is a useful addition to any diet; the key to eating bacon and gaining health benefits is keeping portions to reasonable sizes; and

WHEREAS, Baconfest is a fun-filled, walk-around, tasting event, featuring the most creative bacon dishes from the best chefs in Chicago; since 2009, Baconfest has raised over \$300,000, enabling partners like the Greater Chicago Food Depository to distribute more than 924,000 meals to hungry people in the area; and

WHEREAS, Pork is versatile, affordable, and accessible for many Americans; its many beneficial qualities make it easy to incorporate into any healthy diet; and

WHEREAS, Pork is not only a good source of protein, but also provides several important vitamins and minerals; a 3-ounce serving of pork is an excellent source of thiamin, selenium, protein, niacin, vitamin B6, and phosphorus and a good source of riboflavin, zinc, and potassium; and

WHEREAS, Pork is naturally low in sodium and a good source of potassium - 2 nutrients that, when coupled, can help regulate blood pressure; today's pork is 16% leaner and 27% lower in saturated fat compared to 20 years ago; and

WHEREAS, Pork - representing 42.6% of total meat consumed - is the world's most widely eaten meat according to the United States Department of Agriculture; 7 cuts of pork meet the USDA guidelines for "lean" by containing less than 10 grams of fat, 4.5 grams of saturated fat, and 95 milligrams of cholesterol per 100 grams of meat; and

WHEREAS, Pork tenderloin is certified as heart-healthy by the American Heart Association with its Heart-Check mark, indicating that it contains less than 6.5 grams of fat, 1 gram or less of saturated fat (and 15% or less calories from saturated fat), and 480 milligrams or less of sodium per label serving, among other criteria; pork tenderloin has the same amount of fat as a skinless chicken breast; and

WHEREAS, Illinois ranks 4th in the nation in swine production; pork producers have enhanced feeding and breeding practices to deliver leaner options for today's health conscious consumers; and

WHEREAS, The Illinois Pork Producers Association (IPPA) represents more than 2,000 pork producers throughout Illinois; the IPPA is comprised of county pork producer groups in approximately 20 counties throughout Illinois; the IPPA is an affiliate of the National Pork Producers Council and the National Pork Board; the Illinois pork industry contributes more than \$1.8 billion and more than 10,500 jobs to the State's economy; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we call upon the leaders of the State of Illinois to recognize and continue to defend the importance of bacon and other pork products, along with the pork producers, to the economy, job growth, and the consumer preference of the people of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Pork Producers Association as a symbol of our respect and esteem.

HOUSE RESOLUTION 851

Offered by Representative Wehrli:

WHEREAS, There are nearly 7,000 diseases and conditions considered rare (each affecting fewer than 200,000 Americans) in the United States, according to the National Institutes of Health; and

WHEREAS, While each of these diseases may affect small numbers of people, rare diseases as a group affect almost 30 million Americans; and

WHEREAS, Many rare diseases are serious and debilitating conditions that have a significant impact on the lives of those affected; and

WHEREAS, While more than 450 drugs and biologics have been approved for the treatment of rare diseases according to the Food and Drug Administration, millions of Americans still have rare diseases for which there is no approved treatment; and

WHEREAS, Individuals and families affected by rare diseases often experience problems such as diagnosis delay, difficulty finding a medical expert, and lack of access to treatments or ancillary services; and

WHEREAS, While the public is familiar with some rare diseases, many patients and families affected by less widely known rare diseases bear a large share of the burden of funding research and raising public awareness to support the search for treatments; and

WHEREAS, Residents of Illinois are among those affected by rare diseases as nearly one in 10 Americans have rare diseases; and

WHEREAS, The National Organization for Rare Disorders is organizing a nationwide observance of Rare Disease Day on February 29, 2016; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, we declare February 29, 2016 as "Rare Disease Day" in the State of Illinois.

HOUSE RESOLUTION 855

Offered by Representative Welch:

WHEREAS, Gun violence is an ever present problem in the State, as well as nationwide; an example of which is 8 persons dying in Chicago in one week in October due to gun violence; and

WHEREAS, In the past few years, court rulings, including the United States Supreme Court in District of Columbia V. Heller, in interpreting the Second Amendment to the United States Constitution have overturned long standing precedent, which had supported state and local authority to deny gun possession when necessary to promote and protect public safety; in order to reach its decision, the 5 member majority of the United States Supreme Court either ignored or misinterpreted much of the clear and plain wording of the Second Amendment; and

WHEREAS, As stated by U.S. Supreme Court Justice Stevens in his well-thought out dissent on behalf of 4 Justices in Heller: "The Second Amendment was adopted to protect the right of the people of each of the several States to maintain a well-regulated militia. It was a response to concerns raised during ratification of the Constitution that the power of Congress to disarm the state militias and create a national standing army posed an intolerable threat to the sovereignty of the several States. Neither the text of the Amendment nor the arguments advanced by its proponents evidenced the slightest interest in limiting any legislature's authority to regulate private civilian uses of firearms. Specifically, there is no indication that the Framers of the Amendment intended to enshrine the common-law right of self-defense in the Constitution."; rather the Second Amendment's original purpose was to act as a check on federal gun-making policy, not to prevent individual states from creating gun policy as they saw fit; and

WHEREAS, The legal view of the Second Amendment as a collective, militia right, and not an individual right, held for over 200 years until the Heller decision in 2008, which invalidated a law barring individuals from possessing a handgun not registered before the law took effect and annual registrations for the remaining handguns; and

WHEREAS, The Heller decision and other pro-firearm industry court rulings have resulted in a proliferation of guns in numerous communities and have diminished the security and freedom of our citizens to enjoy a life free of gun violence; living with the fear of gun violence is contrary to living in a free society; high levels of gun violence are a threat to the security of whole communities; and

WHEREAS, The cost of gun violence has been pushed onto everyone except the people and companies that produce and sell firearms; the firearms industry benefits financially when more guns are sold; more firearms in circulation leads to more gun crimes, homicides, and suicides to the extent that gun-related deaths will soon exceed the number of deaths in automotive crashes; but the Heller decision effectively said that most of the Second Amendment should be disregarded in favor of the part that is most profitable to the firearms industry, "the right of the people to keep and bear arms shall not be infringed"; and

WHEREAS, Throughout the history of the United States, federal and state laws have regularly placed restrictions on who can legally own, possess, and use firearms; even prior to the ratification of the U.S. Constitution, gun control laws were enacted; therefore laws restricting gun access are not anomalous to American law; and

WHEREAS, Before these court decisions, state legislatures had been able to pass laws restricting gun access if it was in the best interests of public safety; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the courts, especially the United States Supreme Court, to restore interpretation of the Second Amendment as a right afforded to state-sponsored militias that as Justice Stevens stated in his Heller dissent, " ... it does not curtail the Legislature's power to regulate the non-military use and ownership of weapons ... ".
