HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 965

Offered by Representative Bourne:

WHEREAS, Rare diseases affect almost 30 million Americans; in the United States, children with rare genetic diseases account for more than half of the population affected by rare diseases; and

WHEREAS, Individuals with rare diseases experience challenges that include difficulty in obtaining an accurate diagnosis, limited treatment options, and difficulty finding physicians or treatment centers with expertise in their disease; and

WHEREAS, The National Organization for Rare Disorders is an organization established in 1983 to provide services to and advocate on behalf of patients with rare diseases; the organization was a primary force behind the enactment of the Orphan Drug Act and remains a critical public voice for people with rare diseases; and

WHEREAS, The National Organization for Rare Disorders sponsors Rare Disease Day to increase public awareness of rare diseases; Rare Disease Day has become a global event occurring annually on the last day of February, providing hope and information for rare disease patients around the world; and

WHEREAS, Residents of Illinois are greatly affected by rare diseases like Infantile Neuroaxonal Dystrophy, an extremely rare genetic disorder that affects the nervous system and causes a breakdown of the nerves throughout the body; and

WHEREAS, Infantile Neuroaxonal Dystrophy causes children to unlearn skills like walking and talking and, in some cases, affects their vision; most children diagnosed with Infantile Neuroaxonal Dystrophy do not live to see their tenth birthday; and

WHEREAS, Infantile Neuroaxonal Dystrophy affects about 30 children around the world, including Illinois resident Grace Louise Herschelman, the daughter of Kyle and Mary Herschelman of Hillsboro; and

WHEREAS, Grace Herschelmann attends Hillsboro United Methodist Church's preschool program 3 mornings a week; she loves music, reading books, spending time with her friends, and Minnie Mouse; and

WHEREAS, Grace Herschelmann had the opportunity to go on a trip to Auluani, Hawaii, which was provided by the Make-A-Wish Foundation, to meet Minnie Mouse; and

WHEREAS, Grace's family has made her story known through their blog called A Grace Filled Journey, which allows Grace to touch the lives of individuals all over the world; the community has become engaged in supporting research for Infantile Neuroaxonal Dystrophy by supporting events such as the Grace Filled Journey 5K and a one-mile run/walk event in Hillsboro; and

WHEREAS, These events have provided Grace Herschelmann and her family the opportunity to raise over \$70,000 to help fund a study for treatment options, as there are currently no treatments or cure for those affected with Infantile Neuroaxonal Dystrophy; and

WHEREAS, Infantile Neuroaxonal Dystrophy families around the world have raised more than \$450,000 for 2 INAD studies and fundraising efforts and continue to help children like Grace Herschelmann; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we join in the global observance of Rare Disease Day by designating February 29, 2016 as "Rare Disease Day" in the State of Illinois; and be it further

RESOLVED, That we recognize the courage of Miss Grace Herschelmann and others like her as they battle rare diseases and give our wholehearted support for a State, national, and global commitment to improving access to and developing new treatments, diagnostics, and cures for rare diseases and disorders; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Grace Herschelmann as an expression of our deepest admiration and respect for her and her parents' continued efforts to raise awareness for Infantile Neuroaxonal Dystrophy.

HOUSE RESOLUTION 967

Offered by Representative Cloonen:

WHEREAS, Career and technical education is a valuable learning opportunity offered in most high schools, area career and technical centers, community and technical colleges, and other post-secondary institutions throughout the State of Illinois; and

WHEREAS, Career and technical education strives to develop confident and creative builders of their own future by preparing students to select viable career paths and obtain the training and skills essential for continuing education and a successful future; and

WHEREAS, Career and technical education provides students with leadership opportunities in various fields and allows them to experience real-world practical and technical application of reading, writing, and mathematical skills; and

WHEREAS, Career and technical education provides students with work-based learning experiences and soft-skills training; and

WHEREAS, During the month of February, we encourage both youth and adults in the State of Illinois to learn more about career and technical education in order to recognize the significance to ensure Illinois students are well prepared for secondary education and a career; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate February of 2016 as "Career and Technical Education Month" in the State of Illinois.

HOUSE RESOLUTION 968

Offered by Representative McAuliffe:

WHEREAS, The United States Department of Veterans Affairs (VA): Veterans Health Administration facilitates health care for U.S. veterans that include both physical and mental health services; and

WHEREAS, Veteran Health Administration hospitals and health care clinics are located throughout the United States to offer high quality care to our nation's veterans; and

WHEREAS, Basic eligibility for veterans to qualify for health benefits through the VA are, serving in active military service and being separated under anything other than a dishonorable discharge; current and former members of the reserves or National Guard who were called to active duty by a federal order and completed the full period for which they were called or ordered to active duty may also be eligible for VA health benefits; and

WHEREAS, The VA operates an annual enrollment system that helps to manage the provision of health care and applies a variety of factors during the application verification process when determining a veteran's eligibility for enrollment; once a veteran is enrolled, he/she remains enrolled in the VA health care system with access to certain VA health benefits; and

WHEREAS, Recent studies on veteran access to health care have shown that former members of the reserves and National Guard face greater barriers to access through the VA health care system; these veterans face a more complex set of eligibility rules and barriers to gain access; and

WHEREAS, These studies have shown that despite lengthy periods of service, many reserves and National Guard veterans are not eligible for health care and other basic benefits provided by the VA because they have not met the complex "active duty" and "length of service" requirements to meet the legal definition of "veteran" used by the VA; and

WHEREAS, Veteran status for VA benefits depends on a number of factors, such as having served during wartime (which requires 90 continuous days of service), or peacetime (which requires 180 continuous days of service), and whether the veteran was called to duty under state or federal law; and

WHEREAS, These complex rules often lead to unfair results and make it difficult to receive proper health care for veterans that were in the reserves or National Guard, who served in the U.S. Armed Forces both during times of peace and war; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the United States Department of Veterans Affairs to make changes to eligibility for health care through the Veterans Health Administration to allow for a better rules process to assist veterans from the reserves and National Guard in receiving the proper health care they have earned for serving in the United States Armed Forces; and be it further

RESOLVED, That suitable copies of this resolution be presented to the President of the United States, Barack Obama, the Secretary of Veterans Affairs, Robert McDonald, President of the Senate, Mitch McConnell, and the Speaker of the House of Representatives, Paul Ryan.

HOUSE RESOLUTION 969

Offered by Representative McAuliffe:

WHEREAS, South Asians are individuals who derive their ethnic origins from the Indian Subcontinent, made up of countries such as India, Pakistan, and Bangladesh; and

WHEREAS, South Asians hold a high risk of heart attack and stroke that has often been overlooked; this increased risk is due to a variety of factors, ranging from genetics to lifestyle choices; and

WHEREAS, South Asians are at 4 times greater risk for heart disease than the general population; amongst South Asian men, 25% of heart attacks occur under the age of 40 and 50% occur under the age of 50; South Asian women have a 30% increased risk of heart disease when compared to Caucasians and a 325% increased risk when compared to the Chinese; South Asians make up 17% of the world population, but hold 60% of the world's cardiovascular disease burden; and

WHEREAS, The South Asian Cardiovascular Center at Advocate Heart Institute of Advocate Health Care is the first of its kind in the Midwest designed to serve the South Asian community; the aim of the Center is to educate, screen, prevent, and treat South Asians for their high risk of cardiac disease; and

WHEREAS, The South Asian Cardiovascular Center at Advocate Heart Institute of Advocate Health Care provides a combination of hospital and outpatient clinical services to assure individuals and their families a comfortable and culturally sensitive experience; and

WHEREAS, The outreach efforts at the South Asian Cardiovascular Center at Advocate Heart Institute of Advocate Health Care are intended to inspire change and provide options to live a heart healthy lifestyle; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 12, 2016 as "Red Sari Day" for South Asian Cardiovascular Disease Awareness in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the South Asian Cardiovascular Center at Advocate Heart Institute of Advocate Health Care as an expression of our esteem and respect.

HOUSE RESOLUTION 973

Offered by Representative Ives:

WHEREAS, More than 500,000 American men and women, wearing the uniforms of the United States armed forces, have paid the supreme sacrifice while in the service of their country; and

WHEREAS, After the conclusion of the American Civil War, the 2 sides in the conflict, North and South together, joined hands to create a national sacred day of remembrance in honor of those who had fallen; and

WHEREAS, Through the organizational work of General John A. Logan, born in Murphysboro, Memorial Day became an official United States holiday, observed annually on the 4th Monday in May; and

WHEREAS, Almost every American family and almost every family in Illinois bears upon the rolls of its heart the name or names of one or more military service members bearing our own names who have fallen for America in war and in combat; and

WHEREAS, In 2016, American men and women continue to serve in uniform in active combat zones around the world, especially, but not limited to, the Global War on Terror in numerous countries, including Afghanistan; and

WHEREAS, The supreme sacrifice continues to be made by patriotic Americans of all 50 states, including Illinois, who give their lives for the freedom and future of their fellow Americans; and

WHEREAS, In grateful recognition of these sacrifices, on Memorial Day the people of Illinois gather in places of religious worship, town squares, and places of burial throughout our State to remember and honor the fallen; and

WHEREAS, In recognition of these gatherings, most employers and supervisors throughout Illinois grant their employees and contractors an annual day of remembrance each Memorial Day to enable these individuals to join their families and take part in the annual sacred duty of this day; and

WHEREAS, Despite this sacred custom, the current schedule of the Illinois House of Representatives calls for us to conduct secular business on Memorial Day, May 30, 2016, when we ought to be home with our families and our communities, reaffirming the sacred bonds that tie us together as Americans; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Speaker of the Illinois House of Representatives to recess the House for the duration of Memorial Day, May 30, 2016, and not to call us back into session until the completion of this day of American remembrance and the completion of the sacred duties of this day; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Speaker of the Illinois House of Representatives.

HOUSE RESOLUTION 977

Offered by Representative McAuliffe:

WHEREAS, Eating disorders can affect all individuals regardless of age, gender, race, ethnicity, and socioeconomic status; and

WHEREAS, Up to 30 million individuals in the United States suffer from eating disorders, such as anorexia nervosa, bulimia, and binge eating; and

WHEREAS, Almost 50% of individuals with eating disorders meet the criteria for depression; and

WHEREAS, Approximately 95% of those struggling with eating disorders are between the ages of 12 and 25, with anorexia nervosa being the third most common chronic illness among adolescents with a mortality rate 12 times higher than the death rate associated with all causes of death for females between the ages of 15 and 24; and

WHEREAS, An estimated 10-15% of individuals with anorexia nervosa or bulimia are male, although female individuals are more likely to develop eating disorders; and

WHEREAS, Males are less likely to seek treatment because of the societal perception that eating disorders are "female diseases"; and

WHEREAS, Only one in 10 individuals with eating disorders receive treatment and only 35% of people who receive treatment for eating disorders obtain treatment at a specialized facility for eating disorders; and

WHEREAS, Eating disorders have the highest mortality rate of any mental illness, with one study ranging from 4% mortality due to anorexia nervosa, 3.9% due to bulimia, and 5.2% due to other eating disorders not specified; and

WHEREAS, The mortality rate due to eating disorders may be higher because medical complications, such as heart failure, organ failure, malnutrition, or suicide, are reported as the cause of death instead of the eating disorder that led to the death of the individual; and

WHEREAS, The causes of eating disorders can be comprised of multiple factors, such as genetics, metabolism, psychological aspects including control, coping mechanisms, trauma, personality factors, family issues, and social issues including a society that promotes thinness and media that spread this message; and

WHEREAS, The National Eating Disorders Association (NEDA) holds an annual conference to examine treatment and prevention of eating disorders that can affect the loved ones of family and friends; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the week of February 21 to February 27 of 2016 as "Eating Disorder Awareness Week" in the State of Illinois in concurrence with National Eating Disorder Awareness Week for the purpose of urging both government entities and the citizenry to become aware and educated on the subject of eating disorders in an effort to love and support our loved ones struggling with such disorders; and be it further

RESOLVED, That people are urged to wear periwinkle colored ribbons, which is the color of eating disorder awareness, every day of Eating Disorder Awareness Week and have ribbons available at their offices for those who want to join in the awareness effort; and be it further

RESOLVED, That we extend our sincerest thank you to the National Eating Disorders Association for hosting its NEDA Conference in Chicago from September 29 to October 1, 2016.

HOUSE RESOLUTION 993

Offered by Representative Welch:

WHEREAS, An ovarian cyst is a collection of fluid inside a woman's ovaries; most ovarian cysts occur during ovulation and usually go away within a few months, without any treatment; most ovarian cysts are benign, but a small number of them are cancerous; and

WHEREAS, Ovarian cancer often progresses to an advanced stage before it is detected; 77% of women are diagnosed after the disease has reached an advanced stage; despite advancements in surgery and chemotherapy treatments, the overall 5-year survival rate for women with advanced stage ovarian cancer has remained constant over the past 30 years at approximately 15%; women diagnosed with early stage (Stage I) ovarian cancer have an overall 5-year survival rate approaching 90 to 95%; early-stage detection of ovarian cancer is the best way to improve survival; more than 20,000 women in the United States are diagnosed with ovarian cancer each year, and approximately 15,000 women die annually from the disease; and

WHEREAS, There is currently no early detection test for ovarian cancer; until there is a test, the key to early diagnosis is awareness, and the key to awareness is knowing the subtle symptoms of ovarian cancer and urging women to take early action; and

WHEREAS, The mission of the National Ovarian Cancer Coalition (NOCC) is to save lives by fighting to prevent and cure ovarian cancer, and to improve the quality of life for survivors; and

WHEREAS, Through national programs and local chapter initiatives, the NOCC's goal is to make more people aware of the early symptoms of ovarian cancer; the NOCC provides information to assist the newly diagnosed patient, to provide hope to survivors, and to support caregivers; NOCC programs are possible only with the help of volunteers, committed men and women dedicated to the mission of the NOCC in communities across the country; and

WHEREAS, September of 2016 is Ovarian Cancer Awareness Month; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare September 11-17, 2016 as "Ovarian Cyst

Awareness Week" in the State of Illinois and we urge people to do all that they can to increase awareness of the dangers that some women face with ovarian cysts; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the NOCC as a symbol of our respect and esteem.

HOUSE RESOLUTION 994

Offered by Representative Andersson:

WHEREAS, Our State's continuing efforts to address the critical issues of safety, energy efficiency, water conservation, and resilience in the built environment that affect our citizens, both in everyday life and in times of natural disaster, gives us confidence that our structures are safe and sound; and

WHEREAS, Our confidence is achieved through the devotion of vigilant guardians - building safety and fire prevention officials, architects, engineers, builders, tradespeople, laborers, and others in the construction industry, who work year-round to ensure the safe construction of buildings; and

WHEREAS, These guardians - dedicated members of the International Code Council - use a governmental consensus process that brings together local, state, and federal officials, with expertise in the built environment, to create and implement the highest-quality codes to protect Americans in the buildings where we live, learn, work, worship, and play; and

WHEREAS, The International Codes - the most widely adopted building safety, energy, and fire prevention codes in the nation - are used by most U.S. cities, counties and states; these modern building codes also include safeguards to protect the public from natural disasters such as hurricanes, snowstorms, tornadoes, wildland fires, floods, and earthquakes; and

WHEREAS, Building Safety Month, sponsored by the International Code Council, reminds the public about the critical role of our communities; largely unknown guardians of public safety - our local code officials - who assure us of safe, efficient, and livable buildings; and

WHEREAS, "Building Codes: Driving Growth through Innovation, Resilience, and Safety", the theme for Building Safety Month 2016, encourages all Americans to raise awareness of the importance of building safe and resilient construction, fire prevention, disaster mitigation, water safety and conservation, energy efficiency, and new technologies in the construction industry; Building Safety Month 2016 encourages appropriate steps everyone can take to ensure that the places where we live, learn, work, worship, and play are safe and sustainable; it recognizes that countless lives have been saved due to the implementation of safety codes by local and state agencies; and

WHEREAS, Each year, in observance of Building Safety Month, Americans are asked to consider projects to improve building safety and sustainability at home and in the community, and to acknowledge the essential service provided to all of us by local and state building departments, fire prevention bureaus, and federal agencies in protecting lives and property; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May of 2016 as "Building Safety Month" in the State of Illinois and we encourage citizens to join with their communities in participating in Building Safety Month activities; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the International Code Council as a symbol of our respect and esteem.

HOUSE RESOLUTION 1006

Offered by Representative Bourne:

WHEREAS, The whole people of Illinois - who pay for a General Assembly to plan for the long-term affairs of the State - deserve to have a budget planning document in place that considers medium-term and long-term spending pressures in the setting of State spending priorities; and

WHEREAS, No budget has been enacted for fiscal year 2016, the fiscal year that began on July 1, 2015; as a result, the overall economic climates of many sections of Illinois are threatened, endangering jobs in the

private and public sectors alike; as a result of these threats, local consumption of private-sector goods and services must drop; and

WHEREAS, Central Illinois, with its traditional orientation towards the maintenance of State of Illinois operations is one of these threatened areas; and

WHEREAS, With no budget enacted for fiscal year 2016, soon the State of Illinois will have operated under 4 different budgets in the span of 2 years - the fiscal 2015 budget signed by former Governor Quinn, the revised fiscal year 2015 budget containing necessary "fixes" to the original, flawed FY15 budget, the fiscal year 2016 non-budgeted State spending cycle being carried out right now under a series of State and federal court orders, and an enacted budget that will cover the remainder of FY16; and

WHEREAS, Under the fiscal year 2016 non-budgeted State spending cycle, State spending is continuing without legislative participation, putting Illinois on the financial brink and setting our State on a path to utter financial ruin and economic devastation for our taxpayers; and

WHEREAS, Political pressures associated with the 2016 election cycle will only increase with time, further tainting the budget process with politics and raising the possibility that, in the absence of corrective action, a repetition of this dismal pattern will occur as the spring 2016 deadline nears to craft and enact a budget for fiscal year 2017; and

WHEREAS, The General Assembly needs to re-establish a budget cycle and re-establish the credibility it needs in order to shift its attention to pension reform, property tax relief, crime and violence, the jobs climate, the outmigration from Illinois of younger and highly-educated workers and professionals, and other urgent issues; and

WHEREAS, Many states such as Nebraska, Ohio, and Texas, and including the neighboring state of Indiana, practice 2-year spending plans or full-scale biennial budgeting; and

WHEREAS, The Constitution of Illinois directs the Governor of Illinois to present an annual budget proposal to the General Assembly, but, as we have come to know all too well, nothing constrains the General Assembly's actual responses to these proposals, and nothing prevents the General Assembly from adopting a planning process that faces the fact that we, as a State, are on the financial brink, and responds to it in a professional manner and in keeping with our identity as legislators and our oaths of office; and

WHEREAS, In these times, moving toward a long-term budget planning cycle will enable State agencies performing essential services, third-party service providers whose services are no less essential, and institutions and entities of higher education to obtain the information that their leaders have testified is essential to carrying out their duties; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare that it is expedient for the General Assembly to adopt a 2-year budget planning document to cover revenues in all of fiscal years 2016 and 2017, take account of moneys already spent, and control spending in the remainder of fiscal year 2016 and all of fiscal year 2017; and be it further

RESOLVED, That this planning document should rely upon an honest estimate, without false promises or shoddy planning, of the actual financial income (especially general funds income) that the State will take in during fiscal years 2016 and 2017; and be it further

RESOLVED, That we urge the Commission on Government Forecasting and Accountability and the Governor's Office of Management and Budget to work together to develop an extraordinary consolidated revenue estimate for fiscal years 2016 and 2017, this estimate to be presented to both chambers of the General Assembly no later than 30 days after the adoption of this resolution; and be it further

RESOLVED, That we, the sponsors of this resolution, pledge to use this consolidated 2-year revenue estimate to work with our colleagues to develop a 2-year State budget and financial planning document; and be it further

RESOLVED, That our goal, as we develop this budget planning document, will be to end the current political cycle of reactive emergency measures and budget court orders; and be it further

RESOLVED, That suitable copies of this resolution be presented to Michael J. Madigan, Speaker of the House of Representatives, John Cullerton, President of the Senate, and Bruce Rauner, Governor.

Offered by Representative Bennett:

WHEREAS, It is appropriate for us to remember the many sacrifices and contributions to the cause of freedom made by the outstanding men and women who served in the United States Armed Forces protecting our great nation; and

WHEREAS, Over 600 men and women from Loda Township have served in the armed forces, beginning with the War of 1812; and

HOUSE RESOLUTION 1011

Offered by Representative Ford:

WHEREAS, The import, trade, and labor of slaves in America is a sad chapter in the history of a nation founded upon the principles of freedom, equality, and justice; and

WHEREAS, The use of slave labor undoubtedly led to profits for those who used them for manual labor; and

WHEREAS, In addition to labor benefits, the owners of slaves benefited from selling them to the highest bidder, often separating families permanently; and

WHEREAS, The trading, sale, and transportation of slaves, was an industry in itself; and

WHEREAS, During their enslavement, to increase their value and extend their working lives, slaves received consistent health care and treatment for illness and injuries; and

WHEREAS, After Emancipation and well into the century afterwards, African Americans were often denied employment, or paid less than whites for the same work; denied housing or forced to pay more for housing than whites; denied the same educational opportunities as whites; denied their right to vote by the use of literacy tests and poll taxes; and

WHEREAS, After Emancipation, with little education, employment, adequate housing, and health care, the life expectancy of African Americans dropped significantly; and

WHEREAS, Over the course of our nation's history, many groups that have been wronged by the government have received reparations for those wrongs, including Japanese Americans, Mexican Americans, Filipino Americans, and Native Americans; and

WHEREAS, In 2008, the United States House of Representatives passed a non-binding resolution apologizing for slavery and acknowledging the "injustice, cruelty, brutality and inhumanity" of slavery; and in 2009 the United States Senate passed a similar resolution of apology; and

WHEREAS, The United Nations Working Group of Experts on People of African Descent has recently released a report recommending that reparations be paid to the descendants of African American slaves, and also recommending the establishment of a national human rights commission, and to publicly acknowledge that the trans-Atlantic slave trade was a crime against humanity; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, That we request President Obama to commission a study to detail the economic impact of the slave trade and the use of slave labor; and how Emancipation, while freeing them of their literal bonds, and ending an immoral practice, did not guarantee equality in education, employment, housing, and access to quality affordable health care; and be it further

RESOLVED, That this study also include an analysis for how reparations for past harms have benefited the ethnic groups that have received them during the course of American history; and a proposal for

reparations to the descendants of slaves in America, and how those reparations can help overcome obstacles that still exist today in education, employment, housing, health care, and justice; and be it further

RESOLVED, That a suitable copy of this resolution be presented to President Obama.

WHEREAS, Staff Sergeant Smith's 2009 deployment was his third in Afghanistan with Troop C, 2nd Battalion, 106th Cavalry Regiment, providing protection for Embedded Training Teams and the Afghan army; and

WHEREAS, In late August of 2009, at the age of 43, Staff Sergeant Smith volunteered for a mission, manning the gunner position atop a Humvee, fifth in a military convoy; and

WHEREAS, Staff Sergeant Smith typically rode in the first or last vehicle in the line; he was killed instantly when an improvised explosive device detonated near his vehicle; another soldier was killed and 2 were seriously injured in the explosion; and

WHEREAS, The device was the first of its kind to be floating in a roadside canal, and not on the side of the road like all the others that had caused so much death and injury in the war in Afghanistan; and

WHEREAS, A small home on Jay Street in East Peoria currently holds a beautiful tribute to Staff Sergeant Smith, including photos, a quilt, and a framed sketch by an artist who has done the same for every 2,350 American fatalities in the war in Afghanistan to date; and

WHEREAS, Staff Sergeant Smith's dedication, heroism, and courage will never be forgotten by his family, city, State, and country; therefore, be it

HOUSE JOINT RESOLUTION 123

Offered by Representative Batinick:

WHEREAS, Many government agencies and universities have experience with the difficulty of the procurement process in the State; and

WHEREAS, There is a high administrative cost to procurement; and

WHEREAS, Added compliance costs limit competition and increase the prices that the State must pay; and

WHEREAS, Reverse auctions are done publicly online, increasing transparency and reducing bureaucracy; and

WHEREAS, Reverse auctions may serve to increase competition, lower price, and reduce paperwork; and

WHEREAS, Reverse auction processes have been implemented in other states, including Florida and Texas, and should be studied for use in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Task Force on Reverse Auction Procurement be created to:

(1) thoroughly examine the reverse auction procurement process to determine whether such a system should be implemented in Illinois, including, but not limited to, examining how other states have implemented the system and whether it has been successful there;

(2) recommend amendments to the Procurement Code to implement a reverse auction procurement process if the Task Force decides that it would be beneficial in this State;

(3) produce a final report summarizing the Task Force's findings and detailing recommended statutory changes, if necessary; and be it further

RESOLVED, That the Task Force shall consist of the following members:

(1) two members appointed by the Speaker of the House of Representatives, one of which shall be a member of the House and the other which shall not;

(2) two members appointed by the Minority Leader of the House of Representatives, one of which shall be a member of the House and the other which shall not;

(3) two members appointed by the President of the Senate, one of which shall be a member of the Senate and the other which shall not;

(4) two members appointed by the Minority Leader of the Senate, one of which shall be a member of the Senate and the other which shall not; and

(5) the Director of the Department of Central Management Services or his or her designee, whom shall serve as chairperson; and be it further

RESOLVED, That the Task Force shall meet at the call of the Chair; and be it further

RESOLVED, That the Department of Central Management Services shall provide staffing and administrative support to the task force upon request; and be it further

RESOLVED, That Task Force members shall serve without compensation but may be reimbursed for their expenses incurred in performing their duties; and be it further

RESOLVED, That the Task Force shall submit its report to the General Assembly no later than January 15, 2017.

HOUSE JOINT RESOLUTION 124

Offered by Representative Wallace:

WHEREAS, In 2013, the Supreme Court of the United States, in *Shelby County v. Holder*, held that states can no longer be judged by voter discrimination that went on decades ago; and

WHEREAS, The formula used in Section 4(a) of the Voting Rights Act was found to be unconstitutional, outdated, and no longer relevant in modern times; if a state had qualified under the formula in Section 4(a), Section 5 would be activated, which required review either by the United States District Court for Washington, D.C. or the Attorney General; and

WHEREAS, The U.S. Supreme Court directed Congress to identify jurisdictions that should be singled out now for voter discrimination, as opposed to discrimination 40 years ago, as long as the formula does not include black voter registration and turnout from decades ago; and

WHEREAS, If Congress does not re-authorize the formula in Section 4(a), the Voting Rights Act loses much of its original purpose to prevent discrimination in voting; without a formula in Section 4, Section 5 preclearance goes unused in states with a history of discrimination; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge Congress to re-authorize Section 4 of the Federal Voting Rights Act so that citizens who were previously protected do not become disenfranchised; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Speaker of the United States House of Representatives Paul Ryan, United States Senate Majority Leader Mitch McConnell, and President Barack Obama.

HOUSE JOINT RESOLUTION 125

Offered by Representative Durkin:

WHEREAS, Interstate 55 from Interstate 355 to Interstate 90/Interstate 94 in DuPage, Cook, and Will Counties experiences severe congestion for extended periods of time on a daily basis and is unable to accommodate existing traffic demands; and

WHEREAS, the Illinois Department of Transportation is seeking to move forward with a project to provide additional highway capacity along Interstate 55 from Interstate 355 to Interstate 90/Interstate 94 in DuPage, Cook, and Will Counties and toll the additional capacity; and

WHEREAS, the project is contingent on compliance with applicable environmental requirements and, if federal funds or requirements are involved, approval by the Federal Highway Administration; and

WHEREAS, it is the intent of the Public-Private Partnerships for Transportation Act to promote public-private partnerships for transportation by authorizing transportation agencies to enter into public-private agreements related to the development, operation, and financing of transportation facilities; and

WHEREAS, the Department is seeking to move forward with the project to provide additional highway capacity along Interstate 55 from Interstate 355 to Interstate 90/Interstate 94 in DuPage, Cook, and Will Counties and toll the additional capacity pursuant to the authority provided under the Public-Private Partnerships for Transportation Act; and

WHEREAS, it is a requirement of subsection (d) of Section 15 of the Public-Private Partnerships for Transportation Act that prior to the Department's commencement of a procurement under the Act with respect to any potential project, the General Assembly shall authorize the commencement of the procurement by a joint resolution; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that in accordance with subsection (d) of Section 15 of the Public-Private Partnerships for Transportation Act, we authorize the Department to commence a procurement process for a project to provide additional highway capacity along

Interstate 55 from Interstate 355 to Interstate 90/Interstate 94 in DuPage, Cook, and Will Counties and toll the additional capacity; and be it further

RESOLVED, That a suitable copy of this resolution shall be presented to the Secretary of State and the Secretary of the Department of Transportation.

HOUSE JOINT RESOLUTION 126

Offered by Representative Kifowit:

WHEREAS, During World War II, under a special program known as Women Airforce Service Pilots (WASP), female pilots flew noncombat missions to free up male pilots for combat; and

WHEREAS, WASPs were considered civilians; 38 women died in crashes, but neither they nor their families received military benefits; and

WHEREAS, WASP pilots were granted veteran status in 1977, making them eligible to have their ashes placed at Arlington National Cemetery with military honors; since 2002, this has gone on without controversy; and

WHEREAS, Recently, the United States Army, which oversees Arlington National Cemetery, stated that in 2002, the superintendent of the cemetery had no authority to begin allowing the remains of WASP pilots to be buried there, and under federal law, WASP pilots are only eligible for burial at cemeteries run by the Department of Veterans Affairs; and

WHEREAS, The WASPs were a distinct group of women; they test-flew repaired military aircraft, trained combat pilots, and towed airborne targets that other pilots fired at with live ammunition during training; and

WHEREAS, The WASPs are not asking for anything beyond what they earned; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the United States Army to reverse its decision and once again allow the Women Airforce Service Pilots to be buried in their rightful place at Arlington National Cemetery; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the United States Secretary of the Army.

HOUSE JOINT RESOLUTION 127

Offered by Representative Chapa LaVia:

WHEREAS, English Learners make up 10.3% of Illinois' student population; and

WHEREAS, Over the past two decades, the number of children in the United States living with immigrant parents grew 60% and accounted for 25% of children under the age of 18; and

WHEREAS, Immigrant families who speak a home language other than English should be considered to be powerful assets in their children's education and partners with a shared responsibility for student learning and achievement; and

WHEREAS, Research consistently demonstrates that family engagement is one of the most significant factors in supporting student academic success; and

WHEREAS, The State should help ensure that each school district is able to meet its obligations to provide equitable access for students and families of all linguistic backgrounds; and

WHEREAS, There are currently no professional certification standards for foreign language interpreters in public schools; and

WHEREAS, Developing a training and certification program and establishing minimum standards for individuals providing foreign language interpretation services in schools will help students reach their full academic potential; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Bilingual Advisory Task Force, created by House Joint Resolution 36 of the 99th General Assembly, shall also study the feasibility of professional certification standards for foreign language educational interpreters in public schools; and be it further

RESOLVED, That should the Task Force deem certification standards feasible, those certification standards shall help ensure that interpreters serving school districts have demonstrated the core competencies of fluency, methodology, and ethics of interpretation and translation; and be it further

RESOLVED, That if the Task Force determines that certification standards are needed, it shall recommend procedures for school districts pertaining to when and how to access a language interpreter; and be it further

RESOLVED, That the Task Force may examine the process for certifying educational interpreters for students and parents who are deaf and may recommend a similar process for foreign language interpreters; and be it further

RESOLVED, That two additional members shall be added to the Task Force, to be appointed by the State Superintendent of Education, one of whom shall be the president of a community college, and one of whom shall be an assistant principal in the Chicago public schools; and be it further

RESOLVED, That the Task Force's deadline for submitting its findings and recommendations to the Governor and General Assembly is changed from December 15, 2015 to December 15, 2016, in order to give the Task Force adequate time to complete its work; and be it further

RESOLVED, That a copy of this resolution shall be transmitted to the State Superintendent of Education.

HOUSE JOINT RESOLUTION 128

Offered by Representative Winger:

WHEREAS, The neighbors of O'Hare International Airport understand the importance of this airport to Illinois' economy and its supply of good jobs; and

WHEREAS, The neighbors of O'Hare want to take an active and friendly role in helping the airport deal actively with its many noise problems; and

WHEREAS, Among the sponsors of this resolution are individuals who have talked with representatives of the City of Chicago and who appreciate the work that the Chicago Department of Aviation is doing to improve the technology that it is investing on gathering noise pollution data and improving data communications and database technology to consolidate and store this data; and

WHEREAS, This is not the first time that Chicago has reached out to its "noise neighbors"; as part of its long-term expansion plans, Chicago and many of O'Hare International Airport's principal airlines have maintained multi-year voluntary noise abatement flight procedures, instituted in 1997 and continuously revised since then as the "O'Hare International Airport Fly Quiet Program"; and

WHEREAS, Compliance with the Fly Quiet Program is overseen by the O'Hare Noise Compatibility Commission, an intergovernmental agency that includes Cook County, 41 municipalities, and 16 school districts adjacent to and around O'Hare International Airport; and

WHEREAS, The voluntary flight procedures included in the Fly Quiet Program include approved, voluntary, recommended aircraft pathways for safe commercial jet takeoffs from O'Hare International Airport, effective from 10 P.M. to 7 A.M.; and

WHEREAS, The O'Hare Fly Quiet Program releases quarterly reports to measure compliance with the elements of the Program, including compliance by airlines and their pilots with approved runway departure flight paths; these reports show that, as of 2015, many aircraft departures currently deviate significantly from the approved "Fly Quiet" flight paths, thereby imposing noise pollution upon substantial areas of residences, schools, commercial and industrial structures, as well as property owners, whose properties are not sufficiently monitored for noise pollution and are not sufficiently mapped as impacted by aircraft noise; and

WHEREAS, The Fly Quiet report published by the Chicago Department of Aviation and covering the fourth quarter of calendar year 2014 showed massive partial compliance and noncompliance with Fly Quiet runway departure guidelines, with one runway departure point (22L) showing only 40% of aircraft departure flight paths being implemented so as to keep the aircraft within 0.5 nautical miles of the approved takeoff pathway, so that 60% of the planes during this time period, taking off from this runway location, applied engine power and climbed into the sky while the plane was located at least 0.5 nautical miles or more away from the approved pathway; and

WHEREAS, Above and beyond runway departure point 22L, other O'Hare International Airport runway departure points also showed significant patterns of partial compliance and non-compliance with Fly Quiet takeoff flight path guidelines in the fourth quarter of 2014; and

WHEREAS, Overall monitoring by the O'Hare Noise Compatibility Commission and others indicated that, in 2015, Fly Quiet voluntary guidelines were being adhered to in only 30% of total flights during nighttime hours; and

WHEREAS, These examples of partial compliance and noncompliance impose substantial financial and quality-of-life burdens upon the neighbors of O'Hare International Airport, including individuals and businesses that understand the importance of the airport and want to be good neighbors; and

WHEREAS, The airlines that operate at Chicago O'Hare International Airport also have many other interrelationships with the City of Chicago, the Federal Aviation Administration within the United States Department of Transportation, and many other entities; and

WHEREAS, These airlines include the use of a specified number of departure gates and related support facilities; access to these departure gates and these support facilities are essential assets for doing passenger and cargo business at O'Hare International Airport; access to support facilities is an essential asset for doing non-passenger cargo business at the same airport; and

WHEREAS, Whenever an airline changes hands, and under a wide variety of other circumstances, access to major airport departure gates and support facilities is closely looked at by the owner of the airport, the United States Department of Transportation, and many other stakeholders in the United States airline industry; and

WHEREAS, The O'Hare International Airport Fly Quiet Program should be elevated to the rank of an independent, autonomous stakeholder in any future decisions made by O'Hare International Airport and its partners that will affect future allocations of airport departure gates and support facilities; therefore, be it

RESOLVED, That we urge the Aviation Department of the City of Chicago to select a trusted third party that represents the interests of O'Hare International Airport's noise neighbors and to share the information enumerated in this resolution with this third party; such information-sharing should be carried out in a manner that does not violate the intellectual properties and executive status of secure information controlled by any significant stakeholders at the airport; and be it further

RESOLVED, That, as a part of this information sharing, we urge the Aviation Department and the trusted third party to collaborate to develop a rank-ordered chart of each airline firm's compliance with the guidelines contained in the O'Hare International Airport Fly Quiet Program; the chart should be public information and should be revised and republished not less than every 3 months on the same basis as the reports currently submitted by the Fly Quiet Program to the public; and be it further

RESOLVED, That these charts and the data from which these charts are generated should be given explicit and formal consideration as elements in any decisions made, subsequent to the start of the generation of this data and these charts, on the reallocation of departure gates and support facilities at O'Hare International Airport; and be it further

A petition shall have been signed by the petitioning electors not more than 150

days after an affidavit has been filed with the State Board of Elections providing notice of intent to circulate a petition to recall the Executive Branch officer or member of the General Assembly ~~Governor~~. The affidavit may be filed no sooner than 6 months after the beginning of the officer's or member's ~~Governor's~~ term of office. ~~The affidavit shall have been signed by the proponent of the recall petition, at least 20 members of the House of Representatives, and at least 10 members of the Senate, with no more than half of the signatures of members of each chamber from the same established political party.~~

(b) The form of the petition, circulation, and procedure for determining the validity and sufficiency of a petition shall be as provided by law. If the petition is valid and sufficient, the State Board of Elections shall certify the petition not more than 100 days after the date the petition was filed, and the question "Shall (name) be recalled from the office of (office) ~~Governor~~?" must be submitted to the electors at a special election called by the State Board of Elections, to occur not more than 100 days after certification of the petition. If the Governor is removed, then (i) an Acting Governor determined under subsection (a) of Section 6 of Article V shall serve until the Governor elected at the special successor election is qualified and (ii) the candidate who receives the highest number of votes in the special successor election is elected Governor for the balance of the term. (a) Electors may petition for the recall of an executive branch officer as identified in Section 1 of Article V, a member of the General Assembly, or an individual holding a local elected office, including, but not limited to, mayors, village presidents, council members, school board members, community college officials, and county officials. If the recall petition is valid, on a separate ballot the question "Shall (officer) be recalled from the office of (office)" must be submitted to the electors, along with the names of any candidates certified for the successor election, at a special election called by the State Board of Elections or at a regularly scheduled election to occur not more than 100 days after the date of certification of the recall petition. The officer or member subject to recall may be a candidate in the successor election. Because the Governor and Lieutenant Governor are elected jointly under Section 4 of Article V, a petition to recall either must include both.

(b) An executive branch officer as identified in Section 1 of Article V, a member of the General Assembly, or an individual holding a local elected office, including, but not limited to, mayors, village presidents, council members, school board members, community college officials, and county officials, is immediately removed upon certification of the recall election results if a majority of the electors voting on the question vote to recall the officer, member, or individual. In an election to recall the Governor and Lieutenant Governor, one vote shall be cast jointly for or against recall of both. If an officer, member, or individual is recalled, the candidate who receives the highest number of votes in the successor election is elected successor for the balance of the term. Once a recall election petition is certified, the petition may not be withdrawn and another recall petition may not be initiated against that officer or member during the remainder of his or her current term of office.

(c) Any elector of the State, the applicable Legislative or Representative District, or the applicable election unit may file an affidavit with the State Board of Elections providing notice of intent to circulate a petition to recall an officer, member, or individual no sooner than 6 months after the beginning of the current term of office of the officer, member, or individual. The affidavit must identify the name of the officer, member, or individual and the office to be recalled, the name and address of the proponents of the recall petition, and the date of filing with the State Board of Elections. A recall petition shall not be circulated prior to filing the affidavit, and a recall petition must be filed with the State Board of Elections no later than 160 days after filing the affidavit.

(d) A petition to recall an executive branch officer must include signatures of electors of the State equal to at least 12% of the total votes cast for the office in the election at which the officer was elected, with signatures equal to at least 1% of the vote for the office from at least 5 separate counties. A petition to recall a member of the General Assembly must be signed by electors of the respective Legislative District or Representative District equal to at least 20% of the total votes cast for the office in the election at which the member was elected. A petition to recall an individual holding a local elected office, including, but not limited to, mayors, village presidents, council members, school board members, community college officials, and county officials, must be signed by electors of the applicable election unit equal to at least 20% of the total votes cast for the office in the election at which the member was elected. The form, circulation, and manner of filing a recall petition shall comply with the requirements provided by law for a statewide advisory public question, except for the deadlines set forth in this Section.

(e) A recall petition is valid unless an objection is made within 45 days after the date the petition is filed, and an objection to the recall petition may be made in the same manner as to a candidate for the office subject to recall. The State Board of Elections shall certify the recall petition not more than 105 days after the date the recall petition is filed. Any recall petition or election pending on the date of the next general election at which a candidate for the office subject to recall is elected is moot.

(f) If a recall election is initiated, the name of no successor candidate may appear on the ballot unless a nominating petition has been filed with the State Board of Elections no more than 40 days after filing of the recall petition. The nominating petition of an established party candidate must contain the same number of signatures and be circulated in the same manner as an established party candidate for nomination to the office subject to recall, except the petition must be circulated no more than 40 days prior to the last day for filing

nomination petitions. The nominating petition of an independent or new party candidate must contain the same number of signatures and be circulated in the same manner as an independent or new party candidate, respectively, for election to the office subject to recall, except the petition must be circulated no more than 40 days prior to the last day for filing nomination petitions. A nominating petition may be objected to in the same manner as a candidate for the office subject to recall, unless otherwise provided by law. The State Board of Elections shall certify a valid nominating petition not more than 105 days after the date the recall petition is filed.

(g) An election to determine whether to recall an executive branch officer as identified in Section 1 of Article V, a member of the General Assembly, or an individual holding a local elected office, including, but not limited to, mayors, village presidents, council members, school board members, community college officials, and county officials, and to elect a successor shall be proclaimed by the State Board of Elections and held not less than 60 days and no more than 100 days after the date of certification of the recall petition.

(h) The provisions of this Section are self-executing and judicially enforceable.
