## HOUSE RESOLUTIONS

### HOUSE RESOLUTION 1014

Offered by Representative Ford:

WHEREAS, Every week in the United States, nearly 11 million children younger than age 5 are in some type of child care arrangement; on average, these children spend 36 hours a week in child care; and

WHEREAS, While parents are children's first and most important teachers, child care programs provide early learning opportunities for millions of young children daily, having a profound impact on their development and readiness for school; and

WHEREAS, Various studies have shown that children in higher quality programs do better in school, are less likely to require special education services, are more likely to attend college, are more likely to earn higher wages and pay more in taxes, and are less likely to be involved in the criminal justice system; and

WHEREAS, Employers consistently report that the availability of quality child care improves productivity and reduces absenteeism and turnover from their employees; and

WHEREAS, The Week of the Young Child, held on April 10-16, 2016, is an annual celebration sponsored by the National Association for the Education of Young Children to focus public attention on the needs of young children and their families and to recognize the early childhood programs and services that meet those needs; and

WHEREAS, It is fitting and proper for this body to pay tribute to those who provide much-needed care and attention to the children of this State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the second week of May of 2016 as Child Care Awareness Week in the State of Illinois and thank those men and women who care for the children of this State.

### HOUSE RESOLUTION 1015

Offered by Representative Bourne:

WHEREAS, The members of the Illinois House of Representatives, like all Americans, are heartbroken at the amount of senseless gun violence in the United States; and

WHEREAS, However, we do not believe the actions taken by President Obama address the root cause of gun violence, such as illegally obtained firearms; and

WHEREAS, Furthermore, we do not believe that the unilateral actions taken by President Obama provide an environment to begin a productive or collaborative discussion; and

WHEREAS, We are in agreement with the United States Supreme Court's decision in the case of the District of Columbia v. Heller, which confirmed that the Second Amendment protects an individual right to keep and bear firearms; we also agree with Justice Antonin Scalia that the Second Amendment ". . . elevates above all other interests the right of law-abiding, responsible citizens to use arms in defense of hearth and home"; and

WHEREAS, On January 5, 2016, the President announced a series of gun control actions in the form of executive orders during a press conference at the White House; and

WHEREAS, One executive order will increase the number of vendors who are required to conduct criminal background checks when they sell guns; and

WHEREAS, These executive orders will result in hiring more federal employees to handle those reviews and require dealers to inform federal authorities when a gun sold online is lost or stolen during transit; these executive orders on gun control will also affect many individuals by revoking licenses for dealers who do not sell a sufficient number of firearms; and

WHEREAS, This body will take every action to protect the Second Amendment rights of law-abiding citizens; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we pledge to uphold our oath of office to support the Constitution of the United States and the Constitution of the State of Illinois.

HOUSE RESOLUTION 1017

Offered by Representative Williams:

WHEREAS, The 2016 Theme of National Eating Disorders Awareness Week is "3 Minutes Can Save a Life", which will focus on the life-saving benefits of early detection and intervention; and

WHEREAS, Eating disorders are serious conditions that are potentially life-threatening and have a great impact on both a person's physical and emotional health; too often, signs and symptoms are overlooked, and many individuals, families, and communities are unaware of the devastating mental and physical consequences of eating disorders, as well as the pressures, attitudes, and behaviors which shape them; and

WHEREAS, In the United States, 20 million women and 10 million men suffer from clinically significant eating disorders at some time in their lives; these disorders affect people across all backgrounds and include anorexia nervosa, bulimia nervosa, and binge eating disorders; and

WHEREAS, The National Eating Disorders Association strives to address the many misconceptions regarding eating disorders, and to highlight the availability of resources for treatment and support; and

WHEREAS, National Eating Disorders Awareness Week is a collaborative effort consisting primarily of volunteers, including eating disorder professionals, health care providers, students, educators, social workers, and individuals committed to raising awareness of the dangers surrounding eating disorders and the need for early intervention and treatment access; and

WHEREAS, Eating disorders usually appear in adolescence and are associated with substantial psychological problems, including depression, substance abuse, and suicide; they are serious illnesses, not lifestyle choices; in fact, anorexia has the highest mortality rate of any mental illness; and

WHEREAS, Many cases of eating disorders go undetected; less than one-third of youth with eating disorders will receive treatment; and

WHEREAS, Eating disorders experts have found that prompt intensive treatment significantly improves the chances of recovery; therefore, it is important for educators, medical providers, parents, and community members to be aware of the warning signs and the symptoms of eating disorders; and

WHEREAS, National Eating Disorders Awareness Week will highlight the importance of screenings for the early detection and intervention of eating disorders; intervening during the early stages of development can significantly increase the likelihood of preventing the onset of a full-blown eating disorder and lead to greater chances of a full recovery; and

WHEREAS, The members of this body recognize the vital work of National Eating Disorders Awareness Week in promoting public and media attention to the seriousness of eating disorders and for working to improve education about their biological and environmental causes, as well as how to help those who are struggling with these debilitating diseases; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the week of February 21-27, 2016 as Eating Disorders Awareness Week in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the National Eating Disorders Association.

HOUSE RESOLUTION 1018

Offered by Representative Bill Mitchell:

WHEREAS, A recent study by the Mayo Clinic found that 7 of every 10 Americans currently take at least one prescription medication; and

WHEREAS, The State of Illinois has a population of approximately 12.8 million, which equates to nearly 9 million Illinois citizens taking prescription drugs; and

WHEREAS, The number of people who take prescription drugs has risen by 5% in recent years; and



WHEREAS, According to Express Scripts, average prices for brand name prescription drugs have risen 128% in recent years; and

WHEREAS, The only 2 countries in the world that allow for direct-to-consumer advertising of prescription drugs are the United States and New Zealand; and

WHEREAS, A recent study found that drug makers have spent \$4.5 billion in the last 2 years on advertising prescription drugs, representing a 30% increase in marketing; and

WHEREAS, There is anecdotal evidence that increased marketing of brand name prescription drugs results in patients requesting expensive and unnecessary prescriptions, leading to increased health-care costs; and

WHEREAS, At a recent meeting, the American Medical Association adopted a policy seeking to ban direct-to-consumer advertising of prescription drugs given its concern with proliferation of expensive treatments and escalating drug prices; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to adopt legislation banning direct-to-consumer advertising of prescription drugs; and be it further

RESOLVED, That we urge the United States Food and Drug Administration to adopt appropriate rules and regulations banning direct-to-consumer advertising of prescription drugs; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the members of the Illinois congressional delegation, the United States Food and Drug Administration, and the American Medical Association.

#### HOUSE JOINT RESOLUTION 130

Offered by Representative Tryon:

WHEREAS, On June 12, 2010, Governor Pat Quinn signed the Veterans and Servicemembers Court Treatment Act into law; the Act allows counties in Illinois to create a Veterans and Servicemembers Court Program or Veterans Treatment Courts for military veterans charged with non-violent crimes; and

WHEREAS, Currently, Cook, DuPage, Lake, Madison, Peoria, Will, Winnebago, and several other counties have Veterans Treatment Courts to assist veterans with substance abuse and other related problems; and

WHEREAS, Many returning veterans suffer from Post-Traumatic Stress Disorder, traumatic brain injuries, substance abuse, and other service-related disabilities; and

WHEREAS, Veterans Treatment Courts are used as an alternative venue to the regular criminal justice system for non-violent criminal offenses; the courts connect veterans with specialized treatment and counseling programs to assist them with transitioning to life after their military service; and

WHEREAS, Veterans Treatment Courts require regular court appearances in addition to mandatory attendance at treatment sessions for substance abuse as well as random testing for substance use; and

WHEREAS, Upon successful completion of the program, the charges against the veteran may be dismissed; and

WHEREAS, Veterans Treatment Courts are in a unique position to link veterans with additional services and resources available to them; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we encourage the creation of Veterans and Servicemembers Treatment Courts in all counties in the State of Illinois; and be it further

RESOLVED, That we urge counties that currently have successful programs to work with other counties to help create successful programs and provide assistance in implementation to better serve our veterans in every county; and be it further

RESOLVED, That suitable copies of this resolution be presented to the County Board Chair or President of all 102 Illinois counties.
