### **HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

#### **HOUSE RESOLUTION 1185**

Offered by Representative Fortner:

WHEREAS, In the case of National Bellas Hess, Inc. v. Department of Revenue, 386 U.S. 753 (1967), the United States Supreme Court held, in relevant part, that Congress alone has the power to regulate and control the taxation of commerce, which is conducted between a business that is located within one state, and a customer who is located in another state and who communicates with and purchases from the business using only remote means; and



WHEREAS, The United States Supreme Court established in *Quill Corp. v. North Dakota*, 504 U.S. 298 (1992), that a state government cannot, of its own accord, require out-of-state retailers to collect sales tax on sales within the state; and

WHEREAS, The United States Supreme Court also announced in *Quill* that Congress could exercise its authority under the Commerce Clause of the United States Constitution to decide whether, when and to what extent the states may require collection of sales tax on remote sales; and

WHEREAS, The State of Illinois and municipalities within this State receive significant operating revenue from sales taxes collected by brick-and-mortar businesses and online vendors with a nexus to the State and from use taxes on purchases made online through vendors without a brick-and-mortar location in the State; and

WHEREAS, The tax collection loophole for online retailers deprives local governments of revenue that could be used to fund necessities such as schools, police and fire departments, and other important infrastructure; and

WHEREAS, The Marketplace Fairness Act, S. 698, 114th Cong. (2015), and subsequently the Remote Transactions Parity Act, H.R. 2775, 114th Cong. (2015) proposes to provide states with the authority to require out-of-state retailers, such as online and catalog retailers, to collect and remit sales tax on purchases shipped into the state; and

WHEREAS, The State of Illinois has enacted the Simplified Sales and Use Tax Administration Act, 35 ILCS 171, which is in compliance with the Marketplace Fairness Act, S. 698, 114th Cong. (2015); and

WHEREAS, Since 1999, various state legislators, governors, local elected officials, state tax administrators, and representatives of the private sector have worked together to develop standards, protocols, and tax systems that mitigate the burdens addressed in *Quill Corp. v. North Dakota*; and

WHEREAS, Between 2001 and 2002, 40 states enacted legislation expressing their intent to simplify their sales and use tax collection systems and to participate in discussions to allow for the collection of state sales and use taxes; and

WHEREAS, 24 states have joined the Streamlined Sales and Use Tax Agreement and have refined their state laws accordingly; and

WHEREAS, The end consumer is responsible for paying the statutorily due sales and use tax and the retailer is the state-appointed collector of sales and use tax; and

WHEREAS, The enactment of legislation by Congress that allows states to require remote sellers to collect state sales and use taxes is necessary to treat all sales transactions the same regardless of whether they are done by an in-state, remote, or online retailer; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to pass, without delay, the Remote Transactions Parity Act of 2015, which provides for the fair, uniform, simplified, and constitutional administration of and collection of state and local sales and use taxes due; and be it further

RESOLVED, That suitable copies of this resolution be sent to the Majority Leader of the United States Senate, the Speaker of the United States House of Representatives, the Chair and Co-Chair of the Senate Finance Committee, the Chair and Co-Chair of the House Judiciary Committee, and all members of Illinois Congressional Delegation.

Offered by Representative Anthony:

WHEREAS, The members of the Illinois House of Representatives recognize foster youth and alumni as one of the State's most precious, valuable, and vulnerable citizens; and

WHEREAS, The mission of the Foster Care Alumni of America is to connect the alumni community and to transform policy and practice, ensuring opportunity for people in and from foster care and seeks to serve and act on behalf of the rights, needs, and well-being of current and former foster youth; and

WHEREAS, The Foster Care Alumni of America has 17 State Chapters; Illinois is the state affiliate of the National Foster Care Alumni of America; FCAA-IL has members around the State dedicated to the same mission; and

WHEREAS, The Illinois Department of Children and Family Services protect children who are reported to be abused or neglected and to increase their families' capacity to safely care for them and provide for the well-being of children in its care; provide appropriate and permanent families as quickly as possible for those

children who cannot safely return home; support early intervention and child abuse prevention activities; and work in partnerships with communities to fulfill this mission; and

WHEREAS, The Illinois Department of Children and Family Services includes a Statewide Youth Advisory Board whose mission is to advocate and educate all youth in care; the Statewide Youth Advisory Board is committed to youth empowerment, development, leadership, and achievement across the State of Illinois; and

WHEREAS, FCAA-IL, working together with the Department of Children and Family Services and their Statewide Youth Advisory Board, are proud to host the first Annual Illinois Foster Youth and Alumni Legislative Shadow Day on May 4, 2016; and

WHEREAS, The purpose of this day is to connect current and former foster children with a State legislator to educate them on the legislative process and spend their day mentoring them, help reshape the impression of who youth in foster care and alumni of foster care are, and connect legislators to the youth that they impact directly and indirectly; and

WHEREAS, The actions of FCAA-IL Illinois Chapter founding members April Curtis, Jeremy Harvey, and James McIntyre, DCFS Director George Sheldon, and current and former DCFS Statewide Youth Advisory Board members represent shining examples of those in our communities doing positive things for foster children, past and present, and are responsible for the creation of the first Annual Illinois Foster Youth and Alumni Legislative Shadow Day; therefore, be it
