**SENATE BILLS ON SECOND READING**

Having been reproduced, the following bills were taken up, read by title a second time and held on the order of Second Reading: SENATE BILLS 550, 586 and 2950.

**INTRODUCTION AND FIRST READING OF BILLS**

The following bill was introduced, read by title a first time, ordered reproduced and placed in the Committee on Rules:

HOUSE BILL 6630. Introduced by Representative Batinick, AN ACT concerning revenue.

**HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

**HOUSE RESOLUTION 1508**

Offered by Representative Cassidy:

WHEREAS, The proposed Dakota Access Pipeline (DAPL) is a 1,172-mile pipeline being developed by Energy Transfer Partners and its affiliates, which would carry approximately 450,000 barrels of crude per day from the Bakken oil fields through North Dakota, South Dakota, Iowa, and Illinois, where it would connect with a second pipeline being converted to carry much of the oil to refineries and export facilities on the Gulf Coast of Texas; and

WHEREAS, The DAPL would cross under the Missouri River at Lake Oahe, which provides drinking water to the Standing Rock Sioux tribe, as well as under or through the Mississippi, Illinois, and Kaskaskia Rivers, multiple community water supply lake watersheds, and community water supply zone river intake one protection areas in Illinois; and

WHEREAS, The Missouri, Illinois, and Mississippi Rivers irrigate agricultural land in communities across the Midwest, serving nearly 10 million people; and

WHEREAS, The DAPL would also run through the ancestral lands and waters reserved for the traditional use of the Standing Rock Sioux Tribe by the Fort Laramie Treaty of 1851, including the Missouri River, burial grounds and gravesites, and other sacred sites of cultural, religious, and historical significance; and

WHEREAS, Treaties with American Indians, such as the Fort Laramie Treaty are recognized by the United States Constitution as "the supreme law of the land", and require consultation and cooperation by the United States with its Indian treaty partner before any federal action is taken that affects treaty lands, territories, waters, or other resources; and

WHEREAS, The American Indian Religious Freedom Act of 1978 affirms the need to "protect and preserve for American Indians their inherent right of freedom to believe, express, and exercise the traditional religions", particularly in American Indian sacred places; and

WHEREAS, The State of Illinois recognizes through 17 Ill. Adm. Code 4170.100 "that all human burials and human skeletal remains be accorded equal treatment and respect for human dignity without reference to ethnic origins, cultural background, or religious affiliation. These regulations apply to all prehistoric and historic American Indian, historic Illinoisan, pioneer, Civil War and other human skeletal remains found in unregistered graves, and associated grave artifacts and grave markers found upon or within any public or private land in the State"; and

WHEREAS, Articles, 11, 12, and 25 of the United Nations Declaration on the Rights of Indigenous People (UNDRIP), as endorsed by the United States in 2010, affirms that indigenous peoples like the Standing Rock Sioux Tribe possess the right to maintain and protect their culture, religion, practices, and relationship with their "traditionally owned or otherwise occupied and used lands, territories [and] waters"; and

WHEREAS, Article 32 further provides that governments shall consult with indigenous peoples "in order to obtain their free and informed consent prior to the approval of any project affecting their lands or territories and other resources, particularly in connection with the development, utilization or exploitation of mineral, water, or other resources"; and

WHEREAS, The Illinois Human Rights Act "prohibits discrimination in Illinois with respect to employment, financial credit, public accommodations, and real estate transactions on the basis of race, color, religion, sex (including sexual harassment), national origin, ancestry"; and

WHEREAS, The history of governmental actions in the United States with respect to American Indians makes it imperative that existing treaty and statutory obligations securing American Indian rights be strictly observed; and

WHEREAS, The United States Army Corps of Engineers failed to consult with or obtain the free, prior, and informed consent of the Standing Rock Sioux Tribe as required by the Treaty of Fort Laramie, Executive Order 13175, UNDRIP Article 10, and other federal and international laws, before issuing a "Mitigated Finding of No Significant Impact" that would result in an easement for horizontal directional drilling for the DAPL; and

WHEREAS, Any spill from the pipeline into the Missouri River would irreparably harm the Standing Rock Sioux Tribe's treaty reserved lands, territories, waters, and other resources; burial grounds, gravesites, and other sacred sites of cultural, religious, and historical significance; and spiritual relationships and indigenous ways of life; and

WHEREAS, According to the Prairie Rivers Network, the DAPL would put the water supply of 27,382 people at risk in Illinois and it would cross at least 56 named rivers in the State; and

WHEREAS, The Mayor and City Council of Urbana; the Mayor of the City of Seattle; the City Councils of Portland, Oregon; St. Paul and Minneapolis, Minnesota; Affiliated Tribes of Northwest Indians, comprised of 59 Indian Nations in the Northwest; and nearly 200 Indian Nations, are among the governmental bodies that have taken formal action to support the Standing Rock Sioux Tribe and oppose the DAPL; therefore, be it

RESOLVED, That the State of Illinois is urged not to expend any resources to support this pipeline or actions against the protesters.

WHEREAS, In February of 1946, the academic classes returned with the Navy officially "handing back the keys" to the school on April 30, 1946; 1946 also saw the admittance of the first women to the school; CVCA/ CVS started offering night courses to help returning veterans; and

WHEREAS, The Navy left behind an aircraft hangar, and a small number of aircraft; the school continued to teach aviation maintenance until 1995; and

WHEREAS, Notable alumni of CVCA/ CVS include author and radio host, Michael Baisden; rap artist, Yung Berg; former Chicago Bears linebacker, Dick Butkus; CEO of LM Capital Corporation, Leslie M. Corley; former MLB player, Lou Collier; former MLB player, Marvin Freeman; court reporter, Teri C. Gibson; comedian, Robert L. Hines; former minor league baseball player, DeMarlo Hale; former NBA player, Juwan Howard; comedian, Bernie Mac; former NFL player, Keena Turner; former Chicago Bears linebacker, Chris Zorich; Director of White House Political Affairs and Director of White House Office of Public Liaison under President Clinton, Minyon Moore; and former Illinois State Representative for the 75th District, John Anthony; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the 75th anniversary of the founding of the Chicago Vocational Career Academy; and be it further

RESOLVED, That we declare December 15, 2016 as CVCA/ CVS Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to CVCA/ CVS as an expression of our esteem and respect.

#### HOUSE RESOLUTION 1512

Offered by Representative Walsh:

WHEREAS, According to the Centers for Disease Control and Prevention, motor vehicle crashes are a leading cause of death in the United States; in 2014, more than 33,700 people died from motor vehicle crashes; for every death there are devastating injuries and costly emergency room visits; and

WHEREAS, Drivers on the corridor of I-80 between the exit to I-55 in Joliet and the exit to Route 30 New Lenox, suffer high rates of congestion; the corridor has witnessed a total of eight fatalities and 1456 crashes since 2011; and

WHEREAS, These traffic accidents and the resulting injuries and deaths are tragedies for the families and communities of the victims involved, and for the people of Illinois; and

WHEREAS, The Illinois Department of Transportation is administering a study of I-80 from Ridge Road to US Route 30 in preparation for the reconstruction of I-80 structures in that corridor; the reconstruction may not occur for several years; and

WHEREAS, Motorists would be safer and would take more precautions while driving if they had advance knowledge of the congestion and dangers associated with the abovementioned corridor along I-80; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Department of Transportation to erect signage notifying motorists of congestion and possible dangers along Interstate 80 between the exit to I-55 in Joliet and Route 30; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Secretary of Illinois Department of Transportation and the Mayor of the City of Joliet.
