Now, we've seen the Senate work hard... it may succeed, it may fail... but I don't think we should be relying on the Senate to do anything. What we need to be doing is working on our budget now. And I will tell you, I have had many conversations with people. Some people believe that we can do this without revenue. And that may be true. I think mathematically it is possible. I've also spoken with people who believe that we can do this without reforms. And I suppose in theory that's might be possible too. But there are three numbers that matter, Ladies and Gentleman, 60, 30, and 1. And my question for both sides of that equation is: Do you have the votes? If you do, great, run it. If you don't, and I suspect the answer on both sides is, they don't, then we need to compromise. Compromise requires conversation. And I'm concerned that we're not having that conversation. So, please, I beg you on behalf of the people of the State of Illinois, let's start talking. Let's work together in the spirit of compromise, so that we can get that done. Thank you very much, Mr. Speaker."

Fortner: Thank you, Speaker, Members of the House. We learned last December that the state between 20... summer of 2013, the summer of 2016 lost population each of those three years. Last week, the census released its equivalent data at the county level. And I took some time to go through it and it tells a story that I think deserves our attention. We know that for decades parts of rural Illinois have lost population, indeed, that still continues. What's more alarming is that what used to be some of our growth areas in downstate Illinois: areas like Bloomington-Normal, areas like Peoria, and even here in Springfield, those areas since the last 3 years have each in their counties lost over a thousand people. That's a decline that can't be ignored. Now, we also would typically rely on the suburbs to make up the difference, but we're seeing problems there too. DuPage County also has lost over a thousand people in the same 3 year period. And Lake County has lost population. McHenry County has been virtually flat. Only Kane, Kendall, and Will have been still exhibiting any growth. In fact, if you ask for counties that have grown adding least 100 people or more there are only eight such counties over the last three years. I want to echo some of the concerns raised by my colleague from Kane County that these are deep structural problems that I think do deserve serious debate. We need to be discussing things like the

budget and other techniques that are going to turn around what is a disturbing long-term trend, that, frankly, if you ask why is our revenue falling short of estimation when we've heard those numbers come out. I think that this data, breaking it down by counties, showing where the losses are. And did I mention Cook County alone over those three years has lost more than 36 thousand people. We need to address these concerns and I would ask this Body to seriously take them up. Thank you, Speaker."

Speaker Turner: "Representative Barbara Wheeler is recognized."

Wheeler, B.: "Thank you, Mr. Speaker. Point of personal privilege."

Speaker Turner: "Please proceed, Representative."

Wheeler, B.: "Thank you. I would like to reiterate the points of my colleagues, Representative Steve Andersson and Representative Mike Fortner. I know there isn't a single person in this Body that isn't willing and wanting to move forward on a budget, and do what's right for the State of Illinois. The five years that I've been participating in this Body so often we've been the Party of 'no'. But we can't be the Party of 'no' anymore. This Body can't linger in doing nothing. We must move forward. So I commit to both Parties, to both caucuses that we are no longer the Party of 'no'. We are now the party of 'Let's go'."
