- Fortner: "Thank you, Speaker, Members of the House. House Bill 3396 expands the definition of a qualified eligible utility within the Municipal Code. When we wrote it originally, we were thinking only just in terms of those producing power. This expands it to those who own shares or other types of contracts in power production, allows them to trade on the wholesale level. I'd be happy to answer any questions."
- Speaker Lang: "Those in favor of the Gentleman's Bill will vote 'yes'; opposed 'no'. The voting is open. Have all voted who

wish? Have all voted who wish? Mr. Clerk, please take the record. On this question, there are 112 voting 'yes'; 0 voting 'no'. And this Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 3083, Representative Hernandez. Out of the record. House Bill 3163, Representative Manley. Out of the record. House Bill 2449, Mr. Reick. Please read the Bill."

Clerk Hollman: "House Bill 2449, a Bill for an Act concerning veterans. Third Reading of this House Bill."

Speaker Lang: "Mr. Reick."

Reick: "Thank you, Mr. Speaker. I stand to offer House Bill 2449 which amends the Illinois Service Member Civil Relief Act. Providing for additional exemptions for service members who are sent to active duty or are redeployed for a period of 90 days, allowing them to relieve themselves, to terminate or suspend certain contracts that they've entered into."

Speaker Lang: "Mr. Andersson."

Andersson: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Andersson: "Is this your first Bill?"

Reick: "I believe it is, Sir."

Andersson: "Congratulations. You know, Representative Severin isn't... doesn't appear to be at his desk. And I'm sure he'd only ask one question which is, are you nervous?"

Reick: "Sir, I am in the company of friends and how can one be nervous in the company of friends who have... who have embraced me, who have enfolded me in their warm embrace. Nervous? Nay, nay, a thousand times nay."

Andersson: "Well said."

Speaker Lang: "Nay, nay. Those in favor of the Gentleman's Bill will vote 'yes'; opposed 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? McCombie. Please take the record. On this question, there are 111 voting 'yes', 0 voting 'no'. And this Bill, having received the Constitutional Majority, is hereby declared passed. Congratulations, Representative. House Bill 2462, Representative Moeller. Representative Moeller. Out of the record. House Bill 3172, Mr. Sauer. Please read the Bill."

Clerk Hollman: "House Bill 3172, a Bill for an Act concerning transportation. Third Reading of this House Bill."

Speaker Lang: "Mr. Sauer."

Sauer: "Thank you, Mr. Speaker. House Bill 3172 is a change to the Illinois Vehicle Code. It amends our Code. Right now, we have vehicle safety tests for our trucking industry every six months and it changes it to once a year which is the same as our federal standard, as well as the majority of states. And I'm open to any questions."

Speaker Lang: "Those in favor of the Gentleman's Bill will vote 'yes'; opposed 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Please record yourselves. Feigenholtz, Moeller, Nekritz, Yingling. Please record yourselves. Mr. Clerk, please take the record. On this question, there 96 voting 'yes', 14 voting 'no'. And this Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 2990, Mr. Slaughter. Out of the record. House Bill 3033, Mr. Skillicorn. Please read the Bill."

Clerk Hollman: "House Bill 3033, a Bill for an Act concerning State Government. Third Reading of this House Bill."

Speaker Lang: "Mr. Skillicorn."

Skillicorn: "This is a very simple measure. It just adds two simple words, 'up to' instead of 'shall'. It's a measure from the DNR and what it allowed them to do is to lower a fee that they currently have very low compliance on collecting right now. So, they actually expect to raise revenues from about \$150 thousand a year to half a million dollars a year just by changing the words and implementing this sliding scale for these fees. So, I urge an 'aye' vote for this. And I welcome any questions."

Speaker Lang: "Mr. Davis."

Davis, W.: "Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Davis, W.: "So, you just indicated that they would raise revenue.

For what purpose?"

Skillicorn: "So, right now they offer this as a... DNR says this...

Bill says... current law is that they 'shall' charge a \$500 fee
for inspections. Right now they do not have enough staff to
get 100 percent compliance. So, there's very, very little
compliance. And what they want to do is implement a sliding
scale of these inspections so that now people will have a
higher... there'll be a higher compliance and they will collect
something versus nothing."

Davis, W.: "Who does the inspection?"

Skillicorn: "DNR but they... because they are so understaffed, they do not do quite a few of these inspections."

Davis, W.: "So, how does..."

- Skillicorn: "They... basically, it's on paperwork. So, like a local municipality might have a situation where they do an inspection and they charge, but they have a license. Well, we would probably yell and scream if they say, hey, we want... you want to have this license and be charged for it but then they don't do the inspection. It's just a simple paperwork. This is a situation where the amount charged should reflect the amount of work DNR puts into it."
- Davis, W.: "Well, but you said we're going to change to a sliding scale fee and you think that that will invoke greater compliance. If the paperwork process is still the issue before, then how does charging less or more make more compliant?"
- Skillicorn: "So, right now, there is compliance where people are not applying for this. They're not paying any fee; they're not doing any paperwork. This should bring more individuals and this is about breaking ground into compliance. Again, it's a measure from DNR. And they believe that this will streamline things for them, but also, it would... create... have higher revenue because of the higher compliance of people actually filling out the forms and actually paying something versus nothing."
- Davis, W.: "So, are... are individuals, organizations, companies supposed to be doing this?"
- Skillicorn: "Can you repeat that?"
- Davis, W.: "So, right now, they're supposed to be doing this and they're not doing it?"
- Skillicorn: "That is correct."

- Davis, W.: "And you think by making it cost less means that more will do it?"
- Skillicorn: "That is correct."
- Davis, W.: "That doesn't sound right. How does charging less make more people want to do it? If... if they have to do it and they're not doing it, then how does charging less to do it make them now want to do it more?"
- Skillicorn: "So, right now, the companies and individuals that are breaking ground don't see a value in paying the \$500 because they're not getting an inspection and DNR does not force them to comply because they're understaffed."
- Davis, W.: "But you said breaking ground. So, they're building stuff absent of State Law that says they're supposed to have this inspection prior to breaking ground?"
- Skillicorn: "I would not say that they're building stuff. It could be much more routine than that. And that's why the... DNR wants a sliding scale. So, there's situations like, do you need to do an inspection? But there's also situations where it's mundane and if they don't need to do it and they're understaffed to do it."
- Davis, W.: "Well, I mean, I guess the Bill will probably pass, for whatever reason, but it just seems like what you're saying doesn't mesh right. That if you have a fee, in order for that to happen, you're saying that if we have a sliding scale... So, let me then ask this. So, is the top of the scale still 500 or does..."

Skillicorn: "Yes, it's..."

Davis, W.: "...it go higher than that?"

Skillicorn: "...it's up to \$500."

- Davis, W.: "Up to."
- Skillicorn: "Five hundred dollars is the maximum they can charge and that is unchanged."
- Davis, W.: "That's the maximum that can be charged. So, you're saying if we have a sliding scale, which means that you have lesser amounts than the 500, somehow or another that's supposed to encourage somebody who claim that they're not doing it anyway..."
- Skillicorn: "So, it comes down..."
- Davis, W.: "...to actually do it. Because if I heard you correctly, you said that because of lack of personnel is the reason why the inspections are not taking place. So, how does this..."
- Skillicorn: "That is when..."
- Davis, W.: "...so, is this going to increase the amount of personnel? So, you're going to charge less, less money being charged to do this will somehow translate into DNR being able to hire more people so that we can get more inspections done?"
- Skillicorn: "So, the intent is for a lower fee for the mundane, routine paperwork. So right now, compliance is very low because it's \$500. It's rather expensive and people don't think they're getting a value for it. And what this will do is encourage people to actually go through the routine paperwork instead of going around DNR."
- Davis, W.: "Okay. I apologize, Representative. Maybe there is something that you're really trying to accomplish there. It doesn't seem to make any sense to me how charging less money to do something, that they're supposed to do anyway but charging less to do it, encourages someone to do it. I

apologize. I'm not quite understanding that. So, thank you very much for answering my questions."

Skillicorn: "Thank you, Sir."

Speaker Lang: "Mr. Batinick."

Batinick: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Batinick: "I'm confused. Is this a fee decrease or a fee increase?

'Cause you say you're decreasing the fees, but you're increasing revenues."

Skillicorn: "It is a fee decrease. So, just like in the tax world when you have something and you want to have less of it, you tax it. In this situation, we want to encourage people to work with DNR; we want to encourage people to build in Illinois, so we're decreasing this fee."

Batinick: "Same thing. You're saying, some of the people were just avoiding the fee previously?"

Skillicorn: "That is correct."

Batinick: "Okay. So, they were paying zero before?"

Skillicorn: "That is correct."

Batinick: "Okay. Thank you."

Speaker Lang: "Representative Nekritz."

Nekritz: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Nekritz: "Representative, you offer a lot of projections... DNR offers a lot of projections about how this might work out. What are... would you consider a sunset on this so that we can actually be forced to look at... at an ana... and analyze what the impact of this has been?"

Skillicorn: "What I would suggest is, if this Legislature thinks that it's not working in the future that we, again, amend it. It seems like a rather common sense situation. If we're not offering a service, if we're not offering a physical inspection of the location, I don't see the... a great need to charge \$500. I think that's a fair amount of money. Whereas a, you know, a 50 or 100 dollar application fee might be a better alternative and DNR has... that's their intent, is that they would have a sliding scale to basically... the amount of work involved, the amount of administrative work involved would reflect in that sliding scale."

Nekritz: "Well, I appreciate that, but again, it's based on a lot of speculation and a lot of predictions that there's no data or evidence to support. And I would suggest that a sunset to require the Legislature to come back and take a look at that and have oversight over the Executive Branch might be... might be the best solution to all those questions. Thank you."

Speaker Lang: "We still have five people wishing to speak on this Bill. Ladies and Gentlemen, there are lots and lots of Bills on the Calendar. It would be good if we showed some restraint. Representative Willis is recognized."

Willis: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Lang: "Sponsor yields."

Willis: "Aren't you concerned about what is going to be the overall effect if we're basically saying it's okay to lie to DNR about checking for endangered species when you're going and building in... in these areas? 'Cause that's basically what's going to happen. If we're having people lie and there's no repercussions and now you're lowing the fee, what makes

people... if they never had a repercussion before when they lied and they're effecting endangered species in an... in a wetland or whatever it may be, wouldn't it make more sense to put more of a penalty on for not going through with that?"

Skillicorn: "I would be more than happy to discuss a penalty in another Bill. This just helps with compliance."

Willis: "Okay. I just feel that I think we're going about it the wrong way. The whole idea behind DNR coming out is to make sure that we are protecting the environment and those endangered species that are there. So, I would urge a 'no' vote on this."

Speaker Lang: "Mr. Thapedi."

Thapedi: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Thapedi: "Representative, I want to get a little clarification too 'cause I'm a little confused as well. And it indicates actually in the existing law that all of the fees that are derived from these types of consultation fees are deposited into the Illinois Wildlife Preservation Fund. Is that accurate?"

Skillicorn: "It appears so. Correct."

Thapedi: "How much is in that fund right now?"

Skillicorn: "The total amount in that fund?"

Thapedi: "Yes."

Skillicorn: "I'd have a hard time commenting on that."

Thapedi: "You have a hard time commenting on that?"

Skillicorn: "I would not be able to answer that at this time."

Thapedi: "You don't know?"

Skillicorn: "That is correct."

Thapedi: "Okay. So, the fees that you are tinkering with, it's 'up to' \$500, correct?"

Skillicorn: "Yes."

Thapedi: "So, that means then that the department could charge one person a dollar for consultations and they could charge another person \$500 for a consultation, right?"

Skillicorn: "If you're insinuating that certain individuals will get special treatment, that is not the case. It is the type of request they're looking for. If it includes a physical inspection or is it just a rubber stamp permit, it depends on how much administrative work is required to go ahead."

Thapedi: "I'm not insinuating anything. I'm just trying to understand your Bill. So, what you just described is different scenarios in which the Department may or may not charge a dollar certain for that particular service. Is that what you're saying?"

Skillicorn: "Yes. It's based on the administrative costs."

Thapedi: "Okay. So, why is that not in the Bill though?"

Skillicorn: "In my discussions with DNR, they were very clear that on the sliding scale... even though this Bill doesn't actually say that 'cause the Bill is very simple. It just adds the words 'up to'."

Thapedi: "And I understand that. I understand that."

Skillicorn: "The intent is that... to charge a certain amount of money per administration fees and it's going to be a sliding scale based on a very simple... if it's just going to be a simple license or if they actually have to go out to the location which would be the highest cost."

- Thapedi: "So, what does that mean? If it's a simple license, it costs \$1? If it requires some land survey, it's \$50? If it requires a full-blown analysis, it's \$500? How is that actually going to work?"
- Skillicorn: "So, I'm not going put numbers in their mouths or words in their mouths, but..."
- Thapedi: "But this is about legislative..."
- Skillicorn: "...but again, in a sense, what you're expressing is...
 is somewhat correct. I just can't quantify those dollar
 amounts."
- Thapedi: "Okay. So, would you like to take it out of the record so that you can quantify those amounts?"
- Skillicorn: "I think... I think that change is a good thing. DNR believes that they're going to make... they're going to have more revenue because of this and we're lowering fees for everyday Illinoisans."
- Thapedi: "And I don't dispute that, Representative. Please don't misunderstand what I'm saying. I don't dispute what you're saying, but it seems to me that the Bill is incomplete at this point. Is that if you're unable to articulate what the legislative intent is behind the sliding scale as to how it will work, I think that the Bill, in and of itself, is vague. Wouldn't you agree?"
- Skillicorn: "I think I've been very clear about expressing what DNR's intent is that they are going to have a sliding scale based on the administrative costs."
- Thapedi: "Okay. So, when you talk about a sliding scale, and I'm going to wrap up now, Mr. Speaker. On the sliding scale, how

- many different dollar amounts can DNR charge for different types of consultations on this sliding scale from \$1 to \$500?"
- Skillicorn: "They have not discussed that specific question with me."
- Thapedi: "But isn't that relevant? Shouldn't that be in the statute?"
- Skillicorn: "That wasn't their intent to moving it forward."
- Thapedi: "Okay."
- Skillicorn: "I'm sorry. That wasn't their intent in my discussions. And my intent was to give them... give them those options instead of us regulating every detail of this."
- Thapedi: "So, you would agree with me then that there's still more work to be done on this Bill. Is that a yes?"
- Skillicorn: "What I'll... what I'll do is, how about this. What I'll do is I'll take this back to DNR and I'll get more information and I'll answer those questions about the sliding scale and what those dollar amounts are going to be for specific tasks."
- Thapedi: "All right. I appreciate that. So, I'm assuming then what you're saying is that you're going take the Bill out of the record now; you're going to go back to DNR; you're going to get that clarification as to how this sliding scale will work. And then you're going to come back to the House with those answers. Am I accurate?"
- Skillicorn: "That sounds like an excellent suggestion. I will do that."
- Thapedi: "Thank you."
- Speaker Lang: "The Bill will be taken from the record. House Bill 3248, Representative Winger. Please read the Bill."

Clerk Hollman: "House Bill 3248, a Bill for an Act concerning safety. Third Reading of this House Bill."

Speaker Lang: "Representative Winger."

Winger: "Thank you, Mr. Speaker. House Bill 3248 calls for the IEPA with assistance from IDOT to study the environmental effects of O'Hare expansion as it relates to air pollution, noise pollution and emission... and emissions, gasses and fluids. Due to ongoing expansion of O'Hare Airport runways, the creation of noise and other effects is not fully understood. And what this does is, it calls for the report to be given by October 31, 2019. This Bill does have bipartisan support. I urge an 'aye' vote."

Speaker Lang: "Those in favor of the Lady's Bill will vote 'yes'; opposed 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Ammons, Chapa LaVia. Chapa LaVia. Please take the record. There are 111 voting 'yes', 1 voting 'present'. And this Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 270, Representative Wallace. Out of the record. House Bill 732, Mr. Burke. Please read the Bill."

Clerk Hollman: "House Bill 732, a Bill for an Act concerning regulation. Third Reading of this House Bill."

Speaker Lang: "Mr. Burke."

Burke, D.: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 732 is aimed at protecting the workers and occupants of commercial and industrial buildings. This Bill was an initiative of the Home Builders Association. And it would add a definition of roof repair to the current Roofing Industry Licensing Act so it is consistent with the

International Building Code. Clarifies the exemption that employees of a building owner can still perform roof repair without a license, but a license would be required for more dangerous techniques, for fire safety, liability, workers' comp issues, and those related to OSHA violations. For those that were in the committee, you heard from the Fire Marshal of Springfield that this is an initiative that is very necessary for the protection of life and property across our state. Be happy to answer any questions."

Speaker Lang: "Mr. Andersson."

Andersson: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Andersson: "So Representative, right now, what is the state of the law of this and how are we altering it?"

Burke, D.: "Would you repeat that? What is what?"

Andersson: "What's the current state of the law? I see and I heard what you describe, but I'm trying to understand what can be done today that this is either limiting or expanding? I don't understand it."

Burke, D.: "It would limit the opportunity for owners to do certain types of repairs to roofs that involve the use of flammatory materials."

Andersson: "So, would this preclude the actual owner of the property from working on their own building? It seems like it's saying it's only an employer-employee relationship that would be allowed to do this without a permit."

Burke, D.: "It depends on the extent to which the repair is required. If they have to use flammable materials or engage in the use of a torch, that would require very specific

training and that would be precluded unless that individual were trained and certified in the use of these devices."

Andersson: "But as of today, they could do that absent your Bill.

Is that right?"

Burke, D.: "At the risk of public safety and property damage, yes, they could."

Andersson: "Do we have any evidence that there's actually been circumstances or a lot of circumstances that merit this change?"

Burke, D.: "Were... were you in the committee?"

Andersson: "No, Sir."

Burke, D.: "I had, a moment ago, mentioned that the Fire Marshal of Springfield came to our committee, testified that there was an incident in Springfield where the building caught fire as a result of improper roof repair. And the fact is, the fire occurred on the roof. None of the occupants of the office building were even aware that there was a fire on the roof of the building."

Andersson: "So, we have one incident?"

Burke, D.: "There are several across the state. I don't have the full documents. This has occurred on a regular basis. That's the reason for the change in the legislation."

Andersson: "And I'm assuming this will result in a cost increase to all these projects for individual homeowners, individual business owners 'cause they can't do their own work, right?"

Burke, D.: "Well, I would imagine there'd be some cost up front, but maybe the cost factor behind a fire would be far greater when their insurance wouldn't even cover the cost of the damage..."

Andersson: "Well, it sounds..."

Burke, D.: "...as a result of improper techniques used in the repair of the roof."

Andersson: "It sounds like, at best, you're talking about a handful of incidents across the state and I have no idea how much time. I just question a regulation that's going to increase costs for businesses, once again, for what appears to be a limited benefit. Thank you, Mr. Speaker."

Speaker Lang: "Mr. Davidsmeyer."

Davidsmeyer: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Davidsmeyer: "I was just wondering, looking at this Bill, does this require the individual to be licensed or the company to be licensed who's providing the service?"

Burke, D.: "Well, it seems that the great confusion has been with respect to an employee of a business owner being able to do repairs. Or in other words, the owner of the structure being able to do repairs themselves. Under the majority of circumstances, yes, the owner, yes, the employee of the owner could do certain repairs. If they're engaged in the use of flammable materials and the use of a blowtorch, which is the common practice, they would have to be specifically trained in order to prevent fire or loss of property or loss of life. They would have to... have to be specifically trained in the use of these devices and materials in order to do the work for an owner as an employee of that owner."

Davidsmeyer: "So... so, currently, when you get a roofers license, does the business get a roofers license or does the individual get a roofers license? So, if I'm the owner of a roofing

company, if I get a roofing license, do I have a roofing license for my company or do I have to get each individual certified who's going to be working on the roof?"

Burke, D.: "If you own a roofing company, every one of your employees that's engaged in the use of these devices and materials would have to be certified."

Davidsmeyer: "So, each individual has to be certified?"

Burke, D.: "That is correct."

Davidsmeyer: "Does the state offer a program for certification?"

Burke, D.: "No. This is a national..."

Davidsmeyer: "Who..."

Burke, D.: "...this is a national certification."

Davidsmeyer: "So, who... so, there's currently a national certification."

Burke, D.: "OSHA."

Davidsmeyer: "So, are we just saying we're going to go by the national certification? Is that all we're saying?"

Burke, D.: "That is our only resource."

Davidsmeyer: "So, if I've got a small business that... say he bought my house that I lived in. It's just a normal roof and they're going to put this type of roof on it. It was a house before but now it's owned by a company. Is there a different standard now even though the roof didn't change?"

Burke, D.: "Well, I don't think we're necessarily talking about the common residential roof that is shingled."

Davidsmeyer: "Yeah."

Burke, D.: "We're talking about commercial properties where the roofing materials are flammable and the use of the device of a torch has to be used by one who is competent in the operation

of that device in order to prevent loss of life, loss of property."

Davidsmeyer: "Yeah. And I understand that. So, if my roof of my home currently is that type of roof and then a business comes in and transfers it over into a business, now all of a sudden, that... that property, that house has not changed at all other than transferring owners to a business. So, now it's a corporation. So, now we're going to require somebody else to come in and do the work that I could have done myself before?"

Burke, D.: "You, as the owner, are able to do whatever repairs you desire or choose to do."

Davidsmeyer: "So..."

Burke, D.: "But you cannot require your employee who is not trained and certified in the use of these devices to do it. But you, the owner, have every right to do whatever you care to do with that building."

Davidsmeyer: "So, could I call up a friend and say, hey, my back's bad. I just bought this... this place and now I'm under these new regulations. My back's bad. Can you come over and help me do this?"

Burke, D.: "Well, certainly. It's a free country. You could choose whoever you want to choose to do your roofing repairs. But if a fire were to result in the misuse of these materials and the misuse of the blowtorch, I would hate to think how you'd ever recover damages from your insurance company."

Davidsmeyer: "But isn't that my risk to take?"

Burke, D.: "Yes, it is."

Davidsmeyer: "Would this Bill allow me to take that risk?"

Burke, D.: "Yes, it would."

Davidsmeyer: "Okay. Thank you."

Speaker Lang: "Mr. Batinick."

Batinick: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Batinick: "Real quick, Representative. I'm looking at the engrossed version and you talked about commercial roof where torches are required?"

Burke, D.: "Yes."

Batinick: "Okay. And I'm... I'm reading the Bill and I'm hoping I didn't... I didn't misplace it, but I don't see where in the Bill it talks about the use of torches."

Burke, D.: "Talking about... waterproofing work. I'm advised that under the national standards that would not be considered roof repair."

Batinick: "Okay. I'm not sure what that means 'cause what... getting to Representative Davidsmeyer's question. He was talking about... and this is very prevalent in my district. People think of commercial properties, not all commercial roofs are the same. Some of them have tar and heated and the stuff that you're talking about. In my district, we have a lot of converted homes that use traditional residential shingles that don't use any torches. And my understanding and one of the reasons why I strongly oppose the Bill was because those... those types of properties which are no different than they were a couple years ago when they were residential, suddenly fall under this. So, I'm looking for a clarification 'cause if the Bill says you can't use torches on it, that's different than if the Bill says you can't have one of your employees repair a commercial roof."

Burke, D.: "With respect to the... the licensure that the state currently engages in, there are two types of roofing licenses in the state: limited and unlimited. A limited license permits a licensee to residential roofing only and an unlimited license permits a licensee roofing work on residential, commercial and industrial buildings. When applying for a license with the department, an applicant must indicate for which type of license he or she is applying for. The following requirements are needed: \$250 thousand insurance for each occurrence, 500 thousand for personal injury, proof of workers' compensation, proof that an applicant is obtained, applied for as an Illinois unemployment insurance employer, proof of a surety bond of at least 10 thousand, designation of a qualifying party, \$125 application fee. Now, it seems that the argument that the department had raised and certain Members have been greatly concerned with the opportunities for owners to still be able to do their roofing repairs themselves."

Batinick: "And I mean, I just... I know we've got a lot of other Bills. I mean, owners and their employees, correct?"

Burke, D.: "Owners..."

Batinick: "I was concerned 'cause right now what we're taking away is the fact of... of owner's employees doing the work."

Burke, D.: "Employees who have been trained in the use of these flammable materials and the blowtorch, certainly, would be able to perform that repair. But typically, you don't find general employees being trained in this specific area."

Batinick: "Right. Well, that's... that's where the disconnect is.

I don't see that in the Bill. What I'm referring to is in an actual shingle roof, we don't use the torches. So..."

Burke, D.: "Correct."

Batinick: "So, that... they wouldn't need to be trained in that then if that's what they're doing."

Burke, D.: "Certainly not."

Batinick: "I'm going to... and you know what, I'll just... I'll make it easy on you. I think we're belaboring the point. It's probably just... there's a little bit of a difference of opinion. I'll go straight to the Bill. This... this is one of those regulation Bills. We heard in committee recently that Illinois ranks 50th in terms of housing permits to population. A lot of it is when whether... whether you look at our electrical Codes or these type of Codes, we keep piling on more and more and more and more Codes. It's stifling growth in the state. So, I know people have their fundamental reasons for... for why they do things and in a vacuum maybe this Bill seems like something that's common sense, but not all commercial roofs are equal. I would strongly urge a 'no' vote. But thank you for bringing the Bill."

Speaker Lang: "Mr. Sommer."

Sommer: "Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Sommer: "Representative, I'm trying to understand this. Comparing it to the Bill last year. Does this Bill still talk about the commercial property of a business owner and his employees be... the torch portion that Amendment, does that... that's in addition to the Bill last year?"

- Burke, D.: "Currently, employees of a building or property owner would be able to do general roof repair. That would be such as the application of asphalt shingles and other materials that don't require the use of a blowtorch. When it comes to the use of these flammable materials such as would require the use of a blowtorch, that individual would not be able to do the repair unless they were trained and certified in the use of those devices."
- Sommer: "Well, I want to get back to the original Bill where it says that the employees can repair a commercial roof but cannot replace that roof. Is that still part of the Bill?"
- Burke, D.: "I think you're referring to Senate Bill 2982 which passed the House overwhelmingly last Session. This new language was added at the request of the Home Builders Association. It adds a definition of 'roof repair' to the current Roofing Industry Licensing Act. So, it would be consistent with the International Building Code and clarifies the exemption that employees of a building owner can still perform roof repair without a license but a license would be required for more dangerous techniques, for fire safety, liability, workers' comp, and those related to OSHA violations. So, if you're talking about an individual that's doing basic roof repair without the use of these dangerous materials, or flammable techniques, they would then require a license or be certified."
- Sommer: "I apologize but back to my original question. Is the language from that previous Bill still in here that refers to a distinction between repair and replacement by the employees?"

Burke, D.: "Yes."

Sommer: "To the Bill, Mr. Speaker. I think you have to look carefully at this Bill. You might say that an owner of a business of commercial property, why does he want employees to be replacing a roof? Well, I think, erroneously, we think of commercial property as a large structure. Each and every one of our districts have business owners who may have one employee, they may have a basic structure. They're trying to make a living. They may have taken a structure like a garage. They may do lawn work. This Bill says that if you have an employee who may have years of experience in construction, cannot get on that building and replace that garage roof. If you look at what the Governor's Veto said last year, it said it takes away basic owners' rights. And I think that is correct. There should be a 'no' vote on this Bill."

Speaker Lang: "Mr. Welch. Mr. Burke to close."

Burke, D.: "Thank you, again, Mr. Speaker. Ladies and Gentlemen, I sometimes scratch my head wondering how people can misinterpret some of the Bills that are considered in our process here. I... let me give you a... just a piece of the proponents of this and if you think you're smarter than the Illinois fires... Firefighters Association, the Illinois Fire Safety Alliance, the Illinois Fire Chiefs Association, the Illinois Association of Fire Protection Districts, Effingham Fire Department, Springfield Fire Department, Grayslake Fire Department, Chicago and Downstate Roofing Contractors, Illinois Council of Code Administrators, Village of Berkeley, Itasca Fire Protection, Frankfort Fire Protection, Bourbonnais Fire Protection, Deerfield Fire Protection, the

list goes on and on. If you think you're smarter than all of these professional firefighting organizations and Code administrators, then you go right ahead and vote 'no'. These are the people that are concerned about protecting the public safety and property. Now, if you're talking about an ice cream parlor where the owner has a scooper get up on the roof and operate a torch, take your chances. What do you think is going to occur? These are very dangerous materials that are being used to replace roofs and repair roofs. There are fire torches being used. I just cited an example of ... an occurrence in Springfield where the roof caught fire, the occupants of the building didn't even know that the building was on fire because it was on the roof. This is a very serious matter, Ladies and Gentlemen. And if you overlook the public safety in this particular instance, you're making a very serious mistake. I would encourage you to support this and to abide by the recommendations of people who are professionals in this particular area. Thank you very much. Please vote 'aye'."

So, upon termination, as long as they made application to be able to purchase those credits that they're eligible for, this just says that as long as they've made application, they can then make a one-time payment to buy that back."

Andersson: "And right now, existing... existing state of the law is they can do it. You're just cleaning up the timing of when they can do it, correct?"

Martwick: "Yes and there has been some confusion. There was a recent lawsuit which created some confusion about this law. This law would not effect that case, but the... there was a question brought up in that suit about this. So, this codifies the practice so that they can continue doing what they've been doing regarding purchasing credit."

Andersson: "And we're in no way expanding the rights of these individuals. We're just allowing the timing to be clear?"

Martwick: "That is correct."

Andersson: "Thank you, Sir."

Martwick: "Thank you."

And Dr. Linda Baker will supervise the students in Springfield. The students, we hope, will gain a valuable experience throughout the internship, including analyzing and reviewing proposed legislation, looking at critical community issues and developing networking skills. And as a Member of the Illinois Republican Hispanic Assembly, I welcome them for both sides of the aisle and would appreciate the chamber welcoming them as well."

Wallace: "We're currently not doing those other things, but that was what the language proposed. And I was just streamlining it to focus on the implicit racial bias."

Andersson: "So... so, we're not doing those things?"

Wallace: "No."

Andersson: "Okay. I see that the Illinois Statewide School Management Alliance is opposed. Did they communicate to you the basis for their objection?"

Wallace: "Literally, they just don't like mandates."

Andersson: "They don't... well, I generally don't like mandates either. Is there any estimated cost to this for the schools?"

Wallace: "No. I don't have an estimated cost."

Andersson: "I'm sorry?"

Wallace: "I don't have an estimated cost."

Andersson: "But you believe there is a cost. There would have to be a cost, right?"

Wallace: "That's possible depending upon what education or training internal staff may already have on the issue."

Andersson: "But they're going to have to develop a training protocol and if you're saying we aren't currently doing any
