Andersson: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Andersson: "Thank you. Representative, so can you explain to me why this isn't covered already? It seems to me if it's a medical necessity that it would be covered?"

Fine: "Correct. Well, right now eating disorders are covered under the mental health parity, but the definition of eating disorder in the Illinois just says anorexia and bulimia. And those are not the only two eating disorders as described by the Psychiatric Association. So, what this does is it clarifies what an eating disorder is. And it'll make the billing process easier for... for doctors and psychiatrists."

Andersson: "So, Amendment 4 created that definition or expanded that definition?"

Fine: "Correct."

Andersson: "And is that the way that... that insurance policies are normally written. Is it by incorporating our statutory definitions or can they create their own?"

Fine: "I... well, they... my guess... my understanding is they can create their own, but under mental health parity this is covered. So, it just clarifies what this means under that mental health parity."

Andersson: "And based on your Amendment, it looks like BlueCross BlueShield is no longer opposed and ILIC is neutral, but IMA and the Statewide School Management Alliance are opposed? Are you aware of why they are opposed?"

Fine: "No, I'm not. I worked on the Amendment with BlueCross."

Andersson: "Okay. So, you didn't communicate directly with IMA or the Statewide School Alliance?"
