- Speaker Lang: "Mr. Clerk, Agreed Resolutions."
- Clerk Bolin: "Agreed Resolutions. House Resolution 509, offered by Representative Brady. House Resolution 510, offered by Representative Meier. House Resolution 511, offered by Representative Turner. And House Resolution 512, offered by Representative Swanson."
- Speaker Lang: "Mr. Harris moves to adopt the Agreed Resolutions.

 Those in favor say 'yes'; opposed 'no'. The 'ayes' have it.

 And the Agreed Resolutions are adopted. Mr. Clerk."
- Clerk Bolin: "Committee Reports. Representative Chapa LaVia, Chairperson from the Committee on Energy reports the

Speaker Lang: "Moving to page 11 in the Calendar, under the Order of Concurrence, there appears House Bill 311. Mr. Harris, please proceed."

Harris, G.: "Thank you, Mr. Speaker, Ladies and Gentlemen of House. House Bill 311 is a Bill regarding network adequacy and transparency for insurance companies and medical providers. As you remember when this Bill left here to go to the Senate, we said there was additional work to be done by the insurance industry, the State Medical Society, and the Hospital Association. This Concurrence reflects an agreement on the issue of non-participating providers by removing the language that was in the original legislation. I believe that there is broad support for this. I would appreciate a 'yes' vote."

Speaker Lang: "Mr. Reis."

Reis: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Reis: "To the Concurrence. I stand in support of the Concurrence.

I was one of the few who did not vote in favor when it left
the House, but as the Sponsor said, the changes were made
over in the Senate, and now I am in full support of this
Bill."

Speaker Lang: "Mr. Davidsmeyer."

Davidsmeyer: "Thank you, Mr. Speaker. I want to thank the Sponsor for working on this. I did have some concerns when it left this... this House, but I'm glad to see that it came back agreed... as an agreed Bill. Thank you."

Speaker Lang: "Mr. Hays."

Hays: "I, too, rise in support of the Bill. Thank you to Representative Harris for his work over a long period of time on this Bill. Thank you for answering some of the questions and concerns that were brought up on the floor during the original debate, and thank you for bringing it back, I think a more complete Bill. Thank you. I urge an 'aye' vote."

Speaker Lang: "Representative Ives."

Ives: "Thank you, Mr. Speaker. To the Bill. I, again, also want to thank Representative Harris for picking up this Bill and running with it. It's taken almost two years to fruition. It's a really good example of what we can do when we work together for the good of the people of Illinois. This is an excellent example of all of us coming together, along with the industry, and working out a Bill that benefits all. Thank you very much."

- Butler: "Thank you, Mr. Speaker. House Bill 434 is a gut and replace. It's an initiative of the Illinois Department of Natural Resources. It would basically roll the \$10 title fee for boats, into the overall fee, it's paid for registration. It would eliminate the need for a title for watercraft under 21 feet in length, eliminate the water usage stamp requirement for non-powered craft. It'd also bring the department into compliance with some audit findings from the Coast Guard, to allow them to obtain some federal funding."

Hoffman: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I move that we concur in Senate Floor Amendment #1. It's a page and line Amendment, which provides that the filing of an Appeal of an Order of the Illinois Labor Relations Board should not automatically stay the enforcement of the Board's order. I don't believe there is any opposition."

Speaker Lang: "Mr. Andersson."

Andersson: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Andersson: "Representative, if you could, just give us a little background of the Bill, since it's been a while. I'm not quite sure where we're at."

Hoffman: "The original Bill was an initiative of the Associated Firefighters of Illinois. It would amend the Illinois Public Labor Relations Act by providing that the filing of an appeal in an Appellate Court... to obtain judicial review of an order of... of the Labor Relations Board, should... would not automatically stay the enforcement of the Board's order. And the Senate then amended it and indicated that the... that the filing of the appeal of an order of the Illinois Labor Relations Board would not automatically stay the enforcement of the Board's order. Under the amended language, an aggrieved party may apply to the Appellate Court for a stay, and then the Appellate Court would make that decision."

Andersson: "But isn't that already the case? I remember this...
this debate when it was in the House before. The existing

Supreme Court rules already provide for a stay upon the request of any party. Why do we need this law?"

Hoffman: "It's my understanding that this is a clarification of the... of the underlying Bill that said that the stay wouldn't automatically be in place."

Andersson: "So, are you saying that without following the court procedures that the stay happens automatically, notwithstanding Supreme Court rules?"

Hoffman: "According... according to my understanding of the Bill.

The firefighters... they petitioned the court. It must be filed with the Appellate Court within 35 days from the date of the copy of the order..."

Andersson: "Sure."

Hoffman: "...or decisions sought. Okay?"

Andersson: "Sure."

Hoffman: "So, that's not changed. We're just saying that it... it will not... the direct order of an administrative agency would not automatically be stayed; however, the aggrieved party can apply for a stay before the Appellate Court."

Andersson: "And either party can apply for the stay, correct?"

Hoffman: "I couldn't hear you."

Andersson: "No problem, I apologize. Either party could... could apply for the stay, correct?"

Hoffman: "Well, I would say the aggrieved party. So, yeah."

Andersson: "Aggrieved, right. Which could be the plaintiff or the defendant."

Hoffman: "Yes."

Andersson: "...in the case?"

Hoffman: "Yes."

Andersson: "Okay. Thank you. To the Bill. This really hasn't changed where we were at the last time, which is I think that the Bill is unnecessary. Existing Supreme Court rules already provide for this system. This is one where we simply are duplicating what already exists. As such, I'd urge a 'no' vote, as it is duplicative. Thank you."

Speaker Lang: "Mr. Hoffman to close."

Hoffman: "I ask for an 'aye' vote. I re... disrespectfully disagree with the... the previous Gentleman."

Speaker Lang: "Those in favor of the Gentleman's Concurrence Motion will vote 'yes'; opposed 'no'. The voting is open. This Bill requires 71 votes. Have all voted who wish? Have all voted who wish? I've already heard from others around the state, that particular firefighters intend to buy the highest priced tires they can and sell them at a profit, when they've gotten a great deal on tires. I know that sounds ridiculous, but essentially we don't even have enough protections to make sure that this Bill isn't abused. So, I'm just going to vote 'no' because there's not enough protections to ensure that money isn't being wasted on this program. Thank you."

Speaker Lang: "Representative Willis."

Willis: "With all due respect to the previous speaker, I think this is a good Bill. This is a Bill that shows bipartisanship

in its best. In many rural communities, we have volunteer firefighters, both men and women, that do use their own vehicles. And it is important to have good tires on those vehicles. They may be going across country roads that may not be in the best shape and this is something that we need to do. The Concurrence is just really narrowing the scope, making sure we have a definite definition of what a volunteer firefighter. These guys are volunteering... these guys and women are volunteering their time, let them buy the tires. I really don't think we have to worry about anybody selling them off on things; that's not what they're doing with this.

I heartily ask for everybody to vote 'aye' on this."

Speaker Lang: "Mr. Breen."

Breen: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Breen: "Representative, I'm confused. I'm reading your Bill. It says the firefighter shall pay for any tires. Is that correct?"

Bryant: "I'm sorry. What did you say?"

Bryant: "The... the firefighter pays for the tires. They get it at a discounted rate that is given to the fire chief when he buys tires for fire vehicles."

Breen: "And they just..."

Bryant: "One set of tires, every three years."

Breen: "But... so the fire districts has a contract through the Joint Purchasing Act to buy a bunch of tires. So, okay. That's fine; that happens. All we're saying with this Bill is that the firefighter may purchase, at the firefighter's expense,

additional tires under the contract and arrangement we already have in place?"

Bryant: "Correct. That's at to get a letter from the chief, saying that they're in good standing. They haven't done it the last three years under the law."

Breen: "I don't care about all the rest of the stuff. I'm just saying..."

Bryant: "Correct. They take their own expense."

Breen: "...there's a contract; the firefighter pays, he gets four tires."

Bryant: "Correct."

Breen: "That's it?"

Bryant: "That's it."

Breen: "Wow. Okay."

Bryant: "Volunteer firefighters only."

Breen: "I'm surprised you need a Bill to do it, but I don't see the problem. Absolutely no costs to anyone, anywhere, involved in the state."

Bryant: "Correct."

Bryant: "Just ask for an 'aye' vote."
