Welch: "I don't have the Governor on mine at all."

It's one of six Bills including SB41, which is the grandfather of all of them that essentially is it trying to secure tied state streams of income so that bondholders are protected. On this question, there are 100 voting 'yes', 0 voting 'no'. And the House concurs with Senate Amendment #1 to House Bill 3261. And this Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 3399, Representative Feigenholtz. Please proceed."

Feigenholtz: "Thank you, Mr. Speaker. I move to concur with Amendment #1 to House Bill 3399. It's an agreement of all parties on... it removes nine counties around Cook that bobcats can be hunted in. And it changes the number. And the department in 2019 will review the population. Everybody's agreed on this Bill."

Speaker Lang: "Mr. Demmer."

Demmer: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Demmer: "Representative, I see this Bill was originally filed by Representative Sosnowski and now, you're the Chief Sponsor of that. Was that part of a... some kind of negotiation or agreement that was made?"

Feigenholtz: "Correct."

Demmer: "And what was... what was that agreement?"

Feigenholtz: "I have... They're all around Cook County."

Demmer: "Okay. All right. Thank you for... for working on this in a bipartisan fashion. I appreciate the effort you put into this. And I encourage a 'yes' vote."

Costello: "Thank you, Mr. Speaker. To the Concurrence. This was, in fact, an agreed to situation where Representative Feigenholtz worked with us. It's agreed by the downstate Legislators and also the... the gun groups: the NRA and the ISRA. I would recommend a 'yes'."

Currie: "My analysis says that the Humane Society and the Environmental Council oppose Senate Amendment 1. So, my question to the Sponsor, if she's willing to answer a question, is whether that is her understanding as well?"

Currie: "Thank you."

Speaker Lang: "Mr. Thapedi."

Thapedi: "Leader Feigenholtz, how does this Bill jive with the Rules that have been in JCAR? I see that you have staff back there with you that's familiar with the process that we've been looking at these issues in JCAR. Does this resolve the issues that we've been dealing with in JCAR or..."

Feigenholtz: "It does, yes."

Thapedi: "It does?"

Feigenholtz: "The Humane Society, I believe, and the Illinois Environmental Council were part of this negotiation and are in agreement with this Concurrence."

Thapedi: "So, does this obviate the need for the Rules or... just so that we're clear. I mean, I'm fully supporting your Bill.

I just want to make sure that if it comes back up in JCAR that at least that we know that we at least have some legislative direction that..."

Feigenholtz: "I'm sorry, Mr. Speaker. I can't hear Representative Thapedi."

Thapedi: "No, no, no. My question, Leader Feigenholtz was..."

Speaker Lang: "Ladies and Gentlemen, I know it's Sunday. Let's bring the noise level down. Mr. Thapedi."

Thapedi: "Thank you, Mr. Speaker. And then, if that is the choice, remains that that those remains are for the purpose of medical study not for any other purpose or partial sale or change of body parts of any group that is not authorized under this Act as a medical institution. And Cook County, as well, is in favor of the Amendment that was made in the Senate."

Thapedi: "When you say medical study, what do you mean by that?"

Brady: "Whole body donation is medical study where that body is donated."

Thapedi: "We're talking about medical students, pathologists, et cetera?"

Brady: "It would be for our schools and insti... medical schools and institutions throughout the State of Illinois for scientific study would be anatomy, study of the body."

Speaker Lang: "Representative Willis."

Willis: "Thank you, Mr. Speaker. I just have a brief question for the Sponsor. With the..."

Speaker Lang: "Sponsor yields."

Willis: "...with the Amendment from the Senate, does that take off the opposition of the Illinois Funeral Association... the Funeral Directors Association?"

Flowers: "Okay."

Brady: "Thirty days."

Flowers: "All right. Before... and the family would be... this would allow family to be notified or looked for?"

Flowers: "And currently, if family members now that are not notified, what happens again to the remains?"

Brady: "There's... there's two options that occur. One is mass burial and identifying a grave with what as a number or cremation. And I believe that the last time that the Cook County Medical Examiner's Office had to do something along this lines, it was around 153 that were cremated or mass burial."

Flowers: "Thank you very much, Representative."

Brady: "Mmm mmm."

Speaker Lang: "Representative Bellock."

Bellock: "Thank you very much, Mr. Speaker. I just want to say we've had a lot of discussion on this Bill in the Human Service Committee. Diverse schools are essential to prepare all children to live and work in a nation which African Americans, Latinos, Asians, Native Americans, Pacific Islanders and other nonwhites will collectively compromise the majority of the United States population by 2042.
