Wheeler, K.: "Thank you, Mr. Speaker. Ladies and Gentlemen of the Body, I'd like to congratulate our friends in small business, National Federation of Independent Business, on 75 years. I'll give quick full disclosure. I am a small business owner and a NFIB member for more than 25 years. My father was a small business owner and a NFIB member for multiple decades. Even my grandfather was a small business owner and a NFIB member years ago. If you haven't dealt with NFIB, you have to understand that this is a member-driven organization. It states in the Resolution itself that the policies of NFIB that advocates for small business are member mandates. Seventy percent of members have to agree on an issue before NFIB will advocate for it. It's truly designed to be a small business owner's voice within Springfield and Washington. So today here in the House, we're giving small business leaders a face. If you look up in the Speaker's Gallery, you'll see members of the NFIB Illinois Leadership Council. I know them. I respect them. I listen to them. In fact, if I wasn't elected and sitting down here, I'd be up there with them right now, as part of them. "Thank you, Mr. Speaker. Ladies and Gentlemen, I wanted Jimenez: to take just a moment to remember a wonderful public servant, who lived and worked in Sangamon County. I first met Judge John Schmidt when I was a cub reporter here in Springfield, and he was the Sangamon County State's Attorney. He was always kind, accessible, and willing to spend extra time to make sure I understood the case or the situation. Before he became the State's Attorney, he had worked in the office as an assistant and prior to that in the U.S. State's Attorney's Office. For the last seven years or so, he served as a judge in both the Circuit and the Appellate court. All the while, he was a loving husband and father. The last time I saw him was at the beer tent at the Illinois State Fair, and he told me how proud he was for some of the votes that I had been taking recently. He was always one to reach out and make sure that you knew that he was proud of you. I met and served with his wife, Robin, on the Springfield Park District Board as well. And she's quite a lady too. As a couple, they loved Sangamon County and served the public every chance they got. Justice John Schmidt died unexpectedly late last year which

was an enormous shock to our community and his family. His wife, Robin, and son, Johnny, are here with us today in the gallery, as we honor his service. Thank you, Robin, for sharing your husband with us. And to their son, Johnny, thank you very much for sharing your dad with us. His impact on our community will be forever remembered. I ask the Body for a moment of silence."

Speaker Lang: "The Body will take a moment of silence. To Thapedi on the Resolution."

Thapedi: "Thank you, Mr. Speaker. And first, I'd like to ask Representative Jimenez to add me as a Sponsor of this Resolution. On multiple occasions, I appeared before Judge Schmidt down here in Sangamon County. And I found him to always be fair, well prepared, extremely knowledgeable of the law, and he'll be greatly missed."

Speaker Lang: "Mr. Butler."

Butler: "Thank you, Mr. Speaker. And I couldn't... I thought Sara said it very well, when the last time she saw John was at the beer tent. That sums up the kind of guy that John was. He was a wonderful individual, a good friend. I had known John for a long time, probably over 20 years. And I think for anyone that you can say that he left this community a better place than when he came here, certainly applies to John. Not only did he make our community safer, he made our community better as being involved in our community as a wonderful... wonderful citizen here in Sangamon County. He's a proud graduate of Western Illinois University. You would see him out at all sorts of community events. Just a super guy. And to Robin and Johnny, our hearts go out to you. John went way too quick,

but he meant a lot to a lot of us and a lot to our community. Thank you."

"Thank you, Mr. Speaker. Ladies and Gentlemen of the Cabello: House, it is with sad duty today to report to you that Illinois State Police Lieutenant Richard Kozik, badge number 4929 of Cadet Class 96, yesterday suffered a medical emergency resulting in him being transported to a hospital to further medical treatment. Lieutenant Kozik later died at hospital. Words that describe this man were dedication, mentor, leader, commitment, sacrifice. Richard was a deeply religious Catholic, who never missed mass. He was always found in good spirits, and he cared deeply about the Illinois State Police Building in Memorial Park. He inspired their annual motorcycle fundraiser. And yesterday, at the hospital, he was surrounded by his fellow command staff and members of the motorcycle enforcement crew. From what I understand is, it was a very somber moment, and it was a show of what this man was actually like. The men and women of the ... that he commanded are devastated today. One of the troopers said on Facebook last night, they were devastated, and that Lieutenant Kozik exemplified what was best of the State Police. He was a caring trooper that spent countless hours helping and caring for others. He was a type of person who would go to the extra mile and never ask for anything in return. He was never too busy for anyone, he was constantly helping, telling other

troopers to keep their chin up. He never complained and always worked hard and displayed the integrity of service and pride that he lived every day of his life. We will miss him, and I would wish the Body to take a moment of silence."

Speaker Lang: "Body will take a moment of silence. Thank you, Members. Thank you, Representative. You may be seated Members. The Chair recognizes Representative Conroy for an introduction."

Conroy: "Thank you, Speaker. Point of personal privilege."

Speaker Lang: "Proceed please."

Conroy: "I would like to introduce to the Body today, my two Pages. Lillian Hoigard, who is a sophomore at Lions Township High School in LaGrange. And Madeleine Hughes, who's also a sophomore at York High School, which happens to be my Alma Mater, and that's in Elmhurst. Please help me welcome these future leaders to our chamber today."

Speaker Lang: "Welcome aboard. We're happy you're here. Mr. Davidsmeyer is recognized."

Davidsmeyer: "Thank you, Mr. Speaker. I have a couple points of personal privilege really quick"

Speaker Lang: "Proceed, Sir."

Davidsmeyer: "Really quick. Judge John Schmidt, he... I met him on the campaign trail when I was first joining the General Assembly. And when I was appointed to join the General Assembly a little bit earlier, I could think of nobody better to swear me in. So about five years ago, I was standing up there where you are, Mr. Speaker, and he was there to swear me in. He was a larger than life individual, always impressive, always funny, a good smile on his face. He will

be missed. There's a large picture on my wall in my district office of him swearing me in, and it will always be up there. That said, I know he's up there making people laugh, enjoying life up there. So, I want to introduce to the General Assembly, my Page for the day, Tim Farmer. He goes to Illinois College. He's a junior at Illinois College and he's actually from Representative Jimenez's district in Auburn. And I just hope we can give him a warm welcome. He interned for me last semester, and I hope he enjoyed it. And I think he is thinking about possibly getting into politics. Thank you."

- Feigenholtz: "Thank you, Mr. Speaker. I stand on a point of personal privilege. I'm not sure… she's probably in the break room hovering around her birthday cake. But let's give Robyn Gabel… let's wish her a happy, happy birthday. She's right in the middle. Thanks."
- Speaker Lang: "Happy Birthday Representative. How many cakes did you actually get her? That's what I thought. Mr. Harris is recognized."
- Harris, D.: "Thank you, Mr. Speaker. Good to see you. A Point of personal privilege, please."
- Speaker Lang: "Proceed, Sir."
- Harris, D.: "Continuing, Ladies and Gentlemen, my personal privilege of saying something good about the State of Illinois. I turn to the Amazon list of 20 locations. And as you know, Chicago is on that list. And when that list was announced, the Governor said from the newspaper that, 'The CEO of Amazon, Jeff Bezos, knows how bad taxes are, and that

State of Washington, where they are coming from, does not have an income tax.' So I decided to do a little bit of research, about those other 20 cities on the Amazon list. Now, if income taxes are the sole determinant of where Amazon is going to locate, then there are three, maybe four cities that they would go to, which would be Austin, Dallas, Miami, no income tax, Nashville doesn't have an income tax, but they tax capital gains. But my guess is that since states are throwing money at Amazon in the billions of dollars, that income taxes are not the sole determinant of where Amazon is going to locate. So, I looked at the other cities on the list and compared Illinois income tax rate, which we know is 4.95 percent... 4.95 percent to... with no county or state income tax to the other cities on the list. Let's look at those other cities on this list: Atlanta-6 percent, Boston-5.1, Columbus, Ohio-7.4, Los Angeles-12.3, Montgomery County, Maryland-8.95, Northern Virginia-5.75, Philadelphia-6.9, Pittsburg-6, Toronto-13.1, Washington, D.C.-8.95, Illinois-4.95. Gosh, doesn't look too bad compared to our competitors does it? Thank you very much."

Speaker Lang: "Thank you, Sir. Mr. Wheeler is recognized."

Wheeler, K.: "Thank you, Mr. Speaker. Point of personal privilege."

Speaker Lang: "Proceed."

Wheeler, K.: "Ladies and Gentlemen, friends and colleagues, I have constituents like you who ask regularly about our Illinois state budget. Whether it's in balance, what we're going to do this year especially. So, I'm going to begin the process of gratefully and graciously requesting that we

actually honor this year, Article VIII Section 2 subsection state constitution, which requires our appropriations for a fiscal year shall not exceed funds estimated by the General Assembly to be available during that year. For three years, you've heard me ask repeatedly about us adopting a revenue estimate. We have not done so. I think it shows in our balance sheet that we have not followed an appropriate process. Our appropriations committees don't do the work they should do in a bipartisan, collegial, collaborative manner to actually demonstrate a budget reflects all of our priorities. So with that, I will begin asking that we consider truly adopting a revenue estimate and following the process, which we all know will serve our constituents and the state in a better way. Thank you for that."

Speaker Lang: "Representative Barbara Wheeler is recognized." Wheeler, B.: "Hello, thank you. Point of personal privilege." Speaker Lang: "You may proceed."

Wheeler, B.: "Thank you. Last week I asked this Body to read House Resolution 783, which dealt with the sexual harassment at the Ford Motor Plant. I hope that many of you did. A few of you had said, it's a little too political, I'm not comfortable signing my name on it. Unfortunately, there is still sexual harassment occurring at the Ford Motor Plant. These members of the UAW, who pay their dues, are not being protected by their leadership. By no means is this a... union... this is by no means a union-busting Resolution. This is about sexual harassment and getting rid of corruption in a union for the union members. So, if you don't like my Resolution, let's

talk about making something possible. Because we heard those women during the Sexual Harassment Task Force meeting, and we want to do something for those women who work at Ford Motor Company. But so far, we have done nothing. Absolutely nothing. And yet, they still sadly are having to perform sexual favors for certain union leaders. Now, if you're okay with that then continue talking and this doesn't matter and we're all waiting to go home. But if it does matter to you, like it matters to like it matters to Representative Fine, Representative Williams, and so many of these people on this floor then help me do something for those women. But yet again, I see the level of attention that this issue is getting here on the floor. And maybe, even though we wore black and we put #MeToo, maybe it really doesn't matter to you. Because it is more of a political issue and not a humane, female, woman issue. So if you're interested, by all means, come forward and help me help those women at Ford."

It wasn't until 1958, 82 years after the first black male was elected to the General Assembly, that Floy Clemmons began her service in the Illinois General Assembly. If you can imagine, 1958 wasn't so long ago. In fact, 1958 was 140 years after the inception of the General Assembly of Illinois, 140 years before the first black woman to serve in the General Assembly. I'm putting an emphasis on time, because it reminds us from whence we've come. As a black woman

Legislator, it is truly an honor to stand and speak on my history of whom I am very proud. The history of Floy Clemmons who opened the door for many including myself to stand here today. But as we see how far we've come, I don't want to fool you. We are reminded in the news daily that we still have a ways to go for all men to truly be created equally. I stand to recognize the efforts of our black Legislators of the past, present, and even the future. And their continued role in making the history of our great state. Thank you, Mr. Speaker."
