"Thank you, Mr. Speaker, Ladies and Gentlemen. DeLuca: file their annual audit Municipalities that with Comptroller's Office using a cash basis or modified cash basis method of a county will find themselves financially impacted by a recently enacted policy change by the Comptroller's Office. Under current State Law, municipalities have the option to file their annual audit reports with the Comptroller using either the accrual or cash basis method of accounting. The option has been both statutorily law and the policy of the Comptroller's Office for decades. However, in June 2017 the Comptroller's Office notified municipalities that there will no longer... they will no longer accept audit statements prepared using the cash basis or modified cash basis accounting method. The policy shift undermined existing law and decades of precedent. Municipalities currently use generally accepted auditing standards when preparing their municipal audits and the Illinois Municipal Code requires audits to be GAAS compliant. Cash basis accounting is GAAS compliant. Requiring that audit statements must be submitted based on the accrual basis method of accounting will add unnecessary complexity and cost to municipalities that utilize cash basis accounting for their audits. A forced conversion will simply... will impact smaller communities the hardest. Now, the legislative history reveals that Legislators focused on the auditing standards rather than the accounting principles. Now, if I revert back to when the original legislation was filed back in 1987, it was discussed on the House Floor and I pulled the transcript and it talked about how that the Bill was about simply providing that the

audits shall comply with generally accepting... accepted auditing standards and the Bill passed unanimously. So, this Bill addresses the recent changes. And I'll be happy to answer any questions. Thank you."

Speaker Lang: "Mr. Breen."

Speaker Lang: "Sponsor yields."

DeLuca: "The cost from moving from an accrual... from a cash basis to an accrual basis."

- Breen: "Okay. So are you... what your Bill is doing is that you can file with either the cash or the accrual at your option, no matter your size?"
- DeLuca: "Yeah. The Bill, as amended, will basically allow those municipalities that have always filed on a cash basis to continue to do so. However, in the future, any municipality that would move from the cash basis to the accrual basis would not be able to revert back."
- Breen: "And why did the Comptroller issue her mandate just now, June 2017, when we've had these... we've had both methods of accounting for so many years?"
- DeLuca: "Well, it had been... the current practice had been in place for 31 years and it was just an interpretation change of the current law."
- Breen: "Okay. And then... how, just for instance, how does the accrued pension liability of a municipality get treated under a cash basis instead of under an accrual basis?"
- DeLuca: "Mr. Leader, we might have to get back to you on that question."
- Breen: "Okay. 'Cause I mean, I... we've now got municipalities in the State of Illinois who are having their tax revenues collect... or they're being withheld from them because of their pension liability. So, if the accrual basis is the one that shows the pension liability and cash is being used by some units to hide it, then I... they know that... that would actually make the Comptroller's mandate a bit more reasonable instead of something that's really... having a negative impact on our municipalities. So, have we got a cost estimate of how much

it costs to go from cash basis to accrual? Or how many... how many municipalities are even using cash basis anymore?"

DeLuca: "I don't have an exact amount. This is usually impacting the smaller municipalities that currently use the cash basis.

And I believe there was about 400 notices that went out back in 2017 from the Comptroller's Office."

Breen: "Four hundred notices. Okay. So that's likely 400... is that all just municipalities or is it all local units of governments?"

DeLuca: "Municipalities."

Breen: "Just municipalities. So 400... how many municipalities do we have? Do we know?"

DeLuca: "In Illinois?"

Breen: "Yeah."

DeLuca: "It's approximately a thousand."

Breen: "So 400 out of our thousand are using cash basis. We're not sure if that's actually properly showing their pension liabilities. So that's a grave concern. I hope that we'll find, before the end of the debate, the answer to that question because we certainly don't want to have... we don't want to be hiding our pension liabilities under any circumstances certainly. So, thank you for the answers to my questions."

We have a provision that was added for McHenry and Lake only that actually would consolidate into the township road districts with less than five... 15 center miles, which would apply to five different townships. In my district, there is

a situation that has made statewide news, \$500 thousand worth of legal bills, criminal investigations. There are three townships now in McHenry County that are under investigation. So all that I'm trying to do here is give the ability to citizens to actually consolidate township government. It has to be approved in a majority vote. And I have talked to most everybody here in the chamber and an issue that has come up is, does this just apply to McHenry County and the cosol ... consolidation provisions? And the answer is absolutely yes on the township 15 miles from us that applies to McHenry and Lake. But what I have said to a number of people, and I'll say it today is I have no plans to call any other townships Bills this Session. I'm focusing on my district, mostly in McHenry County. I believe giving the ability of citizens to consolidate local governments is a positive thing. I would appreciate a 'yes' vote. Thank you very much."

Speaker Lang: "This Bill is on the Order of Short Debate. Mr. Riley, do you rise in opposition? Please proceed."

Riley: "Thank you. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Riley: "Representative McSweeney, I've seen many of these kinds of Bills and where, you know, you've got a right to come up with your Bill, how is what you're proposing any different than what a citizen can do right now by referendum?"

McSweeney: "So Mr. Chairman, right now, as you know, it's next to impossible to actually eliminate township government. With the requirement now is that you would need 10 percent of the signatures of all of the townships in a county. There's not the ability to eliminate an individual township as this Bill would do. You'd have to eliminate all the townships and then there would be a three-fourths requirement of townships to approve it in a majority vote. So this is only applying to McHenry County and this would apply to individual townships. So that's the difference, to answer your question."

Riley: "Well, I think I might disagree with you about, you know, the ease of getting rid of townships or road districts or whatever the case may be. We've had a lot of pieces of legislation that have come up in the last few years doing just so. And I'm... I just have a problem with, again, Township Code is pretty large, pretty comprehensive. And there is a method to do that right now, if those residents within the township so choose. And so to this extent, I just think that this is duplicative of what's already... already in statute."

McSweeney: "And when I'm..."

Riley: "It seems to be begging... begging the question, if you will."

McSweeney: "And this one, Mr. Chairman, again, actually this applies to allow individual townships to be eliminated. So it is different, but I... I understand your remarks."

Riley: "Thank you."

Breen: "Fair enough. And then what it does is you've got a hold order of some sort that if that expires or is rescinded, then the title to the subject property vests in the pawnbroker, but otherwise the person can come and get their... get their property... what is it within 90 days or so?"

Mussman: "Yes. So as you can imagine in a lot of instances there's sort of multiple things written in different locations and they decided that where it was written, in a separate part of the Bill, it wasn't quite so clear and there were some pawnbrokers who were trying to make people pay to get their goods back which is not what the law is intended to do. So we're just making it clear what the law actually intends."

Breen: "And you've got no other opponents besides the pawnbrokers.

Is that right?"

Mussman: "Right. As I said, this Bill passed unanimously with the exact same language just last year. It's just that the Senate turned the Bill into something else, so we have to go through the process of reintroducing."

Breen: "Shame on the Senate, but that's nothing new for folks here."

Mussman: "Exactly."

Breen: "So thanks much. Seems like a good Bill."

And so if you're... you're going down this route, if you're in McHenry County and you're looking at consolidation, you should make them prove up that they're going to save money. Two prominent examples, Fairview Fire Protection District was a 'paper' fire district. It was consolidated, but the 187 property owners never saw any tax savings at all. In fact, what they saw was their property taxes increased because a special services area tax was immediately put on. The latest is last week DuPage County, once again, claimed that it consolidated another fire protection district. All it did was relieve the \$300 thousand of debt and then charged all of the county \$11 thousand per year, instead of just that one special district. So, if we're going to do consolidation, let's make sure that we're saving taxpayers money. And that's the statement I wanted to make and that's the warning to all of you who are in favor of consolidation. Thank you."

ARTICLE IX

REVENUE

SECTION 3. LIMITATIONS ON INCOME TAXATION

- (a) A tax on or measured by income shall be at a non-graduated rate. At any one time there may be no more than one such tax imposed by the State for State purposes on individuals and one such tax so imposed on corporations. In any such tax imposed upon corporations the rate shall not exceed the rate imposed on individuals by more than a ratio of 8 to 5.
- (b) Laws imposing taxes on or measured by income may adopt by reference provisions of the laws and regulations of the United States, as they then exist or thereafter may be changed, for the purpose of arriving at the amount of income upon which the tax is imposed.
- (c) For the purposes of this Section, a tax on or measured by income does not include retirement income, and there shall be no such tax imposed by the State upon retirement income. "Retirement income" as used in this subsection (c) means income derived from pension or any other retirement plan.

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article IX of the Illinois Constitution by changing Section 4 as follows:

ARTICLE IX

REVENUE

SECTION 4. REAL PROPERTY TAXATION

- (a) Except as otherwise provided in this Section, taxes upon real property shall be levied uniformly by valuation ascertained as the General Assembly shall provide by law.
- (b) Subject to the provisions of subsection (d) and such limitations as the General Assembly may hereafter prescribe by law, counties with a population of more than 200,000 may classify or continue to classify real property for purposes of taxation. Any such classification shall be reasonable and assessments shall be uniform within each class. The level of assessment or rate of tax of the highest class in a county shall not exceed two and one-half times the level of assessment or rate of tax of the lowest class in that county. Real property used in farming in a county shall not be assessed at a higher level of assessment than single family residential real property in that county.

- (c) Any depreciation in the value of real estate occasioned by a public easement may be deducted in assessing such property.
- (d) The aggregate real property tax rate imposed on a particular property by a county or other taxing district shall not exceed one percent of the fair market value of that property, unless the voters of the taxing district approve an increase above the one percent rate by three-fifths of the registered voters in the taxing district.
