Representative Jeff Keicher is here from DeKalb. He took over for Bob Pritchard. Behind me is Representative Deanne Mazzochi from Elmhurst. She took over for Representative Bellock. Back and to my left is Representative Mike Marron. He took over for Representative Chad Hays. And in the front Representative Helene Walsh, who took over for Representative Sauer. Thank you, and welcome all."
- Speaker Madigan: "The Chair recognizes Representative Currie.

  House Resolution 1268."
- Currie: "Thank you, Speaker and Members of the House. House Resolution 1268 would fill the vacancy in the current... the vacancy in the office of the Chief Clerk of the Illinois House. The proposal in House Resolution 1268 is that we elect John Hollman to that position. John has spent pretty much his entire adult life working for the Illinois Legislature. Starting in 2003, he was an Illinois Legislative Staff Intern. He went to the Clerk's Office about six years ago and I think he is eminently qualified. You all know him and I hope you will join me in voting for the accession of John Hollman to Clerk... Chief Clerk of the Illinois House."

Carroll: "Thank you, Mr. Speaker. We have to talk about these events more often than we used to. In Pittsburgh, a few weeks ago, we had another mass shooting in this country. Me, being of Jewish descent, my family would go to Synagogue on a regular basis. That would be a place that we would find to be a safe haven where we could pray, reflect, and all the above, and that's becoming less and less of an option for us. So, we put this Resolution forward today to honor the memory of those that perished in the... in the shooting. I want to read a small part of a prayer. It's called the Mourner's Kaddish that we would say at the times when people pass. So, I'm going to read it to you in Hebrew first and then I'll do the part in English. The part in Hebrew is (recites Mourner's Kaddish in Hebrew).

And that says, May you establish peace in heavens, give peace to all of us, and to the earth. And let us all say Amen. May God comfort you among the mourners around the world. Thank you."

  The American Jewish community witnessed a tragedy that many

of us have quietly feared. At the Tree of Life Synagogue in Pittsburgh, 11 of our Jewish brothers and sisters were killed simply because they were Jews. It is devastating, heart wrenching, and shocking. While the Jewish community has long known its fair share of hate through history, this atrocity serves as a reminder that anti-Semitism is not a problem of the past. Anti-Semitism is thriving, growing, all over the United States and the world. This vicious incident is part of a larger trend in Illinois and across the country. In 2017, the Anti-Defamation League tracked a 57 percent increase in anti-Semitic incidents, the second highest number incidents ever recorded. In the Midwest region, including Chicago, 103 percent increase in incidents was noted. Four point two million Anti-Semitic tweets posted from three million unique handles. Violence against Jews does not occur in a vacuum. It is made possible by the slow and insidious normalization of anti-Semitism. What we have learned time and time again, is that hateful words lead to hateful action. We cannot let this normalization take root and we cannot stand quietly when these hateful words are spread. As every person here understands, hate crimes are meant to target not just victims, but entire communities. In this incident, the shooter's goal was to terrorize American Jews and anyone who believes in a just, inclusive society. This was his intent, but we will not let him succeed. With all of us standing together, as we are today and across the country, he will fail and he will fail miserably. We have joined together with united and determined group of allies of all races and ethnicities, elected officials from both sides of the aisle,

law enforcement, faith leaders, friends and neighbors who have all sworn to stand up against bigotry. Let's take comfort in one another. Let us not forget this image right now, and let us dedicate ourselves to the task of eradicating hate from our great state and our great nation. Thank you."
