Attorney General Madigan: "Thank you, Secretary White. Will the Representatives-Elect please stand? And if you will, please raise your right hand and repeat after me. I, *state your name*, do solemnly swear or affirm that I will support the Constitution of the United States and the Constitution of the State of Illinois, and that I will faithfully discharge the duties of the office of Representative in the General Assembly according to the best of my ability. Congratulations, you are now Members of the General Assembly."

Secretary White: "Congratulations everyone. I had the great pleasure of serving in this Body for 16 years and I want to applaud, commend, and thank you and congratulate you for a job well done. Again, will the Members of the House please execute the written oath and submit it to the Provisional Clerk? Members should execute their signature twice on the sheet placed to... at their desks, and pass the oaths to the end of the aisle. The House will be at ease for a few moments. Under Article IV, Section 6(b), of the 1970 Illinois Constitution, the House shall elect from its membership a Speaker of the Illinois House of Representatives as presiding officer. The Rules of the House provide for nominations, and all nominations require a second. The election of office of the Speaker requires the affirmative vote of the majority of those elected. Therefore, 60 votes in favor of the nominee shall be required to be elected Speaker. Debate is not in

Welch: "Good afternoon, everyone. We can do better than that, this is an exciting day. Good afternoon, everyone. Mr. Secretary, Mr. Clerk, Members of the General Assembly, family and friends, and our distinguished guests, my name is Chris Welch and I am proud to stand before you today to nominate Michael J. Madigan for Speaker of the Illinois House of Representatives in the 101st General Assembly. Author and.. author and public speaker, John C. Maxwell, once said, 'A leader is one who knows the way, who goes the way, and who shows the way.' I could not agree more. But I would also add that a great leader is one who listens to the people. Listening is probably the most important character that your leaders can have. Watching Mike Madigan work these last four years has been a real case study in true leadership. it real. Good afternoon, and welcome to the 101st General Assembly. I rise to second the nomination of Michael J. Madigan, the Representative from the 22nd District, home of Chicago's 13th Ward, for Speaker of the House of Representatives in the 101st General Assembly. It was easy to recall several instances in my relatively short time as a Member of the Illinois House that I could point to during the course of business here in Springfield as examples that support my nomination of Mike Madigan for Speaker, but instead I thought it would be better to tell you why Speaker Madigan should lead the Illinois House through the eyes of those I represent. In late 2016, I walked up to a house that I had been at many times over the last several years. I knew the woman who lived there. Her name is Helen and she's quite elderly. In fact, the last time that I had been there she asked me to gather several of her newspapers that had accumulated on her lawn and in her driveway because it was difficult for her to get around. She had been living in her home alone for several years. Her husband had been gone for nearly 15 of the 60 years she had lived in that same house. So as I approached her door I once again grabbed all the newspapers. I could see her coming to the door after I knocked and secretly I was praying she wasn't going to offer me the green Jell-O that she always offers me

because one time I said yes out of politeness and there was fuzz on it, but I ate it anyways. I didn't want to hurt her feelings. Anyway, Helen came to the door... and I know she's not in the audience... and I handed her... I wouldn't have mentioned it... I handed her her newspapers. And we sat down and we talked. She always invited me in. And all of the sudden she got a serious look on her face and she said, hey I heard the state was going to cut my benefits. Now I already knew she was getting benefits through the Community Care Program. And it was because of this program that she was able to remain in her own home and avoid having to be placed in a nursing home facility. I knew that her concerns were real because the impending reduction of her benefits was due to the changes being proposed in the Community Care Program because of our budget crisis. I promised her I would look into her concerns about the reduction in benefits and we went on to talk about other things that she liked to discuss. When I went to leave, she stopped me in her doorway and pointed to an old wooden swing at the end of her porch. It was one of those two seater swings with the chains on both sides and you can swing back and forth on. She pointed at the swing and she said to me, Natalie, every person I've ever loved has swung on that swing with me. I don't want to leave my home. Let me tell you another story. I got a call from Ines, she's the CEO of Guardian Angel Community Services in Will County. Guardian Angel is an organization that serves over 60 thousand people agency wide every year, but the bulk of their work is serving women and children by providing protection for victims of domestic violence, sexual assault, adult protective services,

and overseeing the wellbeing of children in foster care just to name a few. Ines was calling me to tell me she had been at dinner the night before and she saw Speaker Madigan from across the restaurant. She told me that she walked up to the Speaker's table and interrupted his dinner. She told me that she approached him, told him who she was. He stood up, shook her hand, and then proceeded to listen to her as she explained her deep concerns about how dangerously close her organization was to suspending programs due to the budget crisis. She said throughout the conversation Speaker Madigan was genuinely concerned and acknowledged the difficulty she was explaining. She said he didn't place blame, didn't mention any differences of opinions or partisan politics, but instead told her he was aware of how important her work was and that he would continue fighting to pass a budget that properly funded the programs that so many desperately needed. Harris: "Good afternoon. I've been told by one of my Republican friends that it's almost 1:30. So I will give a brief seconding speech to the nomination of Michael J. Madigan. And that's why I'm here, ladies and gentlemen, is to second the nomination of Michael J. Madigan for Speaker of the House of Representatives for the 101st General Assembly. I'm honored to second the nomination of Jim Durkin as Speaker because Jim's leadership style is to respect our intellectual diversity, to ensure everyone is given a voice. Jim strives to support his Members to get practical, consensus solutions where we can say, yes for Illinois. Our current Rules render many on this stage procedurally powerless. In a state that's supposed to respect minority rights, do we accept that or do we decide we're going to change that? Our General Assembly needs to be constructive so we can help our citizens be productive. How can anyone expect to thrive and grow when they fear their State Government's plans for them? When your idea of helping one person in Illinois is to put a punishing burden on the back of someone else in Illinois. And how can we help them when their own State Representative can't get a fair hearing on issues that matter to them. SECTION 2.5. TERM LIMITS

(a) A person may not serve as a Representative for more than 3 terms of office that begin on or after the date that this Section is declared adopted.

(b) A person may not serve as a Senator for more than 3 terms of office that begin on or after the date that this Section is declared adopted.

(c) A person is considered to serve a term of office for the purpose of this Section if the person is elected or appointed to serve any portion of the term.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act and applies to the election of members of the General Assembly in the first general election to occur after this Amendment is declared adopted and thereafter. This Constitutional Amendment does not, however, affect the terms of members of the General Assembly elected before this amendment is declared adopted. There being no further business, the House Perfunctory Session will stand adjourned."
