Speaker Manley: "Good morning, Members. The House will be in order. Members will be in their chairs. We shall be led in prayer by Rabbi Chaim Telsner who is the Director of Chabad of Illinois State University. Rabbi Telsner is the guest of Representative Carroll. Today I'd like to recognize not only Tamara Clayton's sister, but the men and women who traveled down here to Springfield to recognize not only what we're doing today or this week for making sure that cameras capture this evidence and our local prosecutors are allowed to use this evidence. We have Alma Hill in the gallery, Albert Hill, her husband, Louise Baker, Janet Muhammad, Cynthia Ramsey, Marcia Martin, Don Wiershar, Onetta Outlaw, Deborah Davis,

Arlene Mays-Johnson, community activist and recently elected Dalton Trustee, Andrew Holmes, and also Cynthia Dorsey. As I stated earlier, House Bill 331 allows us to work with our State Police Department. These 168 shootings that have happened on our expressway, they closed each and every one of those cases because they couldn't make an arrest and didn't have the ability to capture those shootings on our expressway. So today I ask for your indulgence. I ask that we say a prayer for the family, that we continue to do all that we can to make sure that our roads are safe not only for families, but we bring some justice to Tamara Clayton and her family, and our prayers are with you."

In 1978, the University has been... since 1978 the University has been training specialists for foreign countries and graduate work in 46 University recently won a competition countries. The organized by the Ministry of Education and Science of Russia and has been granted the status of the Flagship University of the Vladimir region. Only 33 universities in Russia have such status. Illinois State University's first student led trip to Vladimir State University was in 2015. ISU has taken students each May since then, a total of 34 students from the School of Kinesiology and Recreation have participated in this experience. Students have also traveled to Vladimir State University with the College of Education. And Illinois State University partners with Vladimir State University in its Institute of Physical Culture and Sports, which provides education in majors very similar to Illinois State School of

Quish. They are from Wilmette with... one of them goes to Central Elementary and the other to High Crest Middle School. And they've shared their interests with me, swimming, Dungeons & Dragons, baseball, basketball. I did ask the question, are either going to go into politics? But we have a future paleontologist and civil engineer joining us today. Welcome boys."

They sued the water heater company and won, but made the decision instead of taking a settlement to commit themselves to changing this and making sure it never happened to another child or another family. So this legislation will prevent that from happening again. This will put a safety valve... require safety valves be put on water heaters so that it can never happen again. voter referendum to change their library board from an appointed board to an elected board. In short, if the voters don't go to referendum then this Bill doesn't have an effect. If they do go to referendum and it does pass then it has an effect. Conversely we had a municipal election. Over 50 percent of the city council was elected and those elected were all in favor of this legislation."

Speaker Manley: "Seeing no further debate, the House... the question is, 'Shall House Bill 910 pass?' All in favor vote 'yes'; opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. With 109 voting in 'favor', 2 voting 'against', and 0 voting 'present', this Bill, having received the Constitutional Majority, is hereby declared passed. On page 23 of the Calendar, we see House Bill 3172, Leader Durkin. Mr. Clerk, please read the Bill."

Clerk Hollman: "House Bill 3172, a Bill for an Act concerning transportation. Third Reading of this House Bill."

Speaker Manley: "Leader Durkin."

Durkin: "Thank you, Madam Speaker. House Bill 3172 is a matter that was brought from the Village of Western Springs where I reside to resolve an issue that has been going on for decades between that town and also the Village of Hinsdale. It relates to the issue of the Tollway Oasis that many of you are aware of when you go north on I-55. You'll see that there's a bridge which connects both sides of the Oasis, the east side abuts on Western Springs, the west side is Hinsdale. For years, the Village of Western Springs has been providing first responder services to the oasis, but the property is currently annexed

in Hinsdale. By history, this annexation in the late 50s was done under an illegal strip annexation and it is ... you cannot challenge it. The time frame to challenge that type of lapsed. There's going to be a annexation has process, widening of reconstruction the roads, resurfacing along 294 from I-55 all the way up to Rosemont over the next many years. And because of that, that bridge will be eliminated. There will be an Oasis on both sides, which will provide similar services. The Village of Western Springs in this matter is hoping to negotiate intergovernmental agreement between Hinsdale and Western Springs as has other communities who have had similar situations such as Mettawa, Lake Forest, South Holland, and Thorton when there is a revenue sharing type of agreement. The bottom line is, is that Western Springs has been carrying 100 percent of the burden and receiving zero percent of the benefit off of the Tollways on both sides. This is a matter of equity. We can't go into court to challenge this, but this Bill would allow for the Tollway to make an assessment that when this construction project is finished and that utilities will have to be separated between both communities. That the Tollway will make an assessment on whether or not there should be a revenue sharing plan. Here's what I... my commitment is, 'cause it has raised the attention of a lot of people over in that region. My commitment is that if we pass this Bill today, the Senate Sponsor, I will tell them not to move this Bill until we've reached a negotiated settlement between both towns. That's how we're going to get this done and that's the only way I think that we should proceed in this matter. But

unless we don't pass this Bill, there's really no incentive on behalf of the Village of Hinsdale to negotiate. So with that, I'd ask for your favorable support."

Clerk Hollman: "House Bill 3097, a Bill for an Act concerning public aid. Third Reading of this House Bill."

Mah: "Thank you, Madam Speaker, Members of the Body. House Bill 3097 would create a unit within the Department of Healthcare and Family Services to provide objective and unbiased information about pharmaceuticals for physician prescribers to those in the Medicaid Program. It's a program that has... that has been passed in a number of other states. And for us it wouldn't cost any money because it would be created out of an interagency agreement between two units that are already doing some of the work, and it would enable the state to access federal matching funds. I ask for your support."

Clerk Hollman: "House Bill 2461, a Bill for an Act concerning civil law. Third Reading of this House Bill."

Meyers-Martin: "Thank you, Madam Speaker. This is House Bill 2461.

It's a legislative initiative by the Illinois Treasurer's Office. The Bill will amend the Illinois version of the Revised Uniformed Unclaimed Property Act by allowing people who have \$100 or less in unclaimed property to simply file an affidavit as well as any other further documentation requested by the Treasurer's Office. Currently, the law requires court certified documentation, but these certifications are costly, particularly for low dollar claims. The Bill will simplify and expedite the claims process for small claims of deceased relative's property owners, saving time and money for the state. And I know of no opposition at this time."

Speaker Manley: "Chair recognizes Leader Wehrli."

Wehrli: "Thank you, Madam Speaker. Will the Sponsor yield?"

Speaker Manley: "She will."

Wehrli: "I just want to be clear that this only applies to assets of a value of \$100 or less. Is that correct?"

Batinick: "Representative, this is actually... Lilly: "Point of personal privilege."

Speaker Hoffman: "Representative Willis."

Willis: "Mr. Speaker. This Bill is in response to a closing in my Approximately a year ago Pipeline Health organization started the process of purchasing a hospital. They actually ended up purchasing three hospitals. They purchased Weiss; they purchased West Suburban; and they Westlake Hospital. Throughout all negotiations, they stated very clearly that they had no intentions of closing any of the hospitals or changing any of the services for two years. The final sale was finished in the end of January and two weeks later they announced that they were going to close Westlake Hospital, which is in my district in Melrose Park. They were able to do this because two years ago... or actually three years ago, we passed legislation that allowed that... from the Illinois Health and Hospital Association that was meant to streamline reorganizations and repurposing of hospitals and health care facilities to make the process a lot easier. They defrauded both the Village of Melrose Park, and I would venture to say the Illinois Health and Hospital Association, along with the Health Care Facilities Board by stating that they were going to keep these... this facility open. This facility is in a very low income community. It is vital to the community. It has over 50 behavioral health beds, 16 maternity ward beds, and it has an ER that is often times the only ER that is open when other hospitals in the area are on bypass. It is known for its stroke care, and I would urge this Body to help me

turn back the time a little bit not... repeal Public Act 99154 with the understanding that after we are able to keep Westlake Hospital open. I promise and I commit to both the health care facilities and to the Hospital Association that I will come back with a trailer Bill that will be a Bill that can take care of the needs of the Hospital Association, the health care facilities, but also keep Westlake Hospital open. Happy to take any questions."

Speaker Hoffman: "This matter is on the Order of Short Debate, which means there will be one person speaking in opposition.

Representative Demmer."

Demmer: "Thank you, Mr. Speaker. I move to put this Bill on the Order of Standard Debate."

Speaker Hoffman: "Standard Debate."

Demmer: "Thank you. Will the Sponsor yield?"

Speaker Hoffman: "She indicates she will."

Demmer: "Representative Willis, we had quite a discussion in committee about this Bill. First, I want to say that I understand the efforts that you and Representative Welch have done to support the community that you represent. And I think you heard in committee that quite a few of us express the same sediment, but it's also important that we understand what this Bill does and the impact that it has across the State of Illinois, because after all we're making... or attempting to make State Law here and not just dealing with one specific hospital. So my first question is, since this Bill passed committee have there been any further Amendments to it?"

Willis: "There are no Amendments pending on this Bill right now."

- Demmer: "Okay. So, you may remember that during the course of voting, Members from both sides, both Members who voted in favor and Members who were opposed in this measure, expressed significant concern with the way that this Bill was drafted. Have you spoken to those Members about their concerns?"
- Willis: "Yes, I have, and that is why I've committed to come back with a trailer Bill. A trailer Bill that will take in the concerns of the health care facilities and the Hospital Association."
- Demmer: "But you have put the caveat on that, that you would not run the trailer Bill until after Westlake has been dealt with.

 Is that correct?"

Willis: "Correct."

- Demmer: "Okay. So that's not really a trailer Bill. That's not really a trailer Bill. That you're asking instead that you're going to take away or make a significant policy change today, have it affect the situation at hand, and then maybe later come back and restore the policy that's at place. That's not a trailer Bill. That's a reversal of a policy that you're putting out today."
- Willis: "Well, I would venture to say that I intend to take care...

 take that up this Session. I do not intend to have it go on
 farther than that. My intent is... and one of the things that
 I cannot stress enough to you is, yesterday... to go a little
 bit further on it, yesterday we went to court, the Village of
 Melrose Park went to court to put a stay in for Westlake
 Hospital to stay open. That stay was granted, but Pipeline is
 ignoring that stay and they are still on bypass for their ER.
 They are still not taking any residents. We need to do

something to send a message to them that they cannot do that.

And that's what this Bill is doing."

Demmer: "Well, you know, looking at the fact that there is an ongoing legal case on this, the judge has issued a temporary restraining order. The enforcement of that is up to the judge to... effectively enforce his own order. We, though, as a Legislature have to understand what our role is in making State Law. What you're asking in this Bill, which you're making a change in this Bill, is to allow one person, the Governor of Illinois, to unilaterally reverse decisions of the Health Facilities and Services Review Board. And I asked you in committee, and I'll ask again, are you aware of any other board which the Governor has unilateral authority to reverse the decisions of?"

Willis: "No, I am not."

"When we think about the precedent that we set and the Demmer: impact that this... that legislation that has passed by this Body has on decisions that function across the state, on making decisions, hospitals with hospitals that are applications before the Health Facilities and Services Review Board, we have to understand that they're not looking at it like this is a Bill for a Westlake Hospital. This is a Bill that has a dramatic change to the state's Health Facilities and Services Review Board. This is the very board that under a previous Governor was completely disbanded because of significant ethical problems. And now the Legislature stood and acted and reconstituted that board and gave them specific charge, and they're carrying out what the charge that this Legislature gave them was. And now, with this Bill, we're

seeking to allow one person, only the Governor, unilaterally reverse a decision of a duly appointed board following the laws of the State of Illinois. You, yourself testified in committee that if it wasn't the Governor of your own party you wouldn't have run this Bill. This is not the kind of legislation that we should pass. We cannot take the Legislature and try to make dramatic changes to public policy to solve an issue that happens in one community, with one hospital, with one transaction. It's up to the Members of this House to understand what we're doing here today. This legislation also entirely removes sections that hospitals to discontinue even a specific service line, even a specific service line. That ability for a hospital to do that, should this Bill become law, is simply removed from state statue. I think we have a very significant... Mr. Speaker, to the Bill. We have a very significant responsibility as Members of this House of Representatives to make good public policy and not to respond to individual problems by passing dramatic and sweeping changes to what is a democratic process that plays out here, where we've established state law, we've established a board to follow that law, the members of the board have been duly appointed and have sworn in to uphold that law. And yet today, the Bill that's before us would completely deviate from that process and empower one person to make a decision. We need to ask ourselves, is this the kind of precedent we want to set? To hand over authority to one person? Is that anywhere else in State Law that we empower one elected official to make a decision that can overturn the wishes of another with no appeal, with no ability to override,

with no check or balance put on it? This legislation is simply an overreach. Members of both the Republican and Democratic parties have said on the record in testimony during... when this Bill was in committee that this is an overreach. That they're uncomfortable with this solution going forward. We cannot let kneejerk policy dictate what happens with State Law. If we want to work on a different solution going forward, fine. The situation you're dealing with in Westlake, I understand is a challenge for your community. There is a process that's playing out in a court right now. There's a restraining order that's been issued. There's a challenge that's at play. This is simply inappropriate for the Legislature to make a sweeping change to the Health Facilities and Services Review Board and empower one person at the expense of every other person in the State of Illinois. I would... Mr. Speaker, if this Bill would receive the requisite number of votes, I'd request a verification. Thank you."

Speaker Hoffman: "You're acknowledged. Representative Mazzochi."

Mazzochi: "Thank you, Mr. Speaker. To the Bill. There are individuals in my district who also use Westlake Hospital and we are not happy about it closing. And we certainly are not happy about the fact that the predicate to the closing was political connections and fraud if the allegations that are set forth in the complaint and that we've heard at hearing testimony is true. That being said, I did offer to work with Representative Welch and Representative Willis to try to craft a Bill that actually would address the real problem here, which was the fraud and which the misrepresentations to the board that led to this hospital closing. Having read the

Amendment, it doesn't do that. It actually makes it easier for future people coming before the board to commit fraud. There's no standards that are set forth for the Governor when in the context of review and that itself leaves itself open to abuse. And a lot of the oversite mechanisms that the board currently has, this Bill eliminates. So again, I would urge there are ways that we can do this to try to eliminate this type of scenario and fix what's going on with Westlake, but this Bill does not do it. And I'm profoundly disappointed, because to me when we know that there is a party out there that likely has committed fraud, we should actually try to address the fraud and not actually do something that's going to make future frauds more likely. So for that reason I cannot support this Amendment as written. It's disappointing."

Speaker Hoffman: "Representative Welch is recognized."

Welch: "Thank you, Mr. Speaker. This Bill is extremely important.

Can we have Unlimited Debate on this?"

Speaker Hoffman: "The Bill is on Unlimited Debate."

Welch: "Thank you, Mr. Speaker. I stand on the floor, today, to speak is support of House Bill 123. I want to thank Leader Willis for having the courage to bring this Bill to the floor today because it's important to her, her district, and the constituents that send her here. Just like the Republican Leader did earlier here today on House Bill 3172, he stood up and advocated for an issue that was important to his district and out of courtesy to him, we supported him. Now we have one of our Leaders standing up on an issue that is critical to our district. It's a matter of life and death, and we're asking for support. We have an out-of-town company based in

L.A. that has come in here and they have lied, they have cheated, and they are mistreating our community. This is a serious discussion and we're asking for the Legislature to help support it. These are people that came in here with full knowledge of the facts, went through due diligence, signed paperwork before the review board under oath, saying they wouldn't make any changes to this hospital for at least two years, saying they would provide charity care for at least two years. Hired people, sent them to talk with all of us and assure us that these attestations signed under oath was their true intent. And two weeks, two weeks after they purchased this community hospital, they did a complete 360. Everyone in here has gone through the purchase of a home process. You know what that's like. You probably had your closing date moved once or twice during that purchase process. This process started in September of 2018. That closing date moved so many times that they didn't close until January of 2019. Why is that? Because they went through due diligence. They knew the facts. They knew every single thing about Westlake Hospital when they bought the hospital and signed under oath that they would keep it open and not make any changes for at least two years. Leader Willis has a Bill on the board that says don't protect liars and cheaters. Don't reward this company for coming in here and abusing our laws. The Village of Melrose Park would be devastated if that hospital closes, employees, 800 plus families, the businesses surrounding the hospital. She's trying to protect the fabric of her community. That's what we're asking here. Out of courtesy, we didn't even ask Leader a question when he ran a Bill earlier here

today to help his district. We shouldn't be asking any questions on this one. Out of deference to Leader Willis, we should vote 'yes' on this Bill. Not only did they blatantly abuse the process of change of ownership, we had a Cook County Circuit Court Judge yesterday enter a temporary restraining order, a specific order from a sitting judge that today is being ignored by these liars and cheaters. Are you going to reward that? This Bill isn't perfect. There's a whole lot of Bills that hit that board that aren't perfect. She has told you she's going to correct those imperfections. We have no reason to distrust her, but what we should be doing here is not rewarding a California company, a bunch of vultures who are lying and cheating and trying to destroy our community. We need to stand up and stand with Representative Willis here today. This is too important to the black and brown families in Melrose Park and Bellwood and Maywood. What's going to happen to that person who's having a stroke or having a heart attack and time is of the essence and these vultures are not even following the judge's orders and won't even admit patients there today? Turning the employees and staff around. It's not right. We should not stand here today and reward Eric Whitaker. We should not stand here today and reward Pipeline Health. We should be standing here today and protecting an Illinois community. And just like it is happening in Melrose Park, it could be happening in your area next. By passing this Bill here today, I guarantee you we're going to make some changes happen. We need your help. We're asking you to help stop lying and cheating that is currently in process. The blatant disregard for our laws has to be

stopped. The blatant disregard for our judge's orders has to be stopped. I ask you, today, to stand up for Melrose Park, Bellwood, Maywood, and the 77th District. Stand up for those black and brown families that need health care. We'll fix that Bill like we fix other Bills later, like you guys allowed the Leader to do with his Bill. We need a 'yes' vote on House Bill 123. And let's stop the lying and cheating today."

Speaker Hoffman: "Representative Ramirez."

Ramirez: "Does the Sponsor yield?"

Speaker Hoffman: "She indicates she yields."

Ramirez: "Leader Willis, will you... I stepped out for a second to the back, but can you just tell me a little bit about the impact that not passing this Bill will have in your district?" Willis: "As you heard very eloquently by the previous speaker, there are almost 800 employees of this hospital. This hospital has been open for over a hundred years. It is a vital part of the community. So all those employees would lose their positions. Many of them have been there for over a decade so they are totally vested in the community right there. Many of them walk to work. Not only that, with a hospital that is so community based like that, many people... we have 16 maternity ward beds there. So pretty much everybody either had a baby at Westlake Hospital, or knows somebody that had a baby at Westlake Hospital, or they themselves were born at Westlake Hospital. We also have 50 behavioral health beds there. That is something unique to the community. That is something that everybody in the surrounding neighborhoods are very well aware of. So anybody that does any type of addictive services

that where they need to do in-house hospitalization, they use

Westlake Hospital for that. It's also number one in stroke care in the area. So... if you can tell that someone's having a stroke, Westlake Hospital is renowned for their above and beyond stroke care. Their ER is also one of the few ERs that almost never on bypass. It's been on bypass the last two days because the Pipeline Health Care has decided to close it down, but they are never on bypass. When Gottlieb Hospital is on bypass, when one of the other hospitals farther out is on bypass, the ER is the place at Westlake that is constantly having the Emergency Medical Services come into there."

Ramirez: "Thank you. So you're telling me that over 800 jobs would be lost as a result of this. That black and brown community people who need a hospital that it's right there for them that hospital will be denied to them. That if someone has a stroke and they need immediate care, that that would be denied to them. I just don't understand. I want to ask you a follow up question. How is it that we allow companies that are not even from the State of Illinois to come in and tell us that they're going to do one thing and say work with us and make agreements and them decide to viciously lie to us and close hospitals that we desperately need? How is that possible?"

Willis: "Unfortunately, that's possible because we... two years or three years ago when we passed the legislation, it allowed them to reduce the amount of up front that they needed to do. It streamlined the purchase and transition orders on it making it almost too easy. And that's what we're... that's why we want to repeal that. Let me point out one other thing in the repeal. Where we ask the Governor to step in is only in when we're talking about the exemption that's granted. That is the

only part that we're asking the Governor to come in. And also, while the Health Care Facilities Board does make the final decision... and most times they have said that they usually if there is pending lawsuits, they will hold off until the lawsuit is done. It is not standard. It is not law. It does not mandate that they do that. So for them to say most times ... that's okay, most times, but I need every time. And that's why we put it into this law that every time that there is a pending law suit, the closure will be denied until the law suit is done. And that is why we changed it into this legislation to go through. Let me add one other final thing and then I'll take some more questions on from you on that. One of the things that also came up was that the Health Care Facilities Board says this is a good thing. Actually, when I had my initial talks with them, they said when we pass this Bill in the 99th General Assembly, they were concerned about it then and they actually have language that they would like to see us work with going forward to fix. And that is truly my intent to work with them in a manner that... going forward. But at this point, I need to send a message to Pipeline... my fellow Representatives in the area need to do the same thing. We need to tell Pipeline they cannot do this to us. They cannot do it to the community. They cannot do it to the people that depend upon Westlake Hospital. Anything else?"

Ramirez: "Thank you, Representative. So the last question that I have for you, and I think it just echo's what you just said. So for clarification, you are saying that this Bill and the Amendment in House Bill 123 will give the Governor the power to reverse a decision of the board regarding application for

exemption under the Act to ensure that the hospital is open while that law suit is happening?"

Willis: "Correct."

Ramirez: "To ensure that the employees are there providing the health care that we need in that hospital. Is that correct?"

Willis: "Correct. And then that's something that is so vital. As you heard prior said, we actually went to court yesterday to put a stay on the closing of the hospital. And while the judge did grant that, the Pipeline Health care continues to ignore that. We're hoping that having the Governor put in his additional power behind that, maybe we can get this to stop. We need to do this until... forward. One of the other things that we've gone and I've gone and worked through, and I cannot stress this enough, I've been working with Deputy Governor Flores, and she has told me that she intends fully to put Westlake Hospital on the transformational hospital list and do a certificate of need and a community survey on the need for the community on what services we truly need in Westlake. That is something that should have been done in the beginning, and I'm very happy that the Deputy Governor has agreed to work with me on that as we go forward with this. But it doesn't do me any good if the doors get shuttered tomorrow or on April 30 when the health care facilities meet. We need to keep it open, keep those services vital to the community throughout this process."

Ramirez: "Thank you, Representative. So to the Bill. I urge an 'aye' vote. Health care is a human right. When black and brown people in our state don't have access to the basics because of politics or companies from out of our state who believe

that they can just buy themselves into making one commitment and changing it, that tells us that we don't believe that health cares a human right. So I, today, will be voting 'yes' and I urge an 'aye' vote. Thank you, Leader Willis."

Speaker Hoffman: "Representative Morgan."

Morgan: "A question for the Sponsor."

Speaker Hoffman: "Sponsor yields."

Morgan: "To the Representative, this is definitely an issue that we spoke about in committee. And as you know, I have a background in health care and have worked on issues of certificate of need and health facility licensing over the years as I expressed in committee, I had a number of concerns. And one of my questions that I wanted to talk about a little bit is just what... we discussed this a little bit, but let's talk about the impact of... there were references earlier that this legislation is going to be so problematic for future issues, but one of the other things we spoke about in the subject matter hearing but also in committee was that if we don't address this issue, this could potentially happen to other hospitals throughout the state. Could you address that for us?"

Willis: "Exactly. We have streamlined the process of purchasing hospitals and changing hand so much so that there's really not a checks and balances in there. And that's what we're trying to take it... slow it down, take it a step back, making sure that we truly have a certificate of need as we change hands and that we have it much more strict as to what is the intent of the new purchaser. What are they going to do? How... where they're saying one thing and then if they follow up and

do something else there's nothing to prevent that from happening, and that's what we need to roll it back and not allow that to happen.

"Thank you. And to the Bill. There were a few questions Morgan: earlier about whether this exists in state statute with other processes. One of my well regarded friends on the other side of the aisle asked, does this happen in other state agencies? I do believe there are few process in which an agency can make a recommendation in which the Governor or the Executive Branch can go in a different direction. And I believe, and I could be mistaken, but I think the Pollution Control Board and the Prisoner Review Board are two areas where there are recommendations made to the Governor and the Governor has full discretion to decide whether to accept recommendations or not. So the idea that we are increasing the power and the authority of the Executive Branch I think is misplaced. I also think that we created a certificate of need process, and we create a certificate of need process that reflected problems in the past that we fixed. I think that we all agree the certificate of need process failed us here. The certificate of need process that we created that was supposed to fix some of these problems, failed. It failed this community of the Representative. It failed us as a state. It will continue to fail us over and over again unless we fix it. So this is an important issue and the idea that we can stand by and let the courts do what this Legislative Body should be doing, I think is misplaced. So I urge an 'aye' vote. Thank you."

Speaker Hoffman: "Representative Gong-Gershowitz."

Gong-Gershowitz: "Thank you. Will the Sponsor yield?"

Speaker Hoffman: "She indicates she will."

Gong-Gershowitz: "So, Leader Willis, I'm just curious, normally when a business closes the state isn't necessarily involved and I'm curious... you know, what is the process here for closing a hospital and why is it in the public interest for the state to get involved?"

Willis: "Well, as you've heard with other Speakers, health care is a right. And I think when you're taking that away, certainly when you're taking it away from a community, that is something that the state has to step up and we have to make sure that we have it. It's one of the things that I'm sure you have heard and I have heard whenever we're talking people in the community, affordable, convenient, assessable health care is so vital to everybody's well-being. And when you're taking away a community hospital that doesn't just do inpatient stays, but it does a lot of outpatient work, it has a very robust senior group that comes in there for diabetes checks, for follow ups, for operations. It does a huge thing that has a very robust fitness program that they do throughout the community. It's not just the in hospital aspect of Westlake Hospital that affects it. So it's definitely a community organization and when you pull that out of there that takes a part of the community away from people. And that is why it is so vital to keep this in the community that it has been in for over a hundred years."

Gong-Gershowitz: "And is it correct... that there is a shortage in a number of hospitals that can take mental health patients?"

- Willis: "Yes. I mean that is something that we're constantly hearing, especially inpatient mental health. There is always a wait for beds on that. And when we have a hospital that is in a community, especially a low income community that has 50 behavioral health beds, that is not a place we want to close down. We're looking to expand that if anything else. And that is actually something that the Deputy Governor and I talked about, about possibly, as we do the transformation forward if Westlake Hospital qualifies for a transformation, which would be additional funding, to possibly add more behavioral health beds to the hospital."
- Gong-Gershowitz: "Is it also my understanding that the misrepresentation is specifically the reason why you're bringing this legislation because the process itself was flawed?"
- Willis: "Yes, the exemption process has been flawed and that is what we're so concerned about. It made it too easy to get that exemption without a chance to turn it around. And that's why we're bringing this forward."
- Gong-Gershowitz: "And it was my understanding too, from the hearing that we had, that had the Pipeline Health indicated that they would be closing this hospital in all likelihood, this wouldn't have been approved in the first place. Is that right?"
- Willis: "I would probably venture, yes, that would not have happened. If they had been up front and told what their plans were for Westlake Hospital, it would not have been approved for sale at that point. The previous owners were very upfront with what they wanted to do. They did some transformation

there and now to have these new owners go and blatantly lie, I think that is something that we're seeing on a regular basis with the dealing with Pipeline on why we have to take the hard stand forward with this."

Gong-Gershowitz: "Thank you, Leader Willis. To the Bill."

Speaker Hoffman: "To the Bill."

Gong-Gershowitz: "I urge an 'aye' vote."

Speaker Hoffman: "Representative Guzzardi is recognized."

Guzzardi: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hoffman: "She indicates she will."

Guzzardi: "Leader Willis, you brought this issue to my attention recently and to my discredit, I hadn't paid a lot of attention to it before you and I spoke. And I really appreciate you bringing me up to speed about it. I... I want to talk about process a little bit. So first of all, can you walk us through the process that the company went through in the purchase of the hospital? So, an earlier speaker mentioned that they swore affidavits or gave testimony under oath about their plans for the hospital. Can you describe that process a little bit?"

Willis: "So the way it goes, is there was a number of hearings before the Health Care Facilities Board whenever there is a request to purchase a new hospital or change owners of it. They come up with... they present their financials, they come up with what their plan is, and they present it to the health care facilities and the community in which the health care facilities reside in. And then the Health Care Facilities Board accepts the recommendation along with it and that's when it goes through with the approval of the purchase. That doesn't even count in the banks and all that stuff. I'm not

a banker, so I'm not going to go into that, but this is the part that I'm familiar with."

Guzzardi: "And there were... it sounds like there were community hearings as well as formal hearings in front of a board. Is that right?"

Willis: "I'm sorry, I didn't hear what your question was."

Guzzardi: "It sounds like there were community hearings as well as formal hearings in front of a board?"

Willis: "Yes, there were. Here, I can go through a timeline for you."

Guzzardi: "I'd appreciate that."

Willis: "In September of 2018, they had a state board staff report that talked about the change of ownership, so that was one. They were issued an approval letter in November of 2018, and then that was finalized on February of 2019. And then, by the request of the mayor, on 3/11/2019, we actually then had... this is when we found out that everything was going through and we went through and we had another public hearing. Actually, the public hearing is the one good thing that we had in that Public Act that we did in the 99th General Assembly. It does require a public hearing before a closure can take place, but it doesn't require the public hearing before the transition of ownership takes place. And it also doesn't hold... we had hundreds and hundreds of people come and testify, send in letters, and talk about why they wanted to keep the hospital open, but it doesn't really give a lot of weight to the decision of the Health Care Facilities Board."

Guzzardi: "Sure, I understand. So the process that you're proposing in the Bill that's before us today, the process

would require the hospital to get this certificate of need. Is that right?"

Willis: "Correct."

Guzzardi: "And one other piece of the Bill that jumps out to me is the business about a pending lawsuit. Can you explain a little bit about the idea there?"

Willis: "Right. So the Health Care Facilities Board says normally if there's a pending lawsuit that puts a hold on it but they are not mandated to put a hold on it. And so, we put into this piece of legislation that if there is a pending lawsuit, they are mandated to put a hold on it until after the law suit is done. That's a huge difference because, you know, you're shooting the dice as to where the board's going to go and I don't want to take people's lives on a crap shoot like that."

Guzzardi: "Sure. Well, to the Bill."

Speaker Hoffman: "To the Bill."

Guzzardi: "I think the measure we have before us is a very reasonable provision, a measured response to a very serious challenge facing the Representative's community and the communities in her area. Folks who are profoundly underserved in so many ways, in particularly underserved when it comes to meeting their health care needs, and we have an institution whose fate is hanging in the balance. And this institution provides services that no one else in the community's providing. And for this community to loose such a critical institution, because some out of state vulture profiteers want to come in and extract a few extra bucks seems to me like a profound miscarriage of justice. And I think Leader

Willis has thought long and hard about how to approach this question. I think the Bill before us today is one, as I said, that's measured, that's sensible, that requires a process that we've gone through for many, many years in this state before. This isn't inventing something new out of whole cloth, this is simply returning to a process that we used to use. And frankly, I think the provision in law that Leader Willis is proposing that would suggest that a decision may not be made while a lawsuit is pending in a case, seems very sensible to me that a decision like this if it's working its way through the courts, let the courts make their ruling before the state makes its decision. So I'm very grateful to Leader Willis for bringing this forward. As I said, this was not an issue that I walked into this chamber knowing a ton about, but the more I learned about it, the more it seems like there's a real injustice happening in this community, and we have a very sensible and responsible Bill to address that injustice. So with that, I urge an 'aye' vote."

Speaker Hoffman: "Representative Lisa Hernandez is recognized on this question."

Hernandez, L.: "Thank you, Speaker. Will the Sponsor yield?" Speaker Hoffman: "She indicates she'll yield."

Hernandez, L.: "So, Leader, there was Members that have expressed concerns of about the Bill, and you have said that you're looking to put through a trailer Bill to address some of these concerns?"

Willis: "I am. And one of the most vital concerns is putting all the power in the Governor's Office and I do recognize that, but at this point, I really don't have a different choice to

make. And so, I am willing to put through a trailer Bill to address that and to address some of the concerns of the Health Care Facilities Board."

Hernandez, L.: "Can you speak on some of those concerns?"

- Willis: "Well, the most important one is to make sure that we codify that if there is a lawsuit, if it's pending, that we make sure that that says that they cannot make a decision while that lawsuit is pending. I think the Health Care Facilities Board is open to that, but one of the things that they are concerned about is the Governor's override ability. And so, I'm willing to take that back in a trailer Bill. And they had some other language that was more cleanup language that they would like to see put in there. The certificate of need was certainly an important aspect of them, what they wanted to see. They did have some concerns on the financial statements and I'm willing to work with them on that in the trailer Bill also."
- Hernandez, L.: "So, Representative, it appears to me that you're being very open, you're being very willing, that there probably could even be even more conversation on the… once you put the trailer Bill together."
- Willis: "I would say I try to pride myself in being very openminded and willing to compromise. The only reason that I did
 not put in an Amendment on the Bill at this point is I needed
 to state a stance that I needed to take a strong, hard stance
 against Pipeline Health to let them know that they cannot do
 this to my community and hopefully not to anybody else's
 community. And that is why I am taking the hard stand now
 instead of going and putting it through the Amendment right

away. I want to make sure that we get a message sent to them that they cannot do this to my community, to your community, to anybody else's community."

Hernandez, L.: "Thank you, Leader. To the Bill."

Speaker Hoffman: "To the Bill."

Hernandez, L.: "I think it's sensible what the… what Leader Willis is doing. When at right now, what is being done is impacting a community tremendously. She's open minded. It's a matter of trust here. I trust Leader Willis will do the right thing, very open minded. And I ask all for an 'aye' vote."

Speaker Hoffman: "Representative McSweeney."

McSweeney: "Mr. Speaker, to the Bill. I strongly encourage a 'yes' vote on this Bill. This is important to Leader Willis, it's important to Chairman Welch, to their district. This is a reasonable approach. Nobody can argue that this company has made misrepresentations to the community, to Melrose Park. This is an important facility, I strongly urge a 'yes' vote."

- Speaker Hoffman: "Members, Representative Demmer has requested a verification. All Members please be in your chair and vote your own switches. Leader Willis to close."
- Willis: "Thank you, Members of... Mr. Speaker and Members of the Body. I think in my six-plus years here, I have proven to everyone that I am a trustworthy individual. If I say I'm going to come back with a trailer Bill, you can trust me that I'm going to come back with a trailer Bill and a compromise. I have never lied on this House Floor, I will never lie on this House Floor. But this is so vital and so important to my community that I need to pass it in its entirety today to show to Pipeline Health care that they cannot blatantly lie

to their to their community. They can't lie to a judge. They can't lie to their own employees and the people that depend upon them. We need to have this Bill passed. I urge you, please, to help me protect not only the Village of Melrose Park, but those that are surrounding. We've heard from other Members on both sides of the aisle that many of them have people that go to Westlake Hospital. Please, please I urge you to support me in sending a message to Pipeline Health that they cannot do this to not only my community, but they can't turn around and do it to your community either. Please give me an 'aye' vote on this. Thank you very much."

Speaker Hoffman: "Once again, Members, Representative Demmer has requested a verification. All Members will be in their chairs and vote their own switches. The question is, 'Shall House Bill 123 pass?' All in favor will vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this question, there are 69 voting 'yes', 35 voting 'no', 0 voting 'present'. Mr. Clerk, please read the names of those... Representative Demmer removes his request for a verification. On this question, there are 69 voting 'yes', 35 voting 'no', 0 voting 'present'. This Bill, having received the Constitutional Majority, is hereby declared passed. Representative Bryant on a point of personal privilege."

Bryant: "Thank you, Mr. Speaker. And thank you for letting me do another one today. This is an important point of personal privilege. I rise briefly to recognize the Boys and Girls Club of 2019, Youth of the Year finalist from across the state. They joined us this week in Springfield as a part of

Representing the Scott Air Force Base, as the Military Youth of the Year, Gavin Shelton. Gavin Shelton is from Bethalto, Illinois. Isaiah Loyd of Danville. Ja'Riah Coleman, from the wonderful state... City of Carbondale. Joshua Houston, from Valentine Club in Chicago. Ruben Plaza, representing the Baretto Unit of the Union League Club of Chicago. Sara Fierro, representing the Dundee Township. Yasimine Hamilton, from Bloomington Normal area. And Zoey Dodge, representing the Boys and Girls Club of Livingston County. Please join me in acknowledging the hard work and dedication of all these fine young people and future leaders from across the great state who will all be winners today. Congratulations to the 2019 class of the Illinois Boys and Girls Youth of the Year finalists. Thank you."

Speaker Hoffman: "Representative Bristow, for what reason do you arise?"

Bristow: "To add to Representative Bryant's point of personal privilege."

Speaker Hoffman: "State your point."

Bristow: "I'd like to add my congratulations as well and also a special shout out to my great nephew, Gavin Shelton, from the Boys and Girls Club of Bethalto. Congratulations to all."

Speaker Hoffman: "Representative Ammons."

Ammons: "Thank you, Mr. Speaker. Point of personal privilege as well."

Speaker Hoffman: "State your point."

"Thank you. I just want to join my colleagues in recognizing the Boys and Girls Clubs of America. Many people may not know that I was a former program director for Champaign area Boys and Girls Club, and I wanted to highlight and thank the Legislature for the work that they have done for many years to support Boys and Girls Clubs of which we passed with unanimous support, the House Resolution #250. I want to highlight from that Resolution that the Illinois Alliance of Boys and Girls Clubs provide services to over 63 thousand youth at about a hundred facilities throughout the state with the support of programs such as Teen Reach and 21st Century Community Learning Centers, and funding from community foundations, grants, and the generosity of private donors. As well as the Teen Reach Program is unique to Illinois and represents a partnership between the State of Illinois through the Department of Human Services and the Illinois Alliance of Boys and Gils Clubs that is now entering its 20th year of working together to provide great futures for the youth of Illinois. And finally, I wanted to just add that every \$1 invested in Boys and Girls Clubs returns \$11 to its communities and to those served. I do want to recognize all the students that are here from the Boys and Girls Club and thank all the staff that work with the youth throughout the State of Illinois. Thank you so much. And thank you, Members of the General Assembly, for funding Boys and Girls Clubs throughout the state."

Speaker Hoffman: "Representative Mah, for what reason do you arise?"

Mah: "Thank you, Mr. Speaker. I'd also like to congratulate the youth who are here from the Boys and Girls Club and especially Joshua Houston, who is the winner of Youth of the Year. He is from the Valentine Boys and Girls Club, and there are also finalists from the Union League Boys and Girls Club also in my district. So I'd like to congratulate all of them and thank you for coming down to visit us in Springfield."

Speaker Hoffman: "Representative Greenwood."

Greenwood: "Thank you, Mr. Speaker. Point of personal privilege." Speaker Hoffman: "State your point."

- Greenwood: "I would also like to congratulate Evan Gill. He's one of the Youth of the Year candidates, he's up in the gallery. He's a student at Mascoutah High School and he's out of the Scott Air Force Base Program. So congratulations, Evan. And thank you to the staff who brought him here to Springfield today. Welcome to your Capitol."
- Speaker Hoffman: "Representative Lisa Hernandez on a point of personal privilege, and then we will move back to Third Readings. Representative Hernandez."
- Hernandez, L.: "Thank you, Speaker. I also just want to give a shout out the Boys and Girls Club for coming out and visiting, but especially to Bryan Bautista who's from my District of Cicero. And interestingly, I find out that Cicero only has a Boys Club, so I think I have some work to do. Thank you"
- Speaker Hoffman: "Returning to Third Readings. On page 22 of the Calendar, House Bill 2485, Representative Severin. Out of the

record. On House Bill 3038, Representative Unes. Read the Bill, Mr. Clerk."

Clerk Hollman: "House Bill 3038, a Bill for an Act concerning health. Third Reading of this House Bill."

Speaker Hoffman: "Representative Unes."

Unes: "Thank you, Mr. Speaker. House Bill 3038 is a trailer Bill correcting an unintended consequence from a Bill that we passed last year. This amends SASETA and just provides that an adult survivor... ensures that an adult survivor is going to be able to be treated at the nearest treatment hospital. I know of no opponents and I ask for an 'aye' vote."

Speaker Hoffman: "Seeing no one seeking recognition, the question is, 'Shall this Bill pass?' All in favor vote 'aye'; all opposed 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? D'Amico. Robinson. Have all voted who wish? Mr. Clerk, take the record. On this, there are 112 voting 'yes', O voting 'no', O voting 'present'. And this Bill, having received the Constitutional Majority, is hereby declared passed. On page 19 of the Calendar, appears House Bill 357, Representative Yednock. Read the Bill, Mr. Clerk."

Clerk Hollman: "House Bill 357, a Bill for an Act concerning finance. Third Reading of this House Bill."

Yednock: "Thank you, Mr. Speaker and Members of the House. House Bill 357, known as the Buy Illinois, would require that state agencies give preference when purchasing goods to products made in Illinois. This would be products composed of at least 50 percent Illinois materials or commercially available off the shelf items. If state agencies cannot obtain these Illinois manufactured products then purchase preference must

be given to products manufactured in the United States. We talk a lot about buying in our country and our state, and this Bill is an effort to support our jobs here in Illinois and be sure that our state agencies, when making purchases with taxpayer dollars, keep those dollars here in Illinois. And I would appreciate a 'yes' vote."

Speaker Hoffman: "On this question, Representative Halbrook."

Halbrook: "Yeah, thank you, Mr. Speaker. I'd request a Standard Debate please."

Speaker Hoffman: "Standard Debate."

Halbrook: "Thank you. Question of the Sponsor."

Speaker Hoffman: "Sponsor yields."

Halbrook: "Thank you. So, Representative, my question is, what's the genesis or the reason for doing this Bill?"

Yednock: "For more jobs in Illinois. To support our own home businesses, our locally grown businesses."

Halbrook: "Yeah, there seem to be quite a bit of opposition to this in committee, several large manufacturers. Could you... can you explain what their opposition does? And have you tried to remove any of that?"

Yednock: "I'm sorry, I was not part of that committee to be honest with you. I'm not sure what their objection would be if... especially if they're an Illinois business."

Halbrook: "How could you not be a part of that discussion if you're the Bill's Sponsor?"

Yednock: "Could you repeat that please?"

Halbrook: "How could you be the Sponsor of the Bill and not be a part of the discussion with the opposition?"

- Yednock: "You mean during committee? How... how can I Sponsor this without being in the committee?"
- Halbrook: "At any point in time. I mean... when there's opposition, you would work to sort through what their issues are to solve that to remove that opposition so that your Bill could move forward."
- Yednock: "I really haven't had any of the opposition reach out to me, Representative, other than I do... I will admit, I got an email from Canada."
- Halbrook: "So we've seen the Illinois Manufacturers, Chamber of Commerce, Siemens, C&H Industrial, Organization for International Investment, Consul General of Alberta, Ontario, and Canada are all opposed?"
- Yednock: "None of them in Illinois."
- Halbrook: "Can you tell us what this is going to cost Illinoisans?"
- Yednock: "We haven't had an analysis by Central Management Services. I guess, if I would have to take a guess it's a 10, 12 percent would be what we could look at."
- Halbrook: "I just wanted to follow up to also that you said that these opponents that I named off, that none of them are Illinois, IMA, the Illinois Manufacturers Association, the Illinois Chamber of Commerce, those companies are Illinois. A lot of these companies have production facilities in the State of Illinois, they manufacture worldwide, and they expressed to me they it's very difficult. They have worldwide supply chains and it's very, very difficult to track the different components and things like that to know where we'd stand on this thing."

- Yednock: "Well, again, the Bill is about using the purchasing power of the State of Illinois to buy from manufacturers and producers in Illinois. Which I would assume, since I saw some hats over there about make Illinois great again, you would be for that."
- Halbrook: "Could you explain how this Bill would make Illinois great again?"
- Yednock: "Because we would be actually buying more things with Illinois money to Illinois factories, Illinois jobs would be the benefactor of this."
- Halbrook: "Yeah, so to that point, can you tell me what the guarantees are in this Bill to grow those jobs?"
- Yednock: "I guess there's the same guarantee as anything. We're purchasing from Illinois, trying to purchase... making a preference, I'm sorry to purchase from Illinois companies."
- Halbrook: "So, my concern is that this could cause some problems with the federal trade agreements that were established in '94. I'm not really seeing the guarantee of the Illinois jobs, could potentially result in job loss to the State of Illinois. Small and large companies, like we talked earlier, have these global supply chains that makes this very, very difficult to do. When the Federal Government utilized Buy America, the American Recovery and Investment Act, manufacturers found it very difficult to comply with some of those things. We have a situation that 95 percent of the consumers live outside the U.S., 96 percent of those consumers live outside of Illinois. And my real concern is, this could invite policies by other states and countries that would be retaliatory or reciprocal in nature."

- Yednock: "Again, this is simply about using the purchasing power of Illinois to buy products at a preference from Illinois jobs to Illinois suppliers. It doesn't mean that you exclusively have to, Representative. It's saying to please put a preference towards it, if not, then it goes to American made products and services. And if that's not available then I guess we'll have to find another… another way or purchase it from another country."
- Halbrook: "Thank you, Representative. I have no further questions."
- Speaker Hoffman: "Representative Batinick, are you in support or opposition?"
- Batinick: "I am... I have some questions, but you're probably going to put me in the opposition category. So to be clear."

Speaker Hoffman: "Thank you. Shocker. Please proceed."

Batinick: "Will the Sponsor yield?"

Speaker Hoffman: "He indicates he will."

- Batinick: "Representative, I think I heard you say it, but there's a lot of cross talk, what is the cost to the state?"
- Yednock: "We haven't tallied that. CMS wouldn't provide because they... they quite simply said they they're not sure."
- Batinick: "Do you think it's a good idea to be passing Bills where we are unsure of the cost?"
- Yednock: "It's really just about using Illinois' purchasing power to try to buy products that are manufactured or produced in the State of Illinois."
- Batinick: "So let's be... I mean, I don't even have a... I don't know what to..."

Yednock: "I'm not sure how to answer that question because I... I mean, honestly it's... it's a good thing to be using our funds in Illinois from the Illinois taxpayers to try to buy Illinois products that serve Illinois jobs."

Batinick: "Right. So I guess the answer is you don't know what it's gonna cost."

Yednock: "That's correct."

Batinick: "Okay. Do you know how much CMS spends per year?"

Yednock: "No, I do not."

Batinick: "So, I mean this is, I understand it might be difficult to calculate it to a T, but I don't even have an understanding in my analysis, or you don't. Is this a billion dollars, \$10 billion? If CMS spends \$10 billion and we can go up to 12 percent above that for Illinois purchases, you're looking at a billion dollar cost."

Yednock: "Well, that's also... you're talking labor and a lot of other things. We're talking about products, off the shelf products. It's probably not as quite a big as the whole number of CMS."

Batinick: "Right, but I guess if we're just... my point is... my frustration is we're passing a Bill with no idea what the cost is. Is it hundreds of millions? Is it over a billion? And the other part is, what are the soft costs on this? So there's obviously going to be... we keep talking and... and we talk about how administrative cost of education, higher ed, all these administrative costs are going over, you know, up through the roof, so I assume that this hits universities. So now universities need to spend more money trying to figure out if something is made in Illinois, then trying to figure

out if it's made in the United States before they purchase it. And we pass these small Bills... makes for a good press pop, yet it causes a bunch of administrative costs for universities that are already going through the roof. Does that concern you at all?"

Yednock: "Well, I think they follow that process pretty much as it is now. I... what I understand from the Bill's language is that if they cannot find a product or they think the product is, you know, something they're not going to be able to purchase they can ask for a waiver from the purchasing agent. And it's as simple as I ask this... as simple as the purchasing agent says, go ahead. It's not a huge process. And plus, Representative..."

Batinick: "I'm going to push back a little bit there because I hear from universities and agencies about how difficult our procurement process is and it's a bunch of paperwork and our administrative costs are going through the roof. More importantly, I don't know if I've ever had a product that said, I've had stuff that says made in the USA. I don't know if it gets specific to Illinois, is there even a system in place? How much work does a procurement officer have to do to try to figure out if somethings made in Illinois. And then are we making up our own rules if it's... what if the raw materials are made in Indiana then it's assembled in Illinois or vice versa. Are there even rules for this? I mean there are nationally for countries, but how do you figure out the rules for the state?"

Yednock: "A lot of it has probably to do with labeling. I would assume with, you know, made in Illinois, made in America, but

it is... in the Bill talks about components, products, how much is... how much of the product is valued in Illinois. I mean there's different components of it, but I don't see how it would be that difficult to find out if something was manufactured in Illinois or not."

- Batinick: "I... I'm going to buy a hat at a store, does the store where they bought it even know if it was manufactured? I mean, I'm not trying to be silly here. I think it's really hard to find out, I can see something that's made in the USA, I would have a really hard time finding out whether it's made in Illinois or not and what constitutes being made in Illinois."
- Yednock: "I don't think it... it gets down to the point of buying a hat or a suit, we're talking about certain products."
- Batinick: "Well actually it does because there's a preference. So, the preference says if something's 12 percent more than nationally or less you have to buy in Illinois. So the, I'm trying to envision if I'm buying something small, I'm probably going to spend more on administrative costs then what some of these small purchases actually cost to buy."
- Yednock: "I... I don't know that to be the truth, Sir. I just know that what this Bill does is asks our procurement officers to look at buying Illinois products first as a preference."
- Batinick: "Okay, and... just a little education, I know procurement officers kind of act almost as they're... they make their own rules and I've had a lot of... I've heard from a lot of agencies that they do it differently depending on who's the procurement officer, and that's again part... part of my concern. The last one I had, because this came up in the other Bill, what's the

12 percent? Why not 5? Why not 20? Where does 12 percent come from?"

Yednock: "I... I'm being led to understand that that has to do with the federal procurement process. That is something that the Federal Government allows. That's what I was led to understand. I... I'm being honest with you, Representative Batinick, I don't have the exact answer for that. I questioned it myself, but what I was told it was probably because of the federal procurement process allows that."

Batinick: "Okay. I'm going to go ahead and go to the Bill. I don't know if we know this or not, but I've been... you know, I think we're in a little bit of a budget situation here, a budget shortfall. I'm not sure it's wise to be passing Bills, again, where we have no idea what the cost is. We have no idea what the soft costs are. We don't know if it effects trade agreements because this might go against international trade agreements we have. For those reasons I voted... I urge a 'no' vote. Thank you."

Speaker Hoffman: "Representative Halpin. I assume in support."

Halpin: "Yes, Mr. Speaker."

Speaker Hoffman: "Please proceed."

Halpin: "I'll go straight to the Bill."

Speaker Hoffman: "To the Bill."

Halpin: "When it comes to the cost of this Bill, for many Illinoisans the only cost is going to be the lack of the free time they have because they're going to be more stably employed as we support our state businesses. And I want to point out that, when we talk about the Manufacturers' Association, we talk about the Chamber of Commerce, each and

one... each and every one of their membership could tomorrow decide that they want to have a preference to supply themselves with Illinois businesses and Illinois labor. They have that choice because they are the purchaser of that product. The State of Illinois should have the same option to put its purchasing power behind Illinois businesses and keep those dollars within the State of Illinois. And I should say that I hope each of those organizations does encourage their membership to support Illinois businesses, and do Illinois sourcing, and made in America sourcing. So... the State of Illinois should be able to have that same option. That's all this Bill does. And I would urge a 'yes' vote."

Speaker Hoffman: "Representative Scherer."

Scherer: "Thank you, Mr. Speaker. To the Bill."

Speaker Hoffman: "To the Bill."

Scherer: "I can guarantee that if I go home any of my constituents... which for me would be just to walk outside the building... but any of my constituents would say, if I went up and pulled them and said, 'would you rather that we buy our products in Illinois, made in Illinois? Or would you rather that someone from China made our products?' A hundred out of a hundred times they're going to say keep the jobs local, grow local, shop local, keep it in Illinois. We see it and we hear it and many Members in this very august Assembly, say that very thing day after day. I'm working on a Bill right now with teacher testing for student teachers and the Bill is produced by a company called Pearson, they're from Massachusetts and owned by a company in Britain. There's no reason that that can't be done in Illinois, and we wonder why we have budget problems.

To the gentleman earlier, yes, we have budget problems, and it's because of Bills just like this when you don't use common sense and you argue when you're from Illinois whether things should come from Illinois. That's why we have budget problems to begin with. I strongly urge an 'aye' vote."

Yednock: "Thank you, Mr. Speaker. I would just appreciate a 'yes' vote on this."

Speaker Hoffman: "The question is, 'Shall House Bill 357 pass?'
All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this question, there are 70 voting 'yes', 38 voting 'no', 3 voting 'present'. And this Bill, having received the Constitutional Majority, is hereby declared passed. Continuing with Third Readings, we have House Bill 386, Representative Crespo. And that is page 24 of the Calendar. 3586, Representative Crespo. Out of the record. House Bill 347, Representative Flowers. Read the Bill, Mr. Clerk."

Clerk Hollman: "House Bill 347, a Bill for an Act concerning civil law. Third Reading of this House Bill."

Speaker Hoffman: "Representative Flowers."

Flowers: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 347 changes the Probate Act by expanding the definition of abuse for probate purposes to include the crimes of assault, assault... aggravated assault, battery, and aggravated battery. The Bill aimed to make it more difficult for individuals convicted of elder abuse to recover from their

victim's estate. I would appreciate an 'aye' vote and I'd be more than happy to answer any questions."

Speaker Hoffman: "Seeing no one seeking recognition, the question is, 'Shall House Bill 347 pass?' All in favor vote 'aye'; all opposed 'nay'. The voting is open. Have all voted who wish? Harper. Sommer. Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On this question, there are 112 voting 'yes', 0 voting 'no', 0 voting 'present'. This Bill, having received the Constitutional Majority, is hereby declared passed. On House Bill 142, page 18 of the Calendar, Representative West. Read the Bill, Mr. Clerk."

Clerk Hollman: "House Bill 142, a Bill for an Act concerning finance. Third Reading of this House Bill."

Speaker Hoffman: "Representative West."

West: "Thank you, Mr. Speaker. House Bill 142 is a Bill from the Illinois Community College Board to clarify community college districts reporting requirements under Business the Enterprise for Minorities, Women, and Persons Disabilities Act, also known as the BP...
