RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article XIV of the Illinois Constitution by changing Section 3 as follows:

ARTICLE XIV

CONSTITUTIONAL REVISION

SECTION 3. CITIZEN INITIATIVE FOR CONSTITUTIONAL AMENDMENTS

Amendments to this Constitution may be proposed by a petition signed by a number of electors equal in number to at least eight percent of the total votes cast for candidates for Governor in the preceding gubernatorial election. The initiative process shall not be used for the proposal, modification, or repeal of any portion of the Bill of Rights of this Constitution or to modify the initiative process for proposing amendments to this Constitution. A petition shall contain the text of the proposed amendment and the date of the general election at which the proposed amendment is to be submitted, shall have been signed by the petitioning electors not more than twenty-four months preceding that general election and shall be filed with the Secretary of State at least six months before that general election. The procedure for determining the validity and sufficiency of a petition shall be provided by law. If the petition is valid and

(a) A referendum to reject any Public Act, excepting appropriation measures, passed by the General Assembly and enacted into law may be proposed by a petition signed by a number of electors equal in number to at least 5% of the total votes cast for Governor in the preceding gubernatorial election. The petition shall be signed by the petitioning electors and filed with the State Board of Elections not more

than 90 days after the enactment of the Public Act. A petition shall contain the Public Act number, the date of the general election at which the proposed amendment is to be submitted, and the date, if the Public Act is rejected, that it will cease to be in effect.

(b) The procedure for determining the validity and sufficiency of a petition shall be provided by law. If the petition is valid and sufficient, the proposed referendum shall be submitted to the electors at the general election specified in the petition. If the voters in the specified election reject the Public Act, it shall cease to be in effect on the date specified in the referendum.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.
