Butler: "Thank you, Sir. I would just like to say, on behalf of all the EIU graduates, happy 126th birthday to both Eastern Illinois University and Northern Illinois University, which I think Representative Keicher's going to say a few words about tomorrow. One hundred and twenty-six years ago, the Enabling Acts for both of these fine institutions were enacted. EIU has a great history in our state of educate... it started as a teachers' college. We educated generations of teachers that have gone out and taught generations of Illinoisans ever since we were founded in 1895. We have an excellent journalism school that has produced award-winning journalism ... journalists around the world. We have a leader in quarterbacks and coaches in the NFL, as you may know. And my favorite, we produce a lot of great public servants. And in this Body, we have several EIU... folks who attended EIU in this Body. Representative Scherer. We've got the EIU row back here with Representative Murphy, myself, and Representative Caulkins, Representative Bennett, Representative Niemerg, all EIU graduates. And EIU still remains as the only Illinois public institution that has educated a Governor, Governor Edgar. So, I would say happy birthday to EIU. Happy birthday to NIU. Go Panthers."

Speaker Harris: "State your point."

Keicher: "I would like to share in Representative Butler's admiration for our institutions. Like so many of you I know in this room, Northern Illinois University has a strong legacy

So many families, time and again, have come up to me and shared with me the proud legacy, the proud Huskie legacy that we have established through the success of our people and the chance that NIU gives for generational improvement to the residents of the State of Illinois. I'm proud here to say happy 126th birthday to Northern Illinois University. Go Huskies."

Yesterday, while we were voting on Third Readings, I inadvertently pressed the 'yes' switch on SB2150, when I intended on voting 'present' due to a potential conflict. And just like it so noted. Grant: "Point of personal privilege."

Speaker Harris: "Please state your point."

"Okay. Now, what I'm going to talk about is a little bit Grant: more serious. But people in my district... I have had numerous messages and telephone calls and conversations about this particular Bill. And I'm going to quickly talk about my objection to a proposed Bill that may be presented to this Body for vote. This House Bill 1797 will not require a parent to give their consent to a girl seeking an abortion, but it will repeal notifying a parent of her intent. Under current law, it is illegal for minors to use a tanning bed, get a tattoo or body piercing. Minors cannot vote, buy cigarettes, serve in the military, or purchase lottery tickets, but they will be able to get an abortion at any time, for any reason, without their parents' knowledge. We all are aware on how medical study after medical study have shown brain development in minors is not complete. This is why so many of our laws require parental involvement. There should not be an Bill 1797 repealing exception with House parental notification. Even more importantly, this is the most important thing, that the law would allow human traffickers and adult abusers to take their minor victims to clinics to

erase the evidence of their abuse without anyone knowing. We need to protect our young girls. This legislation is bad for children, bad for parents, and bad for Illinois. I hope it doesn't come to the floor. Thank you."

Speaker Harris: "Representative Kifowit, for what reason do you seek recognition?"

Kifowit: "Point of personal privilege."

Speaker Harris: "Please state your point."

Kifowit: "Thank you, Speaker. I want to inform the Body that on May 3 I received a text from our doorman, Mizell. And he mentioned that he had COVID and pneumonia in both his lungs. I also was asked to relay to the Body that he is doing well. And he wanted me to tell everybody here that he wishes he was at the Capitol. And although he's COVID free, the doctors want his lungs to clear up more, and that will take away the shortness of breath. Rule 88(g), the Judiciary - Civil Committee reviewed the firm's amended fee petition requesting reimbursement for a little under \$32 thousand. However, based on our review with the filing's record, prior qualifications challenges before the House involving attorney reimbursement, the Judiciary -Civil Committee denied in part, and granted in part, the Miller Shakman amended fee petition. It is the Judiciary -Civil Committee's recommendation that the reasonable, just, and proper reimbursement sum is, and shall not exceed, \$25,246. It is further the committee's strong recommendation that upon the firm receiving this reimbursement sum, that the firm refund Representative Delgado her security retainer in full. I would like to thank Minority Spokesperson Mazzochi for her thoughtful work in resolving this matter. And should she choose to explain the matter... how this matter is intended to be considered by the House, among other House precedent in the future, I believe we both agree. Thank you. I ask the House approve and adopt House Resolution 323."

Mr. Frederick's remains were returned to the United States on March 13, 1974, and he's buried in the Mount Hope Cemetery in Tremont. So, we look forward to a portion of Interstate 155 being named in his honor, much too late after his death, but a small honor that we could pay to Mr. Frederick. And I would request a moment of silence for Mr. Frederick. Thank you."

- Speaker Harris: "Representative Mason has moved for the adoption of House Resolution 204. All those in favor say 'aye'; opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Resolution is adopted. On page 11... I'm sorry. On page 12 of the Calendar is House Resolution 219, Representative Lilly. Representative Lilly, House Resolution 219."
- Lilly: "Thank you, Mr. Speaker, Ladies and Gentlemen. House Resolution 219 urges state lawmakers to enact policies to preserve the health, safety, and well-being of women during the COVID-19 pandemic. COVID-19 pandemic has contributed to the economic crisis that has affected women and Americans across the state disproportionately. Women affected the most.

Women of color affected immensely. Women have suffered the forces of this crisis because of inadequate child care, instability, and hard-hit industries, and insufficient health care and safety resources. Women have been disproportionately affected by unemployment, with women suffering 60 percent of the pandemic-related job losses. The unemployment rate of women reaches a staggering 16 percent, with most of the women being affected black, Latino, and disabled women. This pandemic has caused families to go unloved. We here, with this Resolution, is urging the State of Illinois and the Federal Government to ensure health, safety, and wellness of women during the 19... COVID-19 pandemic. With that, I ask for an 'aye' vote."

Speaker Harris: "Representative Lilly has moved for the adoption of House Resolution 219. All those in favor say 'aye'; opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Resolution is adopted. Representative Moeller on House Resolution 220."

Moeller: "Thank you, Mr. Speaker. House Resolution 220 designates March 21, 2021 as Equal Pay Day. As the Body might recall, we celebrate and recognize this day every year as the day that it takes the combined of... women working to meet the same salary level as men. This day was created by the National Committee on Pay Equity in 1996 to bring public awareness to illustrate the difference between men and women's wages. And it's meant to symbolize how far into the air a woman must work on average to earn as much as a man earned the previous year. This is the combined of all women, but we know that in Illinois black women earned 61 cents to the dollar, Latino

women earned 53 cents on the dollar. And women did not receive equal pay for 12 months of work in 2019 until March 31, 2020. So, with that, I would ask the Body to recognize this important day and to continue to work on policies that close the gender wage gap for all of us in Illinois. Thank you."

- Speaker Harris: "Representative Lewis has moved for the adoption of House Resolution 256. All those in favor say 'aye'; opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. Also, on page 12... oh, I'm sorry. And House Resolution 256, having received the Constitutional Majority, is hereby declared adopted. Also, on page 12 is House Resolution 231, Representative Carroll."
- Carroll: "Hello and thank you very much, Mr. Speaker and Members of the Body. HB231 (sic-HR231) pays tribute to the veterans of the Korean War, its victims, and family separated by the war. This salutes the Illinois National Guard Korean War

Resolution Constitutional Amendment #11, offered by Representative Evans. Be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend the Illinois Constitution in Article I by adding Section 25 as follows:

ARTICLE I

BILL OF RIGHTS

SECTION 25. WORKERS' RIGHTS

- (a) Employees shall have the fundamental right to organize and to bargain collectively through representatives of their own choosing for the purpose of negotiating wages, hours, and working conditions, and to protect their economic welfare and safety at work. No law shall be passed that interferes with, negates, or diminishes the right of employees to organize and bargain collectively over their wages, hours, and other terms and conditions of employment and work place safety, including any law or ordinance that prohibits the execution or application of agreements between employers and labor organizations that represent employees requiring membership in an organization as a condition of employment.
- (b) The provisions of this Section are controlling over those of Section 6 of Article VII.
