- Wayne Padget: "Let us pray. Lord, as we prepare for Session today, I ask freshness of your spirit to quicken our thinking, that out of confused issues may come simplicity of plan, that out of fear may come confidence, that out of hurry may come deliberation, and that out of frustration may come guidance. Let us get to work not head first but heart first. May we be able to disagree without being disagreeable, to differ without being difficult, to be honest without tension, and to be frank without offense in an atmosphere of team spirit. These things we asks, Amen."
- Speaker Harris: "We'll be led in the Pledge of Allegiance today by Representative Ozinga."
- Ozinga et al: "I pledge allegiance to the flag of the United States of America and to the republic for which it stands, one nation under God, indivisible, with liberty and justice for all."
- Speaker Harris: "Roll Call for Attendance. Leader Greenwood is recognized to report any excused absences on the Democratic side of the aisle."
- Greenwood: "Thank you, Mr. Speaker. There are no Democrats absent."
- Speaker Harris: "Leader Welter is recognized to report any excused absences on the Republican side."

- Welter: "Mr. Speaker, let the record reflect that Representatives Meier, Sosnowski, and David Friess are excused for the day."
- Speaker Harris: "Have all recorded themselves who wish? Have all recorded themselves who wish? Mr. Clerk, please take the record. With 108 Members answering the roll call, a quorum is present. Mr. Clerk, Committee Reports."
- Clerk Hollman: "Committee Report. Representative Harris, Chairperson from the Committee on Rules reports the following committee action taken on February 22, 2022: recommends be adopted, referred to the floor is Floor Amendment(s) 1 to House Bill 4386, Floor Amendment(s) 1 to House Bill 4739, Floor Amendment(s) 1 to House Bill 5016, Floor Amendment(s) 1 to House Bill 5385, and Floor Amendment (s) 1 to House Bill 5447. A corrected Committee Report from February 17. Representative Robinson reported the following committee action taken on February 17, 2022, from the Cybersecurity, Data Analytics, & IT Committee: it was do pass as amended Short Debate, House Bill 5165."
- Speaker Harris: "Representative Collins for a point of personal privilege."
- Collins: "Thank you, Mr. Speaker. I wanted to address the floor about an incident that took place last Thursday after our debate. After a heated debate last week, I was confronted by my colleague, which caused two Representatives to step in between us to de-escalate the situation. But really quick, before... for those who don't know me or know my story, I lost my mother at five. And the people who were supposed to love me and protect me did not do that. I experienced physical, verbal, and sexual abuse until I became a teenager and found

my voice to say, 'No more.' I lived in several different communities, stretching from the City of Chicago all the way out to the suburbs. I lived on couch to couch. I experienced trauma after trauma while switching from house to house. So, when that moment when I was being confronted by my colleague, and what my colleague said to me in that moment, I was triggered. I was scared. I felt unprotected. And I was shocked that this even transpired. I fought myself over the weekend whether or not I was going to come forth and say something or just turn the other cheek. But I remember that turning the other cheek, what that looked like, what it felt like, and because of that, I felt like this would be the right thing to do. My colleague did try to offer me an apology that day, 10 minutes after the altercation. But in that moment, it wasn't the right time, especially when I stated I felt unsafe. What I took from this is that we can all agree to disagree, but we have to move forward and do the work we were elected to do. As a black woman, we are told to be strong, but at the same time to be quiet, to tone down, don't be too aggressive, and our concerns oftentimes go unheard. I'm thankful for my colleagues who stood to the ready to separate us and to the Leadership who were here who acted so quickly. I hope that we can all put this behind us and keep the people we represent at the forefront. We're all imperfect people. We may not always see eye to eye, but we can always be civil and respectful of one another. This is not political for me. This is me speaking my truth and how I felt in that moment. I'm speaking for the little girl that was told she was not good enough, she wasn't worth it. I'm speaking for the woman, the

man, the children who had the same experience as me in foster care or had worse experience but was unable or able to overcome that. I speak for the working people who are often overlooked for promotions on their jobs, even though they're qualified or over qualified to go up... and still go above and beyond, but still are overlooked. I speak for the people who are struggling to keep their heads above water. I speak for the seniors who need crucial services to live in their own homes. I speak for anyone who was told, 'Wait your turn.' What I would like today is for us to put last Thursday behind us and move forward so we can deliver to the great people of Illinois. No matter how we feel, we have been doing just that, and we should continue to do so if we stay focused. Thank you to Speaker Welch and Leader Durkin for acting so quickly on this matter. Thank you to my Chairman of the Legislative Black Caucus, Kam Buckner, for your leadership. And thank you, Rep West and Leader Evans, for responding so quickly in that moment where this black woman felt unsafe. And lastly, thank you to all my colleagues on both sides of the aisle. I really hope that we can do what we were... what we have come here to do, what we were elected to do, and that's to get the work done and to deliver to the people who rely on us to be there voice in this chamber. Thank you."

Speaker Harris: "Representative Reick for a point of personal privilege."

Reick: "Thank you, Mr. Speaker. I was raised poor. I've achieved things that I never thought I would. What happened on Thursday probably was to some extent the sum total of my upbringing as well. I was taught that you don't take an insult, you don't

take something that is wrong lightly. And when I heard my name being mentioned as one who was violating the mask mandate, I took umbrage at that, because I'm also a rules quy. I believe that these rules are in place ... I disagree with the mask rule completely, but that's the rules. And, hopefully, the day is soon approaching when we won't have to do that on this floor anymore. But the fact remains is that my name being called out as being in violation of a rule that I am bound to follow and respect, in spite of my disagreement, gave me a little bit of ... more than a little bit, a lot of concern because I'm not that kind of guy. I'm just not. I'm big. I'm loud. Sometimes I'm profane. But I'm not that kind of quy. So, when I went over to the Representative and had words with her, they came from an anger of the fact that I was being somehow taken and made into something I was not. I regret those words. I regret those actions. After the... and I want to say that, regardless of how the actions were perceived or the words were perceived, there was no intent at all to cause harm. I hope you understand that. I think you know me well enough to know that I'm blunt, but I don't ... I don't try to cause harm. Ten minutes after this happened, I went back and offered an apology, offered to give the Representative an apology. And she acknowledges that, but I was told by the Speaker that it was not the time. It was not the time to apologize. One of the other things I was brought up with was the fact that if you screw up, you make it right, right away. You don't wait until it's convenient for you to do it. You make sure that you make amends immediately upon having made a mistake. And that's what I tried to do, but I was not

allowed to do that. And so, what happened was, over the weekend letters started to come back and forth demanding things, threatening unstated sanctions possibly, unless I gave a public apology. I will say again, I'm sorry for what I said. And I said that to the Representative in Speaker Welch's office this morning. And I offered to do immediately thereafter. And this all could've be defused, but now it's in the public realm. There are letters that are out there, and there are those who will perceive this as having been done as a result of demands and threats of unspecified sanctions. I'm offering up an apology, but it's no different than the apology I would've offered up had she been willing to listen to me 10 minutes after this happened and this never would've had to occur. That's how you do these things in my world. You're honest. You take care of business. You clean up your own mess and you move on. That's what I intend to do with this, and these are my last words on the thing. Thank you, Mr. Speaker."

Speaker Harris: "Leader Durkin."

Durkin: "Thank you, Mr. Speaker. I'll be brief. Last week, I made a statement on the floor about we need to take the temperature down. And as I process what happened with Representative Reick and Collins had said between then and now, I stand by what I said. I think sometimes we forget that we represent 13 million Illinoisans. Yes, 13 million Illinoisans. They look up to us. They want us to solve problems that they have, that their family has. We have businesses who asks us, help us with this issue. And when I think about that, I think about, overall, that we have much more in common than you really think. We

all have different backgrounds. We were raised differently in different parts of the states... of the state. We have different vocations. But at the end of the day, I know full well one thing that is extremely, and the most important thing that I could say, is that we all love the State of Illinois. That's why we are here. That's why we take up this very noble position. And I do believe it's a noble position of serving in the Illinois House of Representatives. I love my job. I have passion for my job. And what I just heard right now, from both Representative Reick and Collins, are two Members who have great passion for what they do, great passion for their constituency. But, more importantly, we have been able to lower the temperature, which we need to do on a regular basis. Now, earlier today, I asked Speaker Welch, during the course of these letters that were going back and forth, if we could sit down, he and I and the two Representatives, to talk this through and see if we can resolve this in an amicable manner where we can get back to the business of the day. And I will say that I'm glad we had that meeting. I believe that when I walked out of there, I know that ... I know Steve Reick quite well. He's a good, decent man. But I didn't know Representative Collins at all before this. But when I heard her talk about her story, about who she is and where she is right now, it's given me a greater understanding of how she approaches life, but also how she approaches this position. It's a great story, Representative Collins, and you should be proud of it. But at the end of the day, we are here to solve problems, and I'm going to continue with that approach. But also remember, just think about this, we have people watching

us right now and there will be a point in which we will have people will be in the gallery, adults, children. Think about that. Let's respect what's going on, on the floor. Let's listen to somebody's questions. Let's listen to somebody explaining their Bills. How many times have people said, 'What are they doing?' We should be proud of the moment. We should respect the moment. We should give the people who are watching us that opportunity to realize that we're serious people who all have something in common. That's to fix our state, help our neighbors, help our neighborhoods. Because when our state fails and when we fail, I can't imagine... what is our purpose then? But we do that by exercising civility, but that doesn't mean that we can't have a robust debate about language in a Bill or whether or not any one particular proposal is right for the state. We will continue to have that type of dialogue, and I'm no stranger to that. But let's move forward and make a commitment towards civility, respect everyone's positions, their life story, their constituents, and we'll be a better place for that. So, at the end of the day, just remember we need to be the adults in the state. And I'm glad that both my colleagues spoke frankly about a very unfortunate situation, and I hope that we will never get there again. But let's say that, if there are problems in the future, what we did today, myself and the Speaker, we talked about it. We did what adults do. And if that happens again, we'll do it again. But just remember that we are being watched by so many and so many people rely upon us, that we owe more to our constituents than to name call, criticize people unfairly, and to lack the respect that this chamber deserves. So, with that, it's my

hope that we can move forward and we will have our robust debates and votes. 'Cause at the end of the day, we are here based on what the political consequences are of every two years, and we'll take it from there. But like I said earlier, we all have more in common than we don't. Thank you, Mr. Speaker."

Speaker Harris: "Speaker Welch."

Speaker Welch: "Thank you, Mr. Speaker, Members of the General Assembly. Leader Durkin, I join you on the floor today to make a public request in bringing civility back to our great chamber. Today I did have a chance to sit down with the Leader to discuss how our caucuses can productively work together as the duly elected Representatives from our communities all across this great state. After a couple incidents that took place in this chamber last week, I had some serious concerns about our ability to work together as Democrats Republicans. And 13 months ago, I meant what I said. It's important that we work together as Democrats and Republicans as the House of Representatives. I think it is fair to say that many of us, many of us were concerned about the public discourse that was on display last week. But I will say that today, I left a meeting with Leader Durkin, Representative Collins, Representative Reick, and our chiefs of staff feeling very optimistic about where we're headed. Our meeting was cordial and productive. And I'm grateful for that, Leader. That's the way we conduct business around here. That's the way we should work together as Democrats and Republicans. As I've said since I was elected Speaker, we must work to lower the divisive rhetoric. I know it can be hard sometimes. We

are all passionate about the communities that elected us, but we can be respectful when we're being passionate at the same time. Let's lower the divisive rhetoric. That's what we're talking about. Don't lose your passion. Come ready to debate the issues, but let's lower the divisive rhetoric. We must always conduct ourselves with mutual respect for one another. And we must make an effort at all times to find ways to work together. Not only is this how the democratic process should work, it's what the people of our state expect and deserve. With the statements that you've already heard from... from Leader Durkin, Representative Collins, and Representative Reick, I think it's clear we want to put all of this behind us and get serious about the work ahead of us these next seven weeks. I think it's also important to note that, as Leader Durkin mentioned last week and he was very clear when he said this, the rules are the rules. Those rules are in place for a reason. You may not agree with them in your life outside of this chamber, but these rules were approved by a majority of this chamber. They're the House Rules adopted by us, consistent with our powers granted in the State Constitution. We should follow the rules and lead by example. We have a few weeks left here. We can't afford a COVID-19 outbreak amongst ourselves or our staff. More importantly, we have colleagues in this Body who have children or family members who are immunocompromised or ill. Let's do our part to make sure we can all go home safely to our loved ones. Yes, we disagree. But there's people sitting here right now not following the rules that this chamber... not me. I'm not a dictator. I believe in democracy. We all voted on those rules. And there are

people here right now not following our rules. We know there will be times we passionately disagree in the coming weeks. I encourage that passionate discussion. That's okay. The diversity of this state is what makes us strong. The diversity of this state is what makes us the great State of Illinois. But when we disagree, we need to do so civilly and respectfully. Making our colleagues feel unsafe at any time in this Body will not be tolerated. It won't. Civility is important, and we have constituents watching us. Remember that. They're watching everything we're doing. We have kids at home watching what we're doing. We tell our kids to do something. And what did I say 13 months ago? People will doubt what you say, but they believe what you do. They're watching us. They're watching what we are doing. What message are we sending them? Would they be proud of their elected officials here in Springfield? Let's work together to make sure they are. Let's work together to find solutions and a common purpose in this chamber. You've got my commitment on that. Let's work together, even though we're going to have disagreements on how we get there. Let's work together, Leader Durkin, and make this an even better state than it is already. Thank you, all. Mr. Speaker, let's go to work. Thank you all so much."

Speaker Harris: "Leader Greenwood."

Greenwood: "Mr. Speaker, I move that the following Representatives be allowed to participate and cast their vote remotely.

Representatives Yingling, Mayfield, David Friess, Sosnowski, Halbrook, and Miller."

Speaker Harris: "Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On this Motion, there are 64 voting 'yes', 43 voting 'no', and 1 voting 'present'. And the Motion is adopted. Doorkeeper, please remove Representatives Niemerg, Wilhour, and Caulkins from the floor. Representative Chesney, for what reason do you seek recognition?"

Chesney: "Inquiry of the Chair, Mr. Speaker."

Speaker Harris: "Please state your inquiry."

Chesney: "Last Thursday, Mr. Speaker, I was removed for failure to follow House Rule 51.5. I've seen Members on both sides of the aisle remove their face masks during points of debate. I believe this is in violation of 51.5, and I ask that all rules

be in force at all times, including Members on the other side of the aisle. If we're going to follow the rules, we follow all the rules, just not the ones you guys pick and choose to follow. So, we need to wear our face mask when we debate. If we're going to look like idiots, we've got to debate like idiots and we've got to do it with our masks on. Thank you, Mr. Speaker."

Speaker Harris: "Representative Swanson, for what reason do you seek recognition?"

"Thank you, Mr. Speaker. I just want to bring to Swanson: everyone's attention... I'm sure you're all watching the national news. But constituents in your district today and constituents in vour districts in the future... constituents in your districts are about... are at the forefront a... of a major war. We need to go about our daily business thinking and considering the men and women who stand on the border of Ukraine or on a border in Europe or somewhere else across this world, as right now we're close to another major war. I have many friends, I have many colleagues, I have many soldiers I served with who are currently facing the aggression of the Soviet empire once again. And we all must be awake and aware of the fact of what is about to occur. These men and women volunteered to do what they did. Their families accept the responsibility to take care of the home front while the husband, wife, brother, sister, whoever it may be, they keep the fires burning at home. It's not just about the soldiers. But as we think about those Soldiers, Airmen, Sailors, Marines, think too about their families who have been left now at home wondering about what's going on with their loved

ones. Having served in a war-time period, having served in combat, it's the spouses that go through the most struggles. We know what's going on with us. We know we're protected. We're know we're okay, but they don't at all times. So, as our Soldiers, Airmen, Marines, Sailors, Coast Guard are boarding on planes, loading equipment on planes, or going about the task that they've trained for, keep them in mind. Keep them in your prayers and be ever vigilant that your constituents are serving this country proudly to protect our constitutional rights. Thank you."

Speaker Harris: "Representative Reick, for what reason do you seek recognition?"

"Thank you, Mr. Speaker. Actually this is an optimistic Reick: one. The storms that came through Illinois last Thursday were something we hadn't seen in a long time. Illinois looked like the steps of Central Asia at times. We all saw on the TV the pile ups and the trucks and cars off the roads, what happened at El Paso on Route 39. And when I went home on Friday, I drive up Route 39, and I was told by the Illinois State Police that it's going to be a long slog. Southbound lanes are closed, 55 just opened up. When I got to Route 39 in El Paso, there wasn't a truck in the median. There wasn't a truck overturned on the side of the road. It was clear. The roads were dry. I flew home. And I think, right now, each and every one of us should stand up and thank the efforts of IDOT, the Illinois State Police, our county and municipal road crews, county deputies, police departments, people who went out there and went into the storm when we were able to stay safe. There were 2 thousand calls to the Illinois State Police for

help on Thursday night, and they were all answered. Five squad cars, five Illinois State squad cars were sideswiped on Routes 55, 72, 39 by drivers who thought that they could just go ahead and flout Scott's Law. They didn't pull over. Fortunately, no one was injured. All those troopers got home safe. But I do believe that everybody in this room, we should stand up and give all of those folks a big round of applause and our deepest thanks. Thank you, Mr. Speaker."

- Speaker Harris: "Members, we're going to be going to the Order of Second Readings. On page 2 of the Calendar appears House Bill 693, Representative Willis. Out of the record. On page 3 of the Calendar appears House Bill 1780, Representative Gong-Gershowitz. Mr. Clerk, please read the Bill."

Smith: "Today we celebrate black history, if I can have your attention for a moment. We'd like to celebrate Carter G. Woodson, the father of black history and the crusader of Black History Month. Woodson received his education during the four-month term that was established for black schools at the time. A young Woodson taught himself English fundamentals before entering high school. He completed a four-year curriculum in just two years. Carter went on to graduate from Berea College. He continued his education at the University of Chicago where he earned a second bachelor's degree. He also was awarded a Master's Degree in European History. Woodson was an educator that devoted his life to black history studies, which was largely ignored by most scholars in history text books. Woodson took on the challenge of writing black Americans into this nation's history by helping form the Association for the Study of Negro Life and History. This later was named the Association for the Study of Afro American Life and History. The following year, he established the Journal of Negro History. Woodson promoted teaching of black history by pushing for a week of priority in February between the birthdays of Abraham Lincoln and Frederick Douglass. In the end, Negro History Week would become Black History Month and most schools of higher learning would include courses or majors in black history studies into their curricular. Thank you for today's black history moment."
