Kelly: "I wouldn't say so."

Butler: "Okay. Do you know how many drivers' services facilities there are in the State of Illinois?"

Kelly: "I'm sure I do not."

Butler: "What's the most important thing about this legislation?"

Kelly: "That the Secretary of State is behind it."

Butler: "Some of us might argue with that over the years, but that's a good answer since the Secretary of State's retiring.

Who are you supporting... oh, I can't ask you that question, I quess, on that."

Speaker Andrade: "Out of order."

Butler: "Representative, it's great to have you on this committee.

Great to have you on this House. We do miss Representative
D'Amico, but you've been a real pleasure to work with. So,
congratulations on your first piece of legislation."

Kelly: "Thank you."

Speaker Andrade: "Representative Cassidy is recognized."

Cassidy: "Thank you, Mr. Speaker. Some questions of the Sponsor for legislative intent. Representative..."

Speaker Andrade: "Indicates he will yield."

Cassidy: "Thank you."

Speaker Andrade: "Please proceed."

Cassidy: "Representative, on page 10 of your Bill, there's some new language being added to the Vehicle Code that relates to the suspension of drivers' licenses for certain cannabis violations, specifically for a person under 21 years of age possessing cannabis in a motor vehicle and for a person under 21 using a fake ID to obtain access to cannabis. It's my understanding that the Cannabis Regulation and Tax Act already authorizes license suspension for these reasons. Can you please explain why it's necessary to add this language to the Vehicle Code?"

Kelly: "Sure. Adding cross references to these existing provisions of the Cannabis Regulation and Tax Act is the Section of the Vehicle Code will assist the Secretary of State's Office in implementing license suspension laws previously passed by the Legislature. It will facilitate the process of adding codes within the Secretary of State's computer system that correspond to these additional grounds for license suspension relating to cannabis violations."

Cassidy: "Thank you. Just a couple more questions. When the Secretary of State's Office suspends someone's driver's license because of one of these cannabis violations, do you know whether that happens at the time they are charged or issued a citation or does the suspension occur after the individual has actually been found guilty of the violation?"

Kelly: "According to the Secretary of State's Office, to date there have been no suspensions imposed under these provisions. The Secretary of State also advised that, if and when a suspension is ever imposed, that would occur after the

Secretary of State's Office has received notification from the Circuit Clerk that the person has been found guilty of the violation."

Cassidy: "Thank you. I know that some advocacy groups have raised concerns that the current language is a bit unclear on that last point and proposed some language to make it more clear. I've also been told that that clarifying language is acceptable to the Secretary of State's Office but that an Amendment is not being adopted out of concern that amending the Bill at this time could slow it down in the Senate and risk delaying passage of other provisions in the Bill that are important to the Secretary of State's Office. Is that accurate?"

Kelly: "Yes, that's accurate."

Cassidy: "And will you commit to working with me to make those additional clarifications in a trailer Bill during the Veto Session or the 2023 Session?"

Kelly: "I do."

Cassidy: "Excellent. Great Bill. Congratulations on your first Bill."

Kelly: "Thank you."

Speaker Andrade: "Representative Davis is recognized."

Davis: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Andrade: "Indicates he will. Please proceed."

Davis: "Thank you very much, Representative. It's my understanding that this is your first Bill, correct?"

Kelly: "That's correct."

Davis: "I noticed that it's an omnibus Bill. So, can you tell me how many buses are being driven?"

Kelly: "I couldn't. I'll get back to you on that."

Davis: "You'll get back to me on that?"

Kelly: "Yes."

Davis: "Okay. Does this Bill contain language that would allow for the residents of Taiwan that come to this country to be able to exchange their driver's licenses, their Taiwanese driver's licenses in reciprocity for Illinois driver's license?"

Kelly: "I don't see that in this Bill, but I'd have to look. I
 don't think so."

Davis: "You'd have to check..."

Kelly: "Yes."

Davis: "...to make sure?"

Kelly: "Yes."

Davis: "So, does that mean you'll pull out of the record while you check to see if a Taiwanese resident... if that reciprocity is in there?"

Kelly: "I'd rather not pull it out, but... so, I don't think that's
 in there."

Davis: "You're not sure if it's in there? And you still can't tell me exactly how many buses are being driven with an omnibus Bill?"

Kelly: "No, I could not."

Davis: "Okay. Well, you need... have a lot of work to do on your Bill, clearly, to make sure."

Kelly: "I agree."

Davis: "Because the number of buses being driven by an omnibus Bill is extremely, extremely important."

Kelly: "Okay."

Davis: "Will you work with me on that?"

Kelly: "I will work with you on that."

Davis: "Thank you very much. Thank you, Mr. Speaker."

Speaker Andrade: Leader Mazzochi is recognized."

Speaker Andrade: "Indicates he will."

Mazzochi: "One question is, on page four of the Bill, lines three to six, you're expanding the scope of reasons why you can lose your driving privileges if you engage in what's described as 'a similar offense in another state if, at the time of the offense, the person held an Illinois driver's license or identification card.' What's the scope of the similar offenses in the other states that you're referring to here and that you're including?"

Kelly: "As long as they are actions that are criminalized in this
 state."

Mazzochi: "Well, right. But can you identify for us what some of those are? In Section 6-301, 6-301.1, 6-301.2, or Section 14, 14A, or 14B of the Illinois ID Card Act."

Kelly: "Those are violations in relation to presenting fake identification."

Mazzochi: "Okay. Including for 6-301? I know your staffer is frantically looking to see what the answer is."

Kelly: "I believe so."

Mazzochi: "Okay. Well, you believe so... but, I mean, this is your Bill. Do you know?"

Kelly: "To the best of my knowledge."

Mazzochi: "All right. Well, again, you're trying to basically ding people for what could be a violation in other states.

And I want to make sure that people are actually clear as to what is or isn't within the scope of what they're authorized to do under the law. So, I'm a little bit concerned that you don't have those answers. Let's go ahead and take a look at some of the provisions that are being added in on page 35, lines 5 to 9, subsection (m). You're saying here that a person shall be disqualified from operating a commercial motor vehicle for life if that individual uses a commercial motor vehicle in the commission of a felony involving an act or practice in connection with human trafficking, as defined under Federal Law. Tell me how this provision that you're adding in is consistent with the Black Caucus pillars that are trying to focus on restorative justice? And... or consistent with the ideas of you've actually got rehabilitation? And maybe your staffer would like to take the mic and explain."

Kelly: "As far as I know, it doesn't."

Mazzochi: "Well, why... why is that? I mean, this... again, you're basically getting rid of someone's driver privileges for life. No... no appeal. No possibility of being exempted or getting your... getting that driver's license restored. So, how is that consistent?"

Kelly: "Because they're involved with a severe form of human
trafficking."

Mazzochi: "Right. But, I mean, we've got instances where we're allowing people... where we're, under the Black Caucus pillars, the theory is that you're trying to get people back into the workforce system. So, how are you going to be able to achieve that if you're basically banning them for life from having a driver's license?"

- Kelly: "The Black Caucus Bill is not addressing severe forms of human trafficking."
- Mazzochi: "All right. Well, so... all right. Well, maybe you're... I think you're parsing it a little bit differently. But, I mean, in terms of philosophically, the idea of you're not trying to ban people for life from a particular opportunity for work. How do you... how do you consider that to be consistent? Looks like Mr. Ford is going to come over to help you. Or Representative Ford will help you."
- Kelly: "This is specifically for severe forms of human trafficking."
- Mazzochi: "Right, but it's for life. Is the felony conviction for life in this instance? It's not, is it?"
- Kelly: "The suspension of CDL privileges would be for life."
- Mazzochi: "Right. And... so, just to be clear, that you're okay with the idea that someone is going to lose their CDL privileges for life even though they've completed their felony sentence in connection with the underlying offense?"

Kelly: "For a severe form of human trafficking, yes, I am."

Mazzochi: "All right. Thank you, Mr. Speaker."

Speaker Andrade: "Leader Batinick is recognized."

Batinick: "Thank you, Mr. Speaker. Is the Sponsor... will the Sponsor yield?"

Speaker Andrade: "Indicates he will. Please proceed."
