Andrew Johnson: "Thank you very much. This is overwhelming for us, for our Native American community that is allowed to open the Session here. So, I want to say, osiyo, which is hello, a greeting in Cherokee. And I want to hear that from you. Osiyo. Again, thank you for having us. This has been a long time coming. We are very appreciative as a community, and I am here only as an individual, a part of that community. As a citizen of the Cherokee Nation, it is only one of many, many tribal nations that have lived and grown and prospered in this land. So, thank you. I would like to lead... or read a land acknowledgement. So, we began our gathering today by acknowledging the people and land upon which we meet. It is the location of the ancestorial homelands of the people of the Council of the Three Fires. The Potawatomi, the Ojibwe, and the Odawa. It is also the home of the Ho-Chunk, Peoria, Kaskaskia, Piankeshaw, Wea, Miami, Mascouten, Sac and Fox, Muscogee, Kickapoo, and Chickasaw Nations. We all have a responsibility to recognize our native nations and to work with them as we move forward. But why do we acknowledge the land? It is an expression of gratitude and appreciation to those whose territory we reside on and a way of honoring the

- indigenous people who have been living and working on this land from time in memorial. Wado is thank you."

Stoneback: "This week is National Hunger and Homelessness Awareness Week, which calls attention to the problem of homelessness that many people in our state face on a daily basis. Homelessness is a matter of life and death and the scope of the homelessness crisis and the immediate need for housing in Illinois is staggering. Chronic homelessness has increased both in number and percentage. The percentage of the homeless population consisting of chronically homeless people rose from nine percent in 2016 to 22 percent in 2020. In 2020, at least 10 thousand Illinoisans experienced homelessness. And by some counts, when you combine those with who requested services from the Department of Housing and Urban Development over the course of 2020, the count is over 65 thousand people experiencing homelessness in Chicago

alone. According to ISBE, over 47 thousand schoolchildren were identified as experiencing homelessness in the 20... 2019-2020 school year. People experiencing homelessness include people with substance use disorders, HIV, AIDS, serious mental illness, veterans, seniors, and survivors of domestic violence. Black people are eight times more likely to experience homelessness than white people. Black Illinoisans comprise 14 percent of the population of the state, but they constitute 61 percent of residents experiencing homelessness. People experiencing unsheltered homelessness may become frequent utilizers of hospital emergency rooms, encampments, tents, cars, abandoned buildings, and park benches, which are unhealthy, and undignified. And unsheltered homelessness is especially dangerous during cold weather, heat waves, and extreme weather conditions. Crisis housing is the foundational safety-net for people in immediate need of shelter. During COVID-19, shelter capacity diminished significantly and many areas of Illinois lack shelter that they need. This critical part of and gateway to the continuum of housing is severely lacking in Illinois. There is an urgent need for safe, dignified, non-congregate crisis housing. A model of rapid response shelter transitional villages with case management has emerged in the past few years. Residents of these transitional shelter villages are connected to housing with wraparound social services, such as mental health care, showers, and laundry. With a safe place to sleep, supportive environment, access to meals, facilities, and a case manager, residents can focus on finding permanent housing and employment opportunities. This model is

more cost effective than any institutional setting per person or unit and can be built at a fraction of the cost of regular shelters. So, I have filed House Resolution 986 and... in which we urge the state to launch a pilot program to establish a shelter village that will support the crisis housing and health needs of people currently experiencing unsheltered homelessness. So, all of us here today, we're going to be heading back in... very shortly later today to our districts to celebrate Thanksqiving next week. And I'd like all of us to remember those who of... who are not as fortunate as us. Those who lack the most basic necessity, a roof over their head and a place to call home. So, today, in honor of National Hunger and Homelessness Awareness Week, I'd like all of us to commit to real intangible solutions to fight homelessness. And thank you for your attention and consideration. It is my sincere hope that, as we head into this holiday season and the coldest months of the year, that every Member of the General Assembly will support this Resolution. I wish all of you a happy Thanksgiving."
