FOREWARD

The fall 1971 session of the 77th General Assembly is a landmark in the legislative history of the state. It was in October of 1971 that the legislature began recording and transcribing its deliberations under terms of the 1970 Constitution. This meant that floor proceedings of the General Assembly would be accessible in a permanent written form.

Unfortunately, although the debates have been recorded since the fall of 1971, these proceedings have not been published. They have, of course, been available to the public as the 1970 Constitution requires, but this has been through the legislative offices and the Index Department of the Office of the Secretary of State on an individual request basis rather than through a formal and complete publication.

In an effort to make the proceedings of the legislature known to the citizens of the state of Illinois, the floor debates from the 77th General Assembly for the House were microfiched, indexed, and sent to Illinois documents depository libraries and library systems throughout the state. This was an undertaking which involved the efforts of many people. The Speaker's Office taped and transcribed the debates and provided the staff for the typing of the index. The Micrographics Division of the Office of the Secretary of State did the filming, and the State Library distributed the microfiche and prepared the bill number index.

The publication of this index to the House debates marks the final stage in the completion of this project. Similar indexes to House and Senate floor debates of other sessions are also available or are in preparation.

HOW TO USE THIS INDEX


In order to get maximum usage from this index, the researcher should keep the following guidelines in mind:

- 1. Coverage is limited to the 77th General Assembly House floor debates from October 5, 1971 through January 9, 1973.
- 2. Reference is by bill number only. Citations to Public Acts, which are given in the Illinois Revised Statutes and in other sources, can be converted to bill numbers by consulting the appropriate Public Act as it appears in the session laws. Those who need access to debate by subject or sponsor should check the indexes in the Legislative Synopsis and Digest for reference to pertinent bill numbers.
- The purpose of this index is to lead the user to discussion of legislative intent or reasons for particular activity, and not to serve as a record of all action. means that there are no references to stages in the bills' progress which did not involve debate. Many bills, for example, are not amended on second reading. The Clerk indicates that there are no committee amendments, the presiding officer asks if there are floor amendments, is informed that there are none, and the bill is moved to third reading. There will be no citation to second reading debate on such bills since the floor proceedings contain no more information than the House journal or the Legislative Synopsis and Digest. Some bills were put on a consent calendar and passed in a single roll call without separate discussion; these will not have citations to debate on third reading (final passage stage). Sometimes there is no debate on nonconcurrences or refusals to recede from amendments.
- 4. Within the limitations of the preceding guidelines, debate was indexed for all House and Senate bills where it existed. Coverage for resolutions was more selective, since most of them are ceremonial and perfunctory in nature. Debate was indexed for all House and Senate constitutional amendment resolutions and for resolutions which involved controversy (usually investigations of problems or expression of sentiments which were not universally accepted).

To locate debate for a bill:

 Consult the bill number in the index. If there are entries under the bill, they will refer to a day number (#) and pages. Note that the day numbers, which appear in eye legible type in the body of the fiche, are usually not the same as the fiche numbers in the upper left-hand corner.

2. Turn to the Microfiche Frame Locations for exact location in the fiche. Citation is to day, page, fiche number, column and row. Rows and columns are both identified by numbers. Column is given first and row second.



Thus, the frame marked ${\tt X}$ is column 6, row 4 on this microfiche.

The microfiche frame locations are intended to give the user the page number of the first frame in any series of columns. A researcher who has been referred to page 40 of Day 100, for example, will not find a reference to page 40, but will observe that page 38 is at column 1, row 4, and that page 52 is at column 1, row 5. Page 40 will therefore be at column 3, row 4.

Some days are very short and debate will not fill even one line. Day 108 is not cited in the location table, but it will appear between Day 107 and 109 in the line beginning with column 1, row 6.

Even though it is sometimes possible to estimate the location of pages in a day, it is preferable to use the microfiche frame location table. This is because the debates were not originally set up for filming, and consequently some of the page numbers were typed on portions of the page which do not show up on the fiche. Occasionally there may be pages out of order, and the table will lead the user to the correct location.
