Hon. W. Robert Blair: "For what purpose does the gentleman from Cook, Mr. Granata, rise?"

Peter C. Granata: "Mr. Speaker, I want to make a motion. Yesterday I advanced an appropriation bill to second reading without reference to committee. As I understand, there's an understanding with the Chairman and the Speaker that all appropriation bills be sent before the Appropriations' Committee. So, at this time I'm going to move that the bill be taken off of the order of second reading and be sent to the Appropriations' Committee so that it will clear the air and there'll be no no preferences, or anything else. This is a bill that the only one that it affects is the members of the legislature and I don't want anybody to put a favor and say that they're taking care of themselves and ah push everybody else around, so therefore at this time I'm going to move that the bill be sent back to the Appropriations' Committee and given a proper hearing where it belongs."



Hon. W. Robert Blair: "All right, does the gentleman have leave to have House Bill 4101 rereferred to the Appropriations' Committee so it can be set for hearing? All right, hearing no objection, then we will place House Bill 4101 back in the Appropriations' Committee ready for hearing."

Hon. W. Robert Blair: "All right, does the gentleman have leave? All right, 2863 will be tabled. Intro-. .with leave of the House, we'll go back to introduction and first reading of House Bills."

Hon. W. Robert Blair: "All right, with leave of the House, we'll go down to Resolutions so that we can concur in the adjournment resolution. The, ah, yes, we're not going to adjourn now, but we'll concur, the Majority Leader, the gentleman from Cook, Mr. Hyde."

Henry J. Hyde: "Well, Mr. Speaker, Ladies and Gentlemen of the House, Senate Joint Resolution 64 is the adjournment resolution and it provides that when the two Houses adjourn April 12, 1972, Wednesday, and of course we expect that to be perfunctory tomorrow, that we'll be adjourned until Tuesday, April 18, 1972, that's next Tuesday, April 18, 1972 at 12:00 noon. And I now move adoption of Senate Joint Resolution 64."

Hon. W. Robert Blair: "All right, all those in favor of concurring in the adjournment resolution say 'Yeas', the opposed 'No' and the adjournment resolution is concurred in. With leave of the House, we'll go back to introduction and first reading of House Bills."

Gale Williams: "Mr. Speaker and Ladies and Gentlemen of the House, this is a highway easement bill and it is to clarify a mistake that was made in a description of some land on a bill that we passed last session. I would like to have unanimous consent to have the bill read a first time and advanced to second reading without going to committee."

Hon. W. Robert Blair: "Objection? All right, leave's been granted to have the bill advanced to second reading without reference to committee. Second reading. The gentleman from Cook, Mr. Hyde."

Henry J. Hyde: "Mr. Speaker, I now move that this House stand in recess for thirty minutes for purposes of a Republican Conference and the Republicans members are to report to Room M-5. M-5 immediately."

Hon. W. Robert Blair: "The gentleman from Union, Mr. Choate."

Clyde L. Choate: "Mr. Speaker, I would ask the Democratic members to come to Room M-3 and be as prompt as possible because this is a conference that is important to you and we do want to get back on the floor of the House. The Democratic members come to Room M-3."

Hon. W. Robert Blair: "All right, ah, I think we ought to,



we'll be back on the floor at 12:30 P.M., but the conferences are only planned for 12:15, we have to have a conference in there with the Senate leadership on a matter, which will take fifteen minutes, so we will recess for conferences now and until 12:00 P.M. and be back on the floor at 12:30 P.M."

Clyde L. Choate: "Let me again urge the Democratic Members to please come to Room M-3 as quickly as possible."

Hon. W. Robert Blair: "All right, on the on the order of House Bills third reading appears House Bill 3740 on which I understand the gentleman from McHenry, Mr. Lindberg, desires to have it brought back to the order of second reading for purposes of considering an amendment, so we'll take it back to second reading and the Clerk will read the amendment."

Fredric B. Selcke: "House Bill 3740. Amendment Number Two. Amend House Bill 3740 by deleting line 1 and inserting in lieu thereof the following: 'An Act making appropriations to the Secretary of State for the administration of the Illinois Governmental Ethics Act'. and by deleting lines 4 through 7 and inserting in lieu thereof the following:



'The following designated. . .'"

Hon. W. Robert Blair: "The gentleman from McHenry, Mr. Lindberg."

George W. Lindberg: "Ah, Mr. Speaker, I think I can explain this amendment rather simply. When we have the House Bill 3700 in the previous sessions, we also had to provide money for the State Board of Ethics. That, of course, was stricken from the bill so now we have to provide money for the Secretary of State to administer the new Ethics Bill, the Illinois Governmental Ethics Act. This bill simply line items the appropriation for a total of \$50,000.00 in lieu of \$100,000.00 called for in the present bill. I'd move adoption of the amendment, Mr. Speaker."

Hon. W. Robert Blair: "All right, is there discussion? The gentleman from ah the gentleman from Cook, Mr. Shea."

Gerald W. Shea: "Ah, will the gentleman yield for a question?"

Hon. W. Robert Blair: "He indicates he will."

Gerald W. Shea: "Does this in any way change any of the substantial provisions of the Illinois Ethics Act or is this just the appropriation bill?"

George W. Lindberg: "This is just the appropriation."

Gerald W. Shea: "Thank you."

Hon. W. Robert Blair: "Any further discussion? All those in favor of the adoption of Amendment Number Two to House Bill 3740 say 'Yeas', the opposed 'No', the 'Yeas' have it and the amendment's adopted. Are there further amendments? Third reading. Now, on the order of motions appears House



Bill with respect to House Bill 3602 on which the Chair recognizes the gentleman from Champaign, Mr. Hirschfeld."

John C. Hirschfeld: "Mr. Speaker and Ladies and Gentlemen of the House, House Bill 3602 was placed in the legislature last fall and was before the late Representative Gardner's committee and because of his untimely death, we were unable to have it a committee hearing on that business, so the bill would require the Department of Mental Health to indicate to the legislature all the state institutions or any parts thereof that do not meet the minimum standards required and also require recommendations from the Department of Mental Health as to what they intend to do in bringing their facilities up to standards. We had a similar bill in the legislature last Spring which passed this House 144 to nothing, but I was only able to get 29 Democrat votes in the Senate and lost the bill there. In light of the scandal that have recently emerged from Elgin in the Hospital, I would like to move at this time to discharge the committee and to advance this bill to the order of second reading."

Hon. W. Robert Blair: "Is there objection? All right, then unanimous consent will be given to discharge the committee and advance this bill to the order of second reading. Introduction and first reading of House Bills."

Fredric B. Selcke: "House Bill 4215, Clabaugh, et.al. Makes an appropriation to the University of Illinois. First reading of the bill. House Bill 4216, Juckett. A bill for an act to amend 'The Medical Practice Act'. First



reading of the bill. House Bill 4217, Juckett. A bill for an act to amend 'The Public Meetings Act'. First reading of the bill."

Hon. W. Robert Blair: "All right, we're looking over the Agreed Resolutions list right now. If you'll give me your attention for just a moment. Ah, when we come back in next Tuesday, we will be having a Rules Committee meeting at 11:00 A.M., preceding the session starting at 12:00 noon, and the proposals before the Rules Committee for consideration now would indicate that the last day for introduction of bills other than those in the exempt category which are appropriations, revenue, constitutional implementation, reapportionment, I don't know how that got in there, but anyway, the last day for introduction of those will be probably on the 24th, which is a week from this coming Monday, so you should get your bill in in next week, we are going to be having a perfunctory tomorrow and you can leave your bills here or take them to the Clerk's office and they can be introduced tomorrow, too. The gentleman from Cook, Mr. Wall."

John F. Wall: "Mr. Speaker, Ladies and Gentlemen of the House, the Committee on Registration and Regulation had a meeting scheduled for next Monday at 4:00 P.M. Now, that meeting was cancelled and instead we will have the meeting on Tuesday at 10:00 A.M. It's an agreed motion by the Speaker, and the Leadership on the other side of the aisle, so that all the members on the Committee on Registration



and Regulation, we will have a meeting at 10:00 A.M. on Tuesday. Thank you."

Hon. W. Robert Blair: "All right, with leave of the House, we'll go back to House Bills second reading. House Bill 4113."

Fredric B. Selcke: "House Bill 4113. An Act to amend Section 9 of an act in relation to the state finance. Second reading of the bill. No committee amendments."

Hon. W. Robert Blair: "Any amendments from the floor? Third reading. Agreed resolutions."

Fredric B. Selcke: "House Resolution 543, Janczak, et.al. House Resolution 544, Capparelli, et.al. House Resolution 545, Blair and the entire membership. House Resolution 546, Chapman, et.al. House Resolution 547, Juckett, et.al."

Hon. W. Robert Blair: "All right, we're going to close on the agreed resolution list with a death resolution for a member, so we'll go out of order and take the resolutions which will be referred to committee first. Then, we'll go to the agreed resolutions list."

Fredric B. Selcke: "House Joint Resolution 120, Hirschfeld, et.al. House Resolution 121, Calvo, et.al."

Hon. W. Robert Blair: "Agreed resolutions."

Fredric B. Selcke: "All right, there are just a couple of bills here on introduction and first reading of House Bills. House Bill 4218, Blades, et.al. A bill for an act to amend 'The Revenue Act'. First reading of the bill. House Bill 4219, Choate, et.al. Amends 'The Scholarship Article' of



'The School Code'. First reading of the bill."

Hon. W. Robert Blair: "Agreed resolutions."

Fredric B. Selcke: "House Resolution 543, Janczak, et.al.

'Whereas, Our most highly respected colleague, the Honorable John G. Hon. W. Robert Blair: "The gentleman from Cook, Mr. Hyde."

Henry J. Hyde: "Ah, Ladies and Gentlemen of the House, I'm going to describe the three agreed resolutions and then the Clerk is going to read Resolution 547 which is a death resolution in honor of Horace Gardner. Following the death resolution and the adoption, we will adjourn out of respect to the memory of Mr. Gardner and the adjournment once more will be until noon next Tuesday, April 18 at 12:00 noon when we will come back. House Resolution 544 commends Paul Moll for his service to his church. House Resolution 545 congratulates William F-r-e-m-d Fremd for long and dedicated service to the school board. House Resolution 546 commends the players and coaches of the Park Ridge Juvenile Hockey Team for their outstanding performance. And the Clerk will read House Resolution 547, upon the adoption of which we will stand adjourned."

Hon. W. Robert Blair: "All right, will the House be in order, this is a death resolution for Representative Horace Gardner."



Fredric B. Selcke: "House Resolution 547. 'Whereas, The House of Representatives is deeply saddened by the untimely death of its most distinguished colleague, the Honorable J. Horace Gardner; and Whereas, The Honorable J. Horace Gardner has served the people of the 26th Representative District continuously for seven terms with great distinction, he was a most dedicated and tireless member of this House, he was Chairman of the Committee on Public Welfare and a member of the Committee on Personnel and Veterans Affairs and the Committee on Public Utilities; and Whereas, His unswerving devotion to the high principles of liberty, justice, order and human dignity, his deep commitment to civic causes and human relations, his dedication to the American ideals and his unceasing efforts on behalf of the people of the 26th Representative District assure him an exalted and permanent place in the hearts of his friends, colleagues and associates; and Whereas, He will be sorely missed by his widow, Mrs. Edith Gardner, and by the members of his bereaved family, he will also be mourned by his colleagues in the House of Representatives, by his associates and by the many friends to whom he extended the ever present helping hand; therefore, be it Resolved, By the House of Representatives of the Seventy-seventh General Assembly of the State of Illinois, that we extend our deepest sympathies to his widow, Mrs. Edith Gardner, his sister, Mrs. Marion Hammons of Chicago, and all the members of his bereaved family on the death of the Honorable J.
