Hon. W. Robert Blair: "For what purpose does the gentleman from Macon, Mr. Borchers, rise?"

Webber Borchers: "Ah, Mr. Speaker, Fellow Members of the House, I rise to a point of personal privilege. I'd like to have a little attention if you don't mind."

Hon. W. Robert Blair: "Ah, . . ah, state your point."

Webber Borchers: "Ah, last week W.C.I.A. in Champaign-Urbana on television our esteemed Superintendent of Public Instruction proceeded to call all of our newly elected school board members, three of them, and the people elected them paranoids. I want to bring to your attention that this newly elected set of re-elected members were re-elected by the people of our community by a very good majority, they had against them, and incidentally, of course, I include myself, on the point of personal privilege, as one of those who is paranoid, because I voted and supported the newly elected school board and I want to point out that these people are re-elected, over the opposition, all the liberals of our community, the black militants, the W.C.I.A.. the Herald and Review newspaper, whatever you call it a newspaper, and they opposition of the League of Women's voters, for one, you have the kind of opposition and you still win by an outstanding majority to continue the policies of our school board, I think that's indicative of the rights of the people are being expressed by the election. This is a program that there is some discussion about since 1930 and recently in 1970 we appropriated \$18,000.00 here in the General Assembly to pay for some engineering studies and so this would be commended. matter heard on the floor and that was the reason it was left on the Speaker's table rather than being referred to committee. Ah, I suggest you discuss it with the Majority Leader ah if your request is one where you do want to bypass committee and do want the House to have immediate consideration of it. That that was the thing, so why don't you discuss it with the Majority Leader. Fredric B. Selcke: "House Resolution 564, Hyde, et.al."

Hon. W. Robert Blair: "All right, let's have a little order in the Chamber while the Majority Leader explains this, and Mr. Doorkeeper, it seems to me that there are an unusual number of people on the floor that are not entitled to be there, will you see that they are removed from the floor right now. The gentleman from Cook, Mr. Hyde. Now, are you going to proceed to go through it on the changes, so these have been placed on their desks this morning, the rules change and the gentlemen ought to pay attention to it."

Henry J. Hyde: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, House Resolution 564 a copy of which has been placed on your desk, embodies changes in a rule that are very important. Now, I want to point out that these chan-



ges have been agreed upon by the Rules Committee unanimously and also agreed upon by the Senate, and the first change is in 32 (b) which says that all bills except appropriation. constitutional implementation, reapportionment and revenue in order to be considered by June 30 of this year have got to be introduced no later than Monday, April 24th and any bill other than those accepted by this exception that is introduced thereafter will lie upon the Speaker's table and will not be reported on the daily calendar, but will be referred to the appropriate committee after June 30. change in rule 32 (c) is the time table for House bills and as I stated April 24, that's Monday, is the last day for introducing House Bills except appropriation, con implementation, reapportionment and revenue. May 5th will be the final date for standing committees of the House to report on House Bills except those House Bills that have been rereferred to another committee and May 12th is the final date for third reading and passage of House Bills, June 2nd will be the final date for standing committees to report on Senate Bills. The next change is 32 (d) which is a time table for all resolutions that propose changes in the constitution of the State of Illinois or the United States by amendment or by constitutional convention. Monday will be the last day for introducing House Joint Resolutions that proposal of a constitutional amendment. 5th will be the last date for Committees to report on these and May 12th will be the final date for passage. Now, House



Joint Resolutions proposing final proposing constitutional amendments is June 2nd will again be the final date for committees to report on Senate Joint Resolutions proposing constitutional əmendments. Excuse me. An important change is Rule 51, a bill passed after June 30th, now we're talking only about bills that are passed after June 30th, shall not become effective prior to July 1 of the next calendar year unless an earlier effective date is specified in the bill and the bill was approved by three-fifths of the members elected to the House. ority. All resolutions proposing changes to the United States constitution shall require three-fifths constitutional majority. Notwithstanding Rule 93 (a) this rule may not be suspended except upon vote of two-thirds of the members of the House. Now, you have copies of these changes, if there are any questions, read them please, because they are very clear or ask questions later on if you would but again, these are agreed by the House and the Senate and both parties and so I move adoption of House Resolution 564

- Hon. W. Robert Blair: "Any discussion? All right, lets take a roll call vote on this since we are changing the rules. - Brian B. Duff: "Ah, Mr. Speaker, as principal sponsor of

- Hon. W. Robert Blair: "All right, does the lady have leave?

Robert Blair: "All right, the gentleman is requesting leave to suspend the provisions of Rule 17 so that he may post post bills to be heard in his committee next Monday, he'll post them today. All right, is there leave? All right, leave's granted. All right, with leave of the House, we'll go back to House Bills Introductions."
- Fredric B. Selcke: "House Bill 4325, Capparelli, et.al.

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Shea."

Gerald W. Shea: "Mr. . . "

- Hon. W. Robert Blair: "Let's have a little order in the chamber, this is an important matter."
- Gerald W. Shea: "Mr. Speaker, Ladies and Gentlemen of the House, this is a House Joint Resolution that is a companion bill or a companion resolution to the bill that Representative Regner introduced this morning, again to set up for this session of the General Assembly a temporary Joint Committee on Joint Finance. I think that this is probably some of the most legislation that this General Assembly will see because it truly gives to the general assembly the right to make the decisions in the budget making process in the State of Illinois. I think that it gives a new dimension to work and I think it will make us a much stronger legislative body. I would ask for the support of the House of the resolution."
- Hon. W. Robert Blair: "Any further discussion? The gentleman from Cook, Mr. Regner."
- David J. Regner: "Ah, Mr. Speaker, Ladies and Gentlemen of the House, I just wanted to say that I agree wholeheartedly with Representative Shea's efforts to say that this is the agreed resolution that was worked out and necessary to get this committee operating right away so we will have the estimated revenues by the middle of May when we'll need them in passing and sending out our appropriation bills



and I urge the membership to adopt this resolution."

Hon. W. Robert Blair: "All right, is there further discussion?

All those in favor of the adoption of the resolution say

'Yeas', the opposed 'No', the 'Yeas' have it and the resolution is adopted. All right, now we'll go to the Speaker's table and House Resolution 542."

Fredric B. Selcke: "House Resolution 542, Clabaugh, et.al."

Hon. W. Robert Blair: "The gentleman from Champaign, Mr.

Clabaugh."

Charles W. Clabaugh: "Mr. Speaker and Members of the House, I introduced this amendment or this resolution 542 last week which calls upon the Speaker and the committee, a special committee studying the sources of finance providing the various supreme court decisions that come to Illinois, dealing only with the financing of public education not on the distribution of the funds or any of those things so it is not just another layer of committees or commissions on this subject and I'm going to move the suspension of Rule House Rule 38 for immediate consideration and adoption of this resolution which provides that four of the members should be appointed by the Speaker and three by the Minority Board. Four by the Minority leader, I didn't look at that figure in there, Mr. Speaker. And so I'm moving that we suspend Rule 38 for the immediate consideration of the adopt tion of this amendment of this resolution."

Hon. W. Robert Blair: "The gentleman from Union, Mr. Choate." Clyde L. Choate: "Well, Mr. Speaker, I'd like to advise the



House that the Speaker and I have discussed the contents of House Resolution 542 and we share in the same opinion that it is a prerogative of this legislative body to discuss this all important question and to research this all important question as far as the financing of the school systems of the State of Illinois is concerned and I'm happy to say that the Speaker and I agree that it should be approached on a by-partisan basis and I'm happy to say to this House that I also agree with the Speaker in the suspension of the appropriate rules for the immediate consideration and adoption of this resolution, so that future sessions of this General Assembly can possibly find a more adequate way of the financing of the public schools in the State of Illinois. Mr. Speaker, I concur in the remarks of the gentleman from Champaign, and urge the membership to adoption of this by-partisan approach to the financing of the public school system throughout the State of Illinois."

Hon. W. Robert Blair: "All right, does the gentleman have leave to suspend 38 for the immediate consideration? All right, hearing no objection, he has leave. Now, the gentleman moves for the adoption of House Resolution 542. All those in favor signify by saying 'Yeas', the opposed 'No', the 'Yeas' have it and the resolution is adopted. The gentleman from Union, Mr. Choate."

Clyde L. Choate: "Ah, Mr. Speaker, just, I wasn't listening, did you just take a vote on the suspension of the rules or on the adoption of the resolution?"



- Hon. W. Robert Blair: "Ah, we took leave on the suspension and voice vote on the adoption."
- Clyde L. Choate: "Ah, Mr. Speaker, I would suggest that we have a roll call vote on the adoption of the resolution because of the expenditure of money and the resolution."
- Hon. W. Robert Blair: "Well, that's all right, it's not, there is no specific amount provided for, though and it is not required that that be done, but ah not wanting to turn down the Minority Leader, since it's a reasonable request, we'll have a vote on it. - Hon. W. Robert Blair: "All right, with leave of the House,
  we'll go to resolutions. Agreed resolutions. The gentleman from Cook, Mr. Shea."
- Gerald W. Shea: "Mr. Speaker and Ladies and Gentlemen of the House, House Bill 4302 was introduced today and it will



provide a method of getting the judges on the ballot on the November election. I'd like leave of the House to waive the rule with regards to posting and ask that this bill be heard in Elections on Monday."

- Hon. W. Robert Blair: "The gentleman from Cook, Mr. Collins, the Chairman of the Elections Committee."
- Philip W. Collins: "Ah, yeah, Mr. Speaker, I've discussed the matter with Mr. Shea and I have no objection and we will post it, the members of the House have no objection."
- Hon. W. Robert Blair: "All right, does the gentleman have leave to suspend the provisions of Rule 17 so that the House Bill 4302 may be posted for hearing in the Elections Committee on Monday? Hearing no objection, the leave will be granted. All right, with leave of the House, we'll go to while we're checking on the agreed resolutions. . .oh, you're ready, okay."
- Fredric B. Selcke: "House Resolution 556, Jones, et.al.

  House Resolution 558, 558, DiPrima, et.al. House Resolution 559, Lechowicz, et.al. House Resolution 560, Welsh, et.al. House Resolution 561, Welsh, et.al. House Resolution 562, Juckett. - Hon. W. Robert Blair: "The gentleman from Cook, Mr. Hyde."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Hyde."

Henry J. Hyde: "I just want to say Mr. Speaker, that I'm told that Clyde Choate has the shortest one of all."



Hon. W. Robert Blair: "There's some confusion. You're talk-

ing about fuses and you're handling the circuit breaker
bill, right? Okay. All right, ah the gentleman from Cook,
Mr. Hyde."

Henry J. Hon. W. Robert Blair: "All right, all those in favor of the the gentleman from Union, Mr. Choate."

Clyde L. Choate: "Ah, Mr. Speaker, again I was not paying too much attention, I was talking about a piece of legislation, Mr. Speaker, and I'm not sure whether the Majority Leader did or did not, however, if I would like to remind the members at least on this side and I'm sure that it pertains to members on both sides of the aisle, that Monday is the last day for the introduction of bills that are not in the exempt category. And being as it is a perfunctory session, I would say to the members on this side that if you have a bill that you wish to get introduced on Monday, if you'd please bring it by the Office and we'll see that it's introduced for you."



Henry J. Hyde: "Ah, Mr. Speaker, Ladies and Gentlemen of the House, before moving to adjourn I want to remind the members that on Saturday here in this chamber, the Y.M.C.A. Youth Group will be in to hold a session. And I would suggest if you are of a mind to that you lock your desk and or take anything off your desk that you don't want rearranged. Not that I would think that anybody would take anything out of your desk associated with the Y.M.C.A., but they might have a tendency to rearrange things, so I give you that admonition and I now move for adjournment of this House pursuant to the resolution."

Hon. W. Robert Blair: "Allright, all those in favor of the motion to adjourn say 'Yeas', the opposed 'No', the House will stand adjourned now and the next time we will be back in session will be at 10:00 A.M. next Tuesday, perfunct tomorrow and Monday."
