- William J. Cunningham: "Mr. Speaker, Ladies and Gentlemen of the House, this is an amendment that we discussed in committee and it was agreeable with everyone there that we clean up the bill. I know of no opposition to this and I move for its adoption."
- Hon. W. Robert Blair: "Discussion? All those in favor of the adoption of the amendment say 'Yeas', the opposed 'No', the 'Yeas' have it and the amendment is adopted. Further amendments? The gentleman from Cook, Mr. Simmons."
- Arthur E. Simmons: "Would the sponsor explain that amendment again, please?"

- Hon. W. Robert Blair: "Is there further discussion? All those in favor of the adoption of the amendment say 'Yeas', the opposed 'No', the 'Yeas' have it and the amendment is adopted. Further amendments? Third reading. For what purpose does the gentleman from Cook, Mr. Simmons, rise?"
- Arthur E. Simmons: "Would the Clerk read the amendment in the amount of money is it \$15,000.00 or \$15.00?"
- Fredric B. Selcke: "It is \$15,000.00."
- Hon. W. Robert Blair: "Okay. Third reading. All right, on the calendar on the order of second reading House Bills appears House Bill 2360, which should have been re-referred to the Appropriations Committee inasmuch as it has an appropriation, so we will take it off the calendar and put it in Appropriations. All right, House Bills third reading. House Bill 2683."
- Fredric B. Selcke: "House Bill 2683. An act to amend Section 25.a of 'The Civil Administrative Code of Illinois'. Third reading of the bill."

Regner: "Mr. Speaker, Ladies and Gentlemen of the House, these three bills transfer the security staff of the Illinois Bureau of Race Track Leagues into the Department of Law Enforcement to provide race track investigative authorities controlled through the Illinois Department of Law Enforcement and makes an appropriation to do this in the ensuing year and I would ask a favorable vote on these three bills."
- Hon.W. Robert Blair: "All right, does the gentleman have leave to take those three bills out of the record? 4200."
- Fredric B. Selcke: "House Bill 4200. A bill for an act making an supplemental appropriation to the Industrial Commission. Third reading of the bill."
- Hon. W. Robert Blair: "The gentleman from Cook, Mr. Phil Collins."
- Philip W. Collins: "Ah, Mr. Speaker, Ladies and Gentlemen of the House, House Bill 4200 is the supplemental appropriation to the Illinois Industrial Commission to provide the needed funds to pay to pay the increases for the arbitrators and the secretary. These pay raises were authorized by us last year, but the funds were not appropriated, at that time."

 Hon. W. Robert Blair: "Further discussion? The question is



shall House Bill 4200 pass? All those in favor will vote
'Yeas' and the opposed 'No'. Have all voted who wished?

- Fredric B. Selcke: "House Bill 4634. A bill for an act making an appropriation to the Secretary of State for rehabilitation of the House chambers. Third reading of the bill."
- Hon. W. Robert Blair: "The gentleman from Union, Mr. Choate."
- Clyde L. Choate: "Mr. Speaker, this is the appropriation bill of \$900,000.00 for the refurbishing and enlargement of the House chambers. I would appreciate Mr. Speaker, the vote of the entire membership."
- Hon. W. Robert Blair: "The gentleman from Cook, Mr. Simmons."
- Arthur E. Simmons: "Mr. Speaker, is that bill printed? I don't have a copy of it."
- Clyde L. Choate: "The bill is printed and I'll be happy to send you over my copy."
- Arthur E. Simmons: "Well, I'm not the only one, I think we ought to have more than one."
- Clyde L. Choate: "To the best of my knowledge, it was printed,

 Representative Simmons and distributed as far as the membership is concerned."
- Arthur E. Simmons: "Well, I tried to get one in the bill room and I couldn't."
- Hon. W. Robert Blair: "Any further discussion? The gentleman



from Cook, Mr. Richard Walsh."

Richard A. Walsh: "Clyde, can you give us an outline as to what kind of refurbishing and remodeling, the appropriation is for how much?"

Clyde L. Choate: "\$800,000.00, ah, \$890,000.00."

Richard A. Walsh: "\$890,000.00, that's just for the refurbishing of the House chamber?"

Clyde L. Choate: "It is to enlarge and refurbish as I spoke about Representative Walsh. As an example, the press desk, if I recall correctly, according to the architect's suggestions will be taken off the floor of the House. This cloak room here will be taken off of the floor of the House so that we can expand the room for the members to move back and forth as far as moving between the desks are concerned. Hon. W. Robert Blair: "Discussion? All those, the question

Fredric B. Selcke: "House Bill 518. . . "

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Rayson."

Leland H. Rayson: "Mr. Speaker and Members of the House,

House Bill 518 is a drug seizure bill to bring it into conformity with our new drug laws and in the Senate with that idea in mind, we discovered that there was a flaw in the Senate amendment. We conversed this message there with the Senate sponsor and both feel it's in order that there should be a motion to non-concur to move to a conference. - Hon. W. Robert Blair: "All right, the gentleman's asked for leave to suspend the provisions of Rule 38, demonstrable emergency act, so I gather, so does the gentleman have leave?
