Doorkeeper: "All those who are not entitled to the House chamber, will you please retire to the gallery. Thank you.

Hon. W. Robert Blair: "The Doorkeeper will see that those persons not entitled to the floor are removed therefrom. The House will be in order. The invocation this morning will be by Dr. Johnson, the House Chaplain."

Dr. John Johnson: "We pray, Lord God, Ruler of all Nations and judge of all peoples, we stand in awe of your power and judgements. We come before you in this time of National concern and crisis and ask you in your mercy to avert disaster and to stave destruction, give skill to the guidance and planning of your own Government as it seeks to cope with the problems of War and Peace. Take from the hearts of our People the bitterness, the hatred and the fear which would immobilize us both in mind and spirit. Let us not be blinded by wrathful ignorance nor sustained by false hopes. Above all, Oh merciful Father, grant to all who are in positions of authority the spirit of wisdom and love which will leave the minds of our Nation undisturbed and which will help turn our world to peace. Hon. W. Robert Blair: "Roll call for attendance. Committee reports."

Fredric B. Selcke: "Mr. Conolly, from the Committee on Public Utilities which House Bills 4645, 4646 referred, reported the same back with amendments thereto, with the recommenda-

tions that the amendments be adopted and bills amended, do pass. No further Committee reports."

Hon. W. Robert Blair: "House Bills second reading. House Bill 1064, is that ready? Okay. I'm going right down the calendar now so if you've got objections to ah.. your Bill being called why you can get up and let me know, we won't move it on."

Fredric B. Selcke: "House Bill 1064, Bill for an act to amend Sections 1-2-3-6-9-13, The Child Labor Law. Second reading of the Bill. One Committee amendment. Amend House Bill 1064 on Page 1, Line 28 immediately after the word 'engage' by inserting the following: in agricultural pursuits except for those persons under 12 years of age pursuant to Section 1, on Page 2, Lines 4 and 5, andsoforth. The gentleman from Cook, Mr. Telcser."

Arthur A. Telcser: "Mr. Speaker and Ladies and Gentlemen of the House, House Amendment No. 1 is a clarifying Amendment which was suggested by Naomi Heitz with the Commission on Children and it merely clarifies language so as not to indicate that ah..ah..in the chance of approval for children between the ages of 12 and 16 to work. I now move for the adoption of Amendment No. 1, to House Bill 1064."

Hon. W. Robert Blair: "The gentleman from Christian, Mr. Tipsword."

Rolland F. Tipsword: "Ah.. may I ask the Sponsor a question?"

Hon. W. Robert Blair: "He indicates he'll yield."

Rolland F. Tipsword: "Mr. Telcser this is the, is it the



amendment that provides for the members of the family?"

Arthur A. Telcser: "That will be the next Amendment, Representative Tipsword."

Rollend F. Tipsword: "Oh.. I'm sorry. I wasn't listening carefully. Thank you."

Hon. W. Robert Blair: "Further discussion? All those in favor of the adoption of the Amendment say 'aye', those 'no', the 'ayes' have it and the amendment is adopted. Are there further amendments?"

Fredric B. Selcke: "Amendment No. 2, Telcser, amend House Bill 1064 as amended on page 1, line 24, by adding after the word 'age' the following: 'except members of the farmer's own family'."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Telcser."

Arthur A. Telcser: "Mr. Speaker and Ladies and Gentlemen of the House, Amendment No. 2 is the amendment suggested by Representative Tipsword. Ah.. it is self explanatory; it exempts out the members of the farmer's own family. I now move for adoption of Amendment No. 2, to House Bill 1064."

Hon. W. Robert Blair: "Is there discussion?" All those in favor of the adoption of the amendment say 'aye', those 'no', the 'ayes' have it and the amendment is adopted. Are there further amendments? Third reading."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Madigan."

Michael J. Madigan: "Mr. Speaker would the records ah.. show that Representative McDermott is absent because of illness?"

Hon. W. Robert Blair: "The Journal will so reflect. 2791.



Fredric B. Selcke: "House Bill 2791, bill for an act to amend the insurance code. Second reading of the bill. No Committee amendments."

Hon. W. Robert Blair: " Any amendments from the floor? Third reading 2793."

Fredric B. Selcke: "House Bill 2793 bill for an act to add Section 25 to an Act relating to local mutual district, county and township insurance companies', approved March 13, 1936, as amended. Second reading of the bill. No Committee amendments."

Hon. W. Robert Blair: "Any amendments from the floor? Third reading 2794."

Fredric B. Selcke: "House Bill 2794, a bill for an Act to add Section 1a to an Act to permit farm, county and township mutual fire and lightning insurance companies to transact additional kinds of insurance, approved July 29, 1943, as amended." Second reading of the bill. No Committee amendments.

Hon. W. Robert Blair: "Any amendments from the floor? Third reading."



Hon. W. Robert Blair: "2801"

Fredric B. Selcke: "House Bill 2801, bill for an ..huh..

I didn't hear ya. Bill for an act to add Section 28 to the Consumer's Installment Loan Act. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any amendments from the floor? Third reading 2804."

Fredric B. Selcke: "House Bill 2804, bill for an act to add Section 29 to the Consumer Finance Act. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any amendments from the floor? Third reading 3557."

Fredric B. Selcke: "House Bill 3557, a bill for an act in relation to the regulation of traffic on private roads within private areas. Second reading of the Bill. One Committee Amendment. Amend House Bill 3557, page 1, by deleting lines 1 and 2 and inserting in lieu thereof. 'An act to add Section 11-209.1 andsoforth'."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Regner."

David J. Regner: "Mr. Speaker, Ladies and Gentlemen of the House, this is a Committee amendment ah.. which adds to the Bill, the part of the 'Illinois Vehicle Code' which ah.. establishes a criteria for stop signs and ah.. and traffic control lights and such and I move for the adoption of Committee Amendment No. 1 to House Bill 3557."

Hon. W. Robert Blair: "Any further discussion? All those in



the favor of the adoption of the Amendment say 'aye', those opposed 'no', the 'ayes' have it and the Amendment is adopted. Are there further Amendments? That's 35.. 3620."

Fredric B. Selcke: "House Bill 3620, bill for an act to amend Section 20 of the Revenue Act of 1939. Second reading of the bill. One Committee Amendment. Amend House Bill 3620 on Page 2, line 11, by deleting "1972" and inserting in lieu thereof "1973", and on page 2, line 12, by deleting "1973" and inserting in lieu thereof "1974"."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Berman."

Arthur L. Berman: "Thank you, Mr. Speaker. I move the adoption of Committee Amendment No. 1, which merely changes the date for the first assessment year that is applicable to the bill from "1972" to "1973". I move the adoption of Committee Amendment No. 1."

Hon. W. Robert Blair: "Any further discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it. The Amendment is adopted. Are there further Amendments?"

Fredric B. Selcke: "Amendment No. 2, Berman, amend House Bill 3620 on page 2, by striking line 7 and inserting in lieu thereof the following: 'classify real property, condominium units used as single family residences created in accordance'."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Berman."

Arthur L. Berman: "Amendment No. 2, Mr. Speaker, was an amendment agreed upon in Committee to clarify the use by which these condominium units would be only single family residences and would come within the purview of this Bill."





I move the adoption of Amendment No. 2, the House Bill 3620." Hon. W. Robert Blair: "Is there further discussion? All those in favor of the adoption of the Amendment say 'aye', those opposed 'no', the 'ayes' have and the Amendment is adopted. Are there further Amendments? Third reading. 3626."

Fredric B. Selcke: "House Bill 3626, bill for an act to amend Section 12-206 of the 'Illinois Vehicle Code'. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor?"

Fredric B. Selcke: "Amendment No. 1, Carroll, amend House Bill 3626 on page 2, by striking lines 9 through 13 and inserting in lieu thereof the following: '(f) No person shall sell or offer for sale, andsoforth.'"

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Carroll."

Howard W. Carroll: "Thank you, Mr. Speaker. Amendment No. 1 changes sub-section (f) that the reflector on the side of the bike rather than being on the fork would be in the wheels so it would be visible from both sides so that the body won't block it. Move the adoption of the Amendment."

Hon. W. Robert Blair: "Is there discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment is adopted. Are there further Amendments? Third reading. 4107. Now ah.. so we understand what we're doing, I'm going down the calendar on second reading Bills. If you're not in your seat and you've got a bill on second reading, I'm not calling it. So, I would suggest with our deadline being Friday that it might behoove you to be in your seat or you



might not get your Bill called."

Fredric B. Selcke: "House Bill 4107, a Bill for an act to amend Section 25.14a of an act to amend a law in relation to Counties. Second reading of the Bill. One Committee Amendment. Amend House Bill 4107 on page 1, by adding after line 18 the following: 'This amendatory Act of 1972 does not apply to any County'."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Schlickman."

Eugene F. Schlickman: "Mr. Speaker and Ladies and Gentleman of the House, Committee Amendment No. 1 to House Bill 4107 is the standard home rule exemption. I would move for its adoption."

Hon. W. Robert Blair: "Is there discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment is adopted. Are there further Amendments? Third reading. 4108."

Fredric B. Selcke: "House Bill 4108, a Bill for an act to amend Section 2 of an act in relation to the regulation of motor vehicle traffic and the promotion of safety on public highways. Second reading of the Bill. One Committee Amendment. Amend the House Bill 4108 on page 1, by adding after line 31 the following: 'This amendatory Act of 1972 does not apply to any county which is a home rule unit!'"

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Schlickman."

Eugene F. Schlickman: "Mr. Speaker and Ladies and Gentleman of the House, Committee Amendment No. 1 to House Bill 4108 is also the standard home rule exemption. I move for its."



adoption."

Hon. W. Robert Blair: "The ah.. discussion. All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment is adopted.

Are there further Amendments? Third reading. 4144."

Fredric B. Selcke: "House Bill 4144, bill for an act to amend 'The Vehicle Code'. Second reading of the Bill. One Committee Amendment. Amend House Bill 4144 on page 2, by inserting in line 8, after the period, the following: 'However, a resident owner shall not be required to display on his vehicle', andsoforth."

Hon. W. Robert Blair: "The gentleman from Winnebago, Mr. North. The Clerk's read the Amendment."

Frank P. North: "I move the adoption of the Amendment No. 1 to House Bill 4144."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Downes."

John P. Downes: "Mr. Speaker would he explain the Amendment, please?"

Hon. W. Robert Blair: "Yes.. he's going to do that. The gentleman from Winnebago, Mr. North."

Frank P. North: "Yes.. this Amendment provides that a municipality, may impose a fee or a tax on a resident or upon the vehicle having a base in that municipality, but an owner need pay the fee or tax to but one municipality. If he pays the fee or the tax to the municipality wherein the vehicle is based, he has not been also required to pay a fee or a tax to the municipality of his residence."



Hon. W. Robert Blair: "Alright.. Is there further discussion?

All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment's adopted. Are there further Amendments? Third reading. Alright... 2791."

Fredric B. Selcke: "House Bill 2791, bill for an act to amend 'The Illinois Insurance Code'. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. 4167....4167."

Fredric B. Selcke: "House Bill 4167, bill for an act to amend Sections 3 and 4 of and to add Sections 3.1 and 3.2 to the 'Sanitary District Act of 1936'. Second reading of the Bill. Two Committee Amendments. Amendment No. 1, amend House Bill 4167 on page 4, line 10, by striking the word 'be' and inserting in lieu thereof the following: 'by'."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Regner."

David J. Regner: "Mr. Speaker and Ladies and Gentlemen of the House, this is a Committee Amendment. I move for its adoption."

Hon. W. Robert Blair: "Is there any discussion? All those in favor of the adoption... The gentleman from Cook, Mr. Shea."

Gerald W. Shea: "Would you explain what the Amendment does, Dave?"

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Regner."

David J. Regner: "Jerry, I don't have a copy. The Clerk just read it. Fred, it just changed one word...correct?"



Fredric B. Selcke: "Ah..strike the word 'be' and insert in lieu thereof, the word 'by'."

Hon. W. Robert Blair: "4167. The gentleman from Cook, Mr. Shea."

Gerald W. Shea: "I believe there's another Committee Amendment."

Hon. W. Robert Blair: "Is there any further discussion? All those in favor in the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment's adopted. Any further Amendments?"

Fredric B. Selcke: "Committee Amendment No. 2, amend House Bill 4167 on page 3, by striking line 27 and inserting in lieu thereof the following: 'once in any 47 month period'."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Regner."

David J. Regner: "This is another Committee Amendment and I move for its' adoption... for adoption of Amendment No. 2 to House Bill 4167."

Hon. W. Robert Blair: "Is there any further discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment's adopted. Are there further Amendments? Third reading. 4168."

Fredric B. Selcke: "House Bill 4168, bill for an act to amend 'The School Code'. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. 4169."



Fredric B. Selcke: "House Bill 4169, bill for an act to amend Section 5, an act in relation of criminal identification, investigation. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. 4177."

Fredric B. Selcke: "House Bill 4177, bill for an act to amend 'The Vehicle Code'. Second reading of the Bill. One Committee Amendment. Amend House Bill 4177 on page 1 in lines 1 and 5, by striking 'Section 3-818' and inserting in lieu thereof: 'Sections 3-407 and 3-818' and so forth."

Hon. W. Robert Blair: "The gentleman from Vermilion, Mr. Craig. The Amendment on the floor...177."

Robert Craig: "Mr. Speaker, I wish to give Amendment No. 1 to House Bill 4177, gives the Secretary of State...It is an Amendment which gives him the right to issue a license plate for an application for plates that have been filed but are not complete providing the proper fee has been paid in advance. This is due... This is for semi-trailer plates where they have made application but they... It's a hardship on the owner to determine exactly what plates are going on what trailer and this gives him if he makes these applications, he can put them on the trailer and then fill out what trailer it went on after the plates have been installed on the semi. I'd like to move for its' adoption."

Hon. W. Robert Blair: "Is there discussion? All those in favor of the adoption of the Amendment say 'aye', opposed-



'no', the 'ayes' have and the Amendment's adopted. Are there further Amendments? Third reading. 4194."

Fredric B. Selcke: "House Bill 4194, bill for an act to amend 'The Election Code'. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. 4196."

Fredric B. Selcke: "House Bill 4196, bill for an act to amend 'The Election Code'. Second reading of the bill. No Committee Amendments."

Hon. W. Robert Blair: "4213."

Fredric B. Selcke: "4213, a bill for an act to vacate, extinguish abandon and release an easement for highway purposes in Peoria County. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the the floor? Third reading. 4219."

Fredric B. Selcke: "House Bill 4219, bill for an act to amend 'The School Code'. Second reading of the bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. Alright... House Bill 380... 4261."

Fredric B. Selcke: "House Bill 4261, bill for an act to amend 'The School Code'. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. 4264."



Fredric B. Selcke: "House Bill 4264, bill for an act to amend 'The School Code'. Second reading of the bill."

Hon. W. Robert Blair: "No... Take it out of the record. 4268."

Fredric B. Selcke: "House Bill 4268, bill for an act to amend 'The School Code'. Second reading of the Bill. One Committee Amendment."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Schlickman. Ah... want to read the Amendment."

Fredric B. Selcke: "Amend House Bill 4268, page 1, by deleting line 1 and so forth."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Schlickman."

Eugene F. Schlickman: "Mr. Speaker and Ladies and Gentlemen of the House, Committee Amendment to House Bill 4268 was offered by Representative Palmer. The Assembly authorizes The School Billing Commission to construct classroom facilities for Kindergarten's. As you know, in 1969, I believe, we mandated Kindergarten's. Is this now correct? The deficiency that ah.. presently exists in the School Building Commission Act. I move for its' adoption."

Hon. W. Robert Blair: "Alright... Any discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment's adopted. Are there further Amendments? Third reading. 4271."

Fredric B. Selcke: "Bill for an act to amend 'The Pension Code'. Second reading of the Bill. No Committee Amendments."





Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. The gentleman from Wayne, Mr. Blades. For what purpose do you rise?"

Ben C. Blades: "Mr. Speaker, I didn't want to move 4271. I did want to move 4270."

Hon. W. Robert Blair: "Well.. I'll tell ya what we'll do, we'll take 4271 ah.. back from third reading to second reading. Ah.. with leave of the House and ah... we'll come back to those two later. 4273."

Fredric B. Selcke: "House Bill 4273, 'bill for an act to amend 'The Insurance Code'. Second reading of the Bill. Ah.. two Committee Amendments."

Hon. W. Robert Blair: "Take that out of the record. 4278."

Fredric B. Selcke: "House Bill 4278, bill for an act to amend 'The Vehicle Code'. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor?"

Fredric B. Selcke: "Amendment No. 1, Pappas, amend House Bill 4278 on page 2, by deleting line 18 and soforth."

Hon. W. Robert Blair: "The gentleman from Rock Island, Mr. Pappas."

Pete Pappas: "Mr. Speaker and Ladies and Gentlemen of the House, this Amendment was introduced ah.. on behalf ah.. the State Police ah.. it ah.. adds to the Bill of Provision requiring that the tread depth of a tire on a vehicle offered for sale or lease must be 3/32nds of an inch rather than 2/32nds and it also makes secure the minor technical changes. I would move its' adoption."



Hon. W. Robert Blair: "Any discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayés' have and the Amendment's adopted. Are there further Amendments? Third reading. 4283."

Fredric B. Selcke: "House Bill 4283, bill for an to add Sections 1a and 2a to an act in relation to uniform relocation payments, andsoforth. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. 4291."

Fredric B. Selcke: "House Bill 4291, bill for an act to amend 'The School Code'. Second reading of the Bill. One Committee Amendment. Amend House Bill 4291 on page 1, line 26, by inserting after the word 'school' the following: andsoforth."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Glass."

Bradley M. Glass: "Thank you, Mr. Speaker.. Ladies and Gentlemen. Ah.. this is a Committee Amendment ah.. which requires notice in the rights of parents to a Conference with the school authorities in cases of suspension and I move for its' adoption."

Hon. W. Robert Blair: "Is there discussion? All those in favor of the adoption of the Amendment say 'aye, opposed 'no', the 'ayes' have it and the Amendment's adopted. Are there further Amendments? Third reading. 4319."

Fredric B. Selcke: "House Bill 4319, bill for an act to amend Section 3 of an Act in relation to Waterworks Systems, Sewage Systems and combined Waterworks and Sewage Systems. Second reading of the Bill. No Committee Amendments."



Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. For what purpose does the Gentleman from Cook, Mr. Shea, rise?"

Gerald W. Shea: "Ah.. will the Sponsor yield for a question? A.. I think what I'm trying to say there was a Commitment in Committee that he would amend this Bill."

Hon. W. Robert Blair: "Well.. he amended it once. The Gentleman from ah.. Oh no... Okay. That was the last one. The Gentleman from Cook, Mr. Glass."

Bradley M. Glass: "If I've not mistaken ah.. I have prepared an Amendment for House Bill 4319, which is the one I committed to ah.. ah.. amend in Committee and ah.. that was the one in which we would put a one year ah.. limit on. That..that's the next bill that will be called or it's being called now."

Gerald W. Shea: "He called 4319 and there were no Amendments. That's why I'm up."

Bradley M. Glass: "I thought it was 4318. Does the Clerk have the Amendment?"

Fredric B. Selcke: "No.. Amendment No. 1, Glass, amend House Bill 4319 on page 1, by deleting lines 28 and 29 and inserting in lieu thereof the following: 7% andsoforth."

Hon. W. Robert Blair: "The Gentleman from Cook, Mr. Glass."

Bradley M. Glass: "Mr. Speaker and Ladies and Gentlemen, ah. the Committee requested that this Amendment be put on. It simply ah.. places a one year period after the effective date of the Bill in which the 7% per year interest on Bonds



will be effective. I move for its' adoption."

Hon. W. Robert Blair: "Alright... discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment's adopted. Are there further Amendments? Third reading. Now back to ah.. 4318."

Fredric B. Selcke: "House Bill 4318, bill for an act to amend Section 22.07 an act in relation to Waterworks Systems, andsoforth. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Ah.. Gentleman..... Any from the floor? Third reading. Now.. back to 4270."

Fredric B. Selcke: "House Bill 4270, bill for an act to amend 'The Illinois Municipal Code'. Second reading of the Bill. One Committee Amendment. Amend House Bill 4270 on page one, by deleting line 21 and inserting in lieu thereof the following: 'power for such municipality, and, when it is found necessary, andsoforth'."

By Amendment.. Committee Amendment No. 1, House Bill 1205, we eliminate from the Bill the revised funding method so that the Bill as it will be upon the adoption of its' Amendment. Simply a.. Housekeeping Bill. I would move for the adoption of Amendment No.1... Committee Amendment No. 1, to House Bill 1205."

Rep. Arthur A. Telcser: "Is there any discussion? The gentleman has offered to move the adoption of Amendment No. 1, to House Bill 1205. All in favor of the adoption signify by saying 'aye', the opposed 'no', the Amendment is adopted. Are there further Amendments? Third reading. House Bill 1206."

Jack O'Brien: "House Bill 1206, an Act to amend the 'North-east Illinois Planning Act'. Second reading of the Bill. One Committee Amendment. Amend House Bill 1206, on page 1, line 15, by striking 'Two' and inserting in lieu thereof 'Three'."

All in favor of the adoption signify by saying 'aye', opposed 'no', the Amendment is adopted. Are there further Amendments? Third reading. House Bill 2257."

Jack O'Brien: "House Bill 2257, a Bill for an act to codify the law in relation to residential landlord and tenant relations. Second reading of the Bill. No Committee Amendments."

Rep. Arthur A. Telcser: "Are there Amendments from the floor?"

Jack O'Brien: "Amendment No. 1, amends House Bill 2257 on page 24, line 27, by deleting 'agreement' and inserting in lieu thereof the following: 'agreement, including the breach of any implied warranty or habit.'"

Rep. Arthur A. Telcser: "The gentleman from Cook, Representative Rayson."



Leland H. Rayson: "Mr. Speaker, this is a short Amendment to conform with the recent Illinois decision on landlord - tenant law, the Jack Spring Case. And I move now for the adoption of Amendment No. 1."

Rep. Arthur A. Telcser: "Is there any discussion? If not, the gentleman has offered to move the adoption of Amendment No. 1, to House Bill 2257. All in favor of the adoption signify by saying 'aye', the opposed 'no', the Amendment is adopted. Are there further Amendments? Third reading. House Bill 4479."

Jack O'Brien: "House Bill 4479, a Bill for an Act to amend Section 2, an act relating to certain investments, public funds by public agencies. Second reading of the Bill. One Committee Amendment. Amends House Bill 4479 on page 2 by adding to the end of the line 12 the following:; andsoforth."

Rep. Arthur A. Telcser: "The gentleman from Cook, Representative Hyde."

Henry J. Hyde: "Mr. Speaker, Ladies and Gentlemen of the House, this is Committee Amendment No. 1, which was adopted un-animously ah.. in the Executive Committee and ah.. what it provides is privately owned funds held by a public agency must be released to the ah.. party who really owns the money at the earliest reasonable time, but in no ah.. ah.. in no case to exceed 31 days after the private party be-comes entitled to receive them. This will permit private.. rather public agencies to invest this money in accounts that will earn interest. The Amendment further provides that all



of the interest earned will belong to the public agency ah.. or to the ah.. specific fund ah.. otherwise designated by law. Ah.. as I say, this was unanimously adopted and I move adoption of Amendment No. 1 to House Bill 4479."

Rep. Arthur A. Telcser: "Is there any discussion? The gentleman from Cook, Representative Shea."

Gerald W. Shea: "Will the Sponsor yield for question?"

Rep. Arthur A. Telcser: "He indicates he will."

Gerald W. Shea: "Henry, does this now make your Bill in conformity with mine?"

Henry J. Hyde: "It sure does and I want to thank you for the ah.. great help you gave me in drafting my Bill."

Rep. Arthur A. Telcser: "Is there further discussion? The gentleman has offered to move the adoption of Amendment No. 1, to House Bill 4479. All in favor of the adoption signify by saying 'aye', opposed 'no', the Amendment is adopted. Are there further Amendments? Third reading. House Bill 4480."

Jack O'Brien: "House Bill 4480, Bill for an act to amend Section for an Act concerning County Treasurers. Second reading of the Bill. One Committee Amendment. Amend House Bill 4480 on page 2 by adding to the end of line 9 the following: 'Privately owned funds held in the custody of a county treasurer must be released to the appropriate party at the earliest reasonable time, but in no case exceeding 31 days, after the private party becomes entitled to the receipt of them'."



Rep. Arthur A. Telcser: "The gentleman from Cook, Representative Hyde."

Henry J. Hyde: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, this Amendment No. 1, to House Bill 4480, which is a companion Bill was similarly unanimously adopted in the Executive Committee and it provides ah.. really the same ah.. thing as the other Amendment did only this will apply to County Treasurers and I ah.. respectfully move its' adoption."

Rep. Arthur A. Telcser: "Is there any discussion? The gentleman has offered to move the Adoption of Amendment No. 1, to House Bill 4480. All in favor of the adoption signify by saying 'aye', opposed 'no', the Amendment is adopted. Are there further Amendments? Third reading. House Bill 3586."

Jack O'Brien: "House Bill 3586, a Bill for an act in relation to payments of State's services fees or tax. Second reading of the Bill. No. Committee Amendments."

Rep. Arthur A. Telcser: "Are there Amendments from the floor?"

Jack O'Brien: "Amendment No. 1, Katz, amends House Bill 3586 on page 1, in the title, by striking 'State' and inserting in lieu thereof 'governmental'; and on page one, line 17, by deleting 'State'; and on page 1, by deleting lines 18 and 19 and inserting in lieu thereof the following: 'a named person'."

Rep. Arthur A. Telcser: "The gentleman from Cook, Representative Katz."

Harold A. Katz: "Amendment No. 1 unanimously adopted by the Executive Committee ah.. simply broadens the Bill to make clear that the Bills provision about not directing that a



check for services be made payable to the individual but to the official includes not only ah.. State Officials but all officials. It was unanimously adopted by the Committee and I move for its' adoption."

Hon. W. Robert Blair: "Is there any discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment's adopted. Further Amendments? 3559."

Jack O'Brien: "House Bill 3559, a Bill for an act to amend Sections of 'The Illinois Highway Code'. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor?"

Harber H. Hall: "Mr. Speaker, this is an Amendment to a Bill that ah.. refers to ah.. unsuitable lights near or on our Highways ah.. that helps clarify which signs will be effected and which will not be effected and I move for the adoption of the Amendment."



Hon. W. Robert Blair: "Is there discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment is adopted. Are there further Amendments? Third reading. Alright.. the Leader of the House will go the order of Resolutions.. Did I have leave? Thank you."

Hon. W. Robert Blair: "Any Amendments from the floor? Third reading. 3766."

ah.. strike line... strike lines 1 and 2 on page 2."

Hon. W. Robert Blair: "Yeap. That's what is says."

James Y. Carter: "That's what I'd like to do and if ah..

Hon. W. Robert Blair: "But is ah.. doesn't fit into in the  
Bill."

James Y. Carter: "What did ya say?"

Hon. W. Robert Blair: "It doesn't fit into the Bill. I'm  
mean.. the Bill was on Third and previously amended and ah..  
it's not ah..it will not do what you want to do. It doesn't  
ah.. it doesn't work with the way the bill... with the shape  
the Bill's in now. So, take it out of the record."

James Y. Carter: "May I ah.. ask you a question?"

Hon. W. Robert Blair: "Yeas."

James Y. Carter: "The original as read said 'if the person'  
Now.. I'm starting at line 32... on page 1, I guess it is...  
'if the person operating such motor vehicles is not the  
owner, then prove of financial responsibility filed here-  
under must provide that such person is primarily liable  
and the owner secondary liable'. Am I correct in that?"

Hon. W. Robert Blair: "Well.. I don't know what your point is.

Jack O'Brien: "House Bill 3797, a Bill for an act to amend Sections of the 'Illinois Blood Bank Act'. Second reading of the Bill. One Committee Amendment. Amendment No. 1 amends House Bill 3797 by deleting lines 16 through 20 and inserting in lieu thereof the following: andsoforth."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Terzich."

Robert M. Terzich: "Mr. Speaker, Ladies and Gentlemen of the House, ah.. I would like to ah.. table ah.. Committee Amendment No. 1, and adopt ah.. Amendment No. 2, which simply changes the ah.. ah.. Committee Amendment No. 1 by inserting 'hospitals designated as statewide trauma centers'. That's the only change. And I ah.. request your adoption of this Amendment No. 2."

Hon. W. Robert Blair: "Alright... let's do it one at a time. The gentleman offers ah.. and moves the adoption of Amendment No. 1 and then moves to table that Amendment. All



those in favor of tableing the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment is tabled. He now offers Amendment No. 2 which the Clerk will read."

Jack O'Brien: "Amendment No. a amends House Bill 3797 by deleting lines 16 through 20 and inserting in lieu thereof the following: Hospitals designated as statewide trauma centers approved and designated by the Illinois Department of Public Health shall be required to store and maintain supplies of blood, its components, and its derivatives for emergency care. Such care shall include, but not be limited to, all diseases of disorders requiring the employment of blood, its components, or derivatives in treatment. The quantity of such fractions to be stored and made available shall be set by the State Department of Public Health in consultation with all other appropriate state and voluntary health agencies'."

Hon. W. Robert Blair: "Alright... The gentleman from Cook now renews his ah.. motion with respect to adopting Amendment No. 2. And the gentleman from Cook, Mr. Simmons."

Arthur E. Simmons: "I'd like to ask the Sponsor a question."

Hon. W. Robert Blair: "He indicates he'll yield."

Arthur E. Simmons: "I couldn't follow the reading of this Amendment ah.. but it mentioned hospitals. Does it.. Does it mention what kind of hospitals? Whether their human hospitals or also includes animal hospitals..."

Robert M. Terzich: "These are ah.. regular Medical Hospitals, Representative."





Arthur E. Simmons: "Ah.. did the Amendment so state?"

Robert M. Terzich: "Well.. it simply states that 'hospitals designated by the Statewide trauma center. So I, if it was an animal hospital, it sure wouldn't be designated as a trauma unit."

Hon. W. Robert Blair: "Any further discussion? All those in favor of the adoption of Amendment No. 2 say 'aye', opposed 'no', the 'ayes' have it and the Amendment's adopted. Are there further Amendments? Third reading. The gentleman from Cook, Mr. Hyde."

Henry J. Hyde: "Mr. Speaker, Ladies and Gentlemen of the House, I now move that the House stand recessed for 30 minutes for purposes of a Republican conference. The Republicans to report immediately to Room M3."

Fredric B. Selcke: "House Bill 4196, a bill for an act to amend 'The Election Code'. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any amendments from the floor? Third reading. 4269."

Fredric B. Selcke: "House Bill 4269, a bill for an act to amend Section 5 an act relating to wage deductions for the benefit of creditors. Second reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor?"

Fredric B. Selcke: "Amendment No. 1, Shea, amends House Bill 4269 on page 1 by adding after line 19 the following: 'Section 2. This Amendatory Act shall take effect on July 1,



1972'."

Hon. W. Robert Blair: "Any Amendments from the... Oh.. the gentleman from Cook, Mr. Shea."

Gerald W. Shea: "Mr. Speaker, Ladies and Gentlemen of the House, this Amendment would make the Bill effective July 1, instead of October the 1st. I move for the adoption of the Amendment."

Hon. W. Robert Blair: "Is there any discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment's adopted. Are there further Amendments? Third reading. 4273."

Fredric B. Selcke: "House Bill 4273, a Bill for an act to amend the 'The Illinois Insurance Code'. Second reading of the Bill. ah.. Two Committee Amendments. Committee Amendment No. 1."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Moore."

Don A. Moore: "Thank you, Mr. Speaker. At this time, Mr. Speaker, I would like to table Committee Amendment No. 1, to House Bill 4273."

Hon. W. Robert Blair: "Alright... The gentleman have leave."  
Members: "Leave."

Hon. W. Robert Blair: "He offers ah.. the adoption of Amendment No. 1 and moves to table it. The gentlemen have leave. The gentleman from Cook, Mr. Shea."

Gerald W. Shea: "Now as I understand it, this is the no-fault Bill. Is that correct?"

Don A. Moore: "That is correct."



Gerald W. Shea: "And you wish to table Committee Amendment No. 1?"

Hon. W. Robert Blair: "That's what the gentleman's permission is, right."

Gerald W. Shea: "Can you tell us... Can you tell us why you want to table Committee Amendment No. 1."

Don A. Moore: "Committee Amendment No. 2, because Committee Amendment No. 2 strikes everything after the enacting clause and came in an effect to amend the new Bill."

Gerald W. Shea: "In a.. second Amendment."

Don A. Moore: "I will move for its adoption."

Gerald W. Shea: "Is a Committee Amendment which rewrites the entire Bill?"

Don A. Moore: "That is correct."

Gerald W. Shea: "Alright... I'll ask you about Amendment No. 2 when we get there."

Don A. Moore: "Thank you."

Hon. W. Robert Blair: "Is there leave? Alright.. the motion will be tabled. Ah.. Amendment No. 2."

Fredric B. Selcke: "Committee Amendment No. 2 amends House Bill 4273 on page 1, by striking lines 1, 2, and 3 and inserting in lieu thereof the following:."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Moore."

Don A. Moore: "Thank you, Mr. Speaker. Ah.. Committee Amendment No. 2 strikes everything after the Enacting Clause of the original Bill. Under House Bill 4273 as amended, every Insurance Company will have to promptly pay to the injured victims of motor vehicle accidents up to \$2,000.00 in



in Medical, \$150.00 a week in wages and \$12.00 a day for the replacement of essential services if unemployed. They will... They will also have to offer \$50,000. to \$100,000. excess coverage which will provide additional 5 years of Medical, Loss of Wages, Replacement or essential services and Dependent survivor benefits, which the insured can buy instead of.. instead of current mandatory uninsured motorist coverage. These benefits must be paid every 30 days regardless of the other benefits the insured may have. If the insured still wants to make a claim or file a suit against the other party, he can. If the injury is serious, and there are permanent disabilities, his rights to general damages are exactly the same as they are now. There is no change. In order to correct the Supreme Court objection, House Bill 4723 as amended applies to commercial vehicles as well as private passenger automobiles. The provisions relating to the mandatory arbitration in the original Illinois Plan have been stricken in compliance with the Supreme Court. Finally, the limitations on pain and suffering have been clarified to cover the Court objections to the possibility of differential... of different financial settlements in different parts of the State. In effect, what this Bill does... or what Amendment No. 2 does is takes the identical no-fault Bill that was passed by the General Assembly last year and pulls out of it the objections that the Illinois Supreme Court and the Circuit Court had when they declared it unconstitutional. With these provisions...

With these objections removed, we have the same Bill as we passed the last time. There were no other subsequent changes other than to place the Bill in compliance with the objections of the Supreme Court."

Hon. W. Robert Blair: "Discussion? The gentleman from Cook, Mr. Berman."

Arthur L. Berman: "Thank you, Mr. Speaker. Would the Sponsor yield?"

Hon. W. Robert Blair: "He indicates he will."

Arthur L. Berman: "Don, am I correct then that Amendment No. 2 has not been discussed ah.. in the Committee. Is that correct?"

Don A. Moore: "No..no.. Amendment No. 2 was discussed in the Committee and was adopted by the Committee and the Bill as amended was passed out of the Committee."

Arthur L. Berman: "Now.. ah.. can you tell me why ah.. Amendment No. 2 was proposed in Committee which is such a ah.. radical change from what House Bill 4273 originally was."

Don A. Moore: "The reason for the change, because I couldn't get the votes to get the original Bill out of Committee. During the process of the roll call, it was apparent that my original Bill was going to be defeated at which time I requested from the Chairman the right to postpone consideration of the Bill. I subsequently commend with Amendment No. 2 that a majority of the Committee saw fit to vote out."

Arthur L. Berman: "Ah.. calling your attention ah.. to page 5, where we talked about reasonable value of necessary medical treatment may be more than or less than the actual dollar



amount of medical treatment expenses. How would that be handled if I've got a ah.. \$100.00 dollar Doctor Bill and I submit that for payment? Ah.. does that mean that the Company doesn't have to pay it? Or they can pay me more? Could you explain how that would work?"

Don A. Moore: "Well.. in this particular section, this would be where there is a suit ah.. with a jury and a General... ..a General Court Case and the question would be determined by the jury. Do you recall in the other law, it was tied into a percentage ratio with the.. with the specials? That language was removed and in order to cure that objection of the Supreme Court, the reasonable value which may be more or less was inserted."

Arthur L. Berman: "But you don't use that same language when you talked about reimbursement of medical expenses ah.. on page ah.. 2, line 14 through 18. Why would there be a distinction there?"

Don. A. Moore: "Now where?... Your on page 2, where?"

Arthur L. Berman: "Lines ah.. 14 through 18 and on page 1, lines 25 through 29. It talks about payment of reasonable and necessary medical expenses."

Don A. Moore: "Well.. this is the..."

Arthur L. Berman: "I'm in the first part of coverage, but you don't put in there that the expenses may be more or less than ah.. the actual."

Don A. Moore: "The reason it wasn't put in there is because the Supreme Court's objection only dealt with Section 608.





It did not comment as far as lines 14 to 18 that you're referring to. That was the law as we had passed it last year and it was therefore not tampered with. Section 608 is the Section where we removed the constitutional question."

Arthur L. Berman: "Mr. Speaker, may I address myself to the Amendment?"

Hon. W. Robert Blair: "You may."

Arthur L. Berman: "I think that we see here, Ladies and Gentlemen an attempt to quickly make a law that has been declared unconstitutional. Ah.. to present to us an alternative which in my humble opinion, does not meet the objections that the Court has previously raised. Ah.. I really think that the Amendment ah.. doesn't do anything to change the major constitutional objections inasmuch as Amendment No. 1 was tabled. I would rather see the Bill held and ah.. re-worked because you've got a problem here with what is reasonable and necessary medical expenses under one part of the proposed Amendment which has a different definition from reasonable and necessary medical expenses in another part of the Amendment. And it doesn't really cure the faults that the Court found in the previous Bill as far as denying due process in equal protection of the laws, the people who are involved in automobile occurrences. You still got the problem that people who do not have automobiles, who do not own them... automobiles and who do not have the mandatory coverage would have.. not have benefits available to them and yet, by this Amendment would still be prevented from



filing suit for the fair reimbursement of their injuries. I think this is ah.. not the proper way to address ourselves to the accident problems in the State of Illinois. And I don't think that the Amendment ah.. deserves our affirmative vote today."

Hon. W. Robert Blair: "The gentleman from Sangamon, Mr. Londrigan."

James T. Londrigan: "Mr. Speaker, Ladies and Gentlemen of the House, I to rise in opposition to this totally new Bill put to us once again. House Bill 4273 is amended. It's still unconstitutional for all the reasons given in the Grace Case. This Bill was unfair in concept and it is still unfair in that it takes away the tort Claims of the people. The real reason the Insurance Companies want this Bill is for greater profit. They do not need a Bill, a no-fault plan to sell Insurance and we all know the Continental Insurance Company sells its' policy now. No no-fault is needed for that reason. Why they want no-fault is to take away the Court claims of the people. That's where they're going to save the money. Now, in Massachussettes, in the last nine months of 1970, they paid out over \$11,000,000. in claims to the people. They put in no-fault and in the same nine months period, they paid out just over \$2,000,000. Thus, saving \$9,000,000. for the Insurance Companies. That's why they want this no-fault Bill. They don't need it for any other reason and it's time we all woke up to this fact. Now, also, in Massachussettes, they have not cut down the premiums. And in this Allstate Case, in this Grace Case,



the Allstate people testified that their not going to cut down the premiums on this no-fault plan. And it's time you stop kidding the people by telling them that their going to cut those premiums. They are not. You're going to cut the money that comes into their pocket. Now this no-fault Bill... What's the hurry? The hurry is to again try to slide it by before the people wake up to what's happening. Let's put in a commission where it belongs. We're all for all no-fault plan, but we're not for a plan to give the Insurance Companies more profit. Let's get out a proper no-fault considered by all of us and get one that the people will appreciate and a no-fault concept that the people will approve of."

Hon. W. Robert Blair: "Further discussion? Gentleman care to close, Mr. Moore."

Don A. Moore: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Mr. Speaker, I would just ah.. briefly reply in so far as this Amendment is concerned to remind the Members of this body that this is the same Bill that passed out of here last year. The question as far as the arbitration procedures which the Court said were unconstitutional, but then have been removed. The question that limited only to automobiles and not all motor vehicles has been removed. The discussions of Judge Covelli that it has discriminated ah.. because of the amount of compensation that an individual could recover for pain and suffering is directly tied into the cost of medical services has been removed. The people,



the 5,000,000 policyholders of the State of Illinois want no-fault. I think this was evidence when this Bill was passed last year by the House and the Senate and signed by the Governor. And it this time, Mr. Speaker, I would respectfully move the adoption of Amendment No. 2, to House Bill 4273."

Hon. W. Robert Blair: "Roll call?.. Okay.. the question is.. All those in favor of the Amendment will vote 'aye', and the opposed 'no'. Have all voted who wish? The Clerk will take the record. Lindberg, 'aye'. On this question, there are 77.. right? 78 'ayes', 37 'nays' and Amendment No. 2 is adopted. Are there further Amendments?"

Fredric B. Selcke: "Amendment No. 3, Moore, amends House Bill 4273 as amended, in paragraph (a) of Section 6, by deleting 'automobile as guest' and inserting in lieu thereof the following: 'motor vehicle as'; and in paragraph (c) of Section 6, by deleting 'Section' and inserting in lieu thereof 'Article'; and in subparagraph (1) of paragraph (d) of Section 6 by deleting 'automobile' at each of the two places it appears and inserting in lieu thereof at each place 'motor vehicle'."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Moore."

Don A. Moore: "Yes, Mr. Speaker, this is a technical Amendment ah.. it corrected some drafting errors that were made in it, removes the word ah.. 'automobile' and replaces the word 'motor vehicle'. Ah.. there are no subsequent changes in the Amendment. And at this time, Mr. Speaker, I respectfully request the adoption of Amendment No. 3."



Hon. W. Robert Blair: "Discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', the 'ayes' have it and the Amendment's adopted. Are there further Amendments? Third reading. 3644."

Fredric B. Selcke: "House Bill 3644, a Bill for an act in regulating contributions by certain Employers to benefit funds or fringe benefits for their Employees. Second reading of the Bill. One Committee Amendment. Amend House Bill 3644 by deleting everything after the enacting clause and inserting in lieu thereof the following: "Section 1. Any employer who promises in writing to make payments to an employee welfare plan, vacation plan, health plan, dental plan, andsoforth."

Hon. W. Robert Blair: "The gentleman from McHenry, Mr. Hanahan."

Thomas J. Hanahan: "Mr. Speaker and Members of the House, Amendment No. 1 is a Committee Amendment that 3644 that changes the penalty from felony to misdemeanor for those employers in the State of Illinois that fail to live up to their agreements with Unions and collective bargaining agreements concerning health, welfare pension and fringe benefit paid plans. The Amendment brings in line 'The Illinois Act' with 'The Michigan Act' insofar that Michigan has already adopted this type of legislation. The opposition to the Bill was generated because the penalty was so great that it was a felony. By adopting this Amendment, it removes it down to a misdemeanor which means that an employer who fails to live up to his agreement may go to jail up to one



year and I move its' adoption."

Hon. W. Robert Blair: "Is there discussion? All those in favor of the adoption of the Amendment say 'aye', opposed 'no', ... Let's try it once again... All those in favor of the adoption of the Amendment say 'aye', those opposed 'no', Alright.. the 'ayes' have it and the Amendment is adopted. Are there further Amendments?"

Fredric B. Selcke: "Amendment No. 2, Simmons, amends House Bill 3644 as amended by deleting the word 'misdemeanor' and the period following that word at the end of the first paragraph of Section 1 and in lieu thereof inserting the following: "violation of this Act. A Person convicted of such a violation shall be fined not to excee \$1,000'."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Simmons."

Arthur E. Simmons: "Ah.. Mr. Speaker and Ladies and Gentlemen, this Bill originally ah.. set up the ah.. violation as a felony which ah.. went up to 10 years of imprisonment in an event of violation and ah.. quite a few of my ah.. people that I've talked to and I feel that a jail sentence for a violation of this kind is toc extreme. So, therefore, I recommend the passage of Amendment No. 2 that would change the ah.. violation from a misdemeanor and ah.. eliminating the jail sentence and ah.. imposing up to \$1,000 dollar fine for violation of this Act. Ah.. I move the adoption of Amendment No. 2."

Hon. W. Robert Blair: "The gentleman from McHenry, Mr. Hanahan."



Thomas J. Hanahan: "Mr. Speaker and Members of the House, if this Amendment was adopted, it would mean that the House of Representatives and General Assembly would be condoning almost the action that if an employer steals... an actually without a gun, steals from his employees their contributions and the health and welfare funds and pension funds that we would be saying that we'll just slap you on the wrist and fine you. This Amendment... the real fear that an employer has is embarrassment that someday if he doesn't live up to his contract, he could go to jail up to one year including Corporations and the Corporate Trust Officers. This type of approach of slapping a person on the wrist with a fine. I don't think is proper because that's all we're talking about and what the man has done wrong in the first place does not pay the bills. But he knows that if he has to face his neighbors and knows that he has the jail sentence of 30, 60, 90 or up to one year for non payment of health, welfare and pension funds, he'd think twice before he'd make this type of mistake and I urge a 'no' vote on this Amendment."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. J. J. Wolf."

Jacob J. Wolf: "Ah.. just a point of inquiry, Mr. Speaker. Is this Amendment in conflict with the one we just adopted?"

Hon. W. Robert Blair: "No. It's alright... The gentleman from Cook, Mr. Glass."

Bradley M. Glass: "Ah.. we'll the Sponsor of the Amendment yield for question?"



Hon. W. Robert Blair: "He indicates he will."

Bradley M. Glass: "Ah.. Art.. maybe you or Representative Hanahan could clarify this question but in arguing against your Amendment, he indicated the possibility that employers might be stealing the contributions that have been made by employees themselves to benefit plans but in reading the synopsis, it doesn't appear that's the case. It refers to payments or contributions ah.. to the employee benefit fund ah.. by the employer."

Arthur E. Simmons: "I believe you're correct."

Bradley M. Glass: "I think it's ah.. if I may speak... The Amendment.. I think it's a good Amendment and I agree with the Sponsor and urge support for it."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Kipley."

Edward L. Kipley: "Ah.. Mr. Speaker, would the gentleman from McHenry yield to a question? Ah.. Tom.. in the synopsis of the Bill, it indicates that certain Corporate Officers will be held liable in the event that the ah.. that this is a Corporation ah.. How do you define certain Corporate Officers? To what extent ah.. do you go on your Bill?"

Hon. W. Robert Blair: "The gentleman from McHenry, Mr. Hanahan."

Thomas J. Hanahan: "In Amendment No. 1 as adopted, the language was changed. We don't refer to Corporate Officers. We allow that under common law which would be the President and Secretary-Treasurer of a Corporation. Ah.. and it's not specified in the Bill any longer with the Adoption of Amendment No. 1."





Edward L. Kipley: "Inotherwords, no chance that I might go to jail."

Thomas J. Hanahan: "I..I hope not."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. B. B. Wolfe."

Bernard B. Wolfe: "Ah.. will the Sponsor of the Amendment yield to a question?"

Hon. W. Robert Blair: "He indicates he will."

Bernard B. Wolfe: "Ah.. Art, does the ah.. you just made a statement on the floor of the House that the Bill itself, the main portion of the Bill, only applies to a breach of contract ah.. by the employer with the union. Ah.. does it also apply to or directed to funds that are retained from the wages of an employee or transferred to a union fund by the employer? Or is that excluded from this particular Bill?"

Arthur E. Simmons: "I would like to refer that question to the Sponsor of Amendment No. 1."

Bernard B. Wolfe: "Alright.. I'll direct my question... if the Speaker will allow me to."

Thomas J. Hanahan: "Representative, there are very few plans but there are some that the employee and employer both contribute to. This Bill pertains to the employer contributing not to a union but to an employer-employee Trust Fund which is completely separate from a union. This is not dues money. This isn't money for an initiation fee. We're talking about fringe benefit money that was negotiated in a collective bargaining agreement in lieu of wages. It's a \$.30 a hour,



to \$.25 an hour that an employee agreed to have ah.. paid in his behalf into a Pension Trust Fund that sometimes these employers fail to contribute. And what we're trying to do is to whip it in line that we can't use mechanics lien law in some types of Industry. We can't use any other kind of law to get the wages or these fringe benefits collected. So, we felt that if we made it a criminal offense and tacked on a misdemeanor, that we would have this money that is really wages ah.. in all reality was in lieu of wages, this fringe benefit collection. So, it ah.. really is the employer's money that he has agreed to pay into a Trust Fund that we're trying to assure the collection of."

Bernard B. Wolfe: "Thank you."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Meyer."

J. Theodore Meyer: "Question to Representative Hanahan."

Hon. W. Robert Blair: "He indicates he'll yield."

J. Theodore Meyer: "Do the same criminal penalties apply to the Trustees of the Union?"

Thomas J. Hanahan: "That type of question... there is no ah.. ah.. Yes.. Yes.. it would apply. My union, for example, contributes on myself to a health and welfare fund. And if my union did not make its' payment within 30 days after the agreement of my union with the health and welfare fund. Yes.. they would be ah.. in violation of this Act became law."

J. Theodore Meyer: "Well.. why do you always... Well.. Okay. Thank you."

Hon. W. Robert Blair: "Further discussion? The gentleman



from Cook, Mr. Simmons to close."

Arthur E. Simmons: "Well.. Mr. Speaker, ah.. we in the General Assembly are looked upon as custodians of and ah.. and probably employers of the teachers and we have failed live up to our responsibility in appropriating money into the teachers ah.. retirement fund. Now, I don't know whether this would effect us but we all might wind up in jail for a year if we didn't live up to our agreement and put the money in as we should have. But that isn't the main reason why I ah.. offered this Amendment. Ah.. in ah.. Committee and in the sub-Committee that both Tom and I were members of the sub-Committee along with the Chairman, it was brought out that ah.. the large employers are not the ones that are guilty most often. It's the small employer ah.. that ah.. in the construction business that gets a little job and then ah.. bids it low and doesn't care of what he agrees to do. Now, by putting a small employer in jail for a year, you wouldn't only be punishing him, you would be putting him completely out of business. And I believe that if he's found guilty once, and fined a \$1,000 dollars that ah.. after that it would be very hard for him to be considered a responsible bidder and ah.. accepted as low bidder if he has ah.. already been found guilty and paid a \$1,000 dollar fine. Hon. W. Robert Blair: "The ah.. shall the House adopt the Amendment? All those in favor will vote 'aye', the opposed 'no', Have all voted who wish? Have all voted who wish?"

I'd like to know what Member filed the petition or motion for fiscal note."

Rep. Arthur A. Telcser: "Well.. Representative Pierce, I'm sure if you ask the Clerk, he'll be able to tell you. I don't know off hand."
