- Hon. W. Robert Blair: "Oh! Well, he's not here. Take it out of the record. 4452."

Fredric B. Selcke: "House Bill..."

- Hon. W. Robert Blair: "Wait.. Wait a minute. Take that out of the record. 4457."
- Fredric B. Selcke: "House Bill 4457, a Bill for an Act to make an appropriation to the Environmental Protection Agency.

Second Reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any from the floor?"

Fredric B. Selcke: "Amendment No. 1, Barry, amend House Bill



- 4457 on Page 1, Line 27, by deleting the period and inserting in lieu thereof, andsoforth."
- Hon. W. Robert Blair: "The gentleman from ah.. Bureau, Mr. Barry."
- T. Barry: "Mr. Speaker and Ladies and Gentlemen of the House, this is an Agreed Amendment on the Grant Appropriation Bill to E.P.A. It's agreed by ah.. Bill Blazier and ah.. Mr. Hyde ah.. through his Staff. Very simply, it makes it very clear that the E.P.A. may allow for grants to landfill operations as well as to ah.. water pollution control operations of various sorts in addition. And, we also have a savings clause. And, I recommend its adoption."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Hyde."

- H. J. Hyde: "Ah.. Mr. Speaker, Ladies and Gentlemen of the House, ah.. the distinguished gentleman from ah.. Ladd, Bureau County, is quite right. It's an Agreed Amendment and it does improve the Bill. And, I join him in moving for its adoption."
- Hon. W. Robert Blair: "The gentleman from ah.. Macon, Mr. Borchers."
- W. Borchers: "Mr. Speaker, I'd like to ask the Sponsor a question of Representative Barry. Ah.. do I understand that this includes for municipalities or townships ah.. grants for ah.. lo.. local landfill planning, etc.?"
- Hon. W. Robert Blair: "The gentleman from Bureau, Mr. Barry."
- T. Barry: "Yes, that's right. That's exactly what it does and it makes the Law very clear in the Grant Appropriation Bureau."



W. Borchers: "Ah.. I might ah.. might say that ah.. something like this ah.., where the ah.. problems are arising in relation to the recovery of land for cities and municipalities, that ah.., if this is judiciously used, it would be an excellent thing."

Hon. W. Robert Blair: "Further discussion? The question is on the adoption of the Amendment. All those in favor say 'aye' opposed 'no', the 'ayes' have it and the Amendment is adopted. Are there further Amendments? Third Reading. 4540."

- Fredric B. Selcke: "House Bill 4669, a Bill for an Act to make an appropriation to the Secretary of State. Second Reading of the Bill. No Committee Amendments."
- Hon. W. Robert Blair: "Any Amendments from the floor? Third Reading. 4252."



- Fredric B. Selcke: "House Bill 4252, a Bill for an Act to make an appropriation to the Secretary of State. Second Reading of the Bill. One Committee Amendment. Amend House Bill 4252 on Page 5, by striking Line 19 and on Page 5, Lines 21 and 24, by striking the words 'ordinary and contingent'; andsoforth."
- Hon. W. Robert Blair: "The ah.. gentleman from ah.. DuPage, Mr. Philip. The gentleman from ah.. DuPage, Mr. Philip."
- J. Philip: "Yeah.. Mr. Speaker and Ladies and Gentlemen of the House, Amendment No. 1, to House Bill 4252, ah.. simply strikes out the words 'ordinary and contingent'. It has been... We ve had a disagreement on this before and it has been worked out with the Democratic Leadership on the other side of the aisle. I move the adoption of Amendment No. 1, to 42... House Bill 4252."
- Hon. W. Robert Blair: "Okay.. The gentleman from Cook, Mr. Shea."
- G. W. Shea: "Mr. Speaker, I think, he's explaining Amendment No. 2. And, Amendment No. 1 ah.. is a little bit different. Maybe you ought to try explaining that one."
- J. Philip: "Excuse me, Mr. Speaker. He is correct. Amendment No. 1 deletes the 'job titles' to allow the Bill to conform with the ah.. Personnel Code'. I move the adoption of Amendment No. 1, to House Bill 4252."
- Hon. W. Robert Blair: "Well, the Clerk only has ah.. the one Amendment here, the Amendment that was offered and adopted the day of the Appropriations Committee by Representative ah..



- Collins. Yes, ha..huh.. The Amendment that's attached to the Bill was put on in the Appropriations Committee by Representative Collins. Now, is there... is that the Amendment that the gentleman from Cook, Mr. Shea, is addressing his remarks to?"
- G. W. Shea: "Mr. Speaker, Amendment No. 1 struck about the last four or five pages of the Bill. Now, is there an Amendment No. 2?"
- Hon. W. Robert Blair: "Well,... Well, that's right ah.. It would appear that ah.. nine through thirteen has the entire pages removed by deleting all of the lines. Now, that's the only Amendment that we have up here."
- J. Philip: "Yeah, Mr. Speaker. There is another Amendment."
- Hon. W. Robert Blair: "Alright.. That must be a floor Amendment then. On.. On the first Amendment then, is there any question about ah.. that? Alright.. Alright.. Ah.. it has been suggest that, perhaps, we ought to take it out of the record for the moment. And ah.., see if we can't ah.. ah.. square that up. 4373."
- Fredric B. Selcke: "House Bill 4373, a Bill for an Act to make an appropriation for an investigation of Peoria Lake in Tazewall County. Second Reading of the Bill. No Committee Amendments."
- Hon. W. Robert Blair: "Any Amendments from the floor? Third Reading. 3761."
- Fredric B. Selcke: "House Bill 3761, a Bill for an Act to provide for the nomination and election of Judges to repeal



part of an Act herein named. Second Reading of the Bill.
No Committee Amendments."

Hon. W. Robert Blair: "Any from the floor?"

Fredric B. Selcke: "Amendment No. 1, Burditt, amend House Bill 3761 on Page 1, Line 25,....."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Burditt."

- G. M. Burditt: "Ah.. Mr. Speaker, Ladies and Gentlemen of the House, this is a Bill to provide for the non-partisan election of Judges. The purpose of this Amendment is to provide for an election in 1972 in August so that the Bill will be exactly the same as Senator Partee's Bill, except that this is a non-partisan election and his is a partisan election. I move the adoption of the Amendment."
- Hon. W. Robert Blair: "All those in.. Ah.. is there discussion?

 The question is on the adoption of the Amendment. All those in favor say 'aye', opposed 'no', the 'ayes' have it and the Amendment is adopted. Are there further Amendments?

 Third Reading. The gentleman from ah.. Cook, Mr. Shea."
- G. W. Shea: "Mr. Speaker, would.. with the addition of this Amendment in a special primary, I'm sure it's going to cost a few dollars. So, I would request the Sponsor to file a fiscal note."
- Hon. W. Robert Blair: "Well, I'd already advanced the Bill to Third Reading."
- G. W. Shea: "I'm still requesting a fiscal note."
- Hon. W. Robert Blair: "Well, what Rule are you citing ah.. for your request?"



- G. W. Shea: "Under Rule 42, Mr. Speaker. And, under the Applicable Statues of the General Assembly."
- Hon. W. Robert Blair: "Well, I. I don't think you're under the Rule that you're quoting. It says that, 'in the event that a fiscal note has been requested, a Bill shall be held on the order of Second Reading until the fiscal note has been supplied'. Then, of course, I. as I indicated, I had advanced the Bill to Third Reading."
- G. W. Shea: "Well,...."
- Hon. W. Robert Blair: "Wait a minute. To Third Reading before you made the request. So, on.. on that question, I would ah.. rule ah.. that your point is not well taken. I've been advised, however, by the gentleman from Cook, Mr. Burditt, that he would be happy to furnish you with a fiscal note."

 G. W. Shea: "Thank you."
- Hon. W. Robert Blair: "You're welcome. Ah.. House Bills Third Reading. Now, in order... The gentle man from Union, Mr... Ah.. in order to ah.. quite things down, hopefully, on the floor, the Minority Leader and I have been discussing the fact that there appear to be persons on the floor ah.. that are not entitled to be there. So, we'll ask the Doorkeeper now to see that those persons, who are not entitled to the floor, are removed therefrom. And, to continue ah.. with that, not only with the balance of the Session today, but the rest of the Session. And, by 'Authorized Persons', we mean those that are authorized under the Rules to be on the floor. Ah.. the rest ah.. should not be on the floor. For what pur-



- pose does the gentleman from ah.. Cook, Mr. Richard Walsh, rise?"
- R. A. Walsh: "Well, Mr. Speaker, on that point, ah.. truly the floor of the House can be confusing at times. And, it seems to me that the Pages, passing out literature, ah.. adds to the confusion. And, I just had passed out to me ah.. something which bears ah.. no origin, 'Legislator's Act Scare Him', apparently, from some Newspaper. I don't even know what. And, I just wonder if ah.. ah.. if possibly, we can have some control over the material that the Pages are constantly passing out to us while the House is in Session?"
- Hon. W. Robert Blair: "Ah.. your point is well taken. And ah., the Pages are not supposed to be ah.. ah.. placing things on the desks ah.. that have not been cleared. And, ask the Clerk to see that ah.. the Pages do not ah.. hereafter ah.. put out anything on the desks without prior clearance. Ah.. 4087."
- Fredric B. Selcke: "House Bill 4087, an Act to provide for the ordinary and contingent expenses of the Illinois Arts Council. Third Reading of the Bill."
- Hon. W. Robert Blair: "Ah.. the gentleman from ah.. Lake, ah..
 Mr. ah.. John ah.. Henry Kleine."
- J. H. Kleine: "Mr. Speaker and Ladies and Gentlemen of the House, this is the annual appropriation for the Council. I know of ah.. It's the same.... The appropriation is the same as it was the year before. I know of no objection and I ask your favorable support."



- Hon. W. Robert Blair: "Is there discussion? The gentleman from McLean, ah.. Mr. ah.. The gentleman from Adams, Mr. McClain."
- E. McClain: "Will the gentleman yield for a question?"
 Hon. W. Robert Blair: "He indicates he will."
- E. McClain: "Ah.. here ah.., John, where you talk about appropriating money for grants, salaries and contractual agreements and other necessary payments. Now, how about ah.. the portion for salaries? Has that gone up?"
- J. H. Kleine: "Ah.. no, it hasn't. The ah.. is the same as ah.. The appropriation is the same as it was last year."
- E. McClain: "Well ah.., I didn't support it last time and I won't support it again."
- Hon. W. Robert Blair: "Any further discussion? The gentleman from Cook, Mr. Phil Collins."
- P. W. Collins: "Ah.. Mr. Speaker, it's no secret that I've been ah.. an opponent of the Arts Council ah.. ever since I've been a Member of this House. And, this year, I was rather inclined to go along with ah.. the appropriation. Bu ah.., things have come up recently that have disturbed me somewhat. And, I wonder if the Sponsor would yield ah.. to ah.. a couple questions?"
- Hon. W. Robert Blair: "He indicates he will."
- P. W. Collins: "Ah.. John Henry, ah.. there was an Article in one of the Chicago Newspapers on Saturday, reporting on the last Meeting, and I understand that there was some debate ah.. concerning the Mississippi River Festival. And ah...



- And ah.., ah.. vote on how much money would be ah.. expended on that project. Could you tell us ah.. ah.. just what was the amount ah.. appropriated and.. and ah.. and what was the vote ah.. taken in the Council?"
- J. H. Kleine: "Ah.. Representative Collins, I am not aware of that Article. I would suggest though that ah.. in Committee and in the debate that ah.. it was indicated to me and, I believe, to you too, that no money was.. was being directly appropriated, State Funds, for that particular ah.. Festival. This probably comes through Private and Federal Grants."
- P. W. Collins: "Ah. I. I'm not sure that your right on. on that. But, what was indicated to us in Committee, you're absolutely right. Now, furthermore, there was ah. some discussion as to accepting invitations from Europe and the Far East to send the Free Street Theatre Project ah. over there. Now, while I may ah. agree that this would be a good place to put it, I wonder if it's proper to ah. send Illinois Funds to ah. Europe ah. ah. and Asia for Free Street Theatre. Were you. Are you familiar with this portion of the ah. of ah. the last Meeting?"
- J. H. Kleine: "Ah.. Representative Collins, ah.. there's no indication, at this time, that any State money would be used for that purpose."
- P. W. Collins: "Ah.. what money is going to be used for that or ah.. is it ah.. is there any ah.. Do you know what money is going to be used on it?"



- J. H. Kleine: "I.. I would suggest that it's probably the Federal ah.. State Deparment's money. You remember the ah.. the Chicago Symphony Orchestra, who went ah.. to Europe last year, was ah.. a tremendous success for the State of Illinois. And ah.., provided this State with a fine reputation of a fine Organization."
- P. W. Collins: "Well, I.. I'm just going over the minutes of the Meeting. And ah.., well, I wanted to do everything I could to help the ah.. the Council this year because, I thought, that they were proceeding in the proper direction. And then, something like European trips for ah.. ah.. ah.., something like the Free Street Theatre, is a questionable value ah.. even in the State. And then, ah.. to send it ah. across a couple of Oceans, I certainly can't support that. And, I'm looking at the minutes where the move was made to expend the money to the Mississippi River Festival. And, it's ah.. There's no qualification as to whether it's State or Federal Funds. I ah.. I think, again, we're ah.. we're getting into a breakdown of communications in this Agency. And ah.. ah.., again, I guess I'll have to.. to ah.. ah.. remain consistent and urge the Members of ah.. the House to ah.. to reject this ah.. ah.. this appropriation again. Ah.. ah.. the first thing we know, we'll be sending Mr. Ochmishino over to ah.. paint subway in Tokeyo and, perhaps, that's where he should be, but not at our expense. And, I would ask for a 'no' vote on this appropriation."

Hon. W. Robert Blair: "Further discussion? The ah.. gentleman



- from ah.. Alright.. The gentleman from Lake, Mr. Kleine, to close."
- J. H. Kleine: "Mr. Speaker, I ask your favorable consideration on this very fine piece of Legislation."
- Hon. W. Robert Blair: "Alright.. The question is, 'shall House Bill 4087 pass?'. All those in favor will vote 'aye', and the opposed 'no'. The gentleman from Macon, Mr. Borchers."
- W. Borchers: "Mr. Speaker and Gentlemen of the House, in explaining my 'no' vote, I just merely want to point out that this is one of the finest boondoggling project that we are supporting. And, I think, it's time to draw part of it to a close."
- Hon. W. Robert Blair: "The ah.. gentleman from St. Clair, Mr. Flinn."
- M. L. Flinn: "Mr. Speaker, in explaining my vote, I think, that this Bill should pass. They do some very fine work. Now, I don't know what happens to all of the money. In fact, I don't know what happens to all of the money in any of the appropriations that we have here. But, without this, we would not have the Mississippi River Festival down in my District.

 And, it's a very fine thing. It's... It's something that we really need down there. And, I.. I strongly support this and ask that you give us a 'yes' vote."
- Hon. W. Robert Blair: "The ah.. gentleman from ah.. Cook, Mr. J. J. Wolf."
- J. J. Wolf: "Well, Mr. Speaker and Members of the House, I have to, once more, join my Colleague, Phil Collins, in opposing



this Bill. We've seen this thing grow from a biennial appropriation of \$150,000. Now, it's \$600,000 a year. And, all it seems to do is provide the employment for some of the so-called Art people that couldn't find a job on the open market. And, I'm going to oppose it now and urge my Colleagues to vote against this Bill."

Hon. W. Robert Blair: "The gentleman from Livingston, ah.. Mr. Hunsicker."

- C. T. Hunsicker: "Mr. Speaker and Ladies and Gentlemen of the House, I have to agree with the previous Speaker. I can remember... If my memory serves me correctly, when the first appropriation to the Illinois Art Council was made about eight or ten years ago, it was \$60,000. And now, it has increased to \$600,000. And, it appears to me that this money could be used far better in other areas of the State than for this particular purpose. And, I vote 'no'."
- Hon. W. Robert Blair: "The gentleman from ah.. Christian, Mr. Tipsword."
- R. F. Tipsword: "Thank you, Mr. Speaker. Mr. Speaker, due to the fact that we are in an economic crisis and that we need money for the public schools, we need money for highways, for transportation and for so many other things, and all of us would like to see the expenses of the State of Illinois as well as our Local Governments cut. While I am... I re.. I would regret very much if the Arts were to suffer tremendously. It appears to me that this is one area in which we.. we could save a lot of money. It also appears to me that....



I don't want to be ah.. in opposition to the promotion of the Arts. And so, consequently, in that dilemma, I would be asked... I would ask the Speaker that I might be recorded as voting 'present' on this Bill."

Hon. W. Robert Blair: "Tipsword.. 'present'. The gentleman from ah.. McLean, Mr. Hall."

"Mr. Speaker and Ladies and Gentlemen of the House, H. H. Hall: the reason that I'm voting against this Bill is that, in talking about the purposes of the Arts Council, it was testified in Committee, by the people who ah.. operate the Arts Council, that the purpose of the State donations was as a seed fund ah.. for the encouragement of private donations in operating the Arts Council in conjunction with private donors, philanthropic organizations. Further questioning, brought out the fact that less than \$80,000 total is contributed outside of ah.. taxpayer funds for the operation of the Council. to say, six years ago or five years ago, when I first voted on this measure, the State appropriation was \$50,000. we're going to, apparently, appropriate \$600,000 while private sources are withdrawing their funds because the Government has gotten into this business. Now, this is a ridiculous trend. When ... When they had money privately to support the Arts, people who wanted to were supporting the Arts and had the money and could afford it. Now, we're putting it on the backs of the taxpayers. So, consequently, the private funds dry up and no longer care to ah.. ah.: to support the ah.. idea in concept. So, I would suggest we ah.. ah.. vote a-



gainst this and either lower the amount of the appropriations or make them find matching funds as they had promised to do when they ah.. ah.. first started this "

Hon. W. Robert Blair: "The gentleman from ah.. DuPage, Mr. Hudson."

- G. Hudson: "Mr. Speaker and Ladies and Gentlemen of the House, I am reminded of Abraham Lincoln's admonition to the people at one time in which he said that, 'government should only do those things for the people which they can not do at all or can not do as well for themselves'. I think, this is ah. represents ah.. this appropriation, ah.. represents State intervention and State donation of taxpayers money in an area that can be best handled by the people themselves. certainly not opposed to the Arts or to the development of the Arts. But, I think, here is an area clearly that can be supported by private concerns, private individuals and right fully so and keep this off the back of the taxpayers. if we won't draw a line on these kind of appropriations, and on these kind of expenditures, then where in heaven's name will we draw the line? I would urge a vote 'no'." Hon. W. Robert Blair: "The ah.. gentleman from Cook, Mr. Phil
- P. W. Collins: "Ah.. Mr. Speaker, ah.. in explaining my vote, ah.. Representative Flinn, quite correctly, pointed out that the Mississippi Festival has been ah.. quite ah.. ah.. an accomplisment for that area of the State. However, I

would point out to the Members of the House that this money,



Collins."

that we're talking about in the Arts Council, is not the only money that has been pumped in ah.. ah.. into this so-called Festival. This is the, also the.. the same ah.. endeavor where Southern Illinois University at Edwardsville, with unconscionable disregard for the Legislative process, secretly put \$250,000 into this effort. I.. I think, that this is something that we should take a very good, long look at. And, I think, it's all the more reason why we ah.. should today reject ah.. House Bill 4087."

Hon. W. Robert Blair: "The gentleman from Madison, Mr. Calvo." H. L. Calvo: "Mr. Speaker, in brief reply to the learned gentleman's last speaker's remarks. The Mississippi River Festival is supported primarily by the people of the Area, not in just buying tickets and going to the Festival, but in contributions. The contribution that we get from the Arts Council we're very appreciative of because without it, we couldn't have the Festival. But, we do more than match it with local funds from individuals to contribute. And, it is these people, and there are a few people, of course, that are wealthy enough to contribute to something like this, but it is those people that are keeping this going and they are matching the funds contributed by the Arts Council, in reply to another gentleman's criticism of the Council. I would urge your support of this measure, not just for the Mississippi River Festival, which is a very fine thing and it attracts several hundred thousand people to our Area to see these programs during the summer, but also in support of the entire programs of the



Arts Council. If we can't have a little culture in this State for these few dollars, then, I think, we're in pretty bad shape. And, I would appreciate some more 'green' lights.

Thank you."

Hon. W. Robert Blair: "Have all voted who wished? The Clerk will... The Clerk will take the record. On this question, there are 107 'Ayes', and 43 'Nays' and 1 'Present'. And, this Bill having received a Constitutional majority is hereby declared passed. 4448."

Fredric B. Selcke: "House Bill 4448, an Act to amend the 'Public Junior College Act'. Third Reading of the Bill."

Hon. W. Robert Blair: "The ah.. gentleman from Lee, Mr. Shapiro."

D. C. Shapiro: "Ah.. Mr. Speaker, ah.. I have no aversion to calling the Bill, but it is a companion Bill to the Appropriation. And, more than likely, they should be heard together."

Hon. W. Robert Blair: "Alright.. Ah.. let's take it out of the record. Senate Bills Second Reading. 1373."

Fredric B. Selcke: "Senate Bill 1373, an Act to authorize the sale and conveyance of certain State-owned land situated in Lake County. Second Reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor? Third Reading. On the order of Speaker's Table, appears House Bill 4680. And ah.., leave was obtained last week to ah.. have that matter set in a Committee of the Whole. And, I agreed with the Minority Leader that that will be on this Thursday



at 11:00 A.M. A Committee of the Whole, on House Bill 4680, on this Thursday at 11:00 A.M. Also, on the Speaker's Table, appears House Resolution 4.. 456."

Fredric B. Selcke: "Ah.. House Resolution 456,...."

Hon. W. Robert Blair: "The gentleman from Cook, ah.. Mr. Ron Hoffman."

R. K. Hoffman: "House Resolution 456 creates a special committee, composed of eight Members of the House, to study the Divorce Laws of Illinois and the existing practices and the ethical behavior of those purchased bidding and litigation in Divorce. This is the result of a growing demand, through the news media and the people of Illinois, for more equitable treatment of those involved in litigation. This Committee is not a proponent of Divorce in any manner. It's just to create an ethical manner ah.. to be treated for the litigants in reference to the Attorneys and Judiciary in handling these cases. This was passed from Judiciary I with no dissenting votes. And, I urge the adoption of the House."

Hon. W. Robert Blair: "The gentleman ah.. from Cook, Mr. Rayson."

L. H. Rayson: "Mr. Speaker, would the gentleman yield to a question?"

Hon. W. Robert Blair: "He indicates he will."

L. H. Rayson: "Ah.. I.. I was just passed a sheet which indicates ah.. that maybe there's an Amendment to include the study of existing Divorce Laws and the effects they have on Divorce Prac.. Operations. So, I take it that that's embodied now in this Resolution?"



- R. K. Hoffman: "No, it isn't, Representative. The Resolution, that you're referring to, was passed by the Young Lawyer's Association of the Chicago Bar Association. And, they felt that, not only should this Resolution be adopted and this Committee be formed, that it should be more encompassing. However, the Resolution has not been altered and remains as it has been presented."
- L. H. Rayson: "Ah.. Well, again, according to this sheet, which indicates that it might have merit to include the Study of Divorce Laws, would you be willing to accept an Amendment to this same purpose?"
- R. K. Hoffman: "At this time, we.. we certainly would accept an Amendment to adopt. However, we feel that the thrust of this is to create the Committee to launch this type of concept and investigation. And, thereby, with their findings, if they would warrant so and the reporting date of 1973, we could possibly bring this ah.. concept into the proposal."
- L. H. Rayson: "Well, I.. I think, some of us would support this
 Resolution if you would accept that Amendment and if you would
 hold this so that this Amendment could be prepared. I think,
 it would help ah.. the Resolution and it would ah.. have a
 solitary affect on the purpose of this Resolution."
- Hon. W. Robert Blair: "The ah.. gentleman from ah.. ah.. Mr. ah.. James Y. Carter."
- J. Y. Carter: "Ah.. Mr. Speaker, I hardly concur with the last Speaker. The fact that our Laws force Lawyers into perjury and into other Acts. In order to conform to our present



Laws, means that these here Laws need to be changed. Now, if they will amend this to say that there should be the thrust of it. of the present Divorce Laws to bring them into conformity with some of the things that go on in the practice of Law, I'd be glad to vote for it. But, not in its present form. Thank You."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Epton." B. E. Epton: "Mr. Speaker, Ladies and Gentlemen of the House, I wonder if you could give me your attention for just a moment. I think, that Representative Hoffman has introduced a Resolution which has considerably more merit than many of us may believe. As a matter of fact, when this Resolution came up before the Judiciary Committee, a representative of the Illinois-Chicago Bar Association appeared in front of us and informed us that we had no right to pass this Resolution. He indicated that the House of Representatives had no authority. This gentleman, representing the Chicago-Illinois State Bar Association, advised us that this House of Representatives had no authority to investigate the unethical practices of any Attorney. As a Lawyer, I resented his remarks. And, as a member of both Associations, I think, he was completely in error. As a matter of fact, it would appear that even the Chicago Bar Association doesn't know exactly what's going on in its own house because its younger member's committee did initially support this. Now, to suggest at this time an Amendment be put forth to investigate Divorce Laws simply means that, if the Laws are not proper, Lawyers,



particularly in Cook County, have a right to be corrupt. I think, that it's a silly petition of any Member of the Bar to suggest that, because the Law is inept or inadequate, that we have a right to go beyond it. There are corrupt Lawyers practicing in the City of Chicago. There are corrupt Lawyers in the Divorce Field. And, this Resolution simply suggests that they should be investigated. This Resolution should be passed unanimously. We should investigate, not only those Lawyers, we should investigate those Lawyers in the personal injury field, in any number of areas. There is no excuse for any Lawyer suggesting that we can operate outside the Law. I submit that Representative Hoffman has an extremely laudable Resolution. I submit that its passage will alert the Bar Associations in the State of Illinois that the House of Representatives is fed up with their failure to police their profession. I urge a favorable vote."

- Hon. W. Robert Blair: "Alright.. Further discussion? The gentleman care to close? Oh! The gentleman from Cook, Mr. B. B. Wolfe."
- B. B. Wolfe: "Ah.. Thank you, Mr. Speaker. Just briefly, ah.. this is nothing new ah.. to the House and to Committees which have been in operation in this particular area for the past four or five years. And, many of our Members are experts in this field having all of this background. Now, the only thing that.... To have a meaningful Commission in this area, I.. I think, it would be necessary to adopt the suggested ah.. Amendments ah.. of the Young Lawyer's Committee because



all that that says is that ah.. the Committee shall study... include a study of existing Divorce Laws and the effects of those Laws on existing divorce operations which the Committee is going to study, practices and procedures. And, I think, that ah.. ah.. such an Amendment would be both meaningful and would relate to ah.. the suggested study ah.. that this ah.. Resolution ah.. pertains to. Ah.. this is an area ah.. that ah.. we find affects a family life, ah.. it.. it affects ah.. divorce statistics. And, I think, in arquing House Bill 631, which was directed towards curing some of these defects and a Bill which would tend to correct ah.. some of the abuses. in the divorce practice ah.. ah.. and was voted down by this House, ah. I strongly feel that ah. a meaningful Resolution, at this time, should include ah.. this broad aspect of a relationship to ah.. both the Divorce Laws and the operations, practices and procedures ah.. in the Divorce Courts. would strongly recommend to the Sponsor ah.. that he include ah.. a such an Amendment which would not, in any way, ah.. detour from the present Resolution. I could then support the Resolution."

Hon. W. Robert Blair: "The ah.. gentleman from ah.. Cook, Mr. Glass."

- B. M. Glass: "Will the Sponsor yield for a question, Mr. Speaker?

 Ah.. Ron, was this ah.. does this Committee do essentially
 the same thing that the ah.. Commission would have done ah..
 pursuant to the Bill that you sponsored last year?"
- R. K. Hoffman: "Yes. Ah.. Representative, this is more defini-



tive than the Cammission Bill that was passed out of the House with a good majority and was defeated in the Senate. The only thing that I'm concerned about here and the people and the news media, who are interested in this proposition, are that our primary concern is equity for the litigants. All of the people, who have corresponded with me, both men and women, have indicated that it's the interpretation of the Laws, the ah. actual mechanical procedure ah. instituted by the Attorneys. So, consequently, my main objective here at this point is to provide equity for the people of the State of Illinois."

- B. M. Glass: "Well, if I may comment ah.. As a member of the Sub-Committee, that held a hearing on your Commission Bill, I was certainly convinced of the need for the study. And, if this ah.. ah.. Legis.. if this Resolution will accomplish the same thing or do it more effectively, I'm a hundred percent behind it."
- Hon. W. Robert Blair: "Any further discussion? The gentleman from Cook, Mr. Hoffman, to close."
- R. K. Hoffman: "Thank you, Mr. Speaker and Members of the House, I ask you seriously to consider this. In the past year, I have had many correspondence with the people in the State of Illinois and people outside of the State of Illinois who feel that the greatest abuses are in the Courts in the handling of these cases. Next of the people, who have testified previously in the Hearings, as Representative Glass alluded to, have indicated that that is the treatment that they have re-



ceived that has prompted their action to formulate this. It's a matter where certainly as we are conducting these Hearings we'll relate them to the Laws of the Statutes as they are.

And, if there are recommendations or remedial actions, they will be incorporated into the report. I am primarily concerned in giving the people of the State of Illinois, those who are seriously concerned ah.. with this ah.. particular area, a vehicle to see if we can't clean up some of these inequities and solve some of the problems and give these people, the people who are involved in this, a form so that they might be heard. Thank you, Mr. Speaker. I solicit your support."

- Hon. W. Robert Blair: "The question is, 'shall the House adopt House Resolution 456?'. All those in favor will vote 'aye', and the opposed 'no'. Have all voted who wished? The gentleman from Cook, Mr. B. B. Wolfe."
- B. B. Wolfe: "Ah.. in view of the failure to ah.. adopt, what I consider to be a.. a meaningful Amendment ah.. to the Committee's work, ah.. record me as voting 'present'."
- Hon. W. Robert Blair: "Record the gentleman as voting 'present'.

 The gentleman from ah.. Adams, Mr. McClain. Ah.. Mr.

 McLendon.. 'present'. Yeah.. I.. I got McClain as 'present'.

 Mr. Pierce.. 'present'. Mr. Katz.. 'present'. Mr. Maragos..

 'present'. Mr. Jaffe.. 'present'. Mr. Meyer.. 'present'.

 Mr. Bluthardt.. 'present'. Mr. Craig.. 'present'. Ah..

 Mr. Boyle.. 'present'. Mr. James Y. Carter."
- J. Y. Carter: "Ah.. I'm going to join the majority of Lawyers



in this House and vote 'present' also, please."

Hon. W. Robert Blair: "Ah.. Carter.. James Y. Carter.. 'present'. Duff.. 'present'. Have all voted who wished? Neff.. 'present'. The Clerk will take the record. Berman.. 'present'. On this question, there are... Collins.. Phil Collins.. 'present'. On this question, there are 103 'Ayes' and 6. 'Nays' and 15 'Present' and the Resolution having received a majority of vote is hereby declared adopted. On the order of Concurrences, appears ah.. House Bills ah.. 3737 and 3738 on which the Chair recognizes the gentleman from Cook, Mr. Harold Washington, with regard to Senate Amendment No. 1, concurrences on the 3737 and 3738."

H. Washington: "All these Amendments do, Mr. Speaker and Members of the House, are change the effective dates from ah.. one year, I don't have the Bill in front of me unfortunately. Ah.. there's no disagreement with these. And, I move concurrent with Senate Amendment No. 1, to these two Bills."

Hon. W. Robert Blair: "Alright.. The question then is... Is there any discussion? Alright.. The question is, 'shall the House concur in Senate Amendment No. 1, to House Bill 3737?'. This is final passage. Requires 89 votes. All those in favor will vote 'aye', and the opposed 'no'. Have all voted who wished? The Clerk will take the record. On this question, Campbell.. 'aye', there are 138 'Ayes', and 1 'Nay' and the House concurs in Senate Amendment No. 1, to House Bill 3737. Now, the same question with regard to 3738. All those in favor of the House concurring in Senate Amendment No. 1,



will vote 'aye', and the opposed 'no'. Have all voted who wished? Meyer. The gentleman from Cook, Mr. Meyer."

- J. T. Meyer: "A question of the Sponsor. What does this Bill
 do, Representative Washington?"
- H. Washington: "Actually, the question of what the Bill does is not germane. The Amendment is the one that we're voting on. But, what it does, it incorporates certain misdemeanors into the ah.. new 'Correction Code'. And, it just puts them in a certain category in the 'Corrections Code'. We voted this Bill out by 140 some votes to nothing. And, all the Amendment do is change the effective date to one year."
- J. T. Meyer: "Well, I believe, it's a Marijuana Bill."
- Hon. W. Robert Blair: "Any ah.. further explanations? Have all voted who wished? The Clerk will take the record. On this question, there 138 'Ayes' and 3 'Nays' and this Bill.. and the House concurs in Senate Amendment No. 1, House Bill 3738. House Bill 810, on which the Chair recognizes the gentleman from Cook, Mr. Sevcik, with regard to Senate Amendment No. 2."
- J. G. Sevcik: "Ah.. Mr. Speaker, would you hold that for a second? I have to pick them up there."
- Hon. W. Robert Blair: "Alright.."
- J. G. Sevcik: "Ah.. Mr. Speaker, I have it. Ah.. Mr. Speaker, I move that the ah.. House concur in Senate Amendment No. 1, to House Bill ah.. 810. This also changes the effective date from July 1st, 1972 to July 1st, 1973. And, it also changes the effective date pertaining to the Children and Family



Services to January 1st, 1974. I ask that the House concur. Hon. W. Robert Blair: "Discussion? Alright.. The question is then on the adoption... on concurrence ah.. in Senate Amendment No. 2, to House Bill 810. All those in favor will vote 'aye', and the opposed 'no'. Have all voted who wished? The Clerk will take the record. On this question, there are 142 'Ayes', no 'Nays' and the House concurs in Senate Amendment No. 2, Ah.. House Bill 811. The gentleman from Cook, Mr. Sevcik."

- J. G. Sevcik: "You have an Amendment there ah.. ah.. Mr. Clerk I asked the House to concur in Amendment No. 1. So, the Amendment which changes the effective date."
- Hon. W. Robert Blair: "Well,... Alright.. The question is on concurrence of Senate Amendment No. 1, to House Bill 811.

 All those in favor will vote 'aye', and the opposed 'no'.

 This takes 89 votes. Have all voted who wished? Take the record. Alright.. On this question... question, there are 139 'Ayes', and no 'Nays' and ah.. Senate.. House concurs in Senate Amendment No. 1. Now, Senate Amendment No. 2."
- J. G. Sevcik: "Ah.. Mr. Speaker, Ladies and Gentlemen of the House, I ask that the House concur in Senate Amendment No. 2, which was some technical language that was left out of the.. the ah.. Bill."
- Hon. W. Robert Blair: "Discussion? The question is on the adoption of Senate Amendment No. 2. All those in favor will vote 'aye', and the opposed 'no'. Have all voted who wished?

 The Clerk will take the record. On this question, there are



- T. S. Lechowicz: "Thank you, Mr. Speaker. I know it's a little bit out of order now because the ah.. Amendment No. 2 has passed, but in the explanation of the Amendments, ah.. it's true that it was a clarification or correctional limit as far as the first portion of it. But, it also ah.. eliminates lines 1 through 20 on Page 116. And ah.., actually, that eliminates also the effective date of the ah.. of the Bill. And, I was wondering if there's a corrective.... Was that Amendment No. 1?"
- J. G. Sevcik: "As I understand it ah.:, Ted, they left out a
 page and they had to take it out of ah.. this Amendment, No. 2.
 This was by a ah.. Conference of the Senate and the House."
- T. S. Lechowicz: "Thank you."
- Hon. W. Robert Blair: "On this question, there are 140 'Ayes', and no 'Nays' and the House concurs in Senate Amendment No. 2.

 Maragos.. The gentleman from Cook, for what purpose do you rise?"
- S. C. Maragos: "Mr. Speaker, I would like ah.. to rise and ah.. get unanimous consent of the House to be recorded as voting 'aye' on House Bill 3608 which passed last week. And I ask for unanimous consent to suspend Rule 64. It will not change the result."
- Hon. W. Robert Blair: "Well, Rule ah.. Ah.. Rule 64, you know, has to be ah.. the next Legislative Day."
- S. C. Maragos: "Well, I asked for the suspension of Rule 64. Unanimous consent."
- Hon. W. Robert Blair: "Well now, we have to find it to verify



man have leave ah.. Is there objection to ah.. to suspending Rule 64 so that ah.. his ah.. vote may be recorded ah..."

S. C. Maragos: "'Aye'."

Hon. W. Robert Blair: "As 'Ave' on...."

S. C. Maragos: "House Bill 3608."

Hon. W. Robert Blair: "House Bill 3608. It will not change the result. Alright.. 3 or 1... Senate Amendment No. 1, to House Bill 1976. The gentleman from Cook, Mr. Sevcik."

- J. G. Sevcik: "Ah.. Mr. Speaker, Ladies and Gentlemen of the House, ah.. House Bills 1976 through 1979 and 1999 ah.. they all change the effective date from ah.. January the 1st ah.. 1972 to 1973. Could we hear these all at one time or do you want to go through one at a time, ah.. Mr. Speaker? That's all we do on.. on this whole series of Bills, is change the effective date."
- Hon. W. Robert Blair: "Alright.. The gentleman is asking leave ah.. to have the House consider concurring in Senate Amendments No. 1, House Bills 1976, 1979 through 1999, 3082 through 3534. Now is there objection? Hearing none, then leave has been given for that purpose. Does the gentleman care to once again, explain what that Amendment does?"
- J. G. Sevcik: "Ah.. Mr. Speaker, on that... from 3082 through 3534, except Bills 3256, 3263, 3314, 3374, 3390 and 3404, which were tabled in the Senate because the Law they amended has been repealed. I'd like leave to hear all.. all of the other Bills. And, the Amendment, all it does is change the



effective date to January 1st, 1973."

- Hon. W. Robert Blair: "Alright.. Does he have leave to have this considered on one Roll Call and the Clerk will make sufficient copies of that Roll Call for each of the Bills indicated. There are about 500 in this Series. Hearing no objection, then the question is, 'shall the House concur in Senate Amendment No. 1, to House Bills 1976, 1979 through 1999 and 3082 through 3534?'. All those in favor will vote 'aye', and the opposed 'no'. Now, there is an exception ah. to Bills in that Series ah.. which are indicated on the Calendar as House Bills 3256, 3263, 3314, 3374, 3390 and 3404. All those in favor will vote 'aye', and the opposed 'no'. The gentleman from Cook, Mr. Lechowicz."
- T. S. Lechowicz: "Mr. Speaker, we've been trying to find the Amendment here. I don't know if the Pages put them out or not. I don't have them in my files. And, I was wondering if the Sponsor, in good faith, would just take this cut of the record temporarily until we get the Amendments? It should only take about five minutes, Mr. Speaker. Fine. Thank you, Mr. Speaker."
- Hon. W. Robert Blair: "Alright.. On this question, then there.

 Oh! The Clerk will take the record. On this question, there
 are 135 'Ayes', and no 'Nays' and ah.. in this Series of
 House Concurrences in Senate Amendments No. 1, they are hereby declared concurred in. 2707. Ah.. Senate Amendment No. 1,
 on which the Chair recognizes the gentleman from Vermilion,
 Mr. Campbell."



- C. M. Campbell: "Ah.. Mr. Speaker, Ladies and Gentlemen of the House, ah.. Senate Amendment No. 1, simply reinstates the Legislative Advisory Committee to be consulted with in regard to an expenditure of any excess funds. And, the Department, through the Committee, would report to the General Assembly prior to the enactment of the Department's Appropriations. And, one of the things that it does, it replaces biennium ah.. by fiscal year. And, I move to concur with Senate Amendment No. 1, to House Bill 2707."
- Hon. W. Robert Blair: "Discussion? The question is on ah..

 House concurrence in Senate Amendment No. 1. All those in
 favor will vote 'aye', and the opposed 'no'. Have all voted
 who wished? The Clerk will take the record. On this question, there are 133 'Ayes', and 1 'Nay' and the House concurs
 in Senate Amendment No. 1. 3544. The gentleman from ah..
 Lawrence, Mr. Cunningham."
- R. D. Cunningham: "Mr. Speaker and Members of the House, last November, this House very graciously passed ah.. House Bill 3544 seeking to authorize the University of Illinois to convey twenty acres of unused land to Oblong High School. Subsequently, the Senate, attempting to ah.. correct the subsequent unitization of the Oblong High School, attached Amendment No. 1. But, alas, when the thing was printed, through fault other than that of our esteem Clerk, the Amendment is placed on the wrong line so it strikes the description of the land being ah.. conveyed or sought to be conveyed and ruins the Bill completely. Accordingly, I would re-



spectfully urge that we nonconcur and would assure the Member-ship, if that a wise Committee is appointed, the matter can be corrected expeditiously."

- Hon. W. Robert Blair: "Discussion? The question is, 'shall the House concur in Senate Amendment No... Oh! 'Shall the House nonconcur in Senate Amendment No. 1?'. All those favor will say 'aye', opposed 'no', the 'ayes' have it and the House nonconcurs in House Bill 3544. 3639. The gentleman from Perry, ah.. Mr. Cunningham."
- W. J. Cunningham: "Mr. Speaker, Ladies and Gentlemen of the House, Senate Amendment No. 1, to House Bill 3639 has to do with establishing some base for the filing of records pertaining to General Assembly appointments to Special Districts throughout the State. This Amendment is good in some places and bad in others according to the Leadership on both sides of the aisle of the House. We would prefer to nonconcur in Senate Amendment No. 1, thereby, forcing it into a ah.. Committee and try to work this thing out. At the present time, ah.. the Senate, no doubt, will kill the effect of the Bill if their Amendment is allowed to stand. I've talked to the Senate Sponsors and they now agree with us to shove it into a Committee. I've talked to the Democratic side of the aisle and the Republican Members affected and we are all in agreement of nonconcurrence. I ask your support of a motion to nonconcur."

Hon. W. Robert Blair: "The ah.. Discussion? The question is, 'shall the House nonconcur in Senate Amendment No. 1, to



- House Bill 3639?'. All those in favor will say 'aye', opposed 'no', the 'ayes' have it and the House nonconcurs. 3681.

 The gentleman from Peoria, Mr. Tuerk."
- F. Tuerk: "Mr. Speaker and Members of the House, Senate
 Amendments 1 and 2, to House Bill 3681, Senate Amendment 1,
 actually, makes this ah.. Act ah.. taking effect upon its
 becoming Law. And, Senate Amendment No. 2 merely corrects
 some ah.. language in the Bill that was in the Bill when it
 left the House, but because of some particular error in
 Enrolling and Engrossing, were defective and we made those
 corrections in the Senate. And, the Bill is now in the
 shape that it passed out of here originally. And, I would
 move that the House concur in Senate Amendments 1 and 2,
 to House Bill 3681."
- Hon. W. Robert Blair: "Any further discussion? Alright.. The question is, 'shall the House concur in Senate Amendments

 No. 1 and 2?'. All those in favor will.. The gentleman from ah.. McLean, Mr. Bradley."
- G. A. Bradley: "Mr. Speaker, I wonder if the gentleman would yield to a question. Ah.. Representative Tuerk, ah.. what do these two Amendments, that the Senate put on there, do?"
- F. Tuerk: "Well, Gerry, as I explained, Senate Amendment 1, actually, makes this ah.. Act becoming effective upon becoming Law. That's Senate Amendment No. 1 which would then make the Bill operative and the whole system operative for 1972. Senate Amendment No. 2 merely does some things in language ah.. which were... The language was in the Bill, in the



House Bill, when it left here last Fall. But, because of some particular error, and why I can't explain it, in Enrolling and Engrossing, they were not incorporated in the House Bill in the Senate. So, we merely made those corrections in the Senate to make the Bill, as I mentioned a moment ago, the same Bill in the same language as when it left here and passed out of here by an unanimous vote."

- G. A. Bradley: "Tha.. Thank you. I remember we had this Bill and there was a lot of discussion. But, I wondered if there was a substantious change..."
- F. Tuerk: "No."
- G. A. Bradley: "And, evidently, there is not."
- F. Tuerk: "No."
- G. A. Bradley: "Thank you."

Hon. W. Robert Blair: "Further discussion? The question is then, 'shall the House concur in Senate Amendments No. 1 and 2, to House Bill 3681?'. All those in favor will vote 'aye' and the opposed 'no'. Have all voted who wished? The Clerk will take the record. On this question, there are 147 'Ayes', and no 'Nays' and the House concurs in Senate Amendments No. 1 and 2. 2416. The gentleman from Madison, Mr. Calvo."

- H. L. Calvo: "Mr. Speaker, Ladies and Gentlemen of the House, I would like to move that the House nonconcur in Senate Amendments No. 1 and 2, to House Bill 2416. And, ask that a Conference Committee be appointed."
- Hon. W. Robert Blair: "Alright.. Is there discussion? All those in favor of the gentleman's motion to nonconcur say 'aye',



- opposed 'nay', the 'ayes' have it and the House nonconcurs in House... in Senate Amendments No. 1 and 2, to House Bill 2416. 3060. The gentleman from Lake, Mr. Murphy."
- W. J. Murphy: "Mr. Speaker and Members of the House, I move that the House do concur in this Senate Amendment, to House Bill 3660."
- Hon. W. Robert Blair: "Is there discussion? The question is, 'shall the House concur in Senate Amendment No.... The gentleman from ah.. Cook, Mr. Shea."
- G. W. Shea: "I'm wondering if... Could you explain, Bill, what the Amendment does?"
- W. J. Murphy: "Ah.. Representative Shea, this Amendment was put on House Bill 3060 due to the fact that ah.. the Supreme Court ah.. did not allow personal property tax to be eliminated as we thought it was going to be eliminated. This Amendment pre-empts the double taxation of ah.. of ah.. mobile homes because the Bill, that we passed in the previous Session, allows barefoot price of ah.. up to fifteen cents ah.. fifteen percent a square foot on a trailer. And, they would have to pay that along with personal property tax. And so, for this time, until the personal property tax situation is clarified why, this Amendment eliminates double taxation."
- Hon. W. Robert Blair: "Further discussion? The gentleman from ah.. Cook, Mr. Maragos."
- S. C. Maragos: "Ah.. Representative Murphy, I did not get the full explanation of what the Amendment does."
- W. J. Murphy: "It postpones certain taxation.... It repeals



the Act that we passed giving the County Treasurers the right to put ah.. square foot tax on the trailers because the personal property tax was not eliminated and they have to pay personal property tax this year. And, this would make double taxation. So, we are repealing the Act that we passed in the last Session "

- S. C. Maragos: "What does it do to the present taxation for the year of 1971?"
- W. J. Murphy: "It stays as it was previously where they pay personal property tax."
- S. C. Maragos: "Oh! Alright.."
- Hon. W. Robert Blair: "Any further discussion? The gentleman from Cook, Mr. Lechowicz."
- T. S. Lechowicz: "Thank you, Mr. Speaker. Bill, does this still exclude Home Rule Units?"
- W. J. Murphy: "Well, Ray, the ah.. original Bill did. But, this one is just repealing the original Bill."
- T. S. Lechowicz: "Which excluded Home Rule Units. Is that correct? So ah.., the County of Cook, if my memory serves me correctly, assessed a square foot assessment on these various mobile homes. And, if we concur with this Amendment, that assessment would be invalid. Is that correct?"
- W. J. Murphy: "Well, due to the fact that home rule units ah.. home rule municipalities and ah.. units were out of the other Bill, I would answer that ah.. I don't believe this would affect you in the least."
- T. S. Lechowicz: "Thank you."



- Hon. W. Robert Blair: "Any further discussion? The question is, 'shall the House concur in Senate Amendment No. 1, to House Bill 3060?'. All those in favor will vote 'aye', and the opposed 'no'. Have all voted who wished? The Clerk will take the record. On this question, there are 134 'Ayes' and 1 'Nay' and the House concurs in Senate Amendment No. 1, to House Bill 3060. Now, House Bill 493, the Lady from Cook, Mrs. Chapman."
- E. S. Chapman (Mrs.): "Mr. Speaker, I move to concur with Amendments No. 2 and 3, to House Bill 493. Ah.. what ah.. Amendment No. 2 does is to make a number of changes, which in no way will change the intent of the Bill. They are ah.. ah.. changes which ah.. clarify, changes which the ah.. Law Firm of Chapman and Cutler has requested. Ah.. there is a Home Rule provision added as is an Amendment proposed by Senator ah.. Dan Dougherty. Ah.. the second Amendment, Amendment No. 3, requires approval by the Senate to appointments that are This is... has nothing to do with the Equal Rights ah.. Amendment, Gentlemen. It was passed unanimously in the House last year. And, the Bill is supported by the Illinois Hospital Association, the Illinois Nurses Association, the Chicago Association of Commerce and Industry and the Illinois Association of Homes for the ah.. Aged. Ah.. I respectfully request your support."
- Hon. W. Robert Blair: "The gentleman from ah.. Franklin, Mr. Hart."
- R. O. Hart: "Would the Sponsor yield to a question?"



- Hon. W. Robert Blair: "She indicates she will."
- R. O. Hart: "How does my Wife feel about this Amendment?"
- Hon. W. Robert Blair: "The gentleman ah.. from Cook, Mr. D. J. O'Brien."
- D. J. O'Brien: "Will the Sponsor yield to a guestion?"
- E. S. Chapman (Mrs.): "Yes, Sir."
- D. J. O'Brien: "Ah.. Eugenia, I notice that ah.. this Amendment is a nine page Amendment. And, if I'm not mistaken, this is the Bill that will authorize an Agen... or authorize an authority to be set up that will have a limited bonding power to finance the construction and even to oversee ah.. the construction of ah.. additions to hospitals for hospital or non-hospital purposes. Is that correct?"
- E. S. Chapman (Mrs.): "Ah.. for non-profit hospital and health
 facilities. Yes, Sir."
- D. J. O'Brien: "And, health facilities, thereby, include nursing homes, shelter homes, half-way house, etc.?"
- E. S. Chapman (Mrs.): "Ah.. Ah.. health facilities. Yes."
- D. J. O'Brien: "Ah.. Are these ah.. bonds backed up by any full facing credit of the State of Illinois?"
- E. S. Chapman (Mrs.): "Ah.. as I understand it, the State would be exempted from liability for the payment of the principle or interest or any bonds of the authority and, from the pledged mortgage obligation or agreement, which the authority may undertake."
- D. J. O'Brien: "In other words, these bonds are not backed up by the State of Illinois or any Governmental Agency?"



- E. S. Chapman (Mrs.): "They would be tax exempt bonds. And, this is why the passage of this measure is so important in terms, not only of providing for health facilities needed in this State, but also in helping ah.. train the health occupations, ah.. where we so sadly lack."
- D. J. O'Brien: "Is there an appropriation for this Bill?"
- E. S. Chapman (Mrs.): "No, Sir. This is one of the merits of this measure. Not one cent of Illinois State Revenue is required when you vote 'aye' on this measure. As a matter of fact, three million dollars would have been saved in ah.. funds of the ah.. of public aid last year because our biggest purchaser of health care is the State of Illinois."
- D. J. O'Brien: "Ah.. how is the authority to ah.. take care of the expenses?"
- E. S. Chapman (Mrs.): "Ah.. this is through the issuance of tax exempt bonds."
- D. J. O'Brien: "But, how is the authority going to pay for its expenses over and above the issuance of bonds?"
- E. S. Chapman (Mrs.): "Oh! Ab..."
- D. J. O'Brien: "For the running and administration of this Bill?"
- E. S. Chapman (Mrs.): "Ah.. this... This is a good question.

 Ah.. this also would be repaid by the Organizations receiving the loans."
- D. J. O'Brien: "How will they repay that?"
- E. S. Chapman (Mrs.): "Ah... this would be ah.. a part of the rental payment, Sir."



- D. J. O'Brien: "I see in the Bill, Eugenia, there's a \$15,000 fee ah.. for the ah.. issuance of these bonds for eligibility to receive these bonds."
- E. S. Chapman (Mrs.): "Ah.. this... If an Organization wants to ah.. apply for these bonds, they would need to provide the ah.. for the payment of this fee. This is at their option. No health facility is required. This is an option which we would offer to health organizations in this State."
- D. J. O'Brien: "But, is that how the authority will find itself through the fees they will receive?"
- E. S. Chapman (Mrs.): "Ah.. this would be used partially for this and also for health planning."
- D. J. O'Brien: "Let me just ask one final question in the form of hypothetical. If a not-for-profit hospital was unable to receive financing or any federally quaranteed financing, could it not purchase its own bonds, and thereby, receive financing at no cost to them?"
- E. S. Chapman (Mrs.): "You mean, ah.. purchase its own bonds?"
- D. J. O'Brien: "Yes."
- E. S. Chapman (Mrs.): "I don't know of no hospital that is in that very ah.. position. Ah.. I.. I do not see this as a possibility."
- Hon. W. Robert Blair: "The ah.. gentleman from ah.. Rock Island, Mr. Pappas."
- P. Pappas: "Mr. Speaker, will the Lady ah.. yield to a question?"
 Hon. W. Robert Blair: "She indicates she will."
- P. Pappas: "Ah.. Eugenia, would you explain the authority to me?



- Ah.. how.. how does that authority, seven man authority, how does that work?"
- E. S. Chapman (Mrs.): "It is the public instrumentality of the State of Illinois created by the Legislature and the Governor to performing essential public functions to provide an alternate means of financing the construction of needed hospitals and health care facilities in the State. Now, Organizations, who are eligible and interested, may apply to the authority. And, if they would meet these requirements, bonds could be issued by the authority which would then be paid back by the Organization receiving the loan. Ah. hospitals in this State have calculated the amount of money in which they could save. Ladies and Gentlemen, we do an awful lot of talk about hospital and health care expenses. In voting 'yes' today, you can save as much as \$9.00 per day per patient in health expenses because these are tax exempt bonds."
- P. Pappas: "Eugenia, also now, it's my understanding that this is for non-profit hospitals only?"
- E. S. Chapman (Mrs.): "Ah.. non-profit health facilities only."
- P. Pappas: "Why is it non... Why only the non-profit ah..?
 Aren't we discriminating there?"
- E. S. Chapman (Mrs.): "It would be unconstitutional if we would include profit ah.. organizations ah.. under this umbrella, Sir."
- P. Pappas: "Why... Why would it be unconstitutional if we included all hospitals?"
- E. S. Chapman (Mrs.): "Ah.. Mr. Pappas, this is what Chapman



and Cutler has assured us. This question has been raised with them and I am not able to ah.. ah.. comment on ah.. this particular element in it except to say that we have been assured by Lawyers that this is ah.., particularly Chapman and Cutler, that this would be unconstitutional."

- P. Pappas: "Mr. Speaker, I'd like to speak to the ah.. "
 Hon. W. Robert Blair: "Alright.. Proceed."
- P. Pappas: "Motion, if I may? Ah.. my understanding is that, with a seven member authority, four of whom would constitute a quorum, would empower... they would have the power, at their own discretion with whatever regulations they set up, as to which hospitals in the State of Illinois will be financed. To me, this seems to be too much power in too few a hands. I feel that this concurrent, we should move to nonconcur and put this back into a Conference Committee and try to work something out where it will benefit all of the hospitals and all of the people of the State of Illinois and not just one segment."
- Hon. W. Robert Blair: "The gentleman from ah.. Cook, Mr. Burditt."
- G. M. Burditt: "Mr. Speaker, Ladies and Gentlemen of the House ah.. with all due respect to the last speaker, I rise to ah. request that the House concur in the Senate Amendments. Ah. this authority, which is created by House Bill 493, is very similar to the Illinois Educational Facilities Authority which this Legislature created ah.. last term which is currently working very successfully. The Act has been held



Constitutional and it's providing ah.. very greatly needed help ah.. to Colleges and Universities. This Bill will do exactly the same thing in the ah.. health education field which is, of course, even more important in many respects than the field of education. It certainly is as important in all respects. So, I ah.. would request that the House ah.. follow the lead of the Sponsor of this Bill and concur in the Senate Amendments."

Hon. W. Robert Blair: "The gentleman from ah.. Cook, Mr. ah.. Douglas."

B. L. Douglas: "Ah.. would the ah.. Lady yield for a question or two, please?"

Hon. W. Robert Blair: "Ah.. she indicates she will."

- B. L. Douglas: "Eugenia, I.. I'd like to ask you two things. Ah.. have there been any changes from the original Bill of who the seven members would be on the Committee appointed by the Governor?"
- E. S. Chapman (Mrs.): "Ah.. yes, there... there has been. Ah. the qualifications, which have specified that there would have to be particular people representing particular interests, such as ah.. medicine, ah.. hospital administration and whathave-you, has been deleted."
- B. L. Douglas: "And ah.., the second question, you mentioned that there was a home rule provision included in this. Could you explain what that means?"
- E. S. Chapman (Mrs.): "Ah.. yes. The home rule provision specifically states that this measure in no way limits the home



rule ah.. rights of any ah.. home rule municipality."

- B. L. Douglas: "Thank you."
- Hon. W. Robert Blair: "The gentleman from Peoria, Mr. Day."
- R. G. Day: "Would the Sponsor yield for a question?"
- Hon. W. Robert Blair: "She indicates she will."
- R. G. Day: "Mrs. Chapman, you have indicated, I believe, that the credit of the State of Illinois ah.. is not behind... would not be behind these bonds. In other words, the State could never be held liable for the payment of these bonds. Is that correct?"
- E. S. Chapman (Mrs.): "Ah.. yes, Sir, this is my understanding,"
- R. G. Day: "And, you have also stated, I believe, that these bonds would, and the interest from these bonds, would be exempt from the Federal Income Tax. Is that correct?"
- E. S. Chapman (Mrs.): "That is right."
- R. G. Day: "And, on what basis are they exempt, if they are not State obligations?"
- E. S. Chapman (Mrs.): "Ah.. they are issued by a Governmental Authority."
- Hon. W. Robert Blair: "The gentleman from Cook, ah.. Mr. Meyer "
- J. T. Meyer: "With the permission from the Lady from Cook and the Speaker of the House, I would like to answer the question. The Congress of the United States, in 1969, said that, 'revenue financing by the States for hospital care is permissible type Legislation' and 'this legis'.. and 'if the States enacted legis... enabling legislation, that permitted States to issue revenue bonds for hospital financing, these bonds would not...



would not be subject to Federal Income Tax. The more marketable bonds, the interest rate is lower because an institution that would have to go out and borrow, let's say, a million dollars at a bank, might pay nine percent on today's market. Conceivably, the same institution would go to the bank, the bank would borrow... would buy the revenue bonds, and they would buy them at five or six percent, backing up the only.. the only credit is a lease running from the hospital institution to the financing authority. The.. The advantage of these bonds is the lower interest rate, therefore, it's a saving to the health care institution."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Juckett."

- R. S. Juckett: "Mr. Speaker, will the Lady from Cook yield for a couple of questions?"
- Hon. W. Robert Blair: "She indicates she will."
- Hon. W. Robert Blair: "Isn't it a fact that the not-for-profit hospitals are presently exempt from property tax, a local property tax?"
- E. S. Chapman (Mrs.): "Ah.. I believe so, Sir."
- R. S. Juckett: "Okay.. So, we have them exempt from the local property tax and the private, for-profit hospital is not exempt. Now, you're trying to get them financing so that they'll have an advantage again over the for-profit facilities. It would seem to me, Mr. Speaker and Ladies and Gentlemen of the House, that we're, again, trying to destroy private enterprise in the State of Illinois. We give them an advantage on the property tax. We give them an advantage here in the financing and we're



going to give them every sort of an advantage so that we can destroy the private, the taxpaying, the self-employing facilities. I think, that if we're going to make this fair, and if we're going to eliminate discrimination everywhere, we ought to include all of the facilities, all of the health facilities. I mean, after all, aren't these health facilities providing you and I with the facilities to cure illness and to prevent death? And, just to give a not-for-profit group this kind of an advantage, I think, what we will be doing is, we will be closing the doors of every for-profit facility. And, Ladies and Gentlemen of the House, we don't have enough: money in the State of Illinois to replace the for-profit facilities. And, if you think you're going to be saving money here, you're sadly mistaken. Because to replace the thousands and thousands of beds will cost this State a tremendous amount of money. And, Ladies and Gentlemen, we don't have that money and it's not the responsibility of the State. And, I would urge you to vote 'no' on this motion to concur and let's get it into a House-Senate Conference Committee and let's work out the details so that we will not place an intolerable burden on all of the people of the State where we have people, who are willing and are able and are presently serving all of the people by.. for-profit. So vote 'no'."

Hon. W. Robert Blair: "The gentleman from ah.. Cook, Mr. Simmons."

A. E. Simmons: "Mr. Speaker, I move the previous question."

Hon. W. Robert Blair: "All those in favor say 'aye', the



- opposed 'no', the 'ayes' have it. The Lady from Cook, Mrs. Chapman, to close."
- E. S. Chapman (Mrs.): "Thank you, Mr. Speaker. We all talk about rising hospital costs. Here's an opportunity for you to do something for the taxpayers of the State of Illinois.

 A number of other States are making use of this opportunity to decrease health costs for the citizens of their State to meet health needs for the citizens of their State and cut costs in doing this. I hope that your vote will be 'aye' because a vote to 'nonconcur' is a vote to kill a measure which received 134 votes when it was voted upon by this Body "Hon. W. Robert Blair: "Alright.. The question is, 'shall the
 - House concur in Senate Amendments No. 2 and 3, to House Bill 492?'. All those in favor will vote 'aye', and the opposed 'no'. This takes 89 votes. Have all voted who wished? Have all voted who wished? The Clerk will take the record. On this question, there are 107 'Ayes' and 26 'Nays' and the House concurs in Senate Amendments No. 2 and 3, to House Bill 493. Schoeberlein. 'aye'. House Bills Second Reading 4310."
- Fredric B. Selcke: "House Bill 4310, a Bill for an Act to amend Section 2-105 of the 'Illinois Vehicle Code'. Second Reading of the Bill. No Committee Amendments."
- Hon. W. Robert Blair: "Any from the floor? Third Reading. 4384."
- Fredric B. Selcke: "House Bill 4384, a Bill for an Act to amend 'The Revenue Act'. Second Reading of the Bill. No



Committee Amendments."

Hon. W. Robert Blair: "Any from the floor?"

Fredric B. Selcke: "Amendment No. 1, Hall, amend House Bill 4384 on Page 1, by deleting Lines 17 through 21 andsoforth."

Hon. W. Robert Blair: "The ah.. gentleman from McLean, Mr.

Hall."

H. H. Hall: "Ah.. Mr. Speaker and Ladies and Gentlemen of the House, this Bill is intended to ah.. provide homestead ah.. aid to certain elderly families ah.., who lease ground on which they put their own improvement, their own house ah.. whereas they are not presently ah.. authorized to ah.. take advantage of the homestead exemption. Ah.. this Amendment to the Bill ah.. further clarifies ah.. which individuals this is designed to ah.. take care of. It was suggested in Committee and has been worked out by the Taxpayers Federation and several members of the Appro... or the Revenue Committee. And, I move for adoption."

Hon. W. Robert Blair: "Further... The gentleman from Cook, Mr. Shea."

G. W. Shea: "Harber, does this take care of situations like out at Lake Bloomington where people have ninety-nine year leases?"

H. H. Hall: "Ah.. yes."

G. W. Shea: "I think, it's a good Amendment."

H. H. Hall: "It does."

Hon. W. Robert Blair: "Any further discussion? The gentleman care to close? No. Okay.. The question is on the adoption



of the Amendment. All those in favor say 'aye', opposed 'no', the 'ayes' have it and the Amendment is adopted. Any further Amendments? Third Reading. House Bills Third Reading. 4644."

Fredric B. Selcke: "House Bill 4644, an Act to amend the 'Illi nois Income Tax Act'. Third Reading of the Bill."

Hon. W. Robert Blair: "The gentleman from ah.. Cook, Mr. Duff.

- B. B. Duff: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, House Bill 4644 is a Bill which is designed to exempt from the Illinois Income Tax, qualified employment.. pension and retirement plans for both public and private pensioners. It would include, in other words, not only those past producers of industry, who have reached the retirement age, but also public employees such as G.I., Firemen, Policemen, andsoforth, throughout the State. House Bill 4644 has almost negligible revenue implications to the State of Illinois, at this time. And yet, offers to the past producers of Illinois the advantage of not having to have that burden. I respectfully would request support of the Bill."
- Hon. W. Robert Blair: "The gentleman from Lake, Mr. Matijevich"

 J. S. Matijevich: "Mr. Speaker and Members of the House, I would urge everyone to vote for this Bill. I introduced a Bill ah.. last year relative to those who are G.I.'s, that their ah.. veteran's pension ah.. not be applicable to the Illinois State Income Tax. The Department of Revenue ah.. has made the determination ah.. that ah.., those prior to 1969 under a past ah.. Legislation, ah.. their income ah.., under their



pensions, would not apply to the personal.. the State Income Tax. This Bill would ah.. further help the G.I.'s, the Veterans. So, I would urge the passage of the Bill."

Hon. W. Robert Blair: "The Gentleman from ah.. Cook, Mr. Maragos."

- S. C. Maragos: "Mr. Speaker and Members of the House, as a Co-Sponsor in support of this Legislation in the Revenue Committee and. and in other areas, I solicit your support for the reasons given by the previous speakers. And, it goes in many areas where it is well needed. And, it's just for those people who are now ah. at the end of their life and ah. their later years in life where they can best benefit from these small benefits that we are giving them because it's similar to what we're giving them in the Income Tax Field, in ah. Real Estate Taxation. And now, we're doing it in an area which, I think, is long overdue. And, I ask your support."
- Hon. W. Robert Blair: "The gentleman from Cook, Mr. Phil Collins."
- P. W. Collins: "Ah.. yes, Mr. Speaker, very briefly, I rise in support of House Bill 4644. Ah.. much is made these days of assistance for senior citizens, the elderly. I think, here's an opportunity to give concrete evidence of our desire to assist people, who have retired, who are in the golden years of their life and who have worked to ah.. earn their.. their pension, ah.. who are living on a fixed income. I.. I think, this is excellent Legislation. And, I know that the..



the cost of. of the. the ah. the plan will be minimal.

And ah., I. I would urge all of the Members to support this
Bill."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Palmer."

R. J. Palmer: "Will the Sponsor yield for a question?"

Hon. W. Robert Blair: "He indicates he will."

- R. J. Palmer: "How much will it cost?"
- B. B. Duff: "Well, the present revenue implication are almost non-existent. Under the ah.. ah.. Under the ah.. lump sum payments that would cost less than \$300 or \$1,000 in ah.. 1973, under the ah.. under the.. the qualified retirement pension plans, ah.. it would cost the State absolutely nothing. It does cost the State, in fact, probably more money to elect than they receive in revenue. This is because of a very complicated actuarial ah.. reporting form that is required."
- R. J. Palmer: "We don't have any precise figures for...."
- B. B. Duff: "Well, we don't have precise figures on the cost of election, but we do know ah.. that the ah.. cost is both heavy both to the State, to the employers and to the ah.. pensioners. Ah.. the revenue figures on the... I'd have precise revenue figures on the retirement ah.. plan and pension benefits. And, that is nothing. There will be no cost out of those two. There will be a minimal cost out of the lump sum payment distributions."
- Hon. W. Robert Blair: "The gentleman from ah.. Cook, Mr. Katz."
- H. A. Katz: "Ah.. will the gentleman yield to a question?"



Hon. W. Robert Blair: "He indicates he will. Proceed."

- H. A. Katz: "Ah.. it always seems to me that we should have ah..

 the Income Tax Act in the State that would parallel the
 Federal so citizens would not have to ah.. have separate
 accounting ah.. procedures in order to solve their tax return. Can you tell me whether this will have any affect on
 the parallel structure of the income reported in Illinois
 as against the income required to be reported under the Federal
 Income Tax Act?"
- B. B. Duff: "To my knowledge, it will not have any ah.. complications in that effect. This is one instance where, in fact, we will be simplifying, considerably simplifying the Illinois Income Tax Reporting Form in this regard."
- H. A. Katz: "Well, is the affect only to ah.. not require taxation on income.. on income that accrued prior to the effective date of our Act or does it have an affect from this point on, that income that is accrued since we passed the Act would not have to be reported?"
- B. B. Duff: "That's correct."
- H. A. Katz: "In other words, it would mean that income, that is accruing now, would not have to be reported in the State. Is that correct?"
- B. B. Duff: "That's correct."
- H. A. Katz: "Well then, ah.. the answer... That income would have to be reported on the Federal Tax Reform.. ah.. Report, would it not by any citizen of the State?"
- B. B. Duff: "The dist... The distinction that would be made,



Representative Katz, is that ah.., while the principle, while I would concur with the principle that you expressed, in this instance, ah.. to require, because of the Illinois Law relative to ah.. August 1st, 1969 and the reporting form that is required thereby, in this instance, it would ah.. singularly clarify and simplify the Illinois Income Tax Reporting Forms. So ah.., rather than have two opposed different reporting requirements, the Federal Income Tax might have ah.. ah.. reporting requirement in this instance. But, rather than be contradictory in the State of Illinois, there would simply be none."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Arrigo."

- V. A. Arrigo: "Mr. Speaker, if I may interrupt the proceedings for a moment, I'd like to introduce at the rear of the Gallery, the students from St. Jerome's Roman Catholic School, who are here with Sister Bernadette, Sister Aleta and Father Anthony. It is interesting to note that our own Colleague, Representative Terzich, is a graduate of St. Jerome's School. And, he sup in the Gallery now renewing acquaintances with his classmates."
- Hon. W. Robert Blair: "Alright.. The gentleman care to close?"
- B. B. Duff: "Ladies and Gentlemen of the House, I have been most appreciative of the numbers of the Members of this House who have come to me and supported this Bill and encouraged me to call it. By way of explanation, ah.. to my knowledge, there is no opposition today. Ah.. it was held for a little while we worked out some of the questions that were asked in



Revenue Committee. They have been resolved. I know of no opposition. I would certainly appreciate a favorable vote."

Hon. W. Robert Blair: "The question is, 'shall House Bill 4644 pass?'. All those in favor will vote 'aye', and the opposed 'no'. Have all voted who wished? Have all voted who wished? The Clerk will take the record. On this question, there are 167 'Ayes' and no 'Nays' and this Bill having received a Constitutional majority is hereby declared passed. House.. House Bills Second Reading. House Bill 4652."

- Fredric B. Selcke: "House Bill 4652, a Bill for an Act to provide for the ordinary and contingent expenses of the Court of Claims. Second Reading of the Bill. No Committee Amendments."
- Hon. W. Robert Blair: "Are there any Amendments from the floor?

 Third Reading. On the order of Senate Bills Second Reading.

 appears Senate Bill 1436."
- Fredric B. Selcke: "Senate Bill 1436, a Bill for an Act to amend
 'The Criminal Code'. Second Reading of the Bill. One
 Committee Amendment."
- Hon. W. Robert Blair: "The gentleman... The gentleman from Champaign, Mr. Clabaugh."
- C. W. Clabaugh: "Mr. Speaker, this Amendment... this Amendment was adopted in Committee. And, when I was looking through another Amendment and took it down to the Reference Bureau, I found that, when this Bill was introduced, it was put in the Criminal Code and there was an Amendment in the Senate that took out the ah.. fine penalty that was in it. And,



but yet, it was not taken out of the Criminal Code. And,

Mr. Bobbitt drew an Amendment which is exactly a new Bill

but it's the identical wording that the Bill came out ah.. of

the Committee and even including this Amendment that was

adopted there. But, the only change was that it was put in

the Civil Administrative Code instead of the ah.. Criminal

Code. And, I would like then, Mr. Speaker, to move ah.. that

the Senate Amendment not be adopted, be tabled. Mr. Speaker.."

C. W. Clabaugh: "I move that the Senate Amendment ah.. to House..

or Senate Bill 1436 be ah.. tabled. And then, I'm going to

move the adoption of the other Amendment which includes that

Amendment in it."

Hon. W. Robert Blair: "Yes."

- Hon. W. Robert Blair: "Alright.. Alright.. So, we understand where we are. The gentle... The gentleman has offered and moved the adoption of Committee Amendment No. 1 and then moves to table that Amendment. Now, is there discussion on this gentleman's motion to table. The gentleman from ah.. Cook, Mr. Shea."
- G. W. Shea: "As... As I understand the posture of the Bill right, now, Mr. Speaker, this is a Senate Bill on Second Reading and this is a Committee Amendment. And,... And, could the gentleman tell me why he does not want to adopt the Committee Amendment?"
- Hon. W. Robert Blair: "The gentle man ah.. from ah.. Champaign,
 Mr. Clabaugh."
- C. W. Clabaugh: "Simply, that's what Mr. Mr. Bobbitt suggested,



that we ah.. that we table that Amendment and then adopt
the Amendment which put it over in the ah.. other Code and
also included that ah.. that Committee Amendment in the new
Amendment."

- G. W. Shea: "In other words, you have Amendment No. 2 to offer if this one is tabled?"
- C. W. Clabaugh: "That's correct."
- G. W. Shea: "Thank you."
- Hon. W. Robert Blair: "Alright.. The question is ah.. on the gentleman's motion to table. All those in favor say 'aye', opposed 'no', the 'ayes' have it and the Amendment is tabled. Amendment No. 2 is coming up."
- Fredric B. Selcke: "Amendment No. 2, Clabaugh, amend Senate Bill 1436, Page 1, by deleting Lines 1 and 2, andsoforth."

 Hon. W. Robert Blair: "The gentleman from Champaign, Mr. Clabaugh."
- C. W. Clabaugh: "Now, Mr. Speaker, I'm going to explain and then move that we adopt Senate or the ah.. Amendment No. 2. This Amendment No. 2 transfers the Bill, changes it from the Criminal Code to the Civil Administrative Code. And, it includes the Amendment that was just adopted... or that we just tabled.

 I move its adoption. The Bill.. This Amendment makes the Bill exactly as it came out of the House Committee. Move the adoption of Amendment No. 2."
- Hon. W. Robert Blair: "Alright.. Discussion? The gentleman from Cook, Mr. Maragos."
- S. C. Maragos: "Will the Sponsor of the Amendment yield for a



question?"

- C. W. Clabaugh: "Yes, Sir."
- S. C. Maragos: "Charlie, how does this ah.. differ? You said an additional points than the one that you just tabled. What additional points ah.. Because when you and I were in Judiciary I Committee, you said you were going to amend it to cover certain areas. Would you please define what this ah.. Amendment is now, that you're asking to put on, really does in detail?"
- C. W. Clabaugh: "The second Amendment includes all of the Bill including the Amendment that we put on in the Committee."
- S. C. Maragos: "But, it still eliminates the criminal ah.. ah. penalty. Is that correct?"
- C. W. Clabaugh: "That's right. And, trans... takes it out of the Criminal Code and puts it over in the Civil Administrative Code."
- S. C. Maragos: "The next question is then, the. the only people that they would have jurisdiction to penalize or enjoin then not to penalize but to enjoin, would be the ones who are on the campus within the State of Illinois?"
- C. W. Clabaugh: "Yeah.. They are the ones ah.. Ah.. the Chiefortice, whether he be the Chancellor or the President, ah.. would ah.. ask the ah.. State's Attorney or the Attorney General ah.. for the injunction."
- S. C. Maragos: "This Amendment still, however, does relieve the Administrative Officer of an University or College from having to issue the penalties or seek the injunction?"



- C. W. Clabaugh: "That's true."
- S. C. Maragos: "No, he seeks the injunction. He takes it...

 Noh... He takes it to the... Noh... You're correct in what
 you say."
- C. W. Clabaugh: "Yes, Sir."
- Hon. W. Robert Blair: "The gentleman from ah.. ah.. Cook, Mr. Shea."
- G. W. Shea: "I have a parliamentary inquiry, Mr. Speaker."

Hon. W. Robert Blair: "Alright.. State your point."

- G. W. Shea: "Senate Bill 1436, as it came over from the Senate is an Amendment to the Criminal Code amending Section 17 of the Criminal Code. This Amendment provides for a new Bill. And, no Amendment to the Criminal Code, but a new Act. Ah.. Mr. Speaker, I'll repeat my point. Senate Bill 1436, when it came over from the Senate, was an Amendment to Chapter 38 of the Criminal Code. As the Amendment would make it, it is a new Act, not amending the Criminal Code, but just a new Act. Now, I raise the point. I have no objection to it, but I want to find out if this is proper procedure, by striking the Amendment to the Criminal Code and providing a new Act. The subject matter of the Bill is the ah.. same type of subject matter, but it is no longer an Amendment to the Criminal Code but a new Act."
- Hon. W. Robert Blair: "Well, why don't we ah.. take it out of the record, if that's alright with the gentleman from Champaign, while we get.... The gentleman from Champaign, Mr. Clabaugh."



- C. W. Clabaugh: "I anticipated this question, Mr. Speaker, and I raised that question with Mr. Bobbitt. And, he said, since the language is identical and as the other, that I raised a question about the Third Reading, the three readings, and he said, since the language is the same and completely germane, then ah.. there would be no consitutional question involved."
- Hon. W. Robert Blair: "Alright.. We'll take that out of the record ah.. since we're trying to wind up. Ah.. on the order of concurrences, appears House Bill 3682, ah.. on which the Chair recognizes the gentleman from ah.. ah.. Cook, Mr. Phil Collins."
- P. W. Collins: "Mr. Speaker and Ladies and Gentlemen of the House, ah.. House Bill 3682 on the order of Concurrences, ah.. has ah.. technical difficulties that will need ah.. grammatical changes. And, I would ah.. move ah.. that the House ah.. nonconcur in the Amendments to Senate Bill 3682."
- Hon. W. Robert Blair: "Alright.. The.. Discussion? All those in favor of the gentleman's motion to nonconcur with respect to Senate Amendment No. 1, to House Bill 3682 say 'aye', opposed 'no', the 'ayes' have it and ah.. the ah.. House nonconcurs ah.. On House Bill 2916, the gentleman from Cook, Mr. ah.. Phil Collins."
- P. W. Collins: "Ah.. Mr. Speaker, the same difficulties pertain to ah.. ah.. Senate Bill 2916. And, I would, again, move that we ah.. nonconcur in Amendments ah.. ah.. to ah.. the ah.. House Bill 2916."



Hon. W. Robert Blair: "Alright.. The gentleman moves to non-concur. Is there any discussion? The question is, 'shall the House nonconcur with Senate Amendments No. 1 and 2, to House Bill 2916?'. All those in favor will say 'aye', opposed 'no', the 'ayes' have it and the House nonconcurs. For what purpose does the gentleman from Cook, Mr. Sevcik, rise?"

J. G. Sevcik: "Ah.. Mr. Speaker, Ladies and Gentlemen of the House, having voted on the prevailing side, I move to reconsider the vote by which House concurs in Senate Amendments No. 1, to House Bill 3190. Ah.. there are ah.. some technical errors in this ah.. ah.. Bill. And, I would ask that the Conference Committee be appointed after we reconsider this Bill."

Hon. W. Robert Blair: "What was the number now?"

J. G. Sevcik: "3190."

Hon. W. Robert Blair: "Alright.. The gentleman is moving to reconsider the vote by which House Bill or the House concurred in Senate Amendment No. 1, to House Bill 3190. Now, this will require 89 votes on reconsideration. So, all those in favor will vote 'aye', and the opposed 'no'. Have all voted who wished? Laurino.. 'aye'. The Clerk will take the record. On this question, there are 154 'Ayes' and no 'Nays' and this ah.. The ah.. motion.. the gentleman's motion ah.. to reconsider prevails. Alright.. Now, the gentleman's motion from the ah.. from Cook, is that the ah.. House nonconcur in Senate Amendment No. 1, to House Bill 3190. All those in favor say 'aye', opposed 'no', the 'ayes' have it and the

 A Bill for an Act to amend 'The Revenue Act'. First Reading of the Bill. House Bill 4682, Rose, et.al. A Bill for an Act to amend the 'County Executive and Election Code'. First Reading of the Bill."
- Hon. W. Robert Blair: "Alright.. Ah.. we'll come back to one..

 to one of those Introductions in just a moment, if the gentleman desires to be recognized. In the mean time, the Chair
 recognizes the gentleman from Cook, ah.. Mr. Hyde."
- H. J. Hyde: "Well, Mr. Speaker and Ladies and Gentlemen of the House, ah.. I have a motion to make. Ah.. the motion is prompted by ah.. action taken in the Senate. And, I would ah.. ask the attention of the Members of this House. I now move that all Senate Bills, whether in Committee ah.. or on the Calendar in the non-exempt category, in the exempt



categories are Appropriations, Constitutional Implementation and Revenue, I ah.. move that all Bills, not falling within those categories, now either in Committee or on the Calendar, be tabled."

- Hon. W. Robert Blair: "The gentleman from Union, Mr. Choate."

 C. L. Choate: "Well, Mr. Speaker, I certainly concur in the Majority Leader's ah.. motion. I would assume that every ah.. Member can do as he wishes. But, after the action, that has been taken by the Senate, in the closing days of last week, and I would certainly go into detail on it if the Membership so desires, but, after the action taken by them in the past week, it appears that they do not want to consider Legislation on its merit, but simply wants to get the Calendar cleaned because maybe they haven't been as diligent at their job as this House has been in passing Legislation that does not conform to the exempt status. Then, I would agree with the gentleman's motion, Mr. Speaker."
- Hon. W. Robert Blair: "Alright.. The question is ah.., 'All those in favor of the motion ah.. say 'aye', the ah.. opposed 'no' and all Senate Bills ah.., on the Calendar or in Committee ah.. other than those in the exempt categories mentioned by the Majority Leader, are hereby tabled. Alright.. Now, back to the gentleman from Lake, Mr. Matijevich, who desires recognition to ah.. make a few comments concerning one of the Bills that he introduced."
- J. S. Matijevich: "Mr. Speaker,.... Mr. Speaker and Members of the House, I introduced a Bill just a minute a ago which the



Clerk ah.. announced. And, I'd like to say that ah.. I was across the other side of the aisle and I have ah.. some Republican Co-Sponsors. I didn't have enough time ah.. to get around to everybody. I'd like to say that I introduced a Bill today that mandate County Collectors in Illinois to deposit in escrow personal property taxes paid by individuals. This account would be held pending the decision in the Lakeshore Auto Parts Case. And now, I introduced this Bill. And, I think, it is in the spirits ah.. of the Governor when he made the suggestion that individual personal property taxes, taxpayers should pay their personal property taxes in protest.. What we are doing by this Bill, we are mandating the County Collectors to put this money into an escrow account. In other words, it is an automatic protest. I believe, that the Illinois voters expressed their will overwhelmingly in the 1970 Election, that the personal property taxes to individuals should be eliminated. Now, Mr. Speaker, ah.. I just talked to Representatives Randolph. And, at your suggestion, I would like to.. the Chairman of that Committee to waive the appropriate Rule that this Bill could be heard in the Revenue Committee tomorrow. Ah.. I think, ah.. we would have overwhelming support for this ah.. because it places the burden on... on us rather than the people ah.. to protest ah.. about their personal property taxes."

Hon. W. Robert Blair: "The gentleman from ah.. Cook, Mr. Randolph."

P. J. Randolph: "That is agreeable if he would like to hear



the Bill tomorrow."

- Hon. W. Robert Blair: "Alright.. Does the gentleman have leave to suspend the provisions of Rule 17 so that Bill may be heard in Revenue Committee tomorrow? The gentleman from Cook, Mr. Hyde."
- H. J. Hyde: "Well, Mr. Speaker, to ah.. allay any confusion among the Members, ah.. I would like to ah.. include in the ah.., maybe I'll make a new motion. - Hon. W. Robert Blair: "Alright.. The gentleman from Cook, ah.. ah.. Mr. Simmons is ah.. is recognized."
- A. E. Simmons: "Well, Mr. Speaker, I withdraw my motion for a Roll Call on this."
- Hon. W. Robert Blair: "Agreed Resolutions."
