Hon. W. Robert Blair: "Introduction and first reading of House Bills. For what purpose does the gentleman from Cook, Mr. Shea rise?"



Gerald W. Shea: "Mr. Speaker, the Clerk just read several veto messages, amendatory vetoes, etc. from the Governor, and as I understand the new constitution, we have fifteen days to act on those. Now, is it the interpretation of the Chair or would you inquire of your parliamentarian if it's fifteen legislative days or is it fifteen calendar days, starting to run as of today?"

Hon. W. Robert Blair: "I'll have my parliamentarian look into that and advise me so I can advise you after we have finished the introduction and first reading of the House Bills."

Gerald W. Shea: "Thank you."

Fredric B. Selcke: "House Bill 3543, Conolly. An act made an appropriation to Homer C. Vandenberg. First reading of the bill. House Bill 3544, Roscoe Cunningham. An act authorizing the conveyance of certain real property located in Crawford County, Illinois. First reading of the bill. House Bill 3545, Yourell. A bill for an act to amend the 'Environmental Protection Act'. First reading of the bill."

Hon. W. Robert Blair: "I am advised by my parliamentarian that it's calendar days and that the fifteen days will start with today, which is the day that those vetoed messages will be journalized. The a Chair recognizes the gentleman from Cook, Mr. Hyde."

Henry J. Hyde: "Mr. Speaker, I move that this House recesses until 10:00 A.M., Friday, October 8, is that correct?"

Hon. W. Robert Blair: "At 10:00 A.M., yes. All right, the



House will now be in recess until Friday, October the 8th at the hour of 10:00 A.M. That will be a prefunçtory session and the reason for it is to comply with the three day requirement.
