Hon. W. Robert Blair: "All right, the Regular Session will not come to order. The invocation ah... will be by Representative Davis."

"Let us pray. For the Lord hears my strength and my salvation, whom shall I fear? The Lord is the strength of my life, whom shall I be afraid? - Hon. W. Robert Blair: "Roll Call for attendance. All right, ah... with leave of the House, the same general entries will be made in the Regular Session, with regard to those persons who are not present, as were made in the Special Session. Messages from the Senate."

Hon. W. Robert Blair: "Introduction of Bills."

- F. Selcke: "House Bill 4720. Davis et al. Bill for an Act to add Section to County Hospitals, Governering Commission Act. First Reading of the Bill."
- Hon. W. Robert Blair: "House Bills, Second Reading.' House Bill 4712."
- F. Selcke: "House Bill 4712. A Bill for an Act making an appropriation for Department of General Services. Second Reading of the Bill. No Committee Amendments."
- Hon. W. Robert Blair: "Are there Amendments from the Floor?
  Third Reading. House Bill 4713."
- F. Selcke: "House Bill 4713. Bill for an Act to Amend Section 11-139-2, and support the Illinois Municipal Code. Second

- Reading of the Bill. No Committee Amendments."
- Hon. W. Robert Blair: "Are there Amendments from the Floor?
  Third Reading. House Bill 4719."
- F. Selcke: House Bill 4719. Bill for an Act to add 8-116, the Illinois Vehicle Code, Second Reading of the bill.

  No Committee Amendments."
- A. Telcser: "Are there any amendments from the floor? Third Reading. On the order of House Bills, Third Reading appears 4695 for which purpose the Gentleman from Cook Representative Harold Washington is recognized."
- Harold Washington: "Ah.. Mr. Speaker, I wanted to call 4694 and 97 and hold 95 for a moment or two."
- A. Telcser: "Okay. Take it out of the record. House Bill 4694. House Bill 4694. Bill for an Act to amend Section 3-3-2 and so forth, the United Code of Corrections. Ah.. Third Reading of the Bill."
- A. Telcser: "Gentleman from Cook, Representative Harold Washington."
- Washington: "Ahh.. Mr. Speaker. Indulge me one bit further.

  I would like to include at this point House Bills 4695

  and 4697. They are companion bills."
- A. Telcser: "Does the Gentleman have leave? Hearing no objections, will the Clerk please read House Bills 4695 and 97 a third time."
- F. B. Selcke: "Ah.. House Bill 4695. An Act to conform the Criminal Penalties to certain acts therein name to the penalty classification system established by the Uniform



Code of Corrections, Third Reading of the bill. Ah..

House Bill.. House Bill 4697. An Act to amend Section
5.14 and 5.22 of the Fish Code, Third Reading of the bill."

- A. Telcser: "Gentleman from Cook, Representative Harold Washington."
- Washington: "Ah.. Mr. Speaker and Members of the House.

  All three of these bills are technical amendments to the Code of Corrections which we passed last session. There is no substantive changes in any of these bills. They are strictly House keeping bills clearing up the language, ah.. re-sectioning some of the various paragraphs and ah.. knocking out some obsolete phrases. They're strictly House keeping bills. It takes 3/5 majority to pass these bill out. I ask for your support."
- A. Telcser: "Is there any discussion? Question is shall House Bills 4694, 95 and 97 pass with a 3/5 majority? All those in favor signify by voting 'aye', the opposed by voting 'no'. Have all voted who wished? The Clerk take the record. Be three roll calls. Pappas 'aye'. Redmond 'aye'. Kosinski 'aye'. Brinkmeier 'aye'. On these questions, there are 131 'ayes', no 'nays' and these bills having received the constitutional 3/5 majority are hereby declared passed. House Bill 4698."
- F. B. Selcke: "House Bill 4698. An act making supplemental appropriation of the Illinois Scholarship Commission, third



reading of the bill."

- A. Telcser: "Gentleman from Lee, Representative Shapiro."

  Shapiro: "Ah.. Mr. Speaker, Ladies and Gentlemen of the House.

  House Bill 4698 makes the supplemental appropriation of
  the State Scholarship Commission in the amount of \$355,000.

  Now what this money is for is to pay ah. 1972 claims for
  Veteran Scholarships to Junior Colleges throughout the
  state and also for some regular grant awards to the
  University of Chicago. These claims came in July 31st
  of this year after the regular appropriation had lapsed.

  Therefore this deficiency appropriation is necessary.

  I would urge a favorable vote on the bill and require a
  3/5 vote of those present."
- A. Telcser: "Is there any discussion? Question is shall
  4698 pass with the constitutional 3/5 majority. All those
  in favor signify by voting 'aye', the opposed by voting 'no'
  Bernie Wolfe, 'aye'. Jim Carter, 'aye'. Schoberlein,
  'aye'. Have all voted who wish? Take the record. On this
  question 134 'ayes', no 'nays' and this bill having
  received the constitutional 3/5 majority is hereby declared
  passed. Representative Carter, for what purpose do you
  rise, Sir?"
- Carter: "Ah.. Mr. Speaker. Ah.. the bill which I have, 4719, which has been advanced to third.. I would like to consider the House to recall that bill to Second Reading for the purpose of offering an amendment."
- A. Telcser: "Does the gentleman have leave? Hearing no objections



we will return to House Bill 4719 to the order of Second Reading for the purpose of an amendment. Are the amendments on the Clerk's desk, Representative Carter? The Clerk will read the amendment."

- F. B. Selcke: "Ah.. amendment to House Bill 4719. Amendment No. 1. Carter. Ah.. amend..."
- A. Telcser: "The Gentleman from Cook, Representative Carter to explain Amendment No. 1."
- Carter: "Ah.. Mr. Speaker. Do you remember last week...

  Ah.. this is a bill that concerns the operation of ah..

  for hire vehicles in the City of Chicago. And with

  one which I got advanced to second reading without

  reference to committee. I find out that in the original

  bill as it was drawn, it confines itself primarily to

  the State Police and to the Secretary of State. I wanted

  that to include all law enforcement agencies rather than

  just the State Police. So that's the purpose of the

  amendment. I'd like to offer it please."
- A. Telcser: "Is there any discussion. Gentleman has offered to move the adoption of Amendment No. 1 to House Bill 4719.

  All in favor of adoption signify by saying 'aye'. The opposed 'no'. The amendment is adopted. Are there further amendments? Third Reading. House Bill 4700. We're back on House Bills 3rd Reading. House Bill4700."
- F. B. Selcke: "House Bill 4700. An Act making appropriation for certain claims against the State of Illinois in conformity with an award made by the Court of Claims, Third



Reading of the bill."

- A. Telcser: "Gentleman from Cook, Representative Shea."

  Shea: "Mr. Speaker, Ladies and Gentlemen of the House.

  House Bill 4700 appropriates approximatley \$400,000 ah..

  to the ah.. pay a claim of Cook County ah.. for reimbursement for medical services. Ah.. this was lost out of the original appropriation and since ah.. its two years past, there was a Court of Claims suit filed and it was in agreement between the Attorney General and the States Attorney of Cook County and therefore I would ask for a favorable roll call."
- A. Telcser: "Is there any discussion? Question is shall House Bill 4700 pass? All those in favor signify by voting 'aye'. The opposed by voting 'no'. Have all voted who wish? Schoeberlein 'aye'. Take the record. On this question there are 160 'ayes', one 'nay'. This bill having received the constitutional 3/5 majority is hereby declared passed. House Bill 4704."
- F. B. Selcke: "House Bill 4704. An Act to amend Section 6
  in an Act to provide for the creation management for
  Forest Preserve Districts, Third Reading of the Bill."
- A. Telcser: "The Gentleman from McClain, Representative Hall."
- Hall: "Mr. Speaker and Ladies and Gentlemen of the House.

  4704 authorizes the Forest Preserve District to lease
  ground to a county for the purposes of building a nursing
  home. This is a special case we have in the ah.. 47th..



- the old 47th Legislative District. I think it might be appropriate to some other areas. It's a good bill. I would ask for your support."
- A. Telcser: "Is there any discussion? If not the question is shall House Bill 4704 pass with the constitutional 3/5 majority. All those in favor signify by voting 'aye'. The opposed by voting 'no'. Have all voted who wish?

  J. J. Wolf, 'aye'. Take the record. On this question 124 'ayes', no nays and this bill having received the constitutional 3/5 majority is hereby declared passed. House Bill 4705."
- F. B. Selcke: "House Bill 4705. An Act to amend Section 1 of an Act to appropriate funds to the Department of Transportation, Division of Water Resource Management Capitol Improvement Project. Third Reading of the bill."
- A. Telcser: "Gentleman from DuPage, Representative Redmond."

  Redmond: "Mr. Speaker and Ladies and Gentlemen of the House.

  House Bill 4705 provides for the transfer of \$170,000

  from other projects to ah.. a program for Salt Creek Flood

  Control. It's recommended by the Water Resource Management

  Division and I request your support."
- A. Telcser: "Is there any discussion? Question is shall House Bill 4705 pass with the constitutional 3/5 majority. All those in favor signify by voting 'aye'. The opposed by voting no. Have all voted who wish? Take the record. Duff 'aye'. On this question 121 'ayes', no nays and this bill having received the constitutional 3/5 majority is



- hereby declared passed. House Bill 4299. Representative Pappas, for what purpose do you rise?"
- Pappas: "Ah... Mr. Speaker, I would ask consent to move this Bill back to Second Reading for purpose of Amendment."
- A. Telcser: "Are there any objections? Hearing none, House Bill 4299 will be brought back to the order of Second Reading for the purpose of Amendment."
- F. B. Selcke: "Amendment No. 1. Amend House Bill 4299...

  Gentleman from Rock Island, Representative Pappas."
- Pappas: "Ah... Mr. Speaker and Ladies and Gentlemen of the House, this Amendment seeks to revise the Safety Glazing Act to correct some of the Act's present difficulties. The changes are technical in nature and were requested by the Department of Labor, after their consultation with Representatives of the industry effected. I would move for its adoption."
- A. Telcser: "Gentleman from Cook, Representative Shea."
- Shea: "I wonder if Representative Pappas would explain these technical amendments?"
- Pappas: "I can explain them. I have about a three page ah...
  brief on it. Number 1, the Bill corrects a constitutional
  flaw by making the Act apply only to glass to be installed
  in Illinois instead of all glass manufactured for use elsewhere. It was felt that the State of Illinois could not
  make safety requirements for other States. The Bill also
  seeks to clarify the definition of 'hazardous locations'.
  The present Act allows the Department to add to the list



of hazardous locations. It was felt that these were unconstitutional as it would allow the Department to find new crimes; this being a legislative function. This provision is eliminated. The Bill redrafts the Section on hazardous locations, which is poorly drafted and presently unclear. The new definition makes no real substantive changes; does not increase the risk of safety, which the legislature sought to guarantee in the original Act. The Bill adds definitions of terms used in the definition of hazardous locations. The definition of 'safety glazing material' is updated to include the materials meeting 1972 standards of the American National Standards Institute instead of the 1966 Standards."

A. Telcser: "Gentleman from Cook, Representative Shea." .

Shea: "Ah... is it my understanding the Bill in its present form allows the Department to determine where the hazardous locations are, and that you want to take that away from the Department because you feel that it's an unconstitutional delegation of legislative authority to the Agency?"

Pappas: "That's what the Department of Labor felt. Yes."

Shea: "All right. Thank you."

A. Telcser: "Gentleman from DuPage, Representative Schneider."

Schneider: "Thank you, Mr. Speaker. Mr. Pappas, on the first item you mentioned about the technical change which required the State of Illinois to abide by stricter safety standards as compared to the standards of other States, what happens in the event that glass which is purchased from the State



of Illinois has to meet stricter requirements for safety, is that not in effect marking Illinois out of safety glass by increasing the cost of safety glass?"

Pappas: "Ah... I don't quite follow your question, but the way the Bill was originally drafted, it would have to be that they would have to use safety glass, not only here in Illinois, but it would also have to be in Iowa, Wisconsin, and ah... they would have to also follow the hazardous.... the definition of hazardous locations."

Schneider: "Well, I guess ah... what I was driving at is that in the event that safety glass required stricter ah... obviously stricter requirements for its production, does that mean that glass can come from out of state into Illinois without meeting the requirements, or are we abiding by a law that only allows Illinois to produce safety glass for the State of Illinois."

Pappas: "Any glass used in the State of Illinois has to meet the standards."

Schneider: "Thank you."

A. Telcser: "Is there further discussion? Gentleman from Christian, Representative Tipsword."

Tipsword: "Would the gentleman yield for a question please?"

A. Telcser: "He indicates he will:"

Tipsword: "Representative Pappas, ah... this... does this affect in any way the production of glass in Illinois? Or does it only ah... direct itself to that glass that is used in Illinois?"



Pappas: "It would affect the glass that is used in Illinois, because needless to say, if it's manufactured in Illinois for use in Illinois, it would have to follow the standards, but if it's manufactured in Illinois and is going to some other State for installation, then they would have to follow the requirements of that State."

Tipsword: "As this is drafted now, it's drafted only to affect what glass is to be used?"

Pappas: "That's correct."

Tipsword: "Now the standards that are set up, ah... do not in any way ah... or are not such standards that it will prohibit the use of Illinois Manufactured Glass will it?

The reason I ask this, Illinois is a large glass producing State. We have a large glass company located in various areas of this State, one of the largest producers, I think, throughout the Country, and I was wondering if this would in any way, impose any hazard upon our manufacturers? Do they now meet these specifications in some of their production?"

Pappas: "I understand that most of the manufacturers are tooling up and are going to be producing this glass here in Illinois."

Tipsword: "And is some of it already being produced here?"

Pappas: "Ah... yes it has. That's my understanding, yes."

Tipsword: "Thank you."

A. Telcser: "Is there further discussion? Gentleman has offerred to move the adoption of Amendment No. 1 to House Bill



- 4299. All in favor of adoption, signify by saying 'aye', the opposed 'no'. The Amendment is adopted. Are there further Amendments? Third Reading. O'kay, if the House will stand at ease for a couple of minutes. We'll wait until the Speaker comes back."
- Hon. W. Robert Blair: "All right, with leave of the House, we'll go to Senate Bills, Third Reading, which appears Senate Bill 1281, which the Gentleman from Cook, Mr. Frank Wolf asks leave to have brought back to the Order of Second Reading for purposes of an Amendment. Hearing no objection, the Bill will be brought back to the Order of Second Reading."
- F. B. Selcke: "Senate Bill 1.... Amendment to Senate Bill 1281. Amendment No. 3. Wolf. Amend Senate Bill 1281. Page 1 and so forth."
- Hon. W. Robert Blair: "Gentleman from Cook, Mr. Wolf."

  Wolf: "Having leave to ah... Table Amendment 2, I offer

  Amendment 3, which is no different than eliminating two
  features of the Amendment 2, which have been on your desk
  here two weeks ago. What these two amendments did was to
  ah... ah.... eliminate Section 119.1, which is the
  post retirement increment in the Retirement Annuity, leaving
  it at the age of 60 instead of the 55 and the other ah...
  cancellation or the, shall I say, tabling would be Section
  2-150, which is the Reciprocal Law. Ah... House Bill
  3660, which was ah... Mr. Miller's Bill, reduced the
  Reciprocal Law from eight to six and it was the wishes of



Pension Law Commission to leave it as is, and therefore I ask the adoption of Amendment 3 to Senate Bill 1281."

- Hon. W. Robert Blair: "Discussion? Gentleman from Cook, Mr. Downes."
- Downes: "Mr. Speaker, Ladies and Gentlemen of the House, Are we tabling an Amendment?"
- Wolf: "I had... Mr. Downes, I had the Chair, that is, the Speaker bring back Senate Bill 1281 for the purposes of Amendments and therefore I asked the ah... Speaker to table Amendment 2, in lieu of Amendment 3."
- Hon. W. Robert Blair: "All right, the gentleman's asking for unanimous consent to Table ah... Amendment No. 2. Is there objection? All right, hearing none, Amendment No. 2 will be tabled and the gentleman now has offerred for adoption Amendment No. 3. Is there any further discussion on Amendment No. 3? Gentleman from Cook, Mr. Richard Walsh."
- R. Walsh: "Was the gentleman going to explain Amendment No. 3, Mr. Speaker?"
- Wolf: "Yes, I will. It's identical to Amendment No. 2, outside of... The Amendment No. 2 was originally a five pointed amendment, and I eliminated because of the wisdom of the Pension Laws Commission, which met yesterday, two features of that particular amendment, which I quoted before, and that was the Section on reciprocity, where I left it status quo, which was from eight to six, and the other one was that of the cost of living increment to remain at sixty instead of fifty-five, and that is the only change made



in Amendment 3."

- Hon. W. Robert Blair: "Is there further discussion? All those in favor of the adoption of Amendment, say 'aye', the opposed 'no'. The 'ayes' have it. The Amendment is adopted. Are there further Amendments? Third Reading. Gentleman from Cook, Mr. Hyde."
- Hyde: "Mr. Speaker, Ladies and Gentlemen of the House. I now move that the House stand in recess for one-half hour for purposes of a Republican Conference. Republicans to convene in Room 212, and I believe the distinguished Minority Leader ah... with the Turkish pipe has a similar announcement."
- Hon. W. Robert Blair: "Gentleman from Union, Mr. Choate."
  Choate: "For the Majority Leader's information, it isn't a turkish pipe cause it's hot, and they are water cooled.
  Yes, Mr. Speaker, I would like to ask the Democratic Members to join me in Room M-5 immediately for the purpose of a Democratic Conference."
- Hon. W. Robert Blair: "All right, we'll be in recess then until approximately 1:30 for the purposes of these two conferences."



Hon. W. Robert Blair: "We are now in the Regular Session. The Chair recognizes the gentleman from Cook, Mr. Hyde."

Hyde: "Mr. Speaker, Ladies and Gentlemen of the House. for your information, ah... we have been holding extended meetings ah... in conjunction with the Senate. There is no further business that we can address ourselves to today, but we expect tomorrow morning the Senate to send us over some material tomorrow morning that we will have to deal with. Ah.... and I might point out the matter of when we adjourn and ah... whether we will be here over the weekend, or we will adjourn and come back Monday, still must await a determination by the Senate, as to its wishes and ah... so we are unable to give any firm word on that. However, we will know tomorrow within time to check out of the motels and hotels before checkout time, but ah... in the words of the mortal, Jack Touhey, 'stay loose on that subject', and before I make a motion, I will yield to ah... Peter Granata."

Granata: "I just misunderstood you."

Hon. W. Robert Blair: "All right, gentleman from Union, Mr. Choate."

Choate: "Well, Mr. Speaker, I would ask the Democratic
Members to give me their strict attention. I would ask
that you be on time in the morning for the convening of
the session so that we can attend a Democratic Conference.
I think it will be of the utmost importance that you be
in attendance, which will be at approximately 10:00 in the



morning, after we convene. I mean 11:00 O'Clock after we convene."

- Hon. W. Robert Blair: "All right, ah... for what purpose does the gentleman from Vermilion, Mr. Campbell arise?"
- Campbell: "Mr. Speaker and Ladies and Gentlemen of the House.

  Ah... I would like to move that the Senate Bills 1515

  through 1520 ah... be taken from the Table and placed on
  the Order of First Reading. I've cleared this with both
  sides of the aisle and I know of no opposition. These are
  Bills pertaining to the seven percent interest rate for
  municipal bonding."
- Hon. W. Robert Blair: "All right, the gentleman has moved to take the Bills that he indicated from the Table on the Order of Second Reading. Discussion? The gentleman from Christian, Mr. Tipsword."
- Tipsword: "Would the gentleman care to tell us what the specific provisions of the Bill are in regard to interest rates?"
- Campbell: "Yes, previously ah... we have a seven percent interest rate. As a matter of fact, the interest rate is now 7% and this will merely extend that time from July 1, 1972 to July 1, 1973. Ah... two terms ago, it was decided to revert back to the legislature to take a look at these interest rates at that time. Of course, they... interest rates can be lower than that, but not more than 7%."
- Tipsword: "Does this mean we are going to start this procedure of continuing all of those interest rates that we



raised after a long fight two years ago?"
Campbell: "Mr. Speaker, I would object."

Hon. W. Robert Blair: "The gentleman from Madison, Mr. Calvo." Calvo: "Mr. Speaker, Ladies and Gentlemen of the House, House Bill 2416 was in Conference Committee at the time we adjourned on June.... or recessed on June 30th, and the Second Conference Committee had not had an opportunity to complete their meeting at the time of adjournment, and the synopsis shows that Bill tabled in the House. I would move at this time, Mr. Speaker, to move the appropriate Rules to have the Bill removed from the Table in order that the Conference Committee may again meet to consider the Bill."

Hon. W. Robert Blair: "All right. The only thing is, you'll have to wait because we have a prior piece of business pending on the floor. Mr. Campbell is now in consultation with Mr. Tipsword on his objection and I'll get right back to you as soon as we finish that. What purpose does the gentleman from Champaign, Mr. Clabaugh, arise?"

Clabaugh: "For the purposes of making an announcement, Mr.

Speaker. I would like to call the attention of the members of the Education Study Committee - Representative

Rose, Representative Phil Collins, Representative Yourell,

Hart and Stone, to the fact that as soon as we adjourn,

fifteen minutes later, we will have our short meeting on
