Senate Joint Resolution 8 there is some question in my mind whether it should be an agreed resolution and I would ask if there's anyone here who is a member of the Joliet Marquette Tricentennial Commission or Committee. If there is..I would..a..ask that they ...a..."

Arthur Telcser: "Representative Shea, for what purpose do you rise, sir?"

Representative Shea: "Mr. Walsh, I understand that the Speaker has not appointed the members...a...I know the people from the Commission had talked ...a...to the Speaker about Representative Tuerk and myself and I would ask that you just hold that until we find out just what is, what the Speaker's posture on appointments is gonna be."

Representative Walsh: "Let me say what it is, Jerry. What the

Arthur Telcser: "On the order of motions, the Gentlement from Cook, Representative Douglas."

Representative Douglas: "Thank you Mr. Speaker. It was my intention, Mr. Speaker, at this time, to do something which I hesitate very much to do and that is to ask this body to bypass committee to hear House Resolution 7 on the floor. I have spoken to my co-sponsors, and have decided with their concurrence and I might mention that this Resolution would request the Legislative Investigating Commission to undertake an investigation of the business practices of the Chicago Transit Authority. The C.T.A., itself, at a hearing a few weeks ago in Chicago agreed that they would be happy to cooperate with such an investigation. It was our feeling that if this Resolution were to pass now, and the investigation were to get going, as we reached a compromise and pass the Bill out of the House which would help C. T. A., that it might be in the best interests of the people of the City of Chicago and the



State of Illinois; however, speaking with Representative Collins this morning, I have agreed not to ask to bypass Committee, Mr. Speaker, thank you very much for allowing me this moment to mention the Resolution, it will, according to Representative Collins, be brought before the Executive Committee, next Thursday morning and I would invite any memeber of this House to which the many of us already on this Resolution who feel that the C.T.A. investigated at the same time that we help it out to join the resolution and I will be there to here it in Committee next Thursday morning. Thank you."

Arthur Telcser: "We are down to the order of announcements.

Arthur Telcser: "House Bill's first reading."

Fred W. Selcke: "House Bill 377, Bradley, Amends the Criminal Code of '61, first reading of the Bill."

Arthur Telcser: "Death resolutions."

Fred W. Selcke: "House Resolution 57, Washburn et al. Whereas the Body joins family, friends, and all people of Illinois in mourning the passing of our former State Representative Thomas R. Houd, 47 years old, Kankakee, who died at 7:00 P.M., Tuesday, February 20, 1973, at St. Mary's Hospital."

Arthur Telcser: "Will the members please be in their seats,

this is a death resolution of a former member."

Fred W. Selcke: "And whereas he had served the State Legislature



for three terms, being first elected in 1966, and prior to that, had been a member Kankakee Board of Supervisors, was Township Clerk for eight years, served on the County Housing Authority for five years, and was the first President of the Kankakee Land Community Program, and whereas Mr. Houd was born November 28, 1925 in Kankakee to Mr. and Mrs. Thomas Houd and was reared and educated in Kankakee, later attending St. Bead's College at Peru and both Loyola University and DePaw University in Chicago and whereas he served with the Fifth Army Aircorp in the South Pacific during World War II and after his discharge he became active in the Disabled Veterans and served as Illinois State Commander in 1952, and 1953, holding numerous local and regional offices in this D.A.V. and serving on the State Board of Illinois Association of Crippled Children, and whereas he was a member of numerous civic, fraternal and veterans associations, including the Knights of Columbus, American Legion, an Elk, St. Patrick's Hurdle Club, Southside Athletic Club, Lion's Club, Holy Name Society, and Amvets Post 132, and whereas he was a member of the Commission to Investigate Hospitalization of Paraplegics, and as a member of the General Assembly, he served on the Solicitation and Collection Law Revision Commission and was vice chairman of the County Problems Commission, and whereas he operated his own business in Kankakee, Tom Houd Accounting, was also in the insurance, public relations business, and in printing and direct mail



literature distribution, and whereas he is survived by his wife, Ardis, and five stepchildren, Karen, Larry, Barry, Gary, Karen, all at home, a daughter, Mrs. Linda Moffis of Verbonis, a mother, Mrs. Lillian Houd of Kankakee, brother, James of LaPort, Indiana and sister, Mrs. Madonna Brucell of Kankakee. His first wife was the former Mary Jean Maylow of Kankakee. Therefore, be it resolved by the House of Representatives of the 78th General Assembly, State of Illinois, we deeply regret the passing of our esteemed and respected former collegue, Thomas R. Houd, that we wish to note with all respect his achievements in the service of his State and that our heartfelt sympathies are with his family, and be it further resolved that a copy of this Preamble and Resolution be presented to the family."

Arthur Telcser: The Gentlemen from Grundy, Representative
Washburn."

Representative Washburn: "Thank you Mr. Speaker and Ladies and Gentlemen of the House. A vacuum has been created in the lives of those of us who have served during the 75th, 76th, and 77th Session of the General Assembly, as well as in the lives of countless other people throughout the State by the passing of Thomas R. Houd. We enjoyed Tom's congenial manner and remember him as a protector of local government, as well as a champion of the war veterans. Tom looked forward to the day he could assist Viet Nam prisoners of war who began returning home on the very day
