All right, while we are getting the roll call, established..., I would like to take this opportunity to introduce a distinguished guest, Major General Frank W. Elliot, Jr., who is Commander of Chanute Technical Training Center at Chanute Air Force Base at Rantoul, Illinois. He wants to say hello to us. General."
- Major General Frank W. Elliot, Jr.: "Mr. Speaker, Members of the House, I appreciate the opportunity to say a few words to you today. Recently, I purchased a book on speech-making.



On the dedication page, the author dedicated the book to his daughter, then went on to say: 'It is also written in memory of General George Armstrong Custer'. Let his last engagement serve as a reminder to you. Learn something about your audience. I hope I am before a friendly audience. I know you are very busy, so I will keep my remarks brief. First of all, I would like to say that I sisncerely appreciate the opportunity to address you in this manner. I come to you today to speak on one of the larger, or say a few words on one of the larger educational institutions in the State of ILLInois. It is the Chanute Technical Training Center located at Rantoul. We feel that we do have a large number of students going back and forth to classes at various times of the day ought to be a little more orderly than a number of the educational institutions in the United States, because we certainly have not gotten away from marching completely. We do have a pretty lined street and shaded walk, for students who aren't laden with books and papers, stop to look , not at statues of long dead Generals or bygone General's alumni, but at aircraft . We have dormitories where, on a sunny day, you can hear, from open windows, not the strains of John Phillip Sousa, but the amphlified guitar of a Three Dog Night. ON the same sunny day, you might see on the surrounding lawn, young men and women who, just a few short months ago, could hardly wait to get away from the pencils and the books and teachers dirty looks. Now, with their noses buried deep in their books, at such alien things as court

value and... the emphasis of non-distructive... and the inner workings of equipment designed to measure the height of clouds above the earth. We do have a cirriculum which will not cease in humanities, and fine arts but is equal to other classes, that which you would find in almost any vocational or educational institutions in the United States today. Not only are cources varied and our teaching methods modern, but we are accredited by the North Central Accreditation Association of Universities and High Schools. The same association which gave accreditation to the University of Illinois at Champaign-Urbana. Our instructors are acknowledged experts in this field, and their teaching methods have been proven to the arena of actual experience. When a young man or woman graduates from Chanute Air Force Base, they take with them not only the skills to perform their jobs in today's modern airport, but also acknowledge that their training can be applicable to any civilian occupation. Most cources taught at Chanute result in from 3 to 20 some semester hours of college credit. The recently activated Community College of the Air Force at Randolph Air Force Base in Texas, maintains a transcript for each of our young men and women who might enter the Air Force. We do call Chanute, or you might call Chanute one of the campuses of this college. We're not a degree granting institution, nor are we in competition with other civilian colleges or universities. To the contrary! We are assisted a great deal by the faculty and administrators of the University of Illinois, Parkland College in acchieving our creditation in November of



I might point out that not only we spend a lot of time teaching, but we also spend a lot of time learning. We have a large number of our instructor and other base personel are enrolled in home base night classes taught by Parkland College, Southern Illinois University, Eastern Illinois University. OUr classrooms vary from the standard room with tables, chairs and chalkboards to missle silos, complete with elevators, similators and control consoles. We have airplanes that have been taken apart and put together so many times, we've had to replace the bolts and screws due to wear and tear. New technical training center is a large operation. We have between five and six thousand students at any one time, enrolled in any one of two-hundred plus cources. We are capable of teaching any one of these two-hundred at any one time. At the present time we have approximately 500 young women. The students learn to be air craft mechanics, jet engine mechanics, and how to maintain the Minuteman Intercontinental Balistic Missle. Each year we graduate over 25,000 student, sending them to all countries of the world in which we might have Air Force Communication. The annual operating budget at Chanute Air Force Base is in excess of \$100,000,000, and has been so for some two years. This is.. this is.. a good majority of this goes for personnel pay, both military and civilian. Conservative estimates figure that in excess of \$80,000,000 per year goes back into the surrounding communities. addition to the construction, that is that we are presently engaged. We have approximately 10,000 military and 1800.

civil service. There are some 15,000 apprenticeships at Chanute Air Force Base. In addition to these, there are another 1,000 people working for non-appropriated fund activities, the construction of dormitories, and exchanges and the contract services for the dining facilities. Our people are closly integrated into surrounding communities in every way, and the PTA, the Boy Scouts, and the many other civic programs. One of our officers is president elect of the Rantoul Rotary Club. If I sound like I'm speaking as a member of the Chamber of Commerce for East Central Illinois, perhaps I am. Our friends, in fact, in Rantoul and the twin cities, Champaign-Urbana, have certainly made us feel at home. As a matter of fact, we have a base community council made up of the mayors, the Presidents of the Chamber of Commerce, and the executive secretaries of these communities. Chanute itself, is represented by a technical training center commander, the Air Way Strip Commander, and the Director of Information. In my thirty-one years of service, I've never seen such close friendship and cooperation. We work well whether the occasion is business or social. Recently, fifty of our young airmen participated and volunteered to participate to go to Homer Lake over a week-end, to assist in clearling up the debris from a recent tornado. Two weeks ago, the Rantoul Garden Club presented to the Air Base, twenty-six young trees for base beautification. I could go on and on with any number of things that have occured in the two years I've been at Chanute. When the military lead a transient

existance, the home is very often the trunk of our car, and our friendships are many but fleeting, which is not the case at Chanute. On behalf of the people of Chanute, I would like to say thank you , and reciprocate in some way for the fine hospitality we have received from the People of Illinois. I'd like to extend an invitation to you to come to Chanute and see our base for yourselves. Acting on behalf of the Chanute Base Community Council, each of you will receive a personal invitation to come to Chanute, see our facilities, observe our methods, meet our kids, and see how your tax dollars are being utilized.
