O'Brien: "The floor session is scheduled to start at noon, rather than 1 o'clock. There was some erroneous information put out."

Speaker Redmond: "It looks like we're going to have to stand at ease, until we get some more Members. Representative Lundy has question the quorum so we will have to wait."

Speaker Redmond: "The House will come to order, will the Doorkeeper make the announcement."

Doorkeeper: "All those not entitled to the floor, please ajourn to the gallery... All those not entitled to the floor, please ajourn to the gallery."

Speaker Redmond: "The House will be lead in prayer by Father Krueger."

Father Krueger: "In the name of the Father, the Son and the Holy Ghost, Amen. Bless us to Thy service O Lord this day, Amen. Long ago a monarch of India, asked for a motto short enough to be engraved on a ring... and suitable alike, and prosperity and adversity. His daughter gave him an emerald inscribed with the words... this too shall pass away, and it was written in Arabic. Let us pray. Direct us O Lord and all our doings, with Thy most gracious favor and further us to Thy continual help. That in all our works begun continued and ended in Thee, that we may glorify Thy holy name and finally, above Thy mercy obtain everlasting life, through Jesus Christ our Lord. Amen."

Speaker Redmond: "Roll call for attendance."

Speaker Redmond: "There being 97 Members answering the roll, the quorum is present. Representative Shea, the Gentlemen from Cook County desires to be recognized."

Shea: "Mr. Speaker, I'm wondering that if the Journal could show, that Representative Getty, Berman and Beaupre, were absent because of illness and that Representative Huff, is... absence is excused."

Speaker Redmond: "Hearing no objections, the Journal will so indicate."

Speaker Redmond: "Representative Washburn."

Washburn: "Ah.. yes. Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I would like to have the records show, that Rep-



representative Waddell is absent, due to ah... hospitalization.

Thank you."

Speaker Redmond: "Hearing no objections, so Journalize."

Speaker Redmond: "The order of business is the reading of the Journal of the previous meeting. Mr. Clerk is the Journal printed.... I have been advised by the Clerk that the Journal to the last meeting, is not printed. Does the gentlemen from Winnebago, Representative Giorgi, move that the reading of the Journal be dispensed with."

Giorgi: "I so move, sir."

Speaker Redmond: "All in favor indicate by saying "aye". Opposed "no". The motion carried. Mr. Clerk, it appears that there is 120, present. Do you want to change from the hund..."

Speaker Redmond: "Any Petitions or messages, Mr. Clerk... No messages"

Speaker Redmond: "Reports of Committees, Mr. Clerk... any reports of Committees? No reports of Committees."

Speaker Redmond: "Introduction First Reading House Bills."

O'Brien: "House Bill 482, McPartlin. A Bill for an Act to amend the Illinois Pension Code. First Reading of the Bill. House Bill 483, Emil Jones. A Bill for an Act to amend the School Code. First Reading of the Bill. House Bill 484, Williams. A Bill for an Act to regulate Campaign Financing. First Reading of the Bill. House Bill 485, Williams. A Bill for an Act to amend Sections of the Copper Purchase Registration Law. First Reading of the Bill. House Bill 486, Williams. A Bill for an Act to amend Section of the Unemployment Compensation Act. First Reading of the Bill. House Bill 487, Sharp, et al. A Bill for an Act to amend the School Code. Speaker Redmond: "Representative Hirschfeld."



Hirschfeld: "Mr. Speaker, and Ladies and Gentlemen of the House. While we're on House Bill, First Reading, as a principal sponser of House Bill 363, I would ask leave to table that Bill."

Speaker Redmond: "Leave to table House Bill 363. Does the Gentleman have leave? Hearing no objections, leave granted, the Bill is tabled."

Speaker Redmond: "The Bills introduced will be entered in the Journal."

Speaker Redmond: "Agreed Resolutions. Representative Shea, agreed Resolutions. No, Agreed Resolutions, there being none..."

Speaker Redmond: "Senate Bills... Third Reading. Senate Bill 38. Representative Calvo. You got the Bill, Mr. Clerk?"

O'Brien: "Senate Bill 38. A Bill for an Act to amend Sections of the Anti-Pollutions Act. Third Reading of the Bill."

Speaker Redmond: "Representative Calvo."

Calvo: "Yes. Mr. Speaker, Ladies and Gentlemen of the House. This is the same Bill that ah... the last time we were here we... suspended the ah... rule... or had unanimous consent, so it advanced to Second Reading without reference to Committee. The ah... all this Bill does, is amend the Anti-Pollution Bond Act to provide that the Treasurer of the State of Illinois can appoint someone to sign the Bill... to sign the Bonds, in his absence from the State... Now the ah... this... a little order Speaker. This ah... this puts this ah... Anti Pollution Bond Act in the same position as the rest of the Bond Act. It doesn't make any other changes, it is a fact that the Treasure will be out of the State, and we need this passed as soon as possible because ah... his vacation starts shortly and there will be some bonds to be signed in his absences. I would appreciate your favorable vote on this Bill to pass on the Third Reading."

Speaker Redmond: "Any discussion? The question is, shall this Bill pass. All those in favor signify by saying "aye". Opposed, vote "nay". All voted that wished. Representative Calvo."

Calvo: "Mr. Speaker, I would assume that we need 107 votes, I just wanted you to wait a second. This has to be effective immediatly..."



No... Okay... Well, we've we got them anyway now."

Speaker Redmond: "On this question there are a hundred... Take the roll. On this question there are 110 "ayes", no "nays". This Bill having received Constitutional Majority, is declared passed."

Speaker Redmond: "Senate Bill. Second Reading, Mr. Clerk."

O'Brien: "Senate Bill Bill 34, Brandt. A Bill for an Act to repeal certain appropriation of the Capital Development Board and to make a like appropriation of the Secretary of State for the same purpose. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments form the floor? Representative Shea."

Shea: "Mr. Speaker, I believe there is an error in the printing of the calendar, is there not, and that this Bill in on Second Reading, Second Legislative day."

Speaker Redmond: "That is correct. I have been advised by the Clerk that that is correct."

Shea: "Thank you."

Speaker Redmond: "No Amendments from the floor. Third Reading. Any agreed Resolutions? "

Speaker Redmond: "Senate Bills, First Reading."

O'Brien: "Senate Bill 17. A Bill for an Act to amend the State Finance Act, by adding the Capital Development Board. First Reading of the Bill."

Speaker Redmond: "Representative Shea, any Agreed Resolutions."

Speaker Redmond: "House Bills, First Reading. Introductions of Bills."

O'Brien: "House Bill 490, Mugalian. A Bill for an Act to amend Sections of the Elections Code. First Reading of the Bill. House Bill 491, Kempiners, et al. A Bill for an Act to amend Sections of an Act to provide the Law in relation to counties. First Reading of the Bill. House Bill 492, Mugalian. A Bill for an Act to amend Sections of the Election Code. First Reading of the Bill. House Bill 493, Bradley, et al. A Bill for an Act to amend Sections of the School Code. First Reading of the Bill. Speaker Redmond: "Representative Washburn, do you desire recognition?
There being no further business before the House, Representative
Shea is being recognized for the purpose of a motion of adjournment.
just a minute Mr. Shea. Representative Washburn."

Washburn: "Thank you, ah... Mr. Speaker. I would like to note... notify
the ah... Republican Members that there will be a short conference
in Room 212, in about 10 minutes, if we are ready to adjourn. A
Republican Conference in Room 212, in 10 minutes."

Speaker Redmond: "A Republican Conference in Room 212, 10 minutes
after adjournment. Now, Representative Shea."

Shea: "Mr. Speaker, there has been posted in... the Executive Com-
mittee..."

Speaker Redmond: "Attention please, this is an important announcement,
it concerns the Committee Hearings tomorrow."

Shea: "First Mr. Speaker, there has been posted an Executive to be
heard a ah... Resolution, a House Joint Resolution 10, that had not
been assigned to the Committee. The Committee on assignments met
and just assigned that, so with leave of the House, we would like
permission to hear that Resolution today, if there are no objections."

Speaker Redmond: "Are there any objections? No objections, so ordered."

Shea: "Now the calendar indicates that certain Committees that meets
tomorrow morning... are to meet at 9 o'clock, that is an error
and all Committees will meet at 10 o'clock starting at 10 o'clock
tomorrow morning, not 9 o'clock. So, I hope everybody heard that,
that the Committees on the calendar, posted for 9 o'clock will not
meet until 10 o'clock tomorrow morning, and therefore Mr. Speaker,
there is nothing further, I would move that the House do now stand
adjourned, until 9:30 A.M. tomorrow morning."

Speaker Redmond: "Before putting that in motion, Representative Tuerk,
do you desire recognition?"

Tuerk: "Mr. Speaker, Members of the House. I notice by the calendar



on these Committee Meetings... ah... the first day of Committees already have a conflict ah... Elementary and Secondary and Labor and Commerce are suppose to meet at the same time. I happen to serve on both of those Committees. I wonder if the Chairman, of those Committees can get together and ah... reassign them to a different time. It's ah... impossible to be at both places at the same time."

Speaker Redmond: "Chairmen on Elementary Education.... Representative Shea."

Shea: "Well, Mr. Speaker, I don't know ah... the conflict... but if on Elementary and Secondary Education, that's a four hour Committee that would normally meet on Tuesdays, so you should not have any other Committees on that same date."

Speaker Redmond: "Representative Tuerk."

Tuerk: "Well, the point is that the records show that both Committees are listed at the same time, on the same day. And that's the basis of my ah... calling it to the attention of the Chairman of each Committee. Elementary and Secondary is meeting in Room C1, at 9, and Labor and Commerce is meeting, 122B at 9. Exactly the time."

Speaker Redmond: "Representative Shea."

Shea: "I... I think there is a mistake and we'll get it straightened out, the ah... Wednesday Committee which I think Labor and Commerce is, should be meeting tomorrow afternoon, instead of in the morning."

Speaker Redmond: "Now, the motion for adjournment, Representative Shea."

Shea: "I'm wondering Mr. Speaker, with leave of the House, if we could go back to the order of Resolutions and ask the Clerk to read the Resolution."

Speaker Redmond: "Any objections? Hearing none we will go back to the order of Resolutions. Mr. Clerk."

Speaker Redmond: "Representative Fary, do you seek recognition?"

Fary: "Yes, ah... what is the ah... time of the meeting of Labor and Commerce Committee, tomorrow? When and where."

Speaker Redmond: "10 o'clock."

Fary: "10 o'clock, tomorrow morning in Room 122."

Speaker Redmond: "Right."

Fary: "Thank you."

Speaker Redmond: "I wonder if we could all yell at once and then maybe not yell anymore. This is a little bit like the Tower of Babel. Will you please come to order, we only have a very few minutes of business here. Representative Tuerk."

Tuerk: "Well, I thought, I just heard the Majority leader say there was a Labor and Commerce meeting in the afternoon, now... I would hope that you fellows would get together over there and ah... get these times straight."

Speaker Redmond: "The point is well taken, I'll recognize Representative Shea."

Shea: "The Tuesday Committees will meet in the morning and the Wednesday Committees will meet in the afternoon. And, I believe Labor and Commerce... is a Wednesday Committee, therefore it will meet at 2 o'clock in the afternoon... not 10 o'clock in the morning."

Speaker Redmond: "Does that answer your question, Representative Tuerk. Representative Geo-Karis."

Geo-Karis: "Ah... Mr. Speaker, I believe ah... I have to wait until Mr. Shea... he has a Resolution he is going to prefer for reading."

Speaker Redmond: "Would you read the Resolution, Mr. Clerk."

O'Brien: "House Resolution number 76. Schneider, Kelly. Whereas are esteemed colleague and friend, the gentlement from Oak Lawn, the Honorable Harry Yourell, celebrates the anniversary of his birth on February 27. An whereas, Buss was born under the sign of Pisces, the fish and the fact has been the guiding factor his entire life. And which has lead him... to dampen many a steel hook in the waters of Illinois. And, whereas, Buss Yourell, known in Springfield as one of the most resolute of legislators, is anxious to launch his new battleship size fishstalker, in Lake Michigan in the search for many fund... ah... if any ones, which are without mercury content. And, whereas he retired from the restaurant business to pursue his two favorite forms of relaxation after fish-



ing, which are legislating and telling fish stories, some of which are true... and he seldom gets his fish stories mixed with his legislative. And, whereas this shy... retiring... self-effacing Member is beginning his fifth term in the House, and has through his goodness, patience and willingness to take a back seat... and given new offices which are due to be written up in Better Homes and Gardens, and in Playboy. And, whereas, no citizen be he consituent or fellow legislator has any trouble finding Buss, as he can always be found stalking the halls in the accompany office neighbor and bodyguard, the Honorable Dick Kelly, and sometimes his raccoon. Speaker Redmond: "Representative Geo-Karis."

Geo-Karis: "Mr. Speaker, and Ladies and Gentlemen of the House, my colleagues on my left has asked me to start the Happy Birthday song for Buss. So let's all join together and sing Happy Birthday for dear Buss: Happy Birthday to you, Happy Birthday to you, Happy Birthday dear Bussie, Happy Birthday to you."

Speaker Redmond: "Representative Yourell."

Yourell: "Thank you Mr. Speaker, and Adeline and all the fine voices that joined in. I want to... tell you on the occasion of my 56th Birthday that if you really want to know how to ah... customize an automobile, take a look in the north lot... and you will see what I mean. On the way down to McLean, a steel truck sideswiped me, and took half of the car with me, so I'm delighted to be here today to ah... sing Happy Birthday to me, it could have been very well my



last. Thank you very much."

Speaker Redmond: "The question is on House Resolution 76. All in favor indicate my saying "aye". Opposed. The "ayes" have it. Resolution is adopted."

Speaker Redmond: "Representative Fleck, do you desire recognition?"

For what purpose does the gentlemen rise?"

Fleck: "On a motion Mr. Speaker."

Speaker Redmond: "In the order of business of motions, I would suggest that we pay very strict attention, because this Member never has any trivia."

Fleck: "Ah... Mr. Speaker, this is just a very simple motion to discharge the Executive Committee, I cleared this matter with Representative Matijevich. And it deals with House Bill 97, now what House Bill 97 does is, it corrects an error in the pay raise Bill which the Senate ah... created by an Amendment. They usually do things like that ah... in the Directors in the State ah... official pay raise Bill, the Court of Claims Judges were to be paid \$22,500. Well, the Senate felt that they should cut that down to \$19,000 but what their Amendment did was cut it down to \$12,000, so the Judges in the Court of Claims are presently making less money this year than they did last year. What this Bill will do... I'm trying to discharge the Committee to get it out on the floor and pass it... to correct the error so that these poor fellows don't starve for the next 3 months before we pass any legislation. And I would just ask for the support, it has been cleared as I said, with the Chairman of the Executive Committee."

Speaker Redmond: "Any discussion Representative Washburn."

Washburn: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Representative Fleck, I think, presented the case quite well, it was an error from the other side of the Rotunda, and instead of ah... ah... minor increase they received an substantial decrease in salary due to ah... this Amendment that was passed over in the Senate, and I would also ask for your favorable vote."

Speaker Redmond: "Representative Katz."

Katz: "Ah... Mr. Speaker ah... are you now seeking unanimous consent,



to waive the rule regarding.... assignment to Committee, is that where we are at this stage?"

Speaker Redmond: "This is a motion to... discharge the Committee in advance... the Bill to Second Reading. And I understand that..."

Katz: "Well, Mr. Speaker, I dislike ah... having to be difficult, but it's very early in the session... once we start doing it for one, we are going to have to do it for everybody, you can't really draw the line... ah... it doesn't seem to me that ah... any great harm would come by sending it to Committee, and if the merits are, as I'm sure that they are, and is explained by the chief sponsor, the Committee will report it back quickly.... accordingly I can not give unanimous consent, because I just don't believe that that's the way we ought to operate and we have to apply the same rules to the distinguish gentlemen in Chicago that we apply to everybody else here, so I'm gonna have to not lend my consent to the baptizing of Committee, I regret it."

Speaker Redmond: "Any other discussion, Representative Fleck."

Fleck: "Just in closing Mr. Speaker, I would agree with Representative Katz, in what he is attempting to do. However, I think there is a question if equity and fair play... these gentlemen have received a pay decrease, due to an error in the Senate and I think that it's on our part in the House, and the Senate now to do everything that we can to expedite this Bill and correct the error that the legislature made. And I think that is a fair enough exception that we can discharge the Committee, and at least move the Bill along rapidly so that these gentlemen are paid the proper salary which they should have received. And I once again urge the support of the House."

Speaker Redmond: "Representative Matijevich, for what purpose do you rise?"

Matijevich: "Mr. Speaker, and Ladies and Gentlemen of the House. I rise to support ah... Representative Fleck, because I would ordinarily fight a motion to discharge a Committee, but because of the error that has been made, and I think that in the ah... spirit of



equity... so that we correct that error as expeditiously as possible, ah... I would support his motion and since there has been ah... since Representative Katz, has not allowed unanimous consent ah... I would ask that you support Representative motion.... ah... Fleck in his motion."

Speaker Redmond: "The question is, on the adoption of the motion. All those in favor indicate by saying "aye", and those "no"... ah... voting "aye" and those opposed "no". Take a roll call."

Speaker Redmond: "On this question the "ayes" have 108, "nos" 7. Representative Collins, votes "aye". The "ayes 108, "nos" 7. Motion carried. Second Reading, First legislative day."

Speaker Redmond: "Now, Representative Shea."

Shea: "Mr. Spook.... Mr. Speaker, I move that we now adjourn until 9:30, tomorrow morning."

Speaker Redmond: "It's been moved that we adjourn until tomorrow morning at... what time? 9:30 A.M.. All in favor signify by saying "aye". Opposed "No". We adjourn till tomorrow morning at 9:30."
